REQUEST FROM AMERINDIAN CENTER TO REALLOCATE \$50,000

The Amerindian Center is requesting the release of \$50,000 previously approved for the Furniture Restoration Project to pay off the mortgage on the property in order to free up funds. Kathy Hughes is recommending that at this time we approve the \$25,000 lump sum payment for the purpose of decreasing the monthly debt burden. This payment would not be made until April 1, 1988 as previously planned. \$25,000 will be identified in the FY '89 budget. Purcell would like to see an updated report. Kathy will follow up on this.
