Resolution #5-26-88-A for Refinancing the Rodeway Hotel

WHEREAS, the Oneida Tribe has determined to refinance the mortgage on the Oneida Rodeway Inn, and

WHEREAS, the refinancing includes a recapitalization plan, and

WHEREAS, the Lender, Associated Kellogg Bank, requires \$500,000 to be identified on date of closing, and

WHEREAS, these funds will be set aside in the name of the Oneida Tribe.

NOW THEREFORE BE IT RESOLVED: That the Oneida Business Committee hereby authorizes \$500,000 to be placed in a restricted account earning interest in the following manner; \$300,000 to be placed in a restricted accounted earning interest on date of closing and \$200,000 to be placed in a restricted account earning interest by September 30, 1988.

BE IT FURTHER RESOLVED: That the restricted account may be a certificate of deposit, treasury bill, money market account or any such type of account which will guarantee the principal deposit while earning a specific rate of interest.
