



### REGULAR MEETING

FRIDAY, JULY 22, 1988

Meeting called to order at 9:10 a.m.

Chairman Powless questioned why the original meeting was cancelled. Sue Pastor and Dennis Cozza explained that they did not want to interfere with Green Peace, who were scheduled to be in the area at the same time. The took full responsibility for cancelling the meeting.

Dennis explained the process of how Fort Howard is put on the Superfund. AT the present time, they have been nominated to be on the list and there is a 60 day comment period before it is final if they are put on the Superfund. The process is to identify the Potential Responsible Party (PRP) for the pollution. The PRP has 60 days to negotiate, clean up, and can be extended 30 days. During this time, a consent order is developed to do remedial investigation for clean up.

Remedial investigation includes testing underground water, endangerment assessment to human health and environment, surface water pathways and air surface pathways.

The Negotiation process totals 90 days to develop a work plan to study the details of the action plan to can take 18-22 months. The Health and Safety Plan included must follow EPA guidelines and procedures.

A feasibility study is evaluated and alternatives given which must follow 9 specific points which include cost, overall protection of human health and the environment, long and short range goals, community acceptance and state acceptance. The plan is presented for 21 days for comments. The Record of Decision is then negotiated with the PRP.

The lead agency for Fort Howard has not been determined. The Tribe has the option to be a copartner or DNR and Tribe can be the support agency for consultation.

The final determination for the Superfund list is anticipated in March of '88.

Funds are available for technical assistance grants so that communities can play a larger part in the process. A 35% match up to \$50,000 grant.

Comments during the 60 days must provide good solid information. Mobility, toxidity, and volume are the criteria used to determine alternatives for clean up of sites.

Chairman Powless called the Regular Meeting to order at 10:00 a.m.

David King moved to have a special meeting to discuss the Curfew Ordinance. Ernie Stevens seconded. Motion carried. David King will follow up by setting a date, time and place for the meeting.

## - Highway Railroad Transfer Project

Community concern regarding the Highway-Railroad transfer project by G.B. & Western RR and the rezoning of 117 acres of land from agriculture to light industry. The project will increase truck traffic through Oneida by 100 trucks daily.

Ernie Stevens moved to request the Outagamie County Zoning Commission to defer any action pending a review by the Oneida Community. If deferral is declined then the Business Committee is opposed to the rezoning request. Larry Barton seconded. Motion carried.
