A. RESOLUTIONS - Oneida On-Site Waste Disposal Ordinance

WHEREAS, the best method of protecting the environment and natural resources of the Tribe is through the enactment and enforcement of environmental ordinances, and

WHEREAS, the regulation of On-site Waste Disposal systems is essential to the protection of the natural resources of the Tribe.

NOW THEREFORE BE IT RESOLVED: that the Oneida Business Committee hereby adopts an ordinance entitled the Oneida On-site Waste Disposal Ordinance.

David King moved to adopt Resolution #10-28-88-A with the recommended changes. Ernie Stevens seconded. Amelia Cornelius opposed. Motion carried.

The effective date for implementation will be decided upon at a later date.

2. Policy Proposal for political endorsements/request for financial support - Bobbi Webster

David King moved to adopt the policy, Amelia Cornelius seconded. Motion carried.

Amelia Cornelius moved to recommend no posting of political campaign material within tribal enterprises interior. David King seconded. Motion carried.

David King moved to amend the motion to include no posting campaign material on tribal enterprise grounds. No seconded. Main motion carried.

3. Nathan Smith Request for support in his campaign for Brown County Sheriff.

David King moved to table until Nathan Smith can come to the meeting. Ernie Stevens seconded. Motion carried.

4. On-Line Lottery - Don Wilson

A bid needs to be submitted to the State of Michigan by November 1, 1988 on the computer. The amount of risk to the Tribe is \$15-25,000. Possible to earn a minimum of \$1 million annually with the On-line Lottery.

Amelia Cornelius moved to have Don Wilson proceed with the bid and to use his discretion on the amount. David King seconded. Motion carried.

5. U & 29 - Don Wilson

The construction and development of U & 29 store. New modular building, gas and diesel pumps and increased lighting.

Amelia Cornelius moved to proceed with the development of the U & 29 C-Store. Ernie Stevens seconded. Motion carried.

6. <u>Bingo Pass Request - Adult Children of Alcoholics/Amerindian</u>
Outpost Group

The Alcoholics/Amerindian Outpost Group is requesting four bingo passes for a Halloween Dance. Amelia Cornelius moved to approve, Ernie Stevens seconded. Motion carried.

There is a need to discuss strategy on Class III gaming. It was suggested that the Tribe hold a luncheon with the local legislators and later with Governor Thompson on S.555. The Tribal Secretary, Don Wilson, and Charlie Leonard should set up the meeting and agenda after election in November.
