

A. RESOLUTIONS

### 1. Housing Authority Lease - Resolution #3-24-89-A

WHEREAS, the Oneida Tribe of Indians of Wisconsin and the Oneida Housing Authority entered into a lease agreement approved by the Minneapolis Area Director on January 4, 1988, authorized by the Tribal Business Committee in its Resolution No. 6-23-87A designating the Housing Authority to use five parcels of tribal land for 20 homeownership units; and

WHEREAS, due to extensive revisions in the project, number of designated sites, legal description and survey, the entire lease document will be cancelled and rewritten.

NOW THEREFORE BE IT RESOLVED: that the Oneida Housing Authority and the Oneida Tribe of Indians hereby authorize cancellation of Lease H-1926(88). The Superintendent, Great Lakes Agency, is requested to prepare and recommend approval of the cancellation in accordance with applicable regulations.

BE IT FURTHER RESOLVED: that the Chairman and Secretary of this Committee are hereby authorized to execute the cancellation documents for and on behalf of the Oneida Tribe.

Rick Hill moved to adopt Resolution #3-24-89-A, Kathy Hughes seconded. Motion carried.

Dale Wheelock would like the Tribe to consider a self-funded qualified retirement program. A plan would need to be developed to meet IRS codes. He suggested that the plan could guarantee employees 8% interest and less penalties that are provided by Safeco. It was suggested that a special meeting be held with Dale Wheelock to further discuss this option.

Mr. Lobo from the Radisson presented the Business Committee with an Easter Basket filled with candy.

6. Support for Vehicle Use/Sponsorship - Tina Danforth

Rick Hill moved to have the Women's Basketball team use the Tribal Van for transportation for the Tournament. Ernie Stevens seconded. Motion carried

## 8. Land Committee Recommendations of 3/13/89

- a) Shoreland Protection Ordinance. The Land Committee recommends that the Shoreland Protection Ordinance be administered by the Environmental Manager of the Tribe. David King moved to approve, Ernie Stevens seconded. Motion carried.
- b) The Land Committee recommends to approve the removal of 2 box elder trees from the Nursing Home grounds since they are rotted, Ernie Stevens moved to approve, David King seconded. Motion carried.
