

WHEREAS, the Oneida Business Committee under their management system reviews and approves all program and budgets; and,

WHEREAS, the Oneida Business Committee has established a Social Services division which administers the Alcohol and Other Drug Abuse and Mental Health services; and,

WHEREAS, the 1990 Alcohol and Other Drug Abuse and Mental Health programs are consistent with Tribal goals and objectives.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin request to contract with Indian Health Service for the provision of Alcohol and Other Drug Abuse and Mental Health Services.

BE IT FURTHER RESOLVED: that the proposed 1990 total budget, estimated at \$81,000 for the period of October 1, 1989 through September 30, 1990, be negotiated with Indian Health Service for the delivery of Alcohol and Other Drug Abuse and Mental Health services.

   Chris Doxtator
- 1. The Land Committee requests that Fain Inc be restricted from competing with the Tribe when he develops the Mrs. Karl's property. Recommend approval of the lease to Fain, Inc. Deferred until Attorneys are present.
- 2. Linden Bain request for car lot lease on Town Road. Recommend to deny due to zoning restrictions and on-site waste disposal regulations. Lloyd Powless moved to approve recommendation to deny, Loretta Metoxen seconded. David King abstained. Motion carried.
- 3. Recommendation to assign Vickie Brown's lease to the Associated Bank of DePere for \$30,000 for home construction. Loretta Metoxen moved to approve, David King seconded. Motion carried.
- 4. Recommendation to refer the Erickson and Brenwell properties to the Negotiations Committee and to apply for a loan through FMHA for purchasing these properties. (They are crucial to the sewer project. Loretta Metoxen moved to approve, Lloyd Powless seconded. Motion carried.

Loretta Metoxen moved to amend approval, contingent upon Bingo Management approval and advertising in the Kalihwisaks. David King seconded. Motion carried. Main motion carried
- 6. Recommendation that the Environmental Program correct the leaking holding tanks on Marj Stevens residence immediately, and procedures be followed. David King moved to approve, Amelia Cornelius seconded. Motion carried.
  - Recommendation to approve by Resolution (#7-14-89-B), Wisconsin Land Services, who are representing Northeast Telephone to obtain an easement to bury cable on certain tribal owned lands within one (1) rod off the highway right-of-way. David King moved to approve contingent on payment of fee, Loretta Metoxen seconded. Motion carried.
- 8. Recommendation to accept a tractor donated by Dave Duffin provided repairs do not exceed \$500. Additional equipment needed to complete the crop harvest was discussed and it was agreed to rent the items for sixty (60) months and exercise our purchase option on the 37th month. Therefore not jeopardizing the loan. The wording should come from the Law Office and the agreement needs to be approved as soon as possible because the machinery is needed within the next two (2) weeks. Recommendation to contact the Law Office for assistance on the rental agreement for the four (4) items of machinery and that the rental payments come from the Land Office for this year's budget. Ernie Stevens moved that an agreement be amended and legal counsel is requested to amend the existing lease option agreement to protect the equity of the Land Office. Loretta Metoxen seconded. Amelia Cornelius opposed. Motion carried.

Lloyd Powless moved to have Labor Day set aside for a tribal picnic and to submit a budget to Finance & Appropriations, Loretta Metoxen seconded. Motion carried.

B. Request to Co-Sponsor 'National March for Housing Now''
Roberta Kinzhuma

Loretta Metoxen moved to draft a letter with the AmerIndian Center to support and endorse "Housing Now" and request support from the Community Support for funds for the march and to designate Robert Kinzhuma as the representative. David King seconded. Motion carried.

C. Joint Meeting with Business Committee, Administration, Housing Authority, HIP, & Construction - Don Wilson

Ernie Stevens moved to request Don Wilson to coordinate a joint meeting to be on July 26, 1989 at 8:00 a.m. to discuss housing concerns and to include discussion on the speeding in the Three Sisters site and wells and septic systems for tribal members. David King seconded. Motion carried.

She also informed the Business Committee that the Irene Moore Scholarship award will be presented to Jennifer Hill, Miss Oneida, on July 21, 1989.

She also expressed concerns that were personal and other concerns related to the Kalibwisaks.

Lloyd Powless moved that Bobbi Webster prepare a budget for doing the alihwisaks in newsprint for budget hearings on August 21, Amelia Cornelius seconded. Motion carried.

F. Milwaukee Indian Community School Request for Support at Public Hearing

Lloyd Powless moved to have the Tribal Secretary prepare a package of information, and that he will present at the hearing, Amelia Cornelius seconded. Motion carried.

It was suggested that WCC work with the Community School to assist in the repair needed on the boilers.

G. Petition by Three Sisters Housing Subdivision Residents

Petition regarding speeding by autos in the site. Lloyd Powless moved to have this as the first item for discussion at the Housing meeting on August 26, and to invite Jim Danforth to the meeting. Amelia Cornelius seconded. Motion carried.

H. General Tribal Council Meeting Schedules, budget hearings for August with final Mark-up September 5-6-7, and to have someone chair community meeting for August.

Lloyd Powless moved to approve the schedules on the budget hearings and mark up sessions. David King seconded. Motion carried.

Ernie Stevens volunteered to chair the August community meeting and the topic would be the Tribal Constitution revision.

Wal-Mart Sub-Lease Resolution #7-14-89-C

Amelia Cornelius moved to take from the table, Loretta Metoxen seconded. Motion carried.

WHEREAS, the Oneida Tribe of Indians of Wisconsin is the owner of a parcel of land known as the "Oneida Industrial Park", Oneida Indian Reservation, Brown County, Wisconsin, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin desires that Fain Inc., 1301 Missouri Boulevard, Jefferson City, Missouri, 65109 develop the Oneida Industrial Park; and

WHEREAS, Fain Inc., will develop and construct a 240,000 square foot multi-rental retail shopping center on the Oneida Industrial Park Land, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin leased the Oneida Industrial Park to Fain Inc., for the development and construction of the 240,000 square foot multi-rental retail shopping center, and

WHEREAS, Wal-Mart Properties, Inc. will be a tenant in the multi rental-retail shopping center, and

WHEREAS, Wal-Mart Properties, Inc. has entered into a sublease with Fain Inc. for a 13.52 acre portion of the land to construct a Sam's Wholesale Club, and

WHEREAS, Wal-Mart Properties, Inc., has entered into a lease with Fain Inc., for a store building and appurtenances, which Fain Inc. will construction upon the property, and

WHEREAS, Wal-Mart Properties, Inc. desires that the Oneida Tribe of Indians of Wisconsin consent to the attached sublease, lease and easements and restrictions between Wal-Mart Properties, Inc. and Oak Ridge Plaza, Inc.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Business Committee, in session assembled, hereby consents to the Sublease and Non-Disturbance and Attornment Agreement, Lease and Non-Disturbance and Attornment Agreement and Easements with Covenants and Restrictions Affecting Land ("ECR") between Wal-Mark Properties, Inc., Oak Ridge Plaza, Inc., and the Oneida Tribe of Indians of Wisconsin, such documents attached hereto and incorporated by reference into this resolution:

BE IT FURTHER RESOLVED: that the Chairman of the Oneida Tribe of Indians of Wisconsin is hereby authorized to execute the documents on behalf of the Oneida Tribe of Indians of Wisconsin.

Amelia Cornelius moved to adopt Resolution for the Wal-Mart Sublease and that the development be named Pine Tree Plaza. Loretta Metoxen seconded. Motion carried. David King abstained.
