A. Resolution #7-21-89-A & Reisterer Rental Agreement - Chris Doxtator

WHEREAS, the Oneida Business Committee has determined the need for modern agriculture equipment to enhance and implement it's agricultural operations, and

WHEREAS, contractual agreements to purchase such equipment are being processed with Reisterer Equipment, Inc. of Pulaski, WI which recite lease terms as well as an option to purchase said equipment which is listed.

NOW, THEREFORE BE IT RESOLVED: that the contracts referred to above are hereby incorporated into this resolution and that the option to purchase will not be exercised until after the 36th month and not before the beginning of the 37th month from the date said agreements are executed.

B. Resolution #7-21-89B RE: Tribal School Funding from P.L. 100-297

WHEREAS, the Oneida Tribal School Board is a duly elected body of the Oneida General Tribal Council to be responsible for the continued growth and development of the (K-8) Tribal School Program, and

WHEREAS, the Oneida Tribal School currently contracts under P.L. 93-638, the Indian Self-Determination Act and assumes responsibilities of Self-Determination, and

WHEREAS, the School Board reviewed P.L. 100-297 and made a motion to change the current P.L. 93-638 Contract to Granting via P.L. 100-297.

Resolution #7-21-89-B (Continued)

NOW, THEREFORE BE IT RESOLVED: That the Oneida Tribal School receive funds through the granting process, under P.L. 100-297 for school operations, Chapter I, 94-142, Operations & Maintenance and all other education money the school is authorized to receive by October 1, 1989. This resolution shall remain in effect until rescinded.

Loretta Metoxen moved to adopt, David King seconded. Motion carried.

2. REQUESTS:

A. Travel Reimbursement for John Powless - Ernie Stevens

Travel reimbursement for four days per diem. Ernie Stevens moved to approve travel for purpose of discussing cattle operations to Economic Development & Planning Committee with funds from Business Committee travel budget. Loretta Metoxen seconded. Motion carried. Amelia Cornelius abstained. Loretta Metoxen suggested using a medium cost for travel based on airfare.

B. Election Board Appointees

David King moved to appoint Donna White and Patricia Farmer to the Election Board to replace those who cannot make it. Loretta Metoxen seconded. Motion carried.

C. Small Business Loan Guarantee for Pat Lassila - Loretta
Metoxen

Pat Lassila has been awarded a small business development grant from the Bureau of Indian Affairs in the amount of \$25,000. This grant is conditional on receiving a loan in the amount of \$90,000 which the Associated Kellogg Bank of DePere would do if the Oneida Tribe is willing to guarantee the loan.

Mrs. Lassila is requesting the Oneida Tribe to guarantee her loan, and in return, she is willing to give the Tribe 25% interest in her business. This 25% will be in for form of a percentage of the annual net profits. This percentage will be paid as long as the loan guarantee is in force. If she is able to refinance the loan, the Tribe's 25% interest will be terminated without any penalties.

Mrs. Lassila is also requesting that the Tribe lease space to her in the Wal-Mart complex at \$5.00 per square foot. She would like the lease rate to be in effect for the duration of the Tribal loan guarantee. This is only fair in light of the Tribe's 25% interest in the business.

Loretta Metoxen moved to approve of the above requests contingent upon lease agreement with Bo Fain and consistent with policy. Ernie Stevens seconded.

Amelia Cornelius moved to amend the motion that the contract/agreement with Pat Lassila be processed through legal counsel, Loretta Metoxen seconded. Motion carried.
