2. IHS - RE: Kevin Cornelius Well & Septic

Kevin Cornelius presented his problem with obtaining service for a well and Septic system with Indian Health Service (IHS).

Kathy Hughes moved to send an official letter to IHS requesting them to attend a Business Committee meeting and to invite the State soil testers to attend also. Loretta Metoxen seconded. Motion carried.

Amelia Cornelius moved to invite them to the August 11, 1989 meeting, Larry Barton seconded. Motion carried.

Resolution #8-4-89-A presented by Kevin Cornelius.

WHEREAS, Kevin Cornelius was informed by Jerry Kurowski on behalf of the Oneida Tribe that he was to receive a well and septic system on his planned homesite on Fish Creek Road, and

WHEREAS, Kevin Cornelius purchased a mobile home in April of 89 in good faith that he was to receive a well and septic system, and

WHEREAS, in June of 89, IHS conducted another soil test which results changed from positive the 1987 soil test to a negative result and Kevin Cornelius was dropped from receiving a well and septic system, and

WHEREAS, Kevin Cornelius obtained the required State Certification on July 3, 1989 and was recommended for a mound system, and

WHEREAS, on July 21, both IHS and the State Soil testers were involved in another soil testing with the use of a back hoe, and

WHEREAS, the IHS representative declared that the site would not pass for a septic system, however, the State representatives stated the site would pass, and

WHEREAS, the Outagamie County Soil Tester on July 24 verified the test results on July 21 as correct as passing and recommended for a mount system on the site.

NOW, THEREFORE BE IT RESOLVED: that Kevin Cornelius be replaced on the list to receive a well and septic system (mound),

BE IT FURTHER RESOLVED: that John Spangberg be requested to coordinate with Kevin Cornelius the site plans for his septic system and mobile home, the design plan for the mound system and the well, and

BE IT FURTHER RESOLVED: that the well and septic system be installed within one month.

3 Dog Control Resolution and Ordinance

Amelia Cornelius moved to take the Dog Control Ordinance from the table Rick Hill seconded. Motion carried.

WHEREAS, the Oneida Tribal Government is responsible for the safety and protection of the public who enter the area within the Oneida Reservation boundaries, and

WHEREAS, the changes to the Oneida Tribal Dog Control Ordinance will increase the safety and protection of the public, and

WHEREAS, the Oneida Public Safety Department is on duty twenty-four (24) hours a day; and

WHEREAS, the designation of the Oneida Public Safety Department, as the official department to be contacted in regard to said ordinance will reduce duplication of services by eliminating the Oneida Conservation Department as the contact department.

NOW, THEREFORE BE IT RESOLVED: that all references in the Oneida Tribal Dog Control Ordinance to the Oneida Conservation Department shall be changed to the Oneida Public Safety Department and that the Oneida Public Safety Department shall be the designated contact department for said ordinance.

Rick Hill moved to adopt Resolution #8-4-89-B, adopting the Dog Control Ordinance, Ernie Stevens seconded. Motion carried.

1990 Parks & Wildlife Res. #8-4-89-C - Debbie Doxtator

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a governing body eligible to apply for contracts and grants with the Bureau of Indian Affairs, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined that it will exercise this ability by applying for a Parks and Wildlife Contract with the Bureau of Indian Affairs.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe hereby desires to contract with the Bureau of Indian Affairs during the 1990 Fiscal Year for funds to provide for the management and conservation of Parks and Wildlife on the Oneida Reservation in the amount of \$60,000.00.

BE IT FURTHER RESOLVED: that the Oneida Tribal Chairman is authorized to negotiate and execute the contract and any amendments thereto as necessary for the continuation of the contract, and

BE IT FURTHER RESOLVED: that the authorities granted herein shall be effective until such a time as the Oneida Tribal Governing Body takes further action by resolution.

Rick Hill moved to adopt Resolution #8-4-89-C, Loretta Metoxen seconded. Motion carried.

B. 1990 Roads Contract Res. #8-4-89-D - Debbie Doxtator

WHEREAS, the Oneida Tribe of Indians of Wisconsin has entered into a 638 Contract for Road Maintenance with the Bureau of Indian Affairs, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has been allocated \$17,442.00 for Roads Maintenance in 1990.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin enter into a 638 Roads Maintenance Contract with the Bureau of Indian Affairs in 1990.

Funds are to be maintained in the money market account until information is received on what the Land Committee needs are, consideration is given to further diversification (i.e. another brokerage house) and a decision made on the recommended purchase list. Lloyd Powless moved to approve, Loretta Metoxen seconded. David King and Rick Hill abstained. Motion carried.
- 2) Recommendation to name Kathy Hughes or her designee as the official contact person for buy/sell recommendations. Lloyd Powless moved to approve, Amelia Cornelius seconded. Rick Hill abstained. Motion carried.
