The Town of Hobart has taken a portion of Tribal lands on Silas Road without Tribal approval. Amelia Cornelius moved to table the survey for a legal opinion, David King seconded. Motion carried.

Community Support needs an estimated \$9,000 to cover debts incurred. Top-of-the-Hill Bingo is having problems which include change over to Bingo, and cost of packets from \$15 to \$20.
