B. "Year of the Student-1990" Resolution #1-5-90-A - Thelma McLester

WHEREAS, in keeping with the Oneida Tribe's Educational Mission and Goal Statement, the Tribe has promised to provide and promote quality educational opportunities for all Tribal members in accordance with the Tribe's needs for cultural survival and economic well being.

WHEREAS, the Oneida Tribe does now have the responsibility for 1,032 students attending five separate public school systems in addition to the students in the Tribal School, and

WHEREAS, it is especially difficult to oversee the educational pursuits and achievements of Oneida students due to the districting and separation by boundaries as established by State and Local Governments, and

WHEREAS, instead of community aspect, our youth are bound to attend schools nearest their homes, which makes it more difficult to communicate the Tribe's philosophy and goals to the students, and

WHEREAS, it is imperative that our youth be made aware of their importance to our community, both now and in the future.

WHEREAS, the Oneida Tribe and the community, need to look at our youth as our future and we need to promote education to the fullest in order to have our youth succeed in life.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe designate this year, 1990 the "Year of the Student".

BE IT FURTHER RESOLVED: that this year, 1990, be the beginning of setting forth the recognition, encouragement and support of all of our students in order to make them aware of our concern and expectations. By promoting students' goals and aspirations in education, their future will be secure as far as employment and independence are concerned.

Rick Hill moved to adopt Resolution #1-5-90-A, Loretta Metoxen seconded. Motion carried.

#### Skenandore Court

Discussion o the survey of the property. Problems with a neighbor who seems to be encroaching on tribal property. Also the town took a portion of tribal lands and widened the road without permission or approval of the Tribe. There have been two surveys of the area and they are different. The residents at the end of Silas Drive are having problems with the Town of Hobart plowing in the winter. Two residents have handicapped persons residing in their homes and need to have the road cleared in the event of an emergency.

Loretta Metoxen moved to have Building and Grounds provide snowplowing and other services to the road, Ernie Stevens seconded. Motion carried.

Amelia Cornelius moved to defer to General Tribal Council, Ernie Stevens seconded. 4 members for (David King, Lloyd Powless, Rick Hill, Amelia Cornelius) 4 opposed (Kathy Hughes, Larry Barton, Loretta Metoxen, Ernie Stevens). Chairman votes in favor.
- 2. Well for Lloyd King Cost is estimated at \$1,750. Finance & Appropriations recommends funding from the special Wells & Septic allocation. Rick Hill moved to approve, David King seconded. Motion carried.
  - Larry Barton moved to amend the motion that Jerry Kurowski and Don Wilson provide an updated list of recipients, Loretta Metoxen seconded. Motion carried.
- 3. CCTV Upgrade at Bingo Cost is estimated at \$19,882.68 for an outright purchase. Management recommends a 3 year lease purchase option. Finance & Appropriations recommends approval of the lease option funded from Enterprise Capital Improvements. Rick Hill moved to approve, Kathy Hughes seconded. Motion carried.
- 4. Equipment Purchase for Cattle Project Cost for skid steer is estimated at \$12,200 for a new one and \$8,500 for a used one. Cost for a catch chute is estimated at \$1,300. Because of the conditions of the loan agreement, F&A defers making a final recommendation until a meeting is coordinated with the bank for further discussion. Rick Hill moved to approve, Lloyd Powless seconded. Amelia Cornelius abstained. Motion carried.
- 5. Dump Truck for Building & Grounds Cost is \$56,000. \$13,000 is available from a BIA grant in FY '89. \$12,000 is requested under FY 'contract from BIA. WHEREAS, the Oneida Business Committee was directed on February 14, 1983, by the Oneida General Tribal Council to develop a Memorandum of Agreement which would specify Health Board and the Oneida Business Committee, and

WHEREAS, the Oneida Business Committee was on March 1, 1983, directed by the Oneida General Tribal Council to restructure the membership of the Oneida Health Board, which was accomplished on March 8, 1983, and

WHEREAS, the Oneida Health Board has developed and amended Resolution #3-21-83-A - Roles and By-Laws of the Oneida Health Board, which is attached and hereby incorporated to this Resolution.

NOW THEREFORE BE IT RESOLVED: that the Roles & By-Laws attached are hereby adopted and can not be revised or amended or superceded without formal action of the Oneida Business Committee after consultation with the Oneida Health Board.

BE IT FURTHER RESOLVED: that this Resolution supercedes all prior Business Committee resolutions addressing the creation of membership of the Oneida Health Board.

Loretta Metoxen moved to approve the Resolution adopting the Roles & By-Laws of the Oneida Health Board, Kathy Hughes seconded. Motion carried.

B. Safety for Native Americans - HONOR - Resolution #1-12-90-C

WHEREAS, safety of persons engaged in lawful activities is a privilege ensured in the Wisconsin Constitution. and

WHEREAS, Wisconsin, being a Public Law 280 State, is responsible for the public safety of Native Americans on and off the reservations, and public safety is a shared responsibility of State Officials, County Sheriffs, Judges and District Attorneys, and

WHEREAS, safety is non-negotiable in terms of exchanging safety for other legal rights and priviledges, and

WHEREAS, the experience in 1988 and 1989 has shown that Native Americans and their families are victims of harassment and physical and verbal attacks when exercising their legal rights under the treaties, and

WHEREAS, minimal fines have been assessed against perpetrators of the harassment, and assults, and

WHEREAS, treaty rights are protected in Article VI of the U.S. Constitution and reflect the inherent rights of the indegenous people of the country, and

Resolution #1-12-90-C (Continued)

WHEREAS, the Wisconsin Attorney General is seeking an amendment to the Hate Crimes Legislation that would make interference with treaty rights a pubishable offense under the Act and give the state concurrent prosecutory power.

THEREFORE BE IT RESOLVED: that HONOR (Honor Our Neighbors Origins and Rights) to call the Governor of the State of Wisconsin, Wisconsin judges, Wisconsin Sheriffs, and District Attorneys to publicly declare their intent to use all means within their power to ensure the safety of Native Americans engaged in legal exercise of treaty rights.

BE IT FURTHER RESOLVED: that copies of this resolution be sent to all members of the Wisconsin Congressional delegation, the Constitutional officers of the State of Wisconsin, members of the State Legislature, all County Sheriffs, and District Attorneys, and Judges.

David King moved to adopt the Safety Resolution #1-12-90-C, Larry Barton seconded. Motion carried.

### I. ORCOA Parking

Discussion on parking problems at the Commission on Aging site and the need for wood storage. Chris Doxtator stated that the Land Committee has the purchase of the Ness property on their next agenda. It was also suggested that the attorneys look at the possibility of developing an ordinance on tribal parking and the issuance of citations when cars are parked in reserved spaces, handicapped spaces or in the firelanes.

Rick Hill moved that ORCOA work with the Planning Office on the development of the property at the Commission site, Lloyd Powless seconded. Motion carried.

J. The Learning Community - Debbie Webster

Debbie Webster is promoting the present program and closer cooperation of present educational programs. Community Education takes leadership from AISES and is suggesting that the Tribe become involved. The program is a three year project. The purpose is to utilize and maximize present programs and buildings.

Lloyd Powless moved to approve of the concept, Amelia Cornelius seconded. Motion carried. Attorney Hill suggested that it be coordinated with the Education Department, an article placed in the Kalihwisaks, and that the concept include a component of Oneida Language.

### K. General Manager Resignation

Kathy Hughes moved to accept the resignation of Don Wilson as General Manager, effective April 20, 1990 and that a transitional plan be developed for a new General Manager, Rick Hill seconded. Motion carried.

Ernie Stevens moved that Rick Hill, Kathy Hughes, and Loretta Metoxen be the sub-committee of the Business Committee to develop the transitional plan. Larry Barton seconded. Rick Hill and David King abstained. Motion carried.

Amelia Cornelius moved to approve ½ day vacation for Rick Hill on January 12 1990, Kathy Hughes seconded. Rick Hill abstained. Motion carried.

### N. General Tribal Council Discussion

Discussion on lack of notification of action in regard to employment of top management being made all enrolled Oneida Tribal members at the January 8, 1990 General Tribal Council Meeting.

Lloyd Powless requested a meeting with all area managers and other key staff to assure them and to interpret the action taken at the General Tribal Council meeting. Need to develop a statement from the Business Committee to all employees.

Statements by members present on racial issues, press coverage, media release of information, respect for each other, manipulation of the General Tribal Council, community meetings, conduct of General Tribal Council perception was to get rid of the non-Indian employees, different perceptions for General Tribal Council meetings, no notice given for certain subjects, tribal constitutional questions, actions of General tribal Council, due process for membership to participate in General tribal Council training situations, no reprecussions to employees participating in General Tribal Council meetings, HUD rules in regard to rent, removal of incentives to increase income as it increases amount of rent paid.

Kathy Hughes moved that Amelia Cornelius chair a Committee composed of Education and Training Manager, Human Resources, Career Development staff, and other interested persons to begin drafting the training plan in conjunction with the development of the Career Policy for the Tribe, Rick Hill seconded. Motion carried.

Ernie Stevens moved that the Business Committee issue a Public Statement, by concensus of all Business Committee members, to all employees and to meet with Managers on either Monday or Tuesday, Lloyd Powless seconded. Motion carried.

#### VII. OTHER

#### 1. Wisconsin Counties Association

Discussion on Wisconsin Counties Association meeting being held in Salt Lake City, on January 18-20, 1990. The purpose of the meeting is called to "modernize" the treaties. It is proposed that a task force of at least 6 people attend the meeting and take a pro-active stance and participate in the conference in whatever degree possible at the treaties give us our gaming rights among others and if they are tampered with to whatever degree the Tribe could suffer economically and that the Oneida Tribe must take a proactive stance against the WCA meeting.

# RESOLUTION #1-12-90-B - Treaty Rights

WHEREAS, the Oneida Tribe maintains a policy of resolution by conciliation and negotiation of issues of government with any other government, federal, state, or local as an act of governmental sovereignty, and

WHEREAS, issues of jurisdiction and regulation from time to time arise between governments, and

WHEREAS, the Oneida Tribe vigorously protects its Treaty Rights and the rights of all Tribes reserved pursuant to Treaties entered into with the United States and upheld by the Supreme Court, and

WHEREAS, federal legislation to limit Indian Treaty rights has been upheld by the United States Supreme Court based upon an arbitrary concept of Plenary Power, and

WHEREAS, anti-Indian forces have from time to time made a concerted effort to abrogate those governmental rights reserved to Indians by Constitutional Treaties by litigation and federal legislation, and

WHEREAS, the Wisconsin Counties Association is an organization representing all 72 county governments in Wisconsin including those effected by the Chippewa off-reservation Treaty rights, and

WHEREAS, the Wisconsin Counties Association, with whom the Oneida Tribe has worked cooperatively in the past, will participate in a meeting with their counterparts from other states and which meeting will not be open to the public, and

WHEREAS, the Oneida Tribe is gravely concerned that general and sensationalized issues generated at non-public meetings by anti-Indian and anti-Treaty partisans whose intransigent views have been publicized and are characterized by threats to seek "federally legislated" solutions to local Indian problems, and

WHEREAS, such attempts to stampede the United States Congress into ill-advised and over general legislation which will not only confuse and separate individual issues of local concern but attempts to homogenize Indians issues. Such actions are based upon a spirit of meanness and devoid of serious responsibility. The Oneida Tribe deplores and will fight these actions.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe in protecting its sovereign governmental rights reserved by Treaty with the United States, Treaty of Oneida of 1838 (7 Stat., 566) will confront any and all attempts to abrogate our Treaty by federal legislation, including the Salt Lake City meeting on January 18, 19, and 20, 1990.

Resolution #1-12-90-B (Continued(

BE IT FURTHER RESOLVED: that the Oneida Tribe will join other Indian Tribes and National Indian Organizations in fighting, by all lawful means, any and all attempts to abrogate or limit Indian Treaty Rights.

Ernie Stevens moved to adopt Resolution #1-12-90-B, Amelia Cornelius seconded. Motion carried.

Rick Hill moved to send the resolution to other Tribes throughout the nation for support at the meeting, Ernie Stevens seconded. Motion carried.

#### 2. Fort Howard

Discussion on the final consent order with Fort Howard. The work plan has not been signed by DeMeese. Amelia Cornelius moved to have the Chairman sign after Mr. DeMeese has signed the work plan, Kathy Hughes seconded. Motion carried.

### 3. Christmas Party

Pearl McLester thanked the Business Committee for the Christmas Party for the elders.

#### 4. Draft Press Release

Sharon Cornelius presented a Draft Press Release to be issued after the consent order is signed.

A report on the issues with Fort Howard should be presented to the General Tribal Council membership.
