Joint Meeting with Oneida Housing Authority and Business Committee set for Tuesday, February 27, 1990 at 5:00 p.m. David King moved to approve date and time for meeting, Loretta Metoxen seconded. Motion carried.

- VI. NEW BUSINESS
  - 1. RESOLUTIONS
    - A. Guidelines for Administration in Preparation of FY'91 Individual Budgets - Resolution #2-23-90-A - Kathy Hughes

Loretta Metoxen moved to adopt Resolution #2-23-90-A, Ernie Stevens seconded.

Larry Barton moved to amend the resolution to include provision plans for Enterprises, evaluation format for programs, all personnel, appropriate evaluation format for programs and enterprises. Ernie Stevens seconded. Motion carried. Main motion carried. Resolution #2-23-90-A adopted as follows:

RESOLUTION 2-23-90-A (Continued)

WHEREAS, the Oneida Business Committee through the Treasurer must submit a proposed budget to General Tribal Council for FY'91, and

WHEREAS, the Oneida Business Committee wishes to establish guidelines to assist administration in preparation of individual budgets.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Business Committee instructs administration to adhere to maintain an appropriate FY'90 Funding Level and evaluation format philosophy for programs and enterprises preparing the FY'91 budgets.

- 2. REQUESTS:
  - A. Finance & Appropriation Recommendations of 2/21/90 Kathy Hughes
- 1. Nursing Home Wage Increase Estimate need is \$60,506. F&A recommends referring back to administration to do a full budget analysis. Based on this analysis, F&A will review at next meeting in March. No action required by Business Committee at present.
- 2. Natural Gas to E & EE Estimate Tribal Contribution to complete the project is \$45,000. This is not budgeted. F&A recommends tabling for further input from various program areas affected. Amelia Cornelius moved to approve, Larry Barton seconded. Motion carried.
- 3. Desk Top Publisher F&A referred to the MIS Committee for review and recommendations. Also suggested looking at a lease option. David King moved to approve, Larry Barton seconded. Motion carried.
- 4. Equipment Purchase for Utilities Cost is \$1,408. F&A is referring back to administration for clarification on need and timeframe. David King moved to approve, Larry Barton seconded. Motion carried.
- 5. Upgrade or Register Retail Cost Estimate is \$1,600. F&A tabled this pending an update on the status of the new store costs. No action required by Business Committee at present.
  - B. Amelia Cornelius Request for Action re:
    - 1 Authorization for Tribal Grantswriter to assist Town of Oneida in search of Funds

Authorization for the Tribal Grantswriter to begin research for funds to assist the Town of Oneida to acquire a replacement for the pumper fire truck in 1991. The estimate cost ranges from \$120,000 - \$140,000. David King moved to approve, Kathy Hughes seconded. Motion carried.

Amelia Cornelius Requests For Action (Continued)

2) TV Bingo Free Passes

The TV Bingo Program, in the 13 week trial period, promoted the program by giving TV Bingo Cards to the AJNH and to one Senior Center on a weekly basis. This practice has been discontinued after the 13 weeks. The residents at the AJNH are requesting that they receive at least 15 free cards a week. Promotions is recommending giving 15 free cards of the Outline Diamond Game to the AJNH weekly and 15 cards to other Senior Centers in the viewing area on a monthly basis. This would total to 75 cards a month. Loretta Metoxen moved to approve, David King seconded. Motion carried.

> C. Request to Increase Repair Needs for HIP Recipients Roberta Kinzhuma

David King moved to rescind previous action of limiting HIP Recipients to \$10,000 and increasing to \$20,000. Larry Barton seconded.

Loretta Metoxen moved to amend the motion to include C & D categories in the HIP Recipient List, Kathy Hughes seconded. David King abstained. Motion carried. Main motion carried.

E. Request to Assist Greenpeace Tour - Lloyd Powless

Amelia Cornelius moved to have Lloyd Powless coordinate a meeting place and help in Public Relations thru the Communications Department to inform Oneida employees about the James River Tour.

Need to inform community about Fort Howard testing and well at sludge area.

Loretta Metoxen moved to work with James River Oneida employees and to meet with Greenpeace and the Business Committee in March, David King seconded. Motion carried.

F. Request for Contribution for Sidney Yates for Congress

Larry Barton moved to support and to refer to Finance & Appropriations to identify funds, and recommend type of contribution. Lloyd Powless seconded. Motion carried.

G. Appointment of Beverly Metoxen to American Indian Language Board - Amelia Cornelius

Loretta Metoxen moved to approve, Kathy Hughes seconded. Motion carried.

H. Gaming Director Job Position - Loretta Metoxen

Loretta Metoxen did not complete for discussion or action.

> I. NARF Request for support for the American Indian Freedom of Religion Act and for Federal Protection of Indian Burial Grounds

RESOLUTION #2-23-90-B

WHEREAS, the sanctity of the dead for American Indians and Alaska Natives has never been respected by the dominant, non-Indian society, as evidenced by the untold thousands of deceased Native Americans that have been dug up from their final resting places;

WHEREAS, respect for the dead is a basic human right that is fundamental to all cultures, societies, and religions;

WHEREAS, the Oneida Tribe of Indians of Wisconsin is deeply concerned about the mistreatment of its dead and has experienced problems in the past over the protection of graves and reburial of its dead, and

WHEREAS, four important bills are now pending in Congress that will allow Indian and Native people the basic right to rebury their dead and will extend basic legal protections in the future to Native graves, human remains and funerary objects: S.1021 and S.1980 before the Senate Select Committee on Indian Affairs and H.R. 1381 and H.R. 1646 before the House Committee on Interior and Insular Affairs;

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin strongly supports repatriation, reburial and grave protection legislation that will allow Native people and tribes to rebury Native dead and will protect their dead from future mistreatment;

BE IT FURTHER RESOLVED: that the Oneida Tribe of Indians of Wisconsin directs that this Resolution be mailed to its Representatives and Senators and to Senator Inouye and Representative Udall with a written request on behalf of the Oneida Tribe of Indians of Wisconsin for: 1) their strong support for such legislation; 2) to advise the Oneida Tribe as to their position on the issue; and 3) to inform the Oneida Tribe of any hearings on these important bills.

#### RESOLUTION #2-23-90-C

WHEREAS, the cultural and spiritual survival of Native American people is closely tied to the continuation and well-being of our cultural and spiritual traditions; and

WHEREAS, Native American religions are based upon the natural world and religious and sacred sites are indispensable to the practice of those religions; and

WHEREAS, the United States Supreme Court has ruled that there is no First Amendment right to challenge land management decisions that may impair or destroy the ability of Native American religious practitioners to exercise their religious rights; and

Resolution #2-23-90-C (Continued)

WHEREAS, the American Indian Religious Freedom Act has not prevented the Federal Government from unnecessarily and capriciously engaging in activities which impair or disturb Native American religious activity on Federal lands;

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin urges Congress to enact legislation that will protect Native American religions. At a minimum, such legislation must be binding upon Executive agencies, provide for a legal cause of action to enforce religious rights and ensure that Native American religions are not provided protection that is inferior to that accorded other religions.

BE IT FURTHER RESOLVED: that the Oneida Tribe of Indians of Wisconsin petitions Congress to immediately hold hearings to refine legislative proposals that have been developed with the goal of enacting legislation by the end of 1990.

David King moved to adopt Resolutions #2-23-90-B and #2-23-90-C, Loretta Metoxen seconded. Motion carried.

Loretta Metoxen moved to approve the Agreement for Weatherization Services, Ernie Stevens seconded. Motion carried.

Kathy Hughes requested a status report on Weatherization and units serviced by May 30, Loretta Metoxen seconded. Motion carried.

VII. OTHER

1. HONOR Resolution and Press Conference

RESOLUTION # 2-23-90-D

WHEREAS, safety of persons engaged in lawful activities is a right ensured in the Wisconsin Constitution, and

WHEREAS, Wisconsin, being a Public Law 280 State, is responsible for the public safety of Native Americans on and off the reservations, and public safety is a shared responsibility of State Officials, County Sheriffs, Judges and District Attorneys, and

WHEREAS, safety is non-negotiable in terms of exchanging safety for other legal rights and privileges, and

WHEREAS, the experience in 1988 and 1989 has shown that Native Americans and their families are victims of harassment, and physical and verbal attacks when exercising their legal rights under the treaties, and

WHEREAS, minimal fines have been assessed against perpetuators of the harassment, and assaults, and

WHEREAS, treaty rights are protected in Article VI of the U.S. Constitution and reflect the inherent rights of the indigneous people of this country, and

WHEREAS, the Wisconsin Attorney General is seeking an amendment to the Hate Crimes Legislation that would make interference with treaty rights a punishable offense under the Act and give the state concurrent prosecutory power.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin supports HONOR (Honor Our Neighbors Origins and Rights) calling on the Governor of the State of Wisconsin, Wisconsin Judges, Wisconsin Sheriffs, and District Attorneys to publicly declare their intent to use all means within their power to ensure the safety of Native Americans engaged in legal exercise of treaty rights.

BE IT FURTHER RESOLVED: that copies of this resolution be sent to all members of the Wisconsin Congressional Delegation, the Constitutional Officers of the State of Wisconsin, members of the State Legislature, all County Sheriffs and District Attorneys and Judges.

Amelia Cornelius moved to adopt Resolution #2-23-90-D and to refer the press Conference to Communications Department, David King seconded. Motion carried.
