RESOLUTION #6-13-90-B:

WHEREAS, the Oneida Tribe of Indians are faced with several varied threats to the surface and groundwater resources of the Tribe, and

WHEREAS, the Bureau of Indian Affairs provides funding to Indian Tribes for the purpose of identifying those threats.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin will need fiscal year 1990 Water Quality Management Planning funds to continue ongoing co-operative ground water investigations for the Oneida Tribe.

RESOLUTION #6-13-90-A:

WHEREAS, the Oneida Tribe of Indians of Wisconsin is dependent upon rural, volunteer fire departments for the provision of fire protection for the Oneida people.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin will distribute Fiscal Year 1990 Community Fire Protection Funds equally to the towns of Hobart and Oneida for the purchase of equipment for those fire departments.

Altheimer & Gray Contract (Continued)

WHEREAS, it is the desire of the Oneida Tribe of Indians of Wisconsin that the law firm of Altheimer & Gray with offices at 10 South Wacker Drive, Chicago, Illinois, be retained to serve, for the purposes set forth in the Special Counsel Agreement by and between the Oneida Tribe of Indians of Wisconsin and Altheimer & Gray ("Special Counsel Agreement"), a copy of which is attached to the resolution as Exhibit "A", as Special Counsel for the Oneida Tribe; and

WHEREAS, the law firm of Altheimer & Gray will receive compensation commensurate to the duties performed in accordance with the attached Special Counsel Agreement.

NOW, THEREFORE BE IT RESOLVED: that Altheimer and Gray be employed to act as Special Counsel for and on behalf of the Oneida Tribe of Indians of Wisconsin to negotiate settlement and/or appear before all federal and state courts regarding the controversy with the Fort Howard Corporation pursuant to the terms and conditions of the Special Counsel Agreement, attached hereto as Exhibit "A" and incorporated by reference herein.

BE IT FURTHER RESOLVED: that the Tribal Chairman and Secretary of the Oneida Business Committee are hereby authorized and directed to execute the Special Counsel Agreement employing said attorneys as Special Counsel in accordance with the Special Counsel Agreement.

2. Scope of Representation: Altheimer & Gray shall act as special counsel for and on behalf of the Tribe in connection with any and all claims of the Tribe against Fort Howard arising from Fort Howard's disposal of wastes on land located within, and contiguous to, the Oneida Indian Reservation and properties near Altheimer & Gray Green Bay, Wisconsin. The scope of Altheimer & Gray's representation of the Tribe shall include settlement negotiations and/or such factual investigation and legal research as may be necessary to prepare and, with the Tribe's authorization, file a complaint asserting such claims as the Tribe may have against Fort Howard. In any action against Fort Howard, the Tribe's General Counsel, Francis R. Skenandore, Esquire, shall appear as co-counsel with Altheimer & Gray. The scope of Altheimer & Gray's representation of the Tribe shall not include the pursuit of any tribal claims against the United States.
