A. Resolution #7-9-90-A for Bond Counsel Contract

FmHA needs independent bond counsel opinion in regard to the 75% grant/25% loan needed to construct the sewer system. Fees are reimbursable in the grant/loan.

WHEREAS, the Oneida Tribe is empowered to employ legal counsel, the choice of counsel and fixing of fees being subject to the approval of the Secretary of the Interior, and

WHEREAS, it is the desire of the Oneida Tribe that the law firm of Dorsey & Whitney with offices at 2200 First Bank Place East, Minneapolis, Minnesota be retained to serve, for the purposes set forth in the Special Counsel Contract by and between the Oneida Tribe of Indians of Wisconsin and Dorsey & Whitney ("Special Counsel Contract"), a copy of which is attached to this Resolution as Exhibit "A", as Special Counsel for the Oneida Tribe, and

WHEREAS, the law firm of Dorsey & Whitney will receive compensation commensurate to the duties performed in accordance with the attached Special Counsel Contract.

NOW, THEREFORE BE IT RESOLVED: that Dorsey & Whitney be employed to act as Special Counsel for and on behalf of the Oneida Tribe of Indians of Wisconsin and to appear as such before all federal and state courts, tribunals, departments, agencies and committees of Congress and the State Legislatures pursuant to the terms and conditions of the Special Counsel Contract, attached hereto as Exhibit "A" and incorporated by reference herein.

BE IT FURTHER RESOLVED: that the Tribal Chairman and Secretary of the Oneida Business Committee are hereby authorized and directed to execute the Special Counsel Contract employing said attorneys as Special Counsel in accordance with the Special Counsel Contract.

A. Resolution #7-9-90-B Retroactive Approval for Resolution (#7-7-90) Honoring Melinda Doxtator

WHEREAS, Melinda Doxtator has worked for the Oneida Tribe of Indians of Wisconsin, sharing her knowledge of the Oneida Language, and

WHEREAS, Melinda Doxtator as a keeper of the Oneida Language has been committed to teach the Oneida Language to the teachers of the Oneida Language and

WHEREAS, Melinda Doxtator has always been available to teach and assist other tribal members in the community the Oneida Language, and

WHEREAS, Melinda has shown great love, devotion and commitment in sharing her language skills to the children of the Oneida Headstart program throughout the years, and

WHEREAS, Melinda Doxtator is loved by the community for her caring and sharing.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Business Committee and the Oneida Community extend their thanks and appreciation to Melinda Doxtator for her devotion in sharing her knowledge of the Oneida Language to our community as an integral part of our heritage.

B. Resolution for FY'91 Contract with IHS for Environmental Health-John Spangberg

WHEREAS, the Oneida Business Committee, in the interest of continuing to provide environmental health services to its members and their families, and

WHEREAS, the U.S. Indian Health Service (IHS) has funds available to provide for the continued operation and administration by the Tribe for their Environmental Health Department, and

WHEREAS, the Oneida Business Committee desires to provide for those services under the authority of P.L. 93-638/P.L. 100-472 (Indian Self Determination Act/1988 Amendments) Contract with IHS, and

WHEREAS, the proposed 1991 Environmental Health services budget and statement of work for the period of 10/01/1990 through 9/31/1991 is consistent with the Oneida Tribal goals and objectives.

Resolution #7-9-90-C (Continued)

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin is requesting mature contractor status and does hereby request the writing of a new contract with the Indian Health Service for an indefinite term beginning 10/01/90 for the provision of environmental health services with the understanding that this action will not in any way decrease the FY'91 or future appropriations for the Oneida Tribe of Indians of Wisconsin, and

BE IT FURTHER RESOLVED: that the Oneida Tribal Chairman and/or his designee, and the Oneida Environmental Services Manager are authorized to negotiate the contract, and any amendments and/or renewals, and

BE IT FINALLY RESOLVED: that the authorization under this resolution remain in effect until rescinded or suspended.

Loretta Metoxen moved to adopt Resolution #7-9-90-C, David King seconded. Motion carried.

C. Resolution #7-9-90-D for Adult Education Grant up to \$700,000 - Sherri King

WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined the goal of the Oneida Nation is to protect, maintain and improve the standard of living and the environment in which the Oneida people live; while maintaining and re-establishing the sovereign rights of the Oneida Nation, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Education Department has determined its goal to be the development of educational programs for tribal members that will assist each individual to assume the rights and responsibilities as both tribal and non-tribal members of the community; and to provide leadership that will emphasize the importance of every individual's dignity and morals through the development of every student's potential, regardless of age, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin recognizes the need for reducing the unemployment rate of its tribal members and to retrain and upgrade its employees who desire to improve their employment situation.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin after consideration and planning, make application to the Department of Education, Office of Vocational and Adult Education, to seek funding of an adult vocational education program.

Kathy Hughes moved to adopt Resolution #7-9-90-D, Loretta Metoxen seconded. Motion carried.

D. Resolution #7-9-90-E for Litigation Application Grant for \$75,250.00 - Debbie Doxtator

WHEREAS, the Oneida Tribe of Indians of Wisconsin is involved with litigation and negotiations involving aboriginal land claims, and

Resolution #7-9-90-E (Continued)

WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined the need for additional research, knowledge, expert opinion and testimony to be provided on their behalf, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin recognizes the Bureau of Indian Affairs' Office of Trust Responsibility provides funding to contract for expert consultation services to federally recognized Indian Tribes involved in such litigation under Public Law 93-638.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin intends to contract with the United States Department of Interior's Bureau of Indian Affairs' Office of Trust Responsibility to obtain expert witness, research, and consultation services for issues inherent in the land claim cases of the Oneida Tribe.

Loretta Metoxen moved to adopt Resolution #7-9-90-E, Ernie Stevens seconded. Motion carried.

E. Resolution #7-9-90-F for IHS Contract for AODA & Mental Health - Debbie Doxtator

WHEREAS, the Oneida Business Committee, in the interest of continuing to provide mental health care and Alcohol and Drug Abuse services to its members and their families; and

WHEREAS, the United States Department of Health and Human Services, Indian Health Service has funds available to provide for the continued operation and administration by the Tribe for their Comprehensive Health Center Program; and

WHEREAS, the Oneida Business Committee desires to provide for those services under the authority of P.L. 93-638/P.L. 100-472 (Indian Self-Determination Act/1988 Amendments) Contract with the Indian Health Service; and

WHEREAS, the proposed 1991 Mental Health and Alcohol and Drug Abuse budget and Statement of Work for the period of 10/01/90 through 09/30/91 is consistent with the Oneida Tribal goals and objectives.

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin is requesting mature contractor status and does hereby request the writing of a new contract with the Indian Health Service for an indefinite term beginning 10/01/90 for the provision of Mental Health and Alcohol and Alcohol and Drug Abuse services with the understanding that this action will not in any way decrease the FY'91 or future appropriations for the Oneida Tribe of Indians of Wisconsin; and

BE IT FURTHER RESOLVED: that the Tribal Chairman and/or their designee; and the Oneida Social Services Manager are authorized to negotiate the contract, any amendments and/or renewals, and

BE IT FINALLY RESOLVED: that the authorization under this resolution remain in effect until rescinded or suspended.

David King moved to adopt Resolution #7-9-90-F, Kathy Hughes seconded. Motion carried.

F. Resolution #7-9-90-G for Minority Males - Health & Human Services - Debbie Doxtator

WHEREAS, the Indian Health Service has identified Native American males as being "at risk" due to diseases and health conditions that are caused by lifestyle and behavioral patterns, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined the goal of the Oneida Nation is to protect, maintain and improve the standard of living and the environment in which the Oneida people live; while maintaining and re-establishing the sovereign rights of the Oneida Nation, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin recognizes the need to develop a community coalition to address the health and human service needs of Native American males, and

NOW, THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin apply for a U.S. Department of Health and Human Services, Community Coalition Grant to support the Health and Human Service Needs of Minority Males.

David King moved to adopt Resolution #7-9-90-G, Lloyd Powless seconded. Motion carried.

Lloyd Powless moved to request further discussion on the long term plans for the area around Salt Pork Street, David King seconded. Motion carried.

B. Correction of Legal Description in the Resolution for Carlton John's Property - Chris Doxtator

Amelia Cornelius moved to Rescind Resolution #8-21-87-A (incorrect legal description) and to adopt Resolution #7-9-90-H (correct legal description), Larry Barton seconded. Motion carried.

Discussion on taxation of tribal lands. It is important to get the BIA to recognize and accept the solicitors opinion that tribally owned lands are not taxable.

Loretta Metoxen moved to have Attorney Swamp provide a report on the paper trail necessary to place lands in trust, Lloyd Powless seconded. Motion carried.

C. 5 Bingo Passes for Pink Flamingo Solftball Tournament Fundraiser for Special Olympics & Legion Baseball - Rick Hill

David King moved to approve 5 Bingo passes, Loretta Metoxen seconded. Motion carried.

D. Chicago Meeting 106 Grant - John Spangberg/Kathy King

EPA-106, this will possibly take six months to complete with no assurance that the funds will be returned. David King moved to pursue the request for deviation of funds, Ernie Stevens seconded. Motion carried.
