SPECIAL MEETING WITH BINGO COMMISSION

WEDNESDAY, JULY 11, 1990

Meeting convened at 11:00 a.m.

Discussion on whether meeting should be executive session or open session. Concensus to have open meeting and to go into executive session if necessary.

Discussion on Charter and By-Laws for the Commission. It was pointed out that the basic responsibilities and duties for the Commission are outlined in the Ordinance. It was recognized that there is a need for some type of document for conducting meetings by the Commission and that it is the responsibility of the Commission to develop them and bring them forth to the Business Committee for approval.

Discussion on the Memorandum of Agreement needed to form the relationship between the Business Committee and the Commission.

Discussion on amendments or changes to the Gaming Ordinance and the process to make changes. Gaming Commission participates in revision and/or amendments. Recommendations of documents are presented to the Business Committee for public hearings for review/comments and then for adoption by the General Tribal Council.

Changes have been recommended by the Investigation Committee, Task Force, and Accounting Department for the Ordinance.

Janice Hirth requested assistance in developing FY'91 budget.

Rick Hill restated that Ernie Stevens was delegated by the Business Committee to meet with the Gaming Commission on the Guidelines of Implementation of General Tribal Council recommendations.

Janice Hirth requested assistance in reallocating funds for needed help. Rick Hill asked Kathy Hughes to work with Janice to assist her in reallocation of funds.
