- WHEREAS, the Oneida Tribe desires to meet the concerns and needs of adolescents through a cultural sensitive project that promotes the Oneida culture and provides youth with a sense of their role and responsibility within the culture and community, and
- WHEREAS, the Oneida Tribe seeks to ensure that Indian adolescents have access to age group and culture appropriate health care.

NOW, THEREFORE BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin prepare and submit application to the Indian Health Service in response to the notice of Competitive Grant Applications for "Adolescent Health Centers for American Indians/Alaska Natives."

B. Headstart Family Service Center Proposal- Sherry King

Resolution No. 8-17-90-B

- WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined the goal of the Oneida Nation is to protect, maintain and improve the standard of living and the environment in which the Oneida people live; while maintaining and re-establishing the sovereign rights of the Oneida Nation, and
- WHEREAS, the Oneida Tribe recognizes the deep spiritual nature and inter-relatedness of the spiritual, emotional, mental, and physical health of tribal members, and
- WHEREAS, the Oneida Tribe recognizes the complex nature of Oneida Tribal Headstart families and their need for services, and
- WHEREAS, the Oneida Tribe presently has an Education Department, Human Services Department, a Tribal Library and Literacy Program, a Career Development Center, a JOBS and WJET Program and a Tribal Elementary School, and
- WHEREAS, the Oneida Tribe recognizes the need to formalize the process for delivery of these services to Headstart families through a collaborative Case Management System.

NOW, THEREFORE BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin make application to the Department of Health and Human Services in response to the request for applications for the Headstart Family Service Center Demonstration Project.

C. Flandreau Indian School Support Resolution

Resolution No. 8-17-90-C

- WHEREAS, The Flandreau Indian School Board is committed to the provision of quality of education for all it's students; and
- WHEREAS, the Board believes that quality education will only be realized through the combined efforts of parents, Tribes, administration, teachers, and students to determine the direction of education for students; and,
- WHEREAS, attempts within the past fifteen years have been made by officials within the bureaucracies of the BIA and other agencies to transfer the Division of Education within the BIA to another agency such as the Department of Education or to another new agency within the Department of Interior, negating all positive steps to improve the spectrum of Indian education as designed by Indians themselves.
- NOW, THEREFORE BE IT RESOLVED: That the Flandreau Indian School Board strongly opposes any move to transfer education out of the Bureau of Indian Affairs to any other department or subdivision thereof.

BE IT FURTHER RESOLVED: That the Flandreau Indian School Board wishes to express it's continued support of keeping the BIA division intact and to request that the twenty-six tribal governing bodies who support Flandreau Indian School evidenced by student enrollment from their Tribes be apprised of our concerns and request that they assist our endeavors to forestall any efforts to minimize the services of the BIA's trust responsibility in the realm of education by contacting their respective Congressional delegation immediately by phone or letter, with copies afforded to Ed Brown, Assistant Secretary on Indian Affairs and to Ed Parisian, OIEP.

#### VEHICLE POLICY

#### I. PURPOSE:

This policy outlines the authorities by which the Oneida Business Committee Tribal vehicle will be used and procedures that must be followed while it is in use.

II. <u>AUTHORITY:</u> The Oneida Business Committee has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution by the Oneida General Tribal Council. In fulfilling this responsibility it will be necessary to use a Tribal Vehicle. The Oneida Tribal Vehicle Policy in conjunction with this Oneida Business Committee Vehicle Policy will provide the basis by which the vehicle will be utilized.
