Request for Neighborhood Watch Program by Tribe under Public Safety. Discussion on how to resolve problems with vandalism, reckless driving drug abuse, Ad Hoc Committee of Public Safety, Recreation, Housing. Attorney should develop:

- 1. Loretta Metoxen moved to send a letter to the Mayor, Town Chairman of Hobart and Oneida to reduce speed limits in housing sites to 15 mph, and no passing zone in front of the NHC.
- 2. Loretta Metoxen moved to send a letter to the Brown and Outagamie County Executive Offices to request law enforcement of speed/moving violation in housing sites. Debbie Doxtator seconded. Motion carried.
- 3 Debbie Doxtator moved to have Julie Barton hold a community Meeting with Public Safety, Green Bay Police, Oneida Housing Authority, Human Services, and to invite all Housing residents. Shirley Hill seconded Motion carried.

A) Weatherization Agreement with NEWCAP - Roberta Kinzhuma

Whereas, the Oneida Tribe will receive funding for the calendar year 1990 from the Dept. of Health & Human Services, State of Wisconsin, to

weatherize eligible units in and about reservation land, NEWCAP, Inc will perform the following services at the following costs:

NEWCAP, Inc. will audit minimum of 10 dwelling units Services will include the energy audits of Mobile Home units for eligible applicants. The monitoring of the program shall be the responsibility of the regional monitor, John Mastricola.

For their services, NEWCAP, Inc. will receive \$75.00 per unit, total mot to exceed \$750. Payment will be reimbursed to NEWCAP, Inc., by the Oneida Tribe on a monthly basis, with the understanding that the Tribe will receive from NEWCAP, Inc., invoices, as audits have been completed, documenting the repair needs of each unit.

The Oneida Tribe, in turn will be responsible for the following:

- 1 Provide to NEWCAP, Inc, at 6-10 eligible clients who meet the program's income requirements.
- The Tribe shall be responsible for the client file and any subsequent audits by the State.
- 3 The Tribe shall be responsible for submitting the monthly production reports to the State, due on the 10th of each month.

Loretta Metoxen moved to approve the Weatherization Agreement, Julie Barton seconded. Motion carried.
