A. Resolution for Injury Prevention Grant - Diane Carnes

WHEREAS, the Oneida Business Committee in the interest of continuing to provide comprehensive quality health care services to its members, their families, and other Native Americans residing within the Oneida Health service delivery area; and

WHEREAS, the Wisconsin Department of Health and Social Services has funds available to support injury prevention programs established by 1989 Wisconsin Act 318.

NOW THEREFORE BE IT RESOLVED; The Oneida Business Committee authorizes the submission of the Injury Prevention Program Grant Proposal in the amount of \$30,000 to assist the Oneida Comprehensive Health Center to implement a program to facilitate: 1) reduction of unintentional injury in the elderly population; and 2) to increase community awareness of risk factors for injury in the home.

BE IT FURTHER RESOLVED: That the Tribal Chairman and/or his designee; and the Oneida Community Health Manager are authorized to negotiate the grant, any amendments and/or renewals, and

BE IT FINALLY RESOLVED: That the authorization under this resolution remain in effect until rescinded or suspended.

B. Draft WHEDA Resolution #11-09-90-B- Bob Christjohn

WHEREAS, the Oneida Tribe by the Oneida Housing Authority and the Oneida Law Office administer all Tribal lands on the Oneida Indian Reservation, and

WHEREAS, all Tribal members are amenable to the duly enacted laws of the Oneida Tribe pursuant to the Oneida Constitution, and

WHEREAS, it is the desire of the Oneida Tribe to encourage and assist Tribal members to purchase and construct homes on the Reservation and to take full advantage of government programs created for that purpose, and

WHEREAS, the Oneida Tribe has identified a housing program for Indian families whose income is too high to quality for housing through the local Housing Authority, and ONEIDA [BE OF] NDIAN OF WISCONSIN REGULA ETING - NOVE BER 9, 1990 Page 3

WHEREAS, the U.S. Department of Housing and Urban Development has a new HUD/FHA mortgage insurance program for Native Americans, and

WHEREAS, the new program provides FHA insurance for mortgages on Indian reservations and other restricted lands, and

WHEREAS, the Oneida Tribe will assist the families with their homesite lease, and it will assure that the land will not be sold to non-Indians or otherwise fall out of trust status, and

WHEREAS, the Oneida Tribe does have an enforceable eviction procedure, and

WHEREAS, the laws of the Oneida Tribe pursuant to the Oneida constitution provide for all remedies of enforcement as may be necessary including eviction and foreclosure where indicated without violating the Due Process and Equal Protection rights of individual Tribal members, and

WHEREAS, in the absence of a Tribal Court, the Oneida Housing Board has the authority to enforce all laws, rules and regulations pertaining to the administration of Tribal lands under their jurisdiction and the Oneida Land Committee administers all other Tribal lands in the same fashion with regard to enforcement, and

WHEREAS, the delegation for enforcement authorities are contained in the Oneida Land Office and Oneida Housing Authority Ordinance, respectively duly enacted on January 16, 1968 and December 16, 1976.

NOW THEREFORE BE IT RESOLVED: that allows of the Oneida Tribe will be enforced, including those related to administration of land by either the Oneida Housing Authority or the Oneida Land Committee as may be required, and

BE IT FURTHER RESOLVED: that the Oneida Tribe will permit HUD to have access to the properties for the purpose of servicing, and

BE IT FURTHER RESOLVED: that the Oneida Tribe agrees to the lease form approved by HUD and the BIA, and

BE IT FINALLY RESOLVED: that this resolution shall substitute and supersede any other resolution regarding this matter.
