NOW THEREFORE BE IT RESOLVED: that the Oneida Business Committee through the Treasurer does hereby submit the FY'1991 budget for the approval by the General Tribal Council.

BE IT FURTHER RESOLVED: that enterprises be required to have completed business plans available within 90 days of the date of this resolution for Oneida Business Committee review, and

BE IT FURTHER RESOLVED: that the Oneida Business Committee is adopting the FY'91 Budget due to the fact that there was no quorum at the 11-19-90 General Tribal Council Budget Meeting.

BE IT FINALLY RESOLVED: that when adopted, this resolution shall include the approval of the FY'91 Budget, the Budget Narrative, the Budget Notes, the Per Capita Addendum and the Water and Sewer Addendum.

Loretta Metoxen moved to adopt, seconded by Debbie Doxtator, motion carried unanimously.
