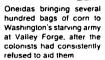

RESOLUTION #1-11-91-A:

WHEREAS, the Oneida Business Committee is the body of the Oneida Tribe delegated to protect the health, safety and welfare of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Utilities Commission has been delegated the authority to construct, operate and maintain a sewer and water system for the benefit of the Oneida Tribe of Indians of Wisconsin, the public and the environment, and

WHEREAS, structure, pipes, lines, equipment and appurtenances for the above system will be upon and under property owned by the Oneida Tribe of Indians of Wisconsin.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin does hereby transfer the use of the property designated below for purposes of construction, operating and maintenance of t structure, s pipes, lines and appurtenances of the sewer and water system. (The attached real estate descriptions shall be used for above mentioned purposes. Please see attachments designated as C.S.M.L.S.1 and C.S.M.L.S.2.

BE IT FINALLY RESOLVED: that said transfer shall terminate and said property shall revert back to the Oneida Tribe of Indians of Wisconsin if the above specified uses are discontinued.

RESOLUTION #1-11-91-B

WHEREAS, the Oneida Business Committee is the elected body delegated to protect the health, safety and welfare of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Utilities Commission has been delegated the authority to construct, operate and maintain a sewer and water system for the benefit of the Oneida Tribe of Indians of Wisconsin, the public, and the environment; and

WHEREAS, pipes, lines, equipment and appurtenances for the above system will be upon and under property, streets and alleys owned or under the control of the Oneida Tribe of Indians of Wisconsin.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin does hereby grant perpetual easements to the Oneida Utilities Commission for the use of property, streets, and alleys for purposes of construction, operating and maintenance of the pipes, lines and appurtenances of the sewer and water system. (The attached real estate descriptions shall be used for the above mentioned purposes. Please see attachments designated as 1. A-C, 4. A-B, 5. A-B, 11. A-B, 16. A-C, 17. A-B, L.S.1. A-C, and L.S.2. A-C)

BE IT FINALLY RESOLVED: that said easements shall terminate and said property shall revert back to the Oneida Tribe if the above specified uses are discontinued.

Amelia Cornelius moved to approve both resolutions pending review and approval by the Land Committee, second by Julie Barton, motion carried. Lloyd Powless and Loretta Metoxen abstained as they are members of the Utilities Commission.

Main motion carried.

Julie Barton moved to refer the development of the site on the corner of Freedom Road and Highway 172 to the Land Committee for redesignation for commercial use, second by Shirley Hill, motion carried unanimously.
