VII. NEW BUSINESS

- 1 RESOLUTIONS
 - A) FY 1991 Water Quality Management Planning Program Resolutin #3-22-91-A Chris Johns

WHEREAS, the Oneida Tribe of Indians is faced with several varied threats to the surface and groundwater resources of the Tribe; and

WHEREAS, the Bureau of Indian Affairs provides funding to Indian Tribes for the purpose of identifying those threats.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin intends to contract with the Bureau of Indian Affairs for funds under the FY 1991 Water Quality Management Planning program to continue on-going cooperative ground water investigations on the Oneida Reservation. This investigation is a cooperative effort between the Oneida Tribe and the U.S. Geological Survey Water Resources Division. The Chairman of the Oneida Business Committee is hereby authorized to negotiate and execute the contract and any amendments thereof. The term of this contract is to be October 1, 1991, through September 30, 1992.

BE IT FURTHER RESOLVED: this Resolution supersedes Resolution #3-8-91-B

Loretta Metoxen moved to adopt Resolution #3-22-91-A, Julie Barton seconded. Motion carried unanimously.

B) Child Abuse Amendments of 1984 Grant Funds under the Family Violence Prevention & Services Act Resolution #3-22-91-B - Chris Johns

WHEREAS, the safety and welfare of Oneida families is a concern and responsibility of the Oneida Tribe of Indians of Wisconsin; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has established the Social Services Division to provide service to families including families which are experiencing domestic violence; and Resolution 33-22-91-B (Continued)

WHEREAS, the Oneida Tribe of Indians of Wisconsin is eligible to apply for and receive grant funds under Title III of the Child Abuse Amendments of 1984 entitled the "Family Violence Prevention and Services Act."

NOW THEREFORE BE IT REVOLVED: that the Oneida Tribe of Indians of Wisconsin declares that it has the authority to submit an application for assistance under the Family Violence Prevention and Services Act on behalf of the members of the Oneida Tribe of Indians of Wisconsin and designates the Social Services Division as the Tribal agency responsible for the administration of this program.

Amelia Cornelius moved to adopt Resolution #3-22-91-B, Russell Metoxen seconded. Motion carried.

C) Earth Week Resolution #3-22-91-C - Amelia Cornelius

WHEREAS, the Oneida Business Committee has expressed concern over the pollution of our Mother Earth and desires to continue efforts to improve the quality of the environment in the Oneida community,

NOW THEREFORE BE IT RESOLVED: that the Oneida Business Committee hereby declares the week of April 21 - 27, 1991 as ONEIDA EARTH WEEK, and

BE IT FURTHER RESOLVED: that the Oneida Business committee hereby declares that Wednesday, April 24, 1991 be declared as ONEIDA ARBOR DAY, and

BE IT FURTHER RESOLVED: that the Oneida Business Committee endorses the attached activities planned for the celebration of Oneida Earth Week.

Following is proposed schedule of events:

There will be a Poster and Essay contest for Oneida students in grades K-5, 6-8, 9-12. The logo for Oneida Earth Week will be the same as 1990. "Bring Back the Circle". - Drainage Ditching Jerry Kurowski is working with Outagamie County, Town of Oneida on plans to develop a proposed ditch design. The Land Committee recommends to pay \$2,500 for the Project. Russell Metoxen moved to approve, Shirley Hill seconded. Motion carried unanimously.
- 2. The Land Committee recommends acceptance of the proposed lease for Bernard and Victoria Johnson on Freedom Road. (Resolution #3-22-91-D) Amelia Cornelius moved to approve, Shirley Hill seconded. Motion carried unanimously.
- 3. Renewal lease for John Peterson Property by Merlin Cornelius. The Land Committee recommends approval with the contingency of receipt of a 5 year plan. Julie Barton moved to approve, Russell Metoxen seconded. Motion carried. Loretta Metoxen and Shirley Hill abstained.
- 4. David Powless requested 22,000 to 30,000 square feet of land for ORTEK. Tribe will own building and it is needed within 2.5 years from now. Land Site requested is Puyleart property. The Land Committee recommends approval to set aside the 5 acres of the Puyleart property for one year for ORTEK, contingent on the approval of the Business Plan by Economic Development, the Land Committee, and the Business Committee, and that is in agreement with the zoning Ordinance.
