VII. NEW BUSINESS

1. RESOLUTIONS -

A) Agreement Between Oneida Tribe, Lois Metoxen & Oneida Land Committee

WHEREAS, Lois Metoxen has agreed to assign her interest in tax parcels #17-0-1940 and #17-0-2046-01 located in Outagamie County to the Oneida Tribe of

Agreement With Lois Metoxen (Cont.)

Indians of Wisconsin in exchange for payment of tax liens on said parcels by the Oneida Tribe;

WHEREAS, the Oneida Tribe wishes to make improvements on said parcels:

WHEREAS, said improvements will benefit both Lois Metoxen and the Oneida Tribe;

WHEREAS, said parcels have been assessed inappropriately for tax purposes, and thus money may be owed to Lois Metoxen by Outagamie County;

WHEREAS, Lois Metoxen may wish to have her interest in the above named parcels returned to her, and

WHEREAS, the Oneida Tribe is investing economically into the improvements of said parcels.

THEREFORE, both parties agree to the following:

- 1. That the Oneida Tribe shall make improvements on said parcels not to exceed \$14,000.00;
- 2. That Lois Metoxen will be granted a life estate on the parcel in the existing home, located at 1755 Freedom Road, DePere, Wisconsin 54115;
- 3. Should Lois Metoxen receive money from the County because of an incorrect assessment and wishes to recover her land, Lois Metoxen will pay the Oneida Tribe for any improvements to the parcels of land the Oneida Tribe has made, as well as paying for the past taxes and other costs the Cheida Tribe has incurred on said parcels in exchange for assigning the land back to Lois Metoxen.

This Agreement is hereby agreed and entered into by Lois Metoxen and the Oneida Tribe of Indians of Wisconsin on the 8th Day of May, 1991.

Loretta Metoxen moved to approve the Agreement, Mark Powless seconded. Motion carried unanimously.

2. REQUESTS

A) TLC Loan for M. Peterson - Chris Doxtator

Amelia Cornelius moved to approve of a Tribal Loan Credit of \$7,000 for Michelle Peterson through Associated Kellogg Bank, Russell Metoxen seconded. Motion carried.

- B) Finance & Appropriation Recommendations of May 1, 1991
- Laptop Computer In lieu of Salary F&A recommends to refer back to the Litigation Committee for a recommendation. No action taken by Business Committee.

Finance & Appropriations (Cont.)

- 2. United Amerindian Center Request is for \$6,500 for drawdown of 1991 grant of support. Balance remaining of \$4,000. F&A recommends UAC pay balance due to Oneida Tribe of \$3,000 and that they identify specific invoice to be paid directly for the remaining \$1,000. Lloyd Powless moved to approve, Russell Metoxen seconded. Motion carried unanimously.
- 3. Sewer & Water Project Update Sarah Plummer Deferred until Sarah is back in office. No action taken by Business Committee.
- 4. Employee Contract Bob Christjohn: Consensus of F&A not to renew. Lloyd Powless moved to approve not renewing contract, Mark Powless seconded Motion carried unanimously.
 - Addendum 1) F&A recommends that Oneida Tribal School, Education, and Land Office work out individual specialized investment policies as subsets of the Tribal Investment Policy. Lloyd Powless moved to approve, Amelia Cornelius seconded. Motion carried unanimously.
 - Addendum 2) F&A recommends that Tribal portfolios be transferred (phased out) to/by Merrill Lynch, according to a plan developed by Merrill Lynch, contingent upon a plan to be presented to the Business Committee after its been reviewed and recommended by the Investment Committee. Loretta Metoxen moved to approve, Lloyd Powless seconded. Motion carried unanimously.
- 5. Front End Loader Updated by Pat Cornelius. Farm has sold cattle at \$6,193.05 and front end loader is in the farm plan. ASCS payment for \$8,342. Also 10 steers to be sold for approximately, \$10,000. F&A recommends that the loader be paid from previous cattle sales. Lloyd Powless moved to approve cost of the front end loader to be paid from previous cattle sales, Mark Powless seconded. Motion carried unanimously. Chris Doxtator stated that ASCS funds are to go for payment of taxes.
- 6. Personal computers and software Since the grantswriter is a priority need, F&A recommends the purchase of one computer for grants. Other "PCs" will be purchased over time to ease cash flow. Software billed back to Administration. Kathy King will bring back in two months for reconsideration. Amelia Cornelius moved to approve, Mark Powless seconded.

Amelia Cornelius moved to amend the motion to purchase Education Computer through grant funds, Mark Powless seconded. Motion carried.

Main motion carried.

- 7. Message Repeater/Gaming F&A has tabled until cash flow improves. No action by Business Committee.
- 8. Vacuum Purchase Rose Melchert F&A recommends purchase from capital expenditures. Amelia Cornelius moved to approve, Russell Metoxen seconded Motion carried unanimously.

- 9. Title Search Assistant F&A recommends tabling until cash flow improves Lloyd Powless moved to have Vera Wilson work with Z. Ron Skenandore for assistance, Russell Metoxen seconded. Motion carried unanimously.
- 10. Plumbing Dept. Truck & WCC Panel Truck F&A recommends to lease/purchase both vehicles from same dealer simultaneously for best deal. Both vehicles are addressed in capital expenditures budget. Mark Powless moved to approve, Loretta Metoxen seconded. Motion carried unanimously.
- 7. Message Repeater Gaming. Amelia Cornelius moved to take from the Table, Loretta Metoxen seconded. Motion carried unanimously.

Amelia Cornelius moved to approve the request to purchase the Message Repeater through a modification of capital expenditures line item, Russell Metoxen seconded. Motion carried unanimously.

C) Charles Peone's Outstanding Bills - Mark N. Powless

Charles Peone will be responsible for personal bills, Tribe and Gaming will split the balance.

D) Request from Mary J. Doxtator RE: Investments

Mary Jane Doxtator presented a portfolio. Referred to Monday Briefing to schedule a meeting.

E) Legal Status of Indian Tribal Boads issued for Economic Development - United Indian Nations in Oklahoma

Amelia Cornelius moved to defer to Attorney Cornelius, Loretta Metoxen seconded. Motion carried unanimously.

F) Meeting With Menominee Chair Glenn Miller - Loretta Metoxen

Chairman Glenn Miller recommends that Oneida send a letter to President Bush and Senator Inouye. Lloyd Powless moved to send two letters, to be drafted by Loretta Metoxen, Mark Powless seconded. Motion carried unanimously. (Include S321, Extension of Gaming, Sovereignty Issue. Bobbi Webster will put a PR package together to send to President Bush.)

G) Kalihwisaks Policy - Proposed Change - Bobbi Webster

Russell Metoxen moved to adopt the new Kalihwisaks Policy, Mark Powless seconded.

Loretta Metoxen moved to amend the motion that the Editor is an AdHoc member and to have 4 committee members for the Editorial Board, Amelia Cornelius seconded. Motion carried unanimously.

Main motion carried.

H) Returning Veterans of Desert Storm - Bobbi Webster

Discussion on honoring the Veterans returning from the Persian Gulf. Amelia Cornelius moved that the Committee coordinate efforts between Jan Malcolm, VFW, Pow-Wow Committee, for honoring veterans, Loretta Metoxen seconded. Motion carried unanimously.

Lloyd Powless reported that there will be a Memorial Day Pow-Wow, and recommends a special Kalihwisaks issue be printed of all tribal veterans.

Lloyd Powless moved to print the Positions, Salary, and Grade of Tribal employees in the annual General Tribal Council Report, Loretta Metoxen seconded Motion carried unanimously.

4) EPA/DNR Appointment

Amelia Cornelius moved to appoint Lloyd Powless and Jackie Smith as EPA & DNR Representatives, Russell Metoxen seconded. Motion carried. Lloyd Powless abstained.

5) OHA

Amelia Cornelius moved to adopt Resolutions A & B, Russell Metoxen seconded for discussion.

Amelia Cornelius withdrew her motion.

Lloyd Powless moved to table until Monday, Loretta Metoxen seconded. Motion carried unanimously.
