WHEREAS, the United States Department of Health and Human Services, Indian Health Service has funds available to provide for the continued delivery of mental health services by the Tribe; and

WHEREAS, the Oneida Business Committee desires to provide for those services under the authority of P.L. 93-638/P.L. 100-472 (Indian Self-Determination Act/1988 Amendments) Contract with the Indian Health Service; and

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin is requesting \$15,000.00 in non-recurring mental health funds to be added to its Fisdal Year 1992 P.L. 93-638/P.L. 100-472 Contract with the Indian Health Service, and

BE IT FURTHER RESOLVED: that the Tribal Chairman and/or his designee; and the Oneida Social Services Manager are authorized to negotiate the contract, any amendments and/or renewals, and

BE IT FINALLY RESOLVED: that the authorization under this resolution remain in effect until rescinded or suspended.

B) Recommendation for "School-to-Work Transition" - Lloyd Powless

It was suggested that a position be developed on this issue in regard to excluding school co-op programs, limit time working when school is in session but not on weekends and enforcement of present laws.

Julie Barton moved to appoint Lloyd Powless to form a task force to develop a position on the school to work a transition program, second by Shirley Hill, motion carried. Lloyd Powless Abstain.

C) Native American Transportation Assoc. Conf. Report & Request for Financial Support

Lloyd Powless moved to refer joining this association and modification of the Business Committee budget for identification of funds for membership fee, second by Debbie Doxtator, motion carried unanimously

Debbie Doxtator moved to send information to Bruce Danforth and the Planning Department, second by Shirley Hill, motion carried unanimously.

Loretta Metoxen moved to adopt a similar resolution which reads as follows, for support to the legislature, second by Lloyd Powless, motion carried unanimously.

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States; and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Native American Transportation Association (NATA) is a National organization of Indian tribes, with associate membership of Indian individuals and organizations, whose mission is to improve transportation infrastructure on Indian reservations and in Indian communities; and

WHEREAS, the present day condition of road systems on Indian reservations are comparable to the rural roads systems of the United States in the 1940's; and

WHEREAS, traffic accidents are the leading cause of death on many Indian reservations; and

WHEREAS, the severe problems experienced by Indian people in the fields of education, health, housing, economic development, and law enforcement cannot be adequately resolved without adequate roads; and

WHEREAS, NATA recognizes that beyond the construction of badly needed roads the IRR program provides significant social and economic impacts to each local reservation economy; and

WHEREAS, the reservation roads needs are now met by funding under the Federal-Aid Highway Act from the Highway Trust Fund with current statutory allocation for the Indian Reservation Road (IRR) system as a part of the Federal Lands Highway Program of \$80,000,000 annually; and

WHEREAS, a 1990 Bureau of Indian Affairs report notes that \$80,000,000, is grossly inadequate; that \$95,000,000 annually is needed simply to maintain the existing level, and that \$227,000,000 annually would be needed to upgrade the IRR to an acceptable level over 25 years; and

WHEREAS, the Surface Transportation Assistance Act of 1987, including reauthorization of funding for the federal-Aid Highway act, must be reauthorized by Congress for fiscal year 1992 and beyond; and

WHEREAS, the Administration's proposed legislation for reauthorization, as contained in S.610 and H.R. 1351, contain a funding level for the IRR far below that recommended in the BIA Report; and

WHEREAS, Senator Domenici of New Mexico and Senator Inouye of Hawaii have jointly introduced S.515 authorizing IRR funding at \$225,000,000 annually and Congressman Miller of California recently introduced a House bill authorizing IRR funding at \$227,000,000; and

WHEREAS, other provisions of the Surface Transportation Assistance act should be re-enacted or modified to meet Indian needs;

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee support NATA at a convention in Albuquerque, New Mexico on April 29-30 and May 1st, on the following:

(A) The NATA supports the more realistic funding levels for IRR for fiscal years 1992-1996 as provided in S.515 and the bill of Congressman Miller of California.

(B) The NATA also supports appropriate amendments to the reauthorization legislation as may best serve the interests of Indian tribes and communities including, among others, provisions to--

(1 ensure that the obligation of the States to fairly and equitably provide road construction services to Indian reservation areas as provided in existing law is enforced;

(2) ensure that the technical	assistance funding for the education and				
training of federal, state, and local highway employees be made					
available to Indian tribe	S;				

- (3) ensure that State Officials are required to consult with tribal officials as "appropriate local officials" in the designation of the state highway system and selection of each state highway project on or near an Indian reservation;
- (4) provide that at least 2% of the annual IRR allocation be made available to Indian tribes, under appropriate criteria, for tribal IRR administration costs, and 2 1/2% of the annual IRR allocation be made available to Indian tribes for tribal transportation planning efforts;
- (5) enhance funding of Indian Highway Safety Programs under the highway Safety Act. This program should include incentives for tribes to develop meaningful highway safety programs and codes;
- (6) ensure that tourism development is encouraged as set out in S.540 by Senator Burns on Montana;
- (7) authorize funding for the construction of major IRR bridges that qualify under the Major Bridge Discretionary Program, namely at Four Bears on Fort Berthold, Fort Yates on Standing Rock, and Birdsprings on the Navajo Indian Reservation. These projects are recommended in the BIA's 1990 report;
- (8) BIA should be directed to develop guidelines for demonstration projects which will demonstrate the effectiveness of tribal programs which incorporate construction and public transit programs in a multiple use concept to stimulate economic development, reduce unemployment and improve the quality of life on Indian reservations. These guidelines should include a requirement for an independent evaluation and report on the effectiveness of such programs;
- (9) Make Public Law 93-6348, the Indian Self-Determination and Education Assistance Act, apply in its entirety to all funds authorized from the Highway Trust Fund for the IRR program;
- (10) provisions of the Buy Indian Act should continue to apply to all funds authorized for the IRR program. The BIA should be directed to promulgate Buy Indian Act regulations by a reasonable but definite date;
- (11) BIA should be directed to consult with tribal representatives and Indian owned businesses to address the issues identified by the Special Committee on Investigations of the Senate Select Committee on Indian Affairs in its Final Report and Legislative Recommendations with regard to procurement under the Buy Indian Act and certification of Indian contractors.
- (12) the Federal Highway Administration and BIA should be required to include tribal representation in the Memorandum of Agreement through which all IRR funds are administered.

(c) That NATA supports such other provisions or amendments of the reauthorization legislation as may best meet tribal interests, and

BE IT FURTHER RESOLVED: that the officer, staff and consultants of NATA take all necessary steps to carry out the provisions of this resolution, including such contacts with congressional committees and staff as may be necessary.

d. Home Garden Resolution

WHEREAS, the Oneida Tribe of Indians of Wisconsin is eligible to apply for contracts with the Bureau of Indian Affairs to plan, conduct, and administer all or parts of Bureau authorized programs, under authority of Public Law 93-638, and

NOW THEREFORE BE IT RESOLVED THAT:

Amelia Cornelius moved to adopt Resolution #5-29-91-A contingent upon changes in the Fire Protection agreements, second by Mark Powless, motion carried. The above resolution has changes incorporated.

e. Appointment of Sarah Plummer as Oneida Representative on DNR Clean Water Resolution.

Chairman Hill recieved a phone call from Jonathon Young Eagle that Sarah was his recommedation.

Shirly Hill moved to take Resolution 5-22-91-C from the table and to reaffirm adoption, second by Mark Powless, motion carried unanimously.

- f. Discussion on the Indian Priority System
- Discussion on the Indian Priority system for the format or distribution of BIA funds to tribal governments. Meeting attended by Loretta Metoxen and Julie Barton. Mr. Jaeger stated they missed the most important part of the meeting which explained the distribution rationale. For FY'92 there will be a \$25 million increase nationally with Great Lakes Agency recieving a 9% increase in an approximate amount of \$380,000 in '92 and approximately a \$150,000 increase in 193 for an overall increase of approximately \$530,000 overall in the next 2 years. Lac Du Flambeau recieved \$102,000 for law enforcement due to their lobbying efforts.

Loretta Metoxen stated that there is still justification for a change in the distribution figures and that the formula should be based on population. Mr. Jaeger does not feel distribution by population would be fair to smaller tribes based on land and population but should be based on need. The funds are basically distributed equally now.

Loretta Metoxen will share information on cooperative education with Thelma McLester. Rick Hill will provide information on the reorganization of the BIA from GLITC to the Business Committee.

Loretta Metoxen's recommendation is to keep \$5,600 in the Fire Protection line item and to move the balance to Safety Management for FY'91 on the Band Analysis and to contact the Central Office in regard to the change.

Lloyd Powless moved to approve the recommendation, second by Debbie Doxtator, motion carried unanimously.

g. Meeting with Sec. Whitburn of Dept. of Social Services in Madison.

Amelia Cornelius moved to approve travel for the Chairman to attend the meeting on June 25, 1991, second by Debbie Doxtator, motion carried unanimously.

### h. DOL Agreement

A copy of the letter and agreement are to be sent to Ujke and Thelma McLester.

### Oneida Group Joint Venture

Comments by Lloyd Powless on the contract and that it is not favorable for the Tribe. Comments by Amelia Cornelius for need for Business Plans, audits, reference checks, financials and past performance of the company. Comments by Debbie Doxtator that due diligence is needed by the Business Committee before the Tribe becomes involved in any joint investments or ventures. Loretta Metoxen commented that the contract is the same as the ORTEK Agreement with minor changes in capital invested and names. It was recommended that this be reviewed by ED&PC, Comptroller, Economic Development, Tribal Attorney and General Manager for recommendations prior to presentation to the Business Committee.

Discussion on investment policy of the Tribe. Loretta Metoxen is recommending shifting responsibility to the Trust Committee as she is unable to handle the daily responsibility of review and monitoring of the investments. A system of monitoring needs to be developed.

Lloyd Powless moved to refer the contract to Kathy King, Jim Van Stippen, Larry Barton, Lynn VandenLangenberg, Planning Department, and Tribal Attorney for review and recommendation, second by Russell Metoxen, motion carried unanimously.

### j. UWGB American Indian Advisory Committee

Amelia Cornelius and Thelma McLester expressed concerns in the Chancellor's handling of the Assistant Chancellor's position vacated by Bill Gollnick. The Chancellor is not supporting the efforts to have Indian Preferance on the description. Other concerns were expressed.

Loretta Metoxen moved that the Secretary write a letter expressing the concerns to the Chancellor with a copy to the Business Committee, second by Julie Barton, motion carried. Amelia Cornelius abstain.

#### OTHER CONCERNS

Chas Wheelock expressed concern over the persons convicted of conspiracy charges in regard to arson at New York and are incarcerated in various prisons throughout the U.S. This was referred to Lloyd Powless and the Iroquois Task Force.

Sarah Plummer informed the Business Committee of the need for a location for the construction company job site trailer. She was referred to work with Bingo staff and Chris Doxtator on a site.
