VII. NEW BUSINESS

RESOLUTIONS

A) Retroactive Approval of Resolution #7-10-91-A RE: Nutritional Services to low-income individuals grant application - Sherri King

WHEREAS, the Oneida Tribe of Indians of Wisconsin has determined the goal of the Oneida Nation is to protect, maintain and improve the standard of living and the environment in which the Oneida people live; while maintaining and re-establishing the sovereign rights of the Oneida Nation, and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has recognized the basic needs and rights of individuals and families and the need to improve the delivery of nutritional services and benefits, especially to those in greatest need.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin authorizes and submits this application to the Department of Health and Human Services in an effort to improve nutritional services to low-income individuals or families; to meet basic needs and provide nutrition benefits that will lead to better health for Oneida Tribal members.

Amelia Cornelius moved to approve, Russell Metoxen seconded. Motion carried.

2. REQUESTS

A) Delinquent Taxes - Brown County - Chris Doxtator

Previously real estate tax foreclosures took place on properties with delinquent taxes of three (3) years or more.

The State law has been changed and counties can now foreclose on delinquent taxes of two (2) years or more.

Properties recently requested for trust acquisition will be prioritized as to the largest tax assessment. Although properties are acquired into trust status in 1991, the 1990 taxes will still have to be paid.

The Tribe's taxes have been paid in full through 1988, therefore 1989 tax foreclosure will take place December 31, 1992. Brown County taxes are approximately \$44,800, and Outagamie County taxes are not available at present, although a projection from the Land Office would be about \$12,300. Request that these taxes be brought back up to date as quickly as possible, and use any left over funds from the FY 91 budget to cover additional year of 1990 and 1991.

Shirley Hill moved to defer to Skenandore & Associates for a recommendation which will be due by July 24, 1991. Russell Metoxen seconded. Motion carried Chris Doxtator is to submit supporting documents to Skenandore & Associates.

Recommend using a small piece of property as a test case.

B) July Enrollments - Debbie Powless

101 individuals. Problem with BIA office in holding up on providing enrollment numbers for tribal members.

Loretta Metoxen moved to send a letter to BIA written by Debbie Powless for Chairman's signature to Eddie Brown of the Minneapolis Area Office, Shirley Hill seconded. Motion carried.

E) NCAI Memorandum of June 27, 1991 - Loretta Metoxen

Loretta Metoxen made the following recommendations:

The Business Committee authorize letters to the Wisconsin Senators supporting S.B. 962 and 963;

- 2 The Business Committee authorize a letter to Senator Slade Gorton on our position (by counsel) regarding Duro;
- 3. The Business Committee authorize letters to be sent to both Wisconsin Senators requesting support for funding for at least 3,000 Indian housing units (and that OHA also be requested to draft similar letters);
- 4 The Business Committee authorize letters to both Wisconsin senators requesting support for H.R. 2145 (Indian Reservation Roads System).

All such letters must be copied to the General Manager and the relevant tribal programs.

The CERA news attachment should be sent to Sharon Metz and Chief Jim Danforth.

Shirley Hill moved to contact the Federal Dept. of Justice with regard to CERA, Mark Powless seconded. Motion carried.

F) Training - Minority Training Project - Kathy King

Kathy King is requesting authorization to apply and participate in the Minority Training Project. The MTP program pays for all training and related expenses. There are approximately 6 courses that are a week at a time, therefore she is requesting education/training time of approximately 6 weeks per year or as required to participate in the course.

Amelia Cornelius moved to approve, Loretta Metoxen seconded Motion carried unanimously.

G) Request from Gwich'in Steering Committee

The Gwich'in Steering Committee requests that the Oneida Tribe support the Gwich'in people by letter and resolution in regards to the permanent protection of the coastal plain of the Arctic Refuge from development, and to send these documents to our Senators, Representatives, in Washington, D.C.

Russell Metoxen moved to approve the following Resolution #7-10-91-B and to send the Resolution and a letter of support to our Senators, Representatives in Congress. Amelia Cornelius seconded. Motion carried unanimously.

WHEREAS, the Oneida Tribe of Indians of Wisconsin supports the Gwich'in Athabascan Indians of northeast Alaska and northwest Canada in their endeavors to prohibit the development in the calving and post-calving grounds of the Porcupine Caribou Herd, and

Resolution #7-10-91-B (Continued)

WHEREAS, for thousands of years the ancestors of the Gwich'in Athabascan Indians of northeast Alaska and northwest Canada, have relied on caribou for subsistence, and continue today to subsist on the Porcupine Caribou Herd which is essential to meet the nutritional, cultural and spiritual needs of their people; and

WHEREAS, the Gwich'in have the inherent right to continue their own way of life; and that this right is recognized and affirmed by civilized nations in the international covenants on human rights. Article I of both the International Covenant on Civil and Political Rights, and the International Covenant on Economic, Social and Cultural Rights read in part:

"...In no case may a people be deprived of its own means of subsistence."; and

WHEREAS, the health and productivity of the Porcupine Caribou Herd, and their availability to Gwich'in communities, and the very future of their people are endangered by proposed oil and gas exploration and development in the calving and post-calving grounds in the Arctic National Wildlife Refuge - Coastal Plain; and

WHEREAS, the entire Gwich'in Nation was called together by their Chiefs in Arctic Village June 5-10 to carefully address this issue and to seek the advice of their elders; and

WHEREAS, the Gwich'in people of every community from Arctic Village, Venetie, Fort Yukon, Beaver, Chalkyitsik, Birch Creek, Stevens Village, Circle, and Eagle Village in Alaska; from Old Crow, Fort McPherson, Arctic Red River, Aklavik and Inuvik in Canada have reached consensus in their traditional way, and now speak with a single voice.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin requests that the United States Congress and President recognize the rights of the Gwich'in people to continue to live their way of life by prohibiting development in the calving and post-calving grounds of the Porcupine Caribou Herd; and

BE IT FURTHER RESOLVED: that the 1002 acre of the Arctic National Wildlife Refuge be made Wilderness to achieve this end.

B. Resolution #7-10-91-C RE: 638 Planning Grant for \$98,168

WHEREAS, the Oneida Tribe of Indians of Wisconsin through the Oneida Business Committee is the chief planning agency for community development activities on the Oneida Reservation; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin wishes to assume more control over programs designed to serve its constituents and to generally diminish Federal domination over programs serving Tribal members; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has demonstrated the ability to develop and implement comprehensive planning activities for the benefit of its members.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin intends to contract with the Bureau of Indian Affairs to conduct a FY 1991 Planning Grant for the purpose of developing a Comprehensive Community Development Plan for the years 1992-96 as outlined in the attached proposal.

Amelia Cornelius moved to adopt Resolution #7-10-91-C, Loretta Metoxen seconded Motion carried unanimously.

C. Request by Mark A. Powless

Mark A. Powless is requesting consideration in regards to the requirements set forth in the Oneida Appeals Commission, which he feels is in conflict with the Tribe's Constitution:

Section A.l.d. of the Oneida Appeals Commission states that: "An appointee cannot have been convicted of a felony."

Article VI, Bill of Rights of the Oneida Tribal Constitution States: "All members of the tribe shall be accorded equal opportunities to participate in the economic resources and activities of the Tribe."

Lloyd Powless moved to waive the restriction in regard to Mark A. Powless to serve on the Appeals Commission, Loretta Metoxen seconded. Motion carried. Russell Metoxen opposed. Amelia Cornelius abstained.

Request Business Committee to review previous action in regard to bondability and risk in other areas.

Amelia Cornelius moved to amend the Appeals Commission by removing the qualification that "No members shall have been or be convicted of a felony". Mark N. Powless seconded. Lloyd Powless, Shirley Hill, Loretta Metoxen, Russell Metoxen opposed. Motion fails.

Lloyd Powless moved to refer the discussion on the felony issue to an Attorney Meeting and to develop a sub-committee, Shirley Hill seconded. Motion carried Mark A. Powless abstained.

D. Amos Christjohn

Amos Christjohn is requesting authorization to stop paying social security taxes on income received from the Oneida Tribe, as per a tax ruling, Rev. Ruling 86-88 which allows him to discontinue paying the tax. This allowance will only be in effect until July 1, 1991.

Amos Christjohn is requesting the Oneida Tribe to reimburse him for the taxes paid in the years 1989, 1990, and until July 1, 1991, withholding only the employers portion of the social security taxes. Mr. Christjohn meets the criterion required to recover the taxes as he has been working continuously for the Oneida Tribe of Indians of Wisconsin prior to 3/31/86.

Lloyd Powless moved to approve the requests, Amelia Cornelius seconded. Motion carried unanimously.

E. Finance & Appropriation Recommendations of 7/8/91

1 15-yd Dump-Truck - Total cost is \$69,999 (Note: Approximately 5-6 Tribal employees are commercial operators). Recommendation to make a definite commitment to purchase next April and in the meantime attempt to negotiate a 10/mo lease for \$1,500/month (conditionally on the April purchase). Funds from capital expenditures.

Russell Metoxen moved to approve purchase of dump truck. Russell Metoxen withdrew motion.

Loretta Metoxen advised to act upon recommendation with funds from UDAG for internal financing.

Lloyd Powless moved to approve recommendation, Russell Metoxen seconded. Motion carried. Loretta Metoxen and Shirley Hill abstained.

2. Plumbing tools (list attached) \$15,000. F&A recommends to purchase from capital expenditures.

Amelia Cornelius moved to approve, Lloyd Powless seconded. Loretta Metoxen and Shirley Hill abstained.

3. A/C Unit for old pit area IMAC - \$10,212.62. F&A recommends to purchase out of capital expenditures from HVAC savings.

Lloyd Powless moved to approve, Russell Metoxen seconded. Motion carried unanimously.

4. Community Water System on County Trunk "H". Sub-contract to Knaus Construction for \$27,639.75. Plumbing will receive \$4,073.25 for administration. Funded totally by IHS.

Lloyd Powless moved to approve, Russell Metoxen seconded. Motion carried unanimously.

Salary at Grade 10 is pending Klaus study and qualifications. Shirley Hill moved to approve contingent upon review of Safety Committee, and return recommendation to the Business Committee for approval prior to posting.

Various comments by Kathy King on duties and responsibilities and qualifications. Lloyd Powless seconded. Motion carried.

Amelia Cornelius moved to approve source of funds, Shirley Hill seconded. Motion carried.

F. Lap Top Computer

Loretta Metoxen is requesting that she be assigned the Lap top so that she can do some of the work related to the Litigation Committee since she is the Chairperson of Litigation and there is no staff, and that the computer was purchased with Litigation funds.

Lloyd Powless moved to approve, Russell Metoxen seconded. Motion carried Shirley Hill and Loretta Metoxen abstained.

Loretta Metoxen withdrew her request for travel.
