B) Drug Grant Application for Housing - Arlyce Paulson

Shirley Hill moved to approve Resolution #7-10-91-A,

WHEREAS, the Oneida Tribe of Indians of Wisconsin has formerly declared it has an objective to establish the Oneida Reservation as a drug free community; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin has made many human and financial resources available and is committed to maintaining a long term commitment to eliminate drugs on the Reservation; and,

WHEREAS, the Oneida Housing Authority has developed a Drug Intervention Grant application with the United States Department of Housing and Urban Development; and

WHEREAS, Oneida Tribal staff and Oneida Housing tenants have played an active role in developing the grant objectives.

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians requests the United States Department of Housing and Urban Development fund the request.

BE IT FURTHER RESOLVED: that the Oneida Tribe of Indians may use in-kind human and financial resources that are available to support this HUD activity.

BE IT FURTHER RESOLVED: that the Oneida Tribe of Indians of Wisconsin will closely monitor the funded activity and use whatever means that area available to institutionalize the program on a long term basis.

Mark Powless seconded. Motion carried unanimously

Loretta Metoxen moved to request that reports from the Social Services department be submitted to the Business Committee on their plan for institutionalizing the program on a long term basis. Mark Powless seconded Motion carried unanimously.

Loretta Metoxen stated that there is additional funds for the Land Committee. The Land Committee will meet with the treasurer to find out how much money there is and where it is.

B) HVS Total Marketing - Ron Peterson

After lengthy discussion on the profits accrued through Shearson Lehman Brothers, Lloyd Powless moved to transfer funds from Shearson Lehman Brothers to Merrill Lynch. Shirley Hill seconded.

Chairman Hill recommends that Joe Gable of Merrill Lynch be authorized to come and set up a transfer portfolio for the Tribe.

Lloyd Powless moved to have the Treasurer and the Comptroller work with Joe Gable on preparing a transfer of the portfolio to Merrill Lynch. Second agrees Motion carried. Loretta Metoxen abstained.
