- VII. NEW BUSINESS
 - 1 RESOLUTIONS
 - A) Oneida Early Childhood Education Department Application for a Child Care & Development Block Grant for Children & Families Resolution #7-24-91-B - Chris Johns

WHEREAS, the Oneida Tribe of Indians of Wisconsin finds that the safety, care and development of children in the Oneida Community is a high priority of the Oneida Tribe; and

WHEREAS, the Oneida Tribe of Indians of Wisconsin, through the Oneida Business Committee and the Oneida Early Childhood Education Department, is constantly seeking to conduct activities which will improve the quality of child care provided to Oneida children and to increase the availability of before-and after-school services to children.

NOW, THEREFORE BE IT RESOLVED: That the Oneida Tribe of Indians of Wisconsin authorizes the Oneida Early Childhood Education Department to apply for a Child Care and Development Block Grant from the Department of Health and Human Service's Administration for Children and Families.

Amelia Cornelius moved to adopt Resolution #7-24-91-B, Julie Barton seconded Motion carried unanimously.

 - A) Economic & Community Development Committee Recommendations of July 12, 1991 - Debbie Doxtator
- 1 ECDC recommends that the Oneida Business Committee write a statement and/or policy on Inter-Departmental charging for services. It appears that there are inconsistencies in this practice at this time.

Shirley Hill moved to defer to General Manager for a policy development Julie Barton seconded. Motion carried unanimously.

Question on private sector for individual business. This is an area that the Tribe has not been able to fund or to provide adequate services.

2 ECDC recommends that Economic and Community Development be included in Master Financial Plan for the Tribe. They are requesting that the Treasu be delegated this responsibility.

ECDC Recommendations (Cont.)

Julie Barton moved to approve the request, Shirley Hill seconded Motion carried. Loretta Metoxen and Debbie Doxtator abstained.

3 ECDC recommends that the Oneida Business Committee set up a Community meeting to discuss the topic of the "Oneida Nation" possible name change

Russell Metoxen moved to approve and to refer to Julie Barton Amelia Cornelius seconded. Motion carried. Julie Barton abstained.

Discussion on sovereignty of Oneida Nation and involvement of the BIA in changing tribal names and other changes in the constitution.

ECDC recommends approval of Policies and Procedures as amended. Following is the purpose of the Economic & Community Development Committee (The Tribal Secretary will make full copies of the Policies & Procedures available upon request.)

PURPOSE: The Economic & Community Development Committee is charged with the task of conducting oversight and staff assignment in the areas of economic and community development. The Committee is also charged with the responsibility of reviewing and approving proposals and projects for final recommendations to the Oneida Business Committee.

Loretta Metoxen moved to approve policies and procedures as amended Mark Powless seconded. Motion carried unanimously.

B) T.L.C. Loan for Mr & Mrs Eric McLester - Chris Doxtator

The Land Committee recommends approval of a down-payment loan to Eric & Catherine McLester for approximately \$6,500. They are in the process of obtaining final approval to build a new home.

Russell Metoxen moved to approve, Loretta Metoxen seconded. Motion carried unanimously.

C) Board Appointment to Oneida Airport Hotel Corp. - Jim VanStippen

The Oneida Airport Hotel Corp. is recommending Bruce King to be appointed to fill the vacant position on their Board.

Amelia Cornelius moved to approve Russell Metoxen seconded Motion carried unanimously.

D) Phase II Sewer Project/Plumbing Enterprise - Larry Barton

Amelia Cornelius moved to approve preliminary authorization to proceed on a bid process for Phase II of the Sewer & Water project with Klaus Construction. Debbie Doxtator seconded. Motion carried. Shirley Hill, Julie Farton Loretta Metoxen abstained.

Discussion on hiring of tribal member

Questions on involving TERO on the Reservation

Discussion on Phase I that FmHA would not change their stand on Indian Preference. Tribal support for S321 to change Indian Preference. Need to find contractors that will hire tribal members.

Discussion on FmHA authority as they control the funds for the project. The Tribe fought the issue up to the point of almost losing the funds. The Business Committee has not taken any action on TERO. It should be referred to ECDC for action.

Need to get status report on TERO to Human Resources.

E) Nursing Home Administration - Lee McLester

Issue with George Samardich and ORCOA and AJNH. Anna John provided information on past action of Wendell McLester in regard to George Samardich. She feels that committees should not be involved in other committees unless their assistance is requested.

Anna John stated that ORCOA is getting a greater percentage of tribal funds towards their budget than the AJNH. Attempts to improve ORCOA should be made before being concerned about another committee.

Anna John invited the Business Committee to visit the Nursing Home anytime

Debbie Doxtator moved to have Mark Powless set up a meeting of AJNH, ORCOA, AJNH Administrative Staff, Deanna Bauman. Shirley Hill seconded. Motion carried unanimously. Third Tuesday - Noon, August 20, 1991.

F) Fire Protection Responsibility - Kathleen Kalina

Attorney Cornelius asked if the town has a back-up plan for fire protection

Amelia Cornelius moved to delegate to the Safety Committee for the development of a back up Fire Protection Plan with the Town of Oneida, Russell Metoxen seconded. Motion carried unanimously.

Request by Julie Barton to follow up with an article on the phone # 731-1500 and 911 Number, and to Advertise in the Kalihwisaks.

G) Chief Oshkosh Beer Advertisements

Chief Oshkosh beer is being advertised on billboards throughout the Fox Valley, which entails the words "Indian Uprising" accompanying a picture of a bottle of beer being poured.

Concern is that the advertisers are insulting Indians as a whole by stereotyping "the drunken Indian".

Russell Metoxen moved to refer to Communications Department Loretta Metoxen seconded. Motion carried unanimously.

H) Request for Donation for Larry Echohawk, Attorney General

Amelia Cornelius moved to refer to Finance & Appropriations, Shirley Hill seconded. Motion carried unanimously.

Short discussion on providing information to Kalihwisaks on activity of NACo

I) Request from Matt Spencer of Bedford, Mass

Matt Spencer is organizing a symbolic "United Indian Nation: that will be able to compete in the 1996 Summer Olympic Games hosted by Atlanta. He is requesting the support of the Tribe.

Julie Barton moved to defer to Communications, Mark Powless seconded. Motion carried unanimously.

J) Request for Support from the Western Shoshone Nation-Chas Wheelock

Amelia Cornelius moved to send a letter of support to defend the homelands of the Dann Band. Debbie Doxtator seconded. Motion carried unanimously.

K) NCAI Elections

Loretta Metoxen requests to have action deferred

Discussion on travel for the Business Committee. Oneida Tribe pays dues of \$1,000 and this provides in-roads to laws being proposed, and testimony development at Washington, D.C.

Debbie Doxtator moved to support Lloyd Powless' request to not support Loretta Metoxen in running for Chairperson of NCAI due to the volume of responsibilities that she must portray here in the Tribe and the volume that will be required by NCAI. Mark Powless seconded. 4 members for, (Debbie Doxtator, Amelia Cornelius, Russell Metoxen, Mark Powless), 3 members abstained (Loretta Metoxen, Shirley Hill and Julie Barton). Motion carried.

Discussion on position in support of the request and responsibility of Business Committee members. Need to change the way internal business is conducted as well as doing outside business. Tribe needs to determine priorities internally and nationally.

Anna John requested an article be put in the Kalihwisaks on travel made by Business Committee members. Concern whether Treasurer is spread too thin with her responsibilities. Support for tribal members to be on National Committees

Loretta Metoxen stated that Officers of NCAI are usually members of Tribal Councils. NTCA started because of concern that elected tribal officials were not involved in NCAI.

Not satisfied with explanation by tribal attorney on I.C.L. contract. No report from special meeting with tribal attorney on review of the I.C.L. Contract.

Allen Doxtator asked if there is any collusion going on with I.C.L. Business Committee needs to determine if there is any fact to the statement of collusion

Amelia Cornelius moved that Attorney Cornelius investigate the rumor of collusion as stated by Allen Doxtator, Debbie Doxtator seconded. Motion carried unanimously.
