A. Loretta V Metoxen - Resolution No 09-04-91-A

WHEREAS, the Oneida Tribe is in a state of extremely high growth rate, and

WHEREAS, Phase I of the Sewer Project is nearing completion, and

WHEREAS, Phase II of the Sewer Project will be constructed in F.Y. '92, and

WHEREAS, space needs for an administration building and Oneida Tribal School are critical and are currently being planned for the inclusion of financial considerations, and

WHEREAS, Gaming revenues makes up approximately 86% of the total income for the Oneida Tribe, and

WHEREAS, the legal and legislative support have increased substantially and will continue to do so throughout F.Y. '92, and

WHEREAS, the General Tribal Council requires a definitive budget for consideration for final approval,

NOW THEREFORE BE IT RESOLVED, that the Tribal expenditures will continue at FY '91 level,

BE IT FURTHER RESOLVED, that the proposed final budget will be presented by t Treasurer to the General Tribal Council for their review and discussion at a General Tribal Council meeting on September 30, and

BE IT FINALLY RESOLVED, that the FY '92 budget will be finally adopted by General Tribal Council on October 21, 1991 which will provide for an adequate comment period.

Loretta Metoxen moved to adopt Resolution 09-04-91-A as changed, second by Mark Powless, motion carried unanimously.

Discussion on need for parking space, need for new facility, future trend is for an increase in the number of ideas to meet the needs of the community.

Debbie Doxtator moved to have Land Committee, Cneida Reservation Commission on Aging and Planning to meet on the issue of the property and to develop a plan. Second by Loretta Metoxen, motion carried unanimously.

2. Julie Barton - Safety Risk Management Policy

Debbie Doxtator moved to approve the Safety Risk Management Policy, second by Mark Powless, motion carried unanimously.

Green Peace will be in area on September 11 1991 Focus on paper pulping process. Possible hold a community meeting

Zero discharge meeting in Traverse, Michigan, September 30. There are no Indians on the Committee.

Request for sharing of information on Ft. Howard negotiation on damages done to the Tribal property. A law suit will be filed against Fort Howard if negotiations fall through.

Lloyd will work with Coordinator with Green Peace.

FINANCE & APPROPRIATION RECOMMENDATIONS OF SEPTEMBER 3, 1991

Chamber of Commerce dues for \$2,850.00. Lloyd moved to approve contingent on a Tribal delegate be designated to attend meetings and submit a report back. Seconded by Mark Powless. Carried unanimously.

Lloyd Powless moved to approve, second by Amelia Cornelius, motion carried unanimously. Lloyd Powless moved to buy a table of 8 for September 25th Dinner, (\$40.00 for 10 tickets) second by Mark Powless, motion carried unanimously.

 Request for Donation/Sponsorship for Block of tickets for underprivileged children. F & A recommends to refer to Community Support Program for possible funding.

Amelia Cornelius moved to refer to Oneida Optimist Club, second by Mark Powless, motion carried unanimously.

3. Phase II Cosatron Ventilation for Bingo (Previously Tabled) Filtering system will take out 80% of smoke. Cost \$17,250 all inclusive. Moved by Mark Powless to approve. Seconded by Russell Metoxen. Motion carried unanimously.

Loretta Metoxen moved to approve, second by Lloyd Powless, motion carried unanimously.

4. Pick-up Truck - Cliff Cornelius: Utilities Dept. will purchase truck with the Utility Commission leasing the truck from the Department. HUD will pay for the crane of \$1,500. F&A recommends ordering now to take advantage of the savings on the '91 moel vs. '92 model. Action is contingent on Utility Department and Utility commission budget separation. Cliff is requested to come back with a report at the next F&A meeting regarding budgetary requirement. Moved by Mark Powless, seconded by Russell Metoxen, motion carried unanimously.

The entire Utilities budget (Tribal and Commission) is a concern relative to the accounting process.

Lloyd Powless moved to approve, second by Mark Powless, motion carried unanimously.

 Carpet for Card Room/Gaming - Louise King (Not present) Moved by Mark N. Powless to approve, second by Russell Metoxen. Motion caried unanimously. Amelia Cornelius moved to approve second by Lloyd Powless motion carried unanimously.

6 Equipment/budget Modification - Rose Melchert - Moved by Russell Metoxen to approve the vacuum cleaner purchases; two for Gaming at \$1,192.00 and three for Retail at \$1,344.00 to be expensed to the respective enterprises. Seconded by Mark Powless, motion carried unanimously.

Amelia Cornelius moved to approve purchases second by Mark Powless motion carried unanimoulsy.

Carpet Cleaning System - Outagamie County Airport uses this system. Total cost for one system is \$6,931. This was budgeted for \$2,500. Need additional funds in the amount of \$4,431.00. Moved by Russell Metoxen to approve the purchase of one complete system, seconded by Mark Powless to be expensed to Gaming expenditures. Motion carried. Russell votes in favor. Mark Abstains. Russellleaves at 4:00 p.m. Lloyd Powless arrives at 4:00 p.m.

Amelia Cornelius moved to approve Carpet Cleaning System second by Mark Powless, motion carried unanimously.
