1. Resolution 10-02-91-A - Native American Rights Fund RESOLUTION # 10-02-91-A

WHEREAS, the cultural and spiritual survival of Native American people is closely tied to the continuation, preservation and well-being of our tribal religious traditions; and

WHEREAS, the right to worship is a fundamental human right that most Americans take for granted; and

WHEREAS, in Lying v. Northwest Indian Cemetery Protective Association, and in Employment Division, Dept. of Human Resources v. Smith, the Supreme Court ruled that the First Amendment does not protect traditional Native American sacred sites from destruction (Lying), or the peyote religion of the Native American Church, (Smith); and,

WHEREAS, the American Indian Religious Freedom Act has not prevented the Federal government from unnecessarily engaging in activities which impair or disturb Native American Religious practices on federal lands;

NOW THEREFORE BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin urges Congress to enact legislation that will protect Native American religions and basic religious freedom, similar to that recently circulated to tribal leaders by Senator Inouve.

BE IT FURTHER RESOLVED: to that end, the Oneida Tribe of Indians of Wisconsin petitions Congress to immediately hold hearings on legislative proposals that have been developed to protect Native American religious freedom, with the goal of passing legislation by the end of 1992.

Loretta Metoxen moved to adopt Resolution 10-02-91-A second by Deborah Doxtator, motion carried unanimously.

Recommend doing only selection cutting, Resource Management takes in consideration of both short and long term concerns. Policy that concerns the entire reservation needs to take into the consideration of all tribal members need more meetings and disucssions on land related issues.

Policy issue and community concerns-usually there is a problem in communications of informing as many tribal members as possible, cost factors included as a part of the issue, to buy out contract - may cost \$20,000. Policy clarification. Safety issue on hunting of areas where homesites are.

Request to have Warden in regard to safety factor for homesite on tribal lands

Russell Metoxen moved to negotiate pay off logger and to stop commercial clear cutting on reservation for next three years, second by Amelia Cornelius,

Shirley Hill would like a referendum vote on the whole issue. Shirley Hill moved to table and to hold a referendum vote on the forestry issue, second by Loretta Metoxen, motion carried unanimously.

Chairman suspend rules t ow for further discussion

Mark Powless moved to take woodcutting issue to Attorney meeting. Attorney Gerald L. Hill requests a special meeting of the Business Committee at which interested parties can speak their mind.

3. Resolution 10-02-91-B (Gerald L Hill)

WHEREAS, the Oneida Tribe has determined that the Indian Gaming Regulatory Act of 1988 has preempted the law over Indian regulated gaming on the reservation, which includes the establishment of a National Indian Gaming Commission to implement IGRA, the classification of gaming into three (3) classes, the assessment of fees by the Commission over Class II games, State-Tribe Class III gaming compacts, among others, and

WHEREAS the National Indian Gaming Commission was not operational for nearly two years, thus inhibiting the promulgation of rules for the conduct of the Commission's responsibilities, specifically including the need to consult with Tribal governments, and

WHEREAS, the National Indian Gaming Commission promulgated its first rules under the IGRA addressing Class II fee assessments which became final on June 28, 1991 with first assessments due on September 30, 1991, and

WHEREAS, the Oneida Tribe with many other tribes objected to the Commission's lack of consultation prior to promulgation of the assessment rules, and other rules to implement the Act, and

WHEREAS, IGRA set forth a general process of negotiating compacts between tribes and states to jointly regulate Class III gaming which is not yet accomplished by the Cheida Tribe although two tribes in Wisconsin have concluded such compacts, and implies the intent of the Act to negotiate issues arising between the Commission and other entities, and

WHEREAS, the Oneida Tribe is aware that the Commission has consulted with the Office of Management and Budget, and will in the future, and other agencies of the federal government on the issuance of proposed regulations under IGRA, and

WHEREAS, IGRA contemplates a cooperative relationship between tribal governments and the Commission which we believe minimally includes <u>prior</u> consultation with tribes to insure that IGRA is effectively and efficiently implemented for the benefit of the tribes, the Commission, the states and the public, and

WHEREAS, the United States Congress passed the Negotiated Rulemaking Act of 1990 for the sole purpose facilitating rulemaking needs of federal agencies and to

avoid costly and time ensumi litigation

NCW, THEREFORE, BE IT RESOLVED, that the Cheida Tribe hereby urges that the Negotiated Rulemaking Act of 1990 be invoked by the National Indian Gaming Commission in the implementation of all further rules promulgated pursuant to IGRA, and that the Commission hold comprehensive hearings in Washington, D.C., and field hearings throughout Indian Country <u>prior</u> to the issuance of any more rules so that tribal governments and other interested parties may participate: the formulation of regulations based upon IGRA, which was enacted to protect Indian gaming.

This resolution wi with whoever goes to WIGA Discussion held a cerning the NIGA.

Loretta Metoxen expressed concerns, stating that Oneida should be at-large committee member to have votes and we should encurage other tribes to do so John Echohawk will be at the next Attorneys Meeting.
