RESOLUTION NO. 1-8-83-A

- WHEREAS, The Oneida Trust Committee is responsible for the funds of the New York Emigrant Claim Award, (Docket 75) and,
- WHEREAS, The Oneida Trust Committee is elected by the General Tribal Council to oversee and implement the Per Capita payment of the Oneida Trust Agreement as stated in Article VIII of the Trust Agreement, and,
- WHEREAS, The Trust Agreement contained a schedule of per capita payments set at a fixed interest rate, and,
- WHEREAS, The interest rate has since risen to the point that there is excess monies in the Trust Account, now,
- THEREFORE BE IT RESOLVED: That the Oneida Trust Committee be authorized to amend the Trust Agreement and to make accelerated per capita payments to distribute the excess interest and to coincide with the fluctuating interest rates, and,
- BE IT FURTHER RESOLVED: That the one million (\$1,000,000.00) principle be kept intact at all times.
