PURCHASER ELIGIBILITY:

Must be an Enrolled Tribal member, their spouse, or their child.

REQUIREMENTS AT TIME OF PURCHASE:

- Cemetery Plot Purchase Request
 - If purchaser is a child or spouse of a Tribal Member, acceptable documentation must be on file or submitted. Acceptable Documentation is:
 - Child – Certified Birth Certificate that fully identifies parents or Court Document that fully identifies parents.
 - Spouse – Certified Marriage License/Certificate.
 - \$100.00 Plot Fee

PLOT ASSIGNEE ELIGIBILITY:

Must be an Enrollment Tribal member, their parent, their spouse, or their child.

REQUIREMENTS AT TIME OF ASSIGNMENT:

- If plot assignee is a parent, a child, or spouse of a Tribal Member, acceptable documentation must be on file or submitted. Acceptable Documentation is:
 - Child/Parent – Certified Birth Certificate that fully identifies parents or Court Document that fully identifies parents.
 - Spouse – Certified Marriage License/Certificate.
 - Stillbirth/Miscarriage – Completed, Notarized Voluntary Paternity Statement.
