SUBJECT: Notice of reconvened special GTC meeting on Tuesday, May 16, 2017

At the special GTC meeting held on March 19, 2017, the following motions were made:

"Motion by Carole Liggins to adopt agenda with moving items IV.C. and IV.D. to the top of the agenda; and that discussion/questions from GTC be limited to three minutes and one time only until everyone has had a chance to speak."

"Amendment to main motion by Linda Dallas that the first item will be IV.D. Employment Law, then IV.A. Election Stipends, then IV.B. Designation of the Oneida Judiciary, then IV.C. 2017 Re-organization Proposal; that the three minute limit be "per person, per topic" not "per person"; and that meeting conclude at 5 p.m. and that any remaining items are forwarded to a future date within 60 days."

A. Petitioners Madelyn Genskow and Yvonne Metivier: Incentive Stipends for Oneida Elections (No Action Required)

<u>Excerpt from March 19, 2017, special meeting</u>: (1) Motion by Yvonne Metivier to direct the Oneida Business Committee to pay \$100.00 to all Oneida tribal members who vote in all Elections (General, Special, Judiciary, and Primary) held under the Oneida Nation Election Law with the onset of the 2017 Primary. Seconded by Bernice Besch. <u>Motion failed for lack of support by show of hands</u> (2) Amendment to main motion by Madelyn Genskow that in future elections, the \$100.00 stipend for the debate before the elections and the provision that would allow candidates to have articles in the

newspaper, would go forward for the next round of elections; and that in the debate before the elections, candidates will be asked: 1) "What do you see as the three (3) most important problems in the Oneida Nation based in WI?" and 2) "What will you do to specifically address those problems?". Seconded by Sandy Dennet. <u>Amendment failed by show of hands</u>

B. Adopt resolution entitled Designation of the Oneida Judiciary as the Judiciary Authorized Pursuant to Article V – Judiciary of the Oneida Nation Constitution (*No Action Required*)

<u>Excerpt from March 19, 2017, special meeting</u>: Motion by Dylan Benton to adopt the resolution found on Page 31 of the meeting materials entitled "Designation of the Oneida Judiciary as the Judicial Authorized Pursuant to Article V – Judiciary of the Oneida Nation Constitution". Seconded by Sherrole Benton. <u>Motion carried by hand count: 643 support; 387</u> <u>opposed; 158 abstained</u>
