#### MEETING REQUIREMENTS

The Committee shall be appointed by the OBC. The regular meeting time, place, and agenda shall be determined at a regular meeting. We have two bingo fundraisers scheduled in Jan and May. We also will do a fundraiser in the community.

## GOALS AND OBJECTIVES

Our main goal is to coordinate 3 annual Powwows with resouces allocated thru our annual budget process.

A second goal is to generate revenues thru raffles, concessions, admissions, (july only), fundraisers, donations, and vendor booth sales.
