

Perhaps, your credit card company will send some personalized checks that seem to have few boundaries on their use. These instant loans might be a quick way to handle the big holiday shopping bills, but you better check the fine print first.

Many of these loans have very high interest rates and fees. Compare rates for loans with local financial unsteadiness before you make any final decision. What was a large holiday bill could easily become huge financial obligation that you could still be paying off well past next Christmas.

Some credit card companies offer "free" month to skip a monthly payment so you can ease the tension of holiday bills. What may seem like a nice gesture could cost you even more money. The interest charges often continue to accumulate, so take the time to read the fine print in any offer.

Also think about the hidden consequences of taking an additional personal loan. You will suddenly show up on multiple mailing lists, increasing the amount of offers mailed to you. The telephone solicitations will also increase.

Avoid some of these problems by budgeting your holiday purchases and sticking to a plan. Also check with your local financial institution to see what services they can offer at reasonable rates.



### Chocolate Ribbon Pie

## Food Tips/Recipes

Tumeric (Curcuma longa) May Help Protect Skin During Radiation Therapy: This intense yellow-orange colored spice may protect skin during radiation therapy for cancer patients because curcumin, the substance that gives turmeric its famous color, is a natural anti-inflammatory compound that scientists have already shown can suppress tumor blood vessel growth. According to a press release issued in October, cancer researchers at the University of Rochester Medical Center in New York have found that curcumin may proteft skin from the burns and blisters that often occur during radiation treatment. "This is significant because skin damage is a real problem for patients undergoing radiation to treat their tumors," says Paul Okunieff, MD chief of radiation oncology, Wilmont Cancer Center, Rochester, N.Y. "If a nontoxic, natural substance can help prevent this damage and enhance the effectiveness of radiation, that's the winning situation."

Doctors and researchers say that cancer patients could consider eating foods with tumeric during their radiation treatment; however, the study does not support turmeric as an alternative medicine because more research is needed.

Below is a recipe for Tunisian Chicken. You can also add tumeric to salad dressings, seafoods, beans, cauliflower, lentil soups, rice or use with poultry, relish or eggs.

### **Tunisian Chicken**

Serves (6)

Ingredients:

6 boneless chicken breasts (3 pounds)

2 cloves minced garlic

2 T fresh minced parslev

2 T fresh minced cilantro

1 tsp ground cumin

1 T ground tumeric

1 tsp ground ginger

juice or zest of two lemons

2 T extra virgin olive oil

### Directions:

Combine all ingredients in a shallow bowl; cover and marinate chicken for 24 hours. Either saute' in a nonstick skillet or bake in a preheated oven until the internal temperature reaches 180 degrees F.

# Dos & Don'ts & Exercise for Low Back Pain

Changing some of your daily activities will help prevent low back pain. The spine protects the spinal cord and carries the weight of your upper body assisted by back, stomach and side muscles. Everything, including internal organs, is hung on the framework of the spine. Like other parts of the body it is affected by bad habits, posture and the aging process, as well as bumps, jars and accidents.

As we grow older the muscles which help support your back become less elastic. When you try to use your back the way you did when you were younger, you often end up with back problems.

The following things to remember while you do daily activities could mean the difference between having low back pain and having no pain.

# Sitting:

Use a hard chair and put your spine up against it. Try to keep one of both knees higher than your hips. A small stool is helpful here. For short rest periods, a contour chair offers excellent support.

# Standing:

Try to stand with your lower back flat. Never lean forward without bending your knees. For women,

shoes with moderate heels cause less strain on the back than those with high heels.

## Sleeping:

Sleep on a firm mattress; put a bed board (3/4" plywood) under a soft mattress. Do not sleep on your stomach. If you sleep on your back, put a pillow under your knees. If you sleep on your side, keep your legs together and bent at the knees and at the hips.

## Driving:

Get a hard seat for your automobile and sit close enough to the steering wheel so that your legs are not fully extended when you work the pedals.

## Lifting:

Be sure you life properly. Bend your knees and use your leg muscles to lift. Avoid sudden movement. Do not try to lift anything heavy over your head.

## Working:

Don't overwork yourself. If you can, change from one task to another before you feel tired. If you work at a desk all day, get up and move around whenever you get the chance. When you work standing up, use a foot rest to help correct swayback.

-Continued on back-

### Exercises for Low Back Pain

- 1. Lie on your back with arms above your head and knees bent. Move one knee as far as you can toward your chest and at the same time straighten out the other leg. Go back to the original position with both knees bent, and repeat the movements, switching legs. Relax and repeat the exercise 3 to 6 times.
- 2. Lie on your back with arms at your sides and your knees bent. Bring your knees up to your chest, and with your hands clasped pull your knees toward your chest. Hold for a count of ten, Keeping your knees together and your shoulders flat on the floor. Repeat the pulling and holding movements three times. Relax and repeat the exercise 3 to 6 times.
- 3. Lie on your back, relax your arms above your head and bend your knees. Now tighten the muscles of your lower abdomen and your buttocks at the same time so as to flatten your back against the floor. This is the flat back position. Hold the position for the count of ten. Repeat the exercise 3 to 6 times.
- 4. Sit on a hard chair. Let your body drop until your head is down between

- your knees. Pull your body back up into a sitting position while tightening your abdominal muscles. Relax and repeat the exercise 3 to 6 times.
- 5. Stand erect while holding on to a table or chair. Squat down, straighten up again, relax, and repeat the exercise 3 to 6 times.

### Exercise Instructions:

Don't overdo exercising, start the movements slowly and carefully. Some mild discomfort may last a few minutes. If pain is more than mild and last more than 15 to 20 minutes, stop and don't do further exercises until you see your doctor.

Do the exercises on a hard surface covered with a thin mat or heavy blanket. Put a pillow under your neck if it makes you more comfortable.

Always start your exercises in the order marked - to allow muscles to loosen gradually. Heat treatments just before you start can relax tight muscles. Follow the instructions carefully; it will be well worth the effort.

ONCOA would like to wrap up this project and begin its preparation for the next community meeting scheduled for Tuesday, January 28, 2003 at the Multi-Purpose Center. This upcoming meeting is designed around a

specific topic: The newly proposed Oneida Lake Development Project with presentations by Lisa Geer, Landscape Architect of Schreiber/Anderson Associates and Tom Nelson of the Oneida Environmental Department. The following is a list of people ONCOA has contacted and requested information from. Unfortunately, we did not receive responses from everyone. As elderly members of this community, we ask that you either contact the resource person yourself to have your questions answered, or contact one of the ONCOA commissioners and we will continue to pursue answers to your questions.

The break down in communication may have been that those renting the hall thought maintenance would open the door, and maintenance thought that those renting the hall would open the back door. It is a matter of having the renters unlock the back door for wheelchair accessibility.

Gas Card: Why does it take so long from the time you apply to the time you get your card?

RESPONSE: See Cheryl Skolaski response in December issue of DRUMS. Also from Diane Wilson, Oneida Division of Land Management, here is still more information:

Gas Tax applications can be started at Land Management, enrollments, or one of the One Stop locations. Gas Tax applications are accepted on a daily basis. Once it is received at Land Management, they are reviewed on a weekly basis. Each Thursday morning, the applications submitted since the prior week, are reviewed and either approved or not approved for various reasons. The majority are approved as long as the applicants address is within the boundaries and they have provided verification that the address given is their residence of occupancy. The process will take longer if the verification is not provided, a letter is sent to the applicant and they are informed it is necessary to provide the verification. If the application is approved, a copy is retained at our office and the original goes out in the mail that day. Enrollments will receive the original applications in their mail, either Friday or Monday. They do their verification and send out the current gas tax stickers. The longest this process should take is 2 weeks. applications are in and out of our office within a week's time. Enrollments has instituted a temporary sticker to supplement for 30 days. This will more than cover the applicant for the time it will take to process the application. I hope this information addresses your inquiry!

Contract Health: No paying for bills, names going to collections. Elders not going to doctor because they do not want their name in collection. Volunteers are going billing in contract health. (See December 2002 issue of DRUMS for response).

The manager at Oneida Housing Authority is rude to elders. This was referred to Lois Powless who sits on the Oneida Housing Board (at the time of this referral).

Rides for dialysis. Again, the issue about the buses. The state pays 70 or 80%, the tribe pays 30 or 20%. What is the status of this agreement?

RESPONSE: It was determined after further discussion at the ONCOA meeting of November 26, that it is not an issue about the buses, but rather one of determining need in the community. REQUEST SUBMITTED TO BRIAN DOXTATOR TO REFER THIS ISSUE TO THE INTEGRATED HEALTH SYSTEMS TEAM TO IDENTIFY NEED AND SOLUTIONS.

Other casinos have special parking for tribal elderly, why doesn't Oneida?

RESPONSE: I received a response from the General Manager and he indicated that due to our size, the multiple locations and the need many times for additional parking, we cannot delegate parking for the elderly as the spaces are in too much demand to have them not in use 24 hours a day. Hope that helps.

- B. Oneida Business Committee Liaison/Brian Doxtator Brian had two issues he wanted to discuss:
- 1. By-laws. There is a section that deals with elections in ONCOA's bylaws. LOC has reviewed the proposed changes submitted by ONCOA, but has tabled approval based on input from ONCOA regarding the notion of appointments versus elections. It is suggested that anyone interested in serving on ONCOA, submit their application. ONCOA would then screen and recommend to the OBC the candidate of their choice. There was great discussion around this issue. Some comments included:

[Lois P.] \*\*What does the election law say? We should stay with elections.

### DISCUSSION:

[Sue Daniels] \*\*The state law that governs the commission states that the tribal government can APPOINT commissioners.

[Valdor John] \*\*How do we address this issue of a tie?

[Lois Strong] \*\*We need backup information before we can meet on this issue. We will need the Election Ordinance. Also, the Election Committee does not have criteria about putting off the elections. Suggestions to election board. Invite someone from the Election Committee to come to the next meeting to discuss this issue.

[Brian Doxtator] \*\*Boards, Committees,

Commissions. What is truly needed? What is an advisory board? Do they really need to be elected? There are no qualifications to require anyone to sit on a board.

[Sue Daniels] \*\*What is the criteria to analyze the need for these committees? [Brian D.] \*\*At one time, ONCOA was separate for those 65+ to vote for candidates to sit on the commission. Since the Election Ordinance was passed, it folded ONCOA into the general elections due to cost factors.

[Dorothy J.] \*\*The Appeals Commission requires training and school. The Health Board requires a medical background. There is some required training.

[Brian D.] \*\*This training comes after a person is elected!

[Lois P.] \*\*There is a problem with the point system used to appoint people to boards. Requested information on the point system, was not forthcoming.

[Clifford D.] \*\*Are there background checks made for people elected/appointed to boards?

CALL FOR THE QUESTION: Motion carried.

2. ONCOA to establish resolution regarding GTC cancellations and deaths in the community. One elder in the community put it simply. "Cancel it." ONCOA may want to consider either an opinion paper or a resolution.

[Lois P.] \*\*What has GTC said about it? Has there been a resolution regarding this issue? A motion?

[Brian D.] \*\*During the past administration, OBC has made a resolution to NOT cancel GTC meetings. [Lois P.] \*\*Can this issue, opinion paper or resolution go on the January semiannual agenda?

[Brian D.] \*\*We may be able to do a separate mailout, but the packets have already gone to printing.

\*\*Motion by Hugh Danforth that ONCOA write a position paper for criteria for

cancellation of GTC meetings based on deaths in the community. Motion fails for lack of second.

[Lois S.] \*\*We need backup information regarding previous discussions/decisions about deaths in the community and GTC cancellations. At one time, the Land Claims Commission took a stand to support the government continue conducting business.

[Valdor John]\*\*The military asks the family what kind of service they want. The federal government elected that only one person be absent at one time.

[Lois S.] \*\*We should meet on this again. Research past discussions/present suggestions.

- Garages and BIA Roads Written Report/John Breuninger/John Status Bauman. Motion by Hugh Danforth to take from table, 2<sup>nd</sup> by Lois Powless. Motion carried. John Breuninger was present to give report and distributed a written report regarding the BIA Roads funding (see attached). The Ad Hoc Committee is a subcommittee of ONCOA. OBC approved the Ad Hoc Committee to continue on with each phase of the Elderly Services Complex development. There was \$500,00 that was transferred from the cancelled CBRF to Elderly

Apartments. There was \$250,000 left over for infrastructure, grounds, and a path system. There were problems with the contractor, and the slope was incorrect. The BIA/TIP program is to pay for the path system from Elderly Services to NHC. This is a three-phase project. 1. Schematics; 2. Design and 3. Construction. The design phase is about 12% of the total cost of the project. The Oneida Tribe receives about \$650,00 per year from the BIA for roads projects.

GARAGES: There are NO funds available for garages. If we want to do garages, ONCOA should consider approaching the Housing Development Board and asking them to direct John Breuninger to do an analysis on garages. If a need exists then a request for funds should be submitted with the FY2004-2005 budgets. At one time, the trailer replacements were given with a life lease through BIA. The first seven trailers, there were no policies or procedures. The life leases had no guidelines. The Development Division has a grant fund and has recommended to OBC that life leases be eliminated and replaced with a "grant" to recipients. Florence Petri and John Breuninger are to meet to look at the existing list of those requesting garages, to establish criteria for garages and to report back to ONCOA.

DRIVEWAYS: Initially, this project was placed in the Planning Department. This should have been put in Elderly Services. This is not in an appropriate department. When John Breuninger came on board, he began to weed out grants and responsibilities and to transfer them to appropriate departments. Elderly Services can now address driveways [2002] and can get free engineering to work on this project.

John and Florence will provide a status update each month on the garages to include if there is a need, the number of those in need and the criteria established to select those to receive garages.

Currently, there is NO money for garages. Currently, there is NO money for driveways. Motion by Lois Powless to approve John's report, 2<sup>nd</sup> by Clifford Doxtator. Motion carried.

This issue cannot be addressed until it is determined if Clifford can wait until July to resign or if for compliance reasons, he There has been must resign now. comments of concern around this issue received by Florence Petri through Barb Mamerow, Director of Bay Area Agency on Aging, however, there has been no official ruling if indeed the three-year plan will be considered non-compliant if that resignation does not take place now. ONCOA took action to address the noncompliance issue in July 2003, however, there is no indication whether or not that letter has been accepted and the proposal has been approved. appears to be an "end around" taking place that someone is going around ONCOA and what they are trying to do. ONCOA worked with Barb Mamerow to determine how to come into compliance, a special meeting was held with ONCOA,

all commissioners were in attendance. and all commissioners agreed to the letter addressing the compliance issue and the proposed resolution. Motion by Lois Strong that the ONCOA Chair contact Barb Mamerow and Jim Smittlehofer to determine the source of complaints/concerns, and if we are or are not in compliance. Also, to have a special meeting on Monday, December 2, 2002 at 3:00 P.M. to determine the results of those conversations and to determine our next steps to be taken. 2<sup>nd</sup> by Hugh DISCUSSION: There is the Danforth. issue of chain-of-command outlined in our bylaws, the Code of Ethics and possible review of the Removal Ordinance for the action taken to circumvent ONCOA as an entity. Motion carried. Motion by Lois Strong to table Item B under Old Business, "Request for four candidates for ONCOA on 2003 election ballot", 2nd by Lois Powless. Motion carried.

- C. Status Update of Community Meeting (September 24. 2002) research/resources. Sue Daniels wanted to know if after the research is conducted and the resources identified, an article should appear in both DRUMS and KaliWisaks, or if that article should come before ONCOA first for approval. Motion by Arlie Doxtator for Sue to go ahead and publish information as it becomes available and that ONCOA does not need to approve it first, 2<sup>nd</sup> by Dorothy J. Skenandore. DISCUSSION: Brian had received seven (7) items from Sue to be addressed by him. Brian indicated that first three:
- 1. What was our investment in Airadigm? Is there a return?
- 2. What is up with Airadigm, Howard Johnson? Would like info on all our investments. There was a \$10 million investment (in Airadigm) and to date there has been a total of \$50-\$60 million.
- 3. Did you know that the OBC is prepared to take out a \$9 million loan to

invest in more ventures.

These three items have been forwarded to Mercie Danforth who will prepare a complete answer and forward to Sue. The other items:

7. Rides for dialysis. Again, the issue about the buses. The state pays 70 or 80%, the tribe pays 30 or 20%. What is the status of this agreement? Brian indicated that Florence needs to go to Janice Hirth to let her know of the need. Janice in turn will present to OBC.

[Florence] \*\*Having more buses will not necessarily address the issue of dialysis. People go at all times of the day and week. What we need is more family support. Can we do home dialysis? How do you apply for this? How many people in Oneida are in need of dialysis? Currently Faith In Action and family members are assisting with transportation of these patients. There is not enough staff.

[Arlie D.] \*\*The issue of need was presented to Arlie Doxtator who in turn discussed it with Transportation Coordinator, Lorna Christjohn.

[Valdor John] \*\*The Veteran's Group in Green Bay will come out and take veteran's for dialysis.

\*\*Medicaid will transport.

[Sue Daniels] \*\*We need to do fact finding on how many people need this service and how they are currently being transported.

Motion by Hugh Danforth that ONCOA address this concern with our liaison, Brian Doxtator, who in turn will present it to the OBC, who in turn will assign it to the General Manager to forward it to the Integrated Health System to research, 2<sup>nd</sup> by Dorothy J. Skenandore. Motion carried. John Breuninger indicated there need be only sixteen individuals to generate a need for a facility. ESRD (End Stage Renal Disease) is an extreme burden on the family.

6. Need OBC to approve eight (8) elderly

workers to work 20 hours. This is to pick up the Title V workers that we will be losing. The cost would be around \$65,000 per year. [Brian Doxtator] Florence is working on this. [Florence] has received approval from Fred Muscavitch and Don White. The positions are currently sitting at HRD.

4. \$9 million Venture Fund. [Brian Doxtator] The past three terms or nine years, there have been capabilities put into the budget to borrow money to do economic ventures. There is a base report on how much has been loaned out. The Marriott, for example, will be a \$3.5 million investment. GTC approved the budget. With that approval, the OBC can go and get money for economic development. [John Breuninger] This money was originally established for the Development Division, for economic development. During the last term of OBC, this responsibility was taken from the Development Division and OBC took control of those funds. The last OBC made decisions about BavBank, the Native American Bank and the Marriott Hotel. There was no "due diligence" from the Development Division staff.

[Lois P.] \*\*There is \$1 million that comes from tribal funds for the Venture Fund, and another \$10 million that is borrowed. That is a total of \$11 million for the Venture Fund.

[Brian D.] When we approve the budget, we approve the borrowing also. There is a Treasurer's Report every month that is open to the public. It is one Wednesday of every month at 1:30. This is a very comprehensive report.

[Lois P.] This information needs to get out to the community. Also, can call GTC to scrutinize projects.

[Brian D.] while the tribe is currently in debt \$42 million, the net worth of the tribe is \$1 billion. There have been funds budgeted to pay the interest on these loans. There is money in other accounts

to pay the entire debt if need be. "Due diligence" means to do a market analysis, In the case of the Marriott, for example, there was analysis on room rates, % of rooms filled, the insurance costs, whether they are up or down because of 9-II, construction costs, etc. [Lois P.] Why do we not have a General Manager? The GM was assigned to the casino project in New York, the Assistant GM was assigned to the hotel project in Washington. How was that done? Were qualifications scrutinized to determine if these people are qualified to do this type of work? Were there job descriptions created for these positions? Who takes care of business at home while the two GM's are involved in these other projects? People want to know how this came about. OBC needs to address these issues.

Motion carried.

The Gaming Commission's position paper was presented. Motion by Dorothy J. Skenandore that ONCOA piggyback the Gaming Commission's position paper, 2<sup>nd</sup> by Lois Powless. Motion carried.

- B. Request for Naming A Building Arlouine Bain. Motion by Lois Powless to approve the two names submitted by recreation and to process accordingly, 2<sup>nd</sup> by Dorothy J. Skenandore. Motion carried.

Sue is to call Vera and apologize for her waiting so long to present her issue. Vera had left the meeting prior to this item. [John Breuninger] understood there is to be a protest march against this waste station. Sue to call Marj Stevens to get particulars on date, time and place.

- D. Request from Lila Watts re: delivery of medication from the OCHC pharmacy. Motion by Hugh Danforth to have Sue call Lila Watts with the information provided by the pharmacy regarding their procedures for mailing medication, 2<sup>nd</sup> by Lois Powless. Motion carried.
- E. Bay Area Agency/ONCOA Representative Motion by Lois Powless to have Arlie Doxtator take Clifford's place on the Bay Area Agency on Aging as an ONCOA representative, 2<sup>nd</sup> by Dorothy J. Skenandore. Motion carried.
- F. Amvets Nominations. Will ONCOA be nominating an Elder of the Year. Everyone will think about a nomination and bring it forward at our next meeting.

### **MINUTES**

- I. CALL TO ORDER: Chairwoman, Dellora Cornelius, called the meeting to order at 3:09 p.m.
- II. WELCOME AND PRAYER: Arlie Doxtator delivered the opening prayer.
- III. ROLL CALL: Present: Dellora Cornelius, Clifford Doxtator, Lois Strong, Nadine Escamea, Lois Powless, Dorothy J. Skenandore, Arlie Doxtator. Excused: Mary Edna Greendeer (call in). Unexcused: Hugh Danforth. Others present: Valder John, Sue Daniels.
- IV. APPROVAL OF AGENDA: No agenda was available at the time of the meeting.
- V. CONCERNS REGARDING COMPLIANCE WITH ONEIDA ELDERLY SERVICES Agency Unit Plan for Older People 2003-2005.

Sue read the draft minutes from the regular ONCOA meeting of November 26, 2002 which provided the basis for today's meeting.

"Motion by Lois Strong that the ONCOA Chair contact Barb Mamerow and Jim Smittlekofer to determine the source of the complaints/concerns, and if we are or are not in compliance. Also, to have a special meeting on Monday, December 2, 2002 at 3:00 p.m. to

determine the results of those conversations to determine our next steps to be taken, 2<sup>nd</sup> by Hugh Danforth. DISCUSSION: There is the issue of chain-of-command outlined in our bylaws, the Code of Ethics and possible review of the Removal Ordinance for the action taken to circumvent ONCOA as an entity. Motion carried."

Sue indicated that she was given the assignment to contact Barb Mamerow and Jim Smittlekopher to determine the source of complaints/concerns and if we are or are not in compliance. Sue handed out a letter from Barb Mamerow, (see attached copy) and indicated in her discussion with Barb that there is in no way an issue or concern regarding compliance. Barb felt the meeting held with ONCOA on October 25, 2002, more than adequately addressed the issue of compliance. She also indicated the action taken by ONCOA to remedy the situation by having Clifford Doxtator step down from his post in July of 2003 was a satisfactory remedy. She assured Sue both verbally and in writing that there is no threat to funding the Oneida Elderly Services Program and the compliance issue was ONCOA's through satisfied recommended/proposed remedy. In terms of the source of concern/complaint, Barb indicated she had received a phone call from Mary Edna Greendeer, but did not construe the call as one of complaint but rather one of inquiry into the compliance issue, a request for clarification of the law and any concerns that may exist regarding the compliance issue.

Sue also reported that she had spoken with Jim Smittlekopher to make the inquiry regarding this same issue. Jim indicated that there was no problem existing with noncompliance, that ONCOA had addressed satisfactorily a recommended solution to deal with the term of commissioner, Clifford Doxtator, by having him vacate his position in July 2003. Jim also indicated that he was not at liberty to divulge who had contacted him, but he did say the nature of the phone call was more as an inquiry than a complaint. He stated that any individual has the right to contact a government agency and ask questions or ask for clarification. He felt the phone call he received was of this nature.

Sue stated that assumptions had been made regarding the nature of Mary Edna's phone call to both Barb Mamerow and Jim Smittlekofer and it was based on those assumptions that this meeting was convened. She recommended the commissioners take any further discussions of this nature into executive session.

Lois Strong wanted clarification on the information presented that may have led people to believe there was an "end around" taking place, or usurping ONCOA's authority, or a problem continuing to exist with non-compliance. Sue indicated that the draft minutes of November 26, 2002 may identify the misunderstanding. It was a reversal of information. The minutes read: "There has been comments of concern around this issue received by Florence Petri through Barb Mamerow, Director of Bay Area Agency on Aging, however, there has been no official ruling if indeed the threeyear plan will be considered non-compliant if that resignation does not take place now. ONCOA took action to address the noncompliance issue in July 2003, however, there is no indication whether or not that letter has been accepted and the proposal has been approved." Sue explained that what had been presented was neither an

acceptance or rejection of the proposal.

Lois Powless stated this has now become a moot issue and we don't need to delve any further. Motion by Lois Powless to accept Sue's report regarding Barb Mamerow and Jim Smittlekofer's report regarding compliance and funding, 2<sup>nd</sup> by Lois Strong. No discussion. Motion carried.
