STIPULATION AND ORDER FOR ENTRY OF JUDGMENT AND

Stipulation

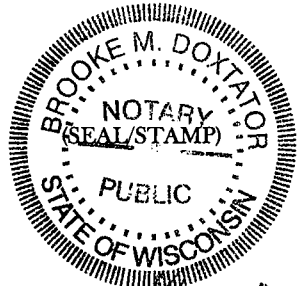
Now comes the Petitioner, Oneida Trust Enrollment Department, and the Respondent, Ann Marie Stevens,

And they do hereby stipulate as follows:

1. Respondent is an enrolled member of the Oneida Tribe of Indians of Wisconsin having an enrollment number of 10822.
2. The Parties acknowledge that on 09/30/2016, the Petitioner deposited to the Respondent's NORTHERN PAPER MILL Bank Account, in error, the sum of \$ 1,000.00.
3. That the Petitioner attempted to contact the Respondent by telephone on 10/31/2016 and mailed written notifications on 11/1/16, 12/1/16, 12/20/16 (returned mail) regarding the overpayment of deposited funds.
4. The Petitioner did a Facebook Page post on the Oneida Trust Enrollment Facebook page to search for Ann M Stevens on 1/12/2017 as there was no current mailing address in record.
5. That the Respondent did call the Petitioner on 1/12/2017 to see why Oneida Trust Enrollment Department wanted to get in contact with her.

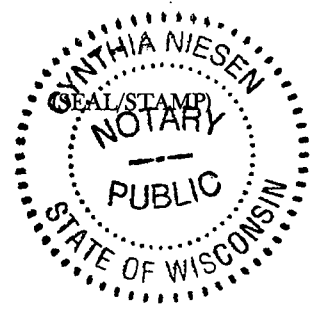
6. The Parties further acknowledge that as a result of the above, the Respondent was overpaid by \$1,000.00.
7. The Respondent agrees that she owes the Petitioner the sum of \$1,000.00, however, she does not have the funds to reimburse the Petitioner.
8. The Parties acknowledge that the Respondent is eligible to receive future per capita payments from the Oneida Nation as said per capita payments are approved and distributed.
9. Therefore, the Respondent agrees to the Court entering a judgment in the sum of \$1,000.00.
10. Petitioner waives the filing fee based upon the Stipulation.
11. Further, the Respondent agrees to an order for attachment of her future per capita payments made by the Oneida Nation until said judgment is paid in full.
