## Petition process questioned after GTC agenda gets cancelled

The General Tribal Council (GTC) took the rare action of deleting the entire agenda during the July 8, 2013 Special GTC meeting.

The agenda featured three petitions surrounding child laws within the Oneida Appeals Commission along with a referendum question asking if tribal members should be allowed to withdraw their custody cases from the Oneida Child Support Program and move them to the County system. The petitions

were submitted to the tribal Secretary's office in February of this year.

The GTC felt the agenda items were already addressed when they took action by adopting the proposed Judiciary Law during the GTC Annual Meeting, Monday, January 7. The Judiciary Law establishes a court system with two branches, the trial court and court of appeals. The new judicial system will start accepting cases November 1, 2014. The amendment to delete the entire agenda was made by Councilman Brandon Stevens.

The move has some asking

for the current GTC petition process to be reviewed.

A GTC meeting can be called by 50 verified voters serving a written notice or by the tribal Chairman.

GTC member Kaylynn Gresham felt petitioners along with the petition process should be examined to make better.

"I just think that we need to start looking for options on how to fix things instead of complaining about what is wrong, I realize that everyone has a story and wants to be heard. Many people are not satisfied with how things are but it's difficult to support something when

there are no options of how to fix a problem. I believe that if people leave their personal issues out of it we would get much more accomplished. Had the petitioners come with some sort of potential solutions I believe more people would have been in support of staying at the meeting and listening to possible solutions," said Gresham.

"Perhaps it is time to consider changing the petition process to require more signatures, although that would require that we amend our constitution, the 50 signature requirement was established when the 75

member to create a quorum was established. As a result of the large number of members that now attend the meetings it may be time to consider an increase of the number or required signatures to call a special meeting. If more signatures are required it demonstrates that there are a larger number of members in the community that support an issue. I believe that if the number was increased it would likely alleviate problems in the future so that what occurred last night does not occur again in the future," she added.

## Paramilitary-style guards 'going to stay,' mining company vows

*Two legislators seek removal of armed security*

Despite harsh criticism from two northern legislators and an outcry from anti-mining activists, a spokesman for Gogebic Taconite said Tuesday that armed, paramilitary-style guards will continue to patrol the site deep in the Penokee Range where the company wants to build a large open pit iron mine.


Bob Seitz, a Madison lobbyist representing Gogebic, said the guards are necessary because of a

confrontation between 15 to 20 protesters and an unknown number of mine workers a month ago.

"The guards are going to stay," Seitz said. "We have a responsibility to provide a safe workplace."

But others say they fear Gogebic Taconite's hiring of the guards only serves to escalate the already heightened tension over the company's plan to build a 4 1/2-mile-long open pit iron mine in northwestern Wisconsin.

And critics of the company say the guards, especially those wearing tactical gear and armed with semi-automatic weapons, are unnecessary because protesters' activities have been almost entirely peaceful.

Since the dustup between protesters and mine workers on June 11, the ongoing protest against the mine — centered largely in an encampment of Chippewa tribal members in the woods not far from the mine site — has been peaceful, according to Iron County Sheriff Tony Furyk.

Furyk said that in the incident, one woman was charged with robbery with the use of force, a felony, after she forcibly took a camera away from a Gogebic employee. Organizers of the Chippewa educational encampment — which is modeled on the harvest camps used by tribal members in the past to fish, gather food and harvest maple syrup — say those protesters acted without their knowledge and added that they have since established strict rules to prevent such individuals from using the camp.

Mel Gasper, a Lac Court Oreilles tribal member who oversees the camp, said he now interviews and screens anyone who wishes to stay at the camp. He said the camp is being used not only to monitor mining company activities but also to educate people about the wild landscape of the Penokees.

Furyk said there have been no problems with the harvest camp or with any protesters since the June confrontation. "I've talked to the permit holders at the camp and they've been very cooperative," he said.

But emotions continue to run high. On the night of July 4, Furyk said,

tribal flags were stolen from the entrance to the harvest camp. And Seitz said anti-mine activists continue to walk from the harvest camp to the mine site.

"They come down in the middle of the night," Seitz said. "It's an ongoing security risk." He added that the company may seek to restrict access to the area in the future.

State Rep. Janet Bewley, D-Ashland, said the company is overreacting.

"There is no reason for them to Rambo up the way they have because things are peaceful," Bewley said. "After a month of peace, why bring in a paramilitary group? We are not lawless up here. We are not Deadwood where there is no law and you need the Pinkertons."

Bewley joined state Sen. Bob Jauch, D-Poplar, in writing a letter this week asking the company to remove the guards, who are from an Arizona private security outfit called Bulletproof.

"The images are horrifying," wrote Bewley and Jauch, "and the action by the company to hire this high security Arizona firm is appalling. These kinds of security forces are common in Third World countries but they don't belong in Northern Wisconsin."

"We cannot begin to describe how upset the citizens of Northern Wisconsin are at the sight of our forests being patrolled by masked soldiers carrying military style assault weapons like mercenaries in a time of war. While no one can argue that your company does not have the right to protect your private property, these armed guards serve no purpose other than to intimidate local citizens and increase local tensions."

The guards were first photographed by Rob Ganson, a mine opponent who regularly visits the harvest camp and takes frequent walks to the mine site to monitor

activity. He was shocked to see the armed guards in tactical gear with face masks. Ganson, who is not a tribal member, said he has been spending time at the harvest camp to learn more about the tribal view on the mine and has in the past brought his wife along. Now, with the presence of powerful weapons in the woods, he is reluctant to bring her along anymore.

"It has definitely ramped up the tension," Ganson said. "The last thing we need is a Kent State up here in the hills."

George Meyer, executive director of the Wisconsin Wildlife Federation, has been heavily involved in mining issues for years. He worked as a lawyer for and served as secretary of the state Department of Natural Resources during the controversial and eventually failed efforts of Exxon Minerals to build a mine near Crandon. That project died largely due to tribal opposition.

Meyer, who has recently given presentations in Iron County on the need for local mining impact regulations and zoning, said the company's heavy-handed approach, including not only hiring the paramilitary guards but also resisting local zoning laws, could be causing some — including previous supporters — to question the entire mining project.

"This is the kind of thing that backfires," Meyer said of the guards. "They're (Gogebic Taconite) losing the goodwill of the public."

## Oneida of the Thames Hospitality, an Experience to Remember

Last week four Business Committee members, three Land Claims Commissioners (including myself) and the Land Claims Coordinator traveled to the Oneida of the Thames Community. Their hospitality was something to experience and be remembered. One young man invited us to his house for corn soup and strawberry drink. He also showed us a "standing stone" in his back field which had five distinct stripes on it—representing the Five Nations. Then, he showed us the following message that he had written. I asked his permission to print it in our paper. Anthony Ireland is a member of the Elected Band Council for the Oneidas of the Thames.

"When I deal with everyday life in my community I think about the different ways we corrupt our Nation and about the outside communities. I

think of how the non-native people treat us, roll their eyes when we use our status cards, and how I sense that they feel we are trespassing on their land. Yes, it does get me down. Sometimes I wish that I were not part of this nation. However, that feeling changed when I went on the "Walk for the Moving of the Fire" for the Longhouse, which I almost didn't go because of the rain and long walk especially for someone who doesn't walk everyday. That morning I thought of my mother, who was doing a lot of cooking for the ceremony, and when she asked me to take some food over to the new Longhouse, I did. When I arrived there I saw all the cars and looked at all the license plates and noticed that people drove from all over Turtle Island. When I saw the bus transporting people to the old Longhouse I decided to go and when I arrived I noticed people I knew and people I didn't know. When everyone started to

# Behind the Naming of Structures in Our Community

## Embracing the Life Achievements of those Honored

### Norbert S. Hill


**W**ho was Norbert S. Hill? He was the son of Charles and Dr. Rosa Minoka Hill born January 18, 1912. He was also a boxer and an engineer of political initiatives. Most memorably, Norbert S. Hill was a Tribal leader who championed a cause to recover tribal lands which rightfully belonged to the Oneida Nation.

Elected as Chairman of the Oneida Tribe in 1966, Norbert served one year then subsequently served as Vice Chairman for 6 years following his Chairman's term. He served the Oneida Nation with honesty and integrity until he passed away in 1975.

Norbert was married to Eileen Johnston Hill and together they raised a family of six children. Norb and Eileen had two daughters, Barbara Hill Author and Rosa Hill Coenen and four sons, Norbert Jr, Charlie, Rick and Jimmy. Rick followed passionately into the footsteps of his father and served as Vice Chairman and Tribal Chairman for many years.

Most of the adult years spent on the Oneida Reservation by Norbert were as a politician in a very young Indian Reorganization Act Tribe. The Oneida Nation morphed from a very traditional form of government into a system that was forced upon the Tribes in the 1930's. It was the BIA way or the highway.

As with every initiative in Oneida, no one is solely responsible, our people are most remembered for their accomplishments in different ways. Norb was engaged in many passionate fights while serving on the Oneida Business



Committee. Preserving and protecting tribal sovereignty was a goal the entire Business Committee shared. While the Oneida Business Committee was at odds over many issues, they always stood united in protecting land and treaty rights.

One issue Norb was well respected and remembered for was the fight to regain title to the lands where the Norbert Hill Center is now located. Previous to being the NHC, it was the Sacred Heart Seminary. The Seminary was located on land where the Catholic Diocese built a large school, church and well protected wild life refuge. Somehow these lands were lost to the tribe and illegally acquired by the Catholic Diocese. Long story short... Oneida Business Committee, attorneys and Tribal members fought the battle to regain title to the land. It was a good fight, very civil and in the end, the Catholic Diocese agreed, the land belonged to Oneida. They asked only that Oneida pay for the improvements they made to the property, which in essence was the buildings constructed.

As a charter member of the Great Lakes Inter-Tribal Council, Norbert was a strong advocate for the power of unity amongst sovereigns. He worked to unite the eleven Tribes in the state of Wisconsin under one umbrella, he believed the strength in their numbers would greatly benefit all Wisconsin Tribes. This organization is over 40 years old. Throughout the Great Lakes Inter-Tribal Council, he was instrumental in securing our first grant for the Oneida Headstart program, still thriving today.

Passionate about land claims, treaty



rights, sovereignty and land acquisition, Norbert was a man who could provide a brief history lesson on any of the aforementioned subjects at the drop of a hat. That means if you asked, he could go into detail about the history of the Oneida Tribe and talk at great length.

Like most of our early Oneida politicians, Norbert was dedicated to advancing the quality of life on our reservation, most of the time without any compensation. He was driven by a vision he inherited from his parents and grandparents. Back in those days visions were inherent, they were not results of tedious sessions of discussion for days, weeks and months. Those who knew Norb will remember how he crept through the halls of the Norbert Hill Center when it was the Sacred Heart Seminary and stopped to visit in offices daily.

Face to face communication was the rule for Norb. He stepped gingerly like a boxer in a bout, but was usually dressed in dress slacks, clean well ironed shirt, bolo tie, suit jacket and tennis shoes. Norb was a leader that showed up everywhere on the reservation, attended every event he could, especially if it was pot luck. He was always engaged in some activity to advance education, recreation, athletics and employment, and of course, economic development.

The Oneida Economic Development Corporation was another project Norb championed. Establishing the first Oneida Industrial Park was an initiative he strongly advocated for. Today there is a Walmart, Sam's Club and other thriving businesses located in the

Oneida Industrial Park. A dream come true.

These are just a few of the recollections about Norbert S. Hill Sr. that should provide some insight as to why there is a facility named in his honor.

#### Seven Generation Visionaries

*This is a series I am composing to profile our past leadership for their contributions to the Oneida Nation and their efforts that will impact our lives for the next seven generations and perhaps beyond. These are recollections that I have about the people I have known throughout my life, my earliest recollection is Oscar Archiquette who was my first teacher of the Oneida Language. Others include, Irene Moore, Lee McLester II, David "Sonny" King, Norbert Hill and others.*

*The first in my series is Anna John, an elder whom I respected and admired for many years. Her grandson Allen, entered a comment on facebook about the new Anna John Nursing Home and felt there was very little attributed to the namesake of that beautiful state of the art facility. That inspired me to begin to write short recollections about all the Oneida people who have places named in their honor. We need to keep their memory alive, but more importantly, Oneida people need to know the spirit that lived in each of these leaders which inspired them to create a better quality of life on our reservation.*

# American Care Act and Native Americans

## Insurance exchange plans to begin enrolling October 1

Administrators at the Oneida Comprehensive Health Division (OCHD) have important information concerning the Affordable Care Act (ACA) to share with the community.

The Affordable Care Act (ACA) permanently reauthorized the Indian Health Care Improvement Act, and provides new opportunities for health insurance coverage.

The ACA will start the open enrollment in the Health Insurance Marketplace or the Federal Marketplace on October 1 of this year. Most Americans will be required to get health

insurance or pay a tax penalty, but there is an exception for Native Americans due to federal treaty and trust obligations.

According to Danforth, Operations Director and Dr. Ravinder Vir, Medical Director, Oneida's current employee health insurance carrier, UMR is the leading insurer for patients of the OCHC followed by medical assistance. OCHC staff members want to help Oneida citizens to begin enrolling in health insurance plans this fall however the path to take is not clear at the moment.

"When Wisconsin had the option of becoming either a state exchange or a federal exchange, Governor Walker made the decision to not accept the Federal funding for the development of a State Exchange and determined that the State would move ahead with

the federal exchange," said Danforth. The federal exchanges are still in the works.

"We're providing information as we receive it. It's still basic information. For Wisconsin, we are moving forward as a Federal Marketplace. Once that detailed information becomes available, we will help people understand what they need to do," said Danforth.

Wisconsin is not the only State that has chosen to go with the Federal Marketplace. There are a total of approximately 16 states overall that will be implementing Federal Marketplaces vs. Individual State Exchanges.

According to HealthCare.gov, the Federal Marketplace will offer health insurance plans that meet the needs of your family and your budget. If you are a

member of a federally recognized Tribe, or are Alaska Native or you currently receive your health care through an IHS or Tribal facility (this is defined as minimum essential coverage) you will receive benefits and protections through the Marketplace which include Cost-sharing reductions on deductibles, co-payments and coinsurance. There will be special enrollment periods for Native Americans and or Alaska Natives allowing you to get health insurance or change insurance in any month not just the yearly open enrollment period.

There will be insurance exchange plans that will be based on income such as Medicaid or the Children's Health Insurance Program (CHIP). If you already have health insurance through your employer, you will not have to enroll in an additional plan. Oneidas or any American Indian/ Alaska Native who enroll in health insurance exchange plans do not have cost sharing.

Cost sharing is the term used for both the deductible and co-pay. A deductible is the amount most consumers pay each year before the insurance

company pays for health services. A co-pay is the amount most consumers pay at each visit. For Oneidas or any American Indian/ Alaska Native with health insurance, there is never any cost sharing when you receive your services from a Tribal or IHS clinic.

"There will be significant changes, and the challenge really is ... those changes are going to impact us in less than six months, probably less than three months when they start enrolling in the exchanges and we don't have the specifics of what that change is going to be," said Dr. Vir.

## 2012/2013 Contract Health Services

### Bill Submission Deadlines

If you're requesting Contract Health Services to assist in payment of your health related bills you must submit all bills to the Contract Health Service Department. It's best to submit your bills as soon as you receive them to prevent them from being turned over to a collection agency. The Contract Health Service fiscal year ends September 30th of each year.

Below is the bill submission deadline dates:

**Date of Service 4/1/13 – 6/30/13** Submission deadline: 9/30/13

**Date of Service 7/1/13 – 10/31/13**, Submission deadline: 1/31/14

**Date of Service 11/1/13 – 12/31/13**, Submission deadline: 3/31/14

Please be sure that your insurance has been billed and made a payment determination on all your claims. If your insurance requires additional information you must respond within the specified timeframes. Once your bills are received CHS will determine your CHS eligibility and pay or notify you if your claims are not eligible for payment.

We advise you to turn the bills in personally so we can give you a receipt for them. In this manner, we and you have a good record of what you submitted and when you submitted them. This will avoid confusion when a bill is not paid for whatever reason. Your Contract Health Services Department tracks your bills submitted for payment in case an outside healthcare provider disputes receiving payment of a bill that you may owe.

## WHEN YOU ARE OUT OF TOWN AND NEED MEDICAL ATTENTION

### During regular business hours

Please call the Oneida Community Health Center at (920) 869-2711 to speak with the triage nurse. The nurse will assess your symptoms and recommend care. If you need further evaluation and treatment, the nurse will direct you to the appropriate healthcare facility. Depending on the urgency of your symptoms, your healthcare insurance, and your current location, you may be sent to an urgent care clinic or emergency room (ER). Please present your healthcare insurance card and a list of your current medications. You are responsible to pay for any prescriptions you need. However, you may turn in your receipt into Contract Health Services (CHS) for reimbursement. Any bills received from the healthcare facility can be submitted to CHS for payment. Your telephone call and recommended care by the nurse will be documented.

### After regular business hours

Please call Oneida Community Health Center at (920) 869-2711. If you are certain that this is a life threatening emergency or injury and you need to go to the ER, please leave a message with the after-hours CHS notification line. The message should include the patient's name, birthdate, phone number and reason for ER visit, name of ER and healthcare insurance information. If you need to discuss your symptoms with the nurse, stay on the line for the Answering Service. Those representatives will gather your contact information and have a nurse call you back. Depending on the urgency of your symptoms, your healthcare insurance, and your current location, you may be sent to either an urgent care clinic or emergency room. Please present your healthcare card and list of current medications. You are responsible to pay for any prescriptions you need. However, you may turn in your receipt into Contract Health Services for reimbursement. Any bills received from the healthcare facility can be submitted to Contract Health Services for payment.

## UW-Green Bay admits first Master of Science in Nursing students

GREEN BAY – The University of Wisconsin-Green Bay Professional Program in Nursing has announced that 19 registered nurses (RNs) have been accepted to the first cohort in the new online Master of Science in Nursing (MSN) Leadership and Management in Health Systems program. Living in 16 cities and six states across the country, with undergraduate degrees from four universities (most are UW-Green Bay alumni), the new admits will begin online MSN courses in Fall of 2013.

The average age of those admitted is 42 years old, and the average grade point average is 3.6 (on a 4.0 scale). The newly admitted RNs aspire to management and leadership roles and practice in diverse areas ranging from the intensive care unit to home care and public health, long-term care, surgery, cardiac care, mental health, emergency services, oncology and correctional nursing. Many already hold managerial or leadership roles such as directors, team leaders, quality measures, vice presidents of business — and even a hospital chief nursing officer.

The UW-Green Bay faculty and staff consulted with nurse managers and leaders across the nation in developing the curriculum for the MSN program. The curriculum covers 34 credits in 12 online courses delivered over two years (six consecutive academic periods). Students will participate in practicum placements during the second year at sites close to their homes.

# Oneida reaching for the clouds

The Oneida organization is moving to the cloud.

According to Application Services Manager James Wildenberg Oneida is updating its software to Office 365 which will allow employees to work on their documents almost anywhere on almost any device.

"(We're) Making more of those services available to you outside of these four walls so you can conduct business not only with your customers but with your employees and your colleagues and your business partners," he said.

This feature will be made possible by utilizing Microsoft "cloud" servers which saves data at a remote location.

"Being able to access certain information, whether it's your documents, your contacts, your calendar, those types of things, from not having to be in the building and connected via wires," said Wildenberg. "It makes for a more connected world."

More features are being added such as instant messaging, web conferencing, and document sharing as well as adding Wi-Fi to all tribal buildings.

"We're spread out over 60 buildings, and we don't always have to hop in the car to conduct business ... We're able to pull up video conference meetings, voice conference meetings, simple chats and those types of things, sharing documents and working collaboratively at the same time," he said.

Wildenberg anticipates that Oneida will be able to reduce the costs of employees traveling within the area for meetings. Also, utilizing the Microsoft servers allows for savings in infrastructure costs.

"We manage a couple

100 servers now, and if you expand that by say another dozen or so, you have more costs and resources to manage those things," he said.

One more savings will be the move to a subscription service instead of buying licenses for software for three year terms.

"By moving to Office 365 we're changing that whole model and moving into a subscription mode which is more pay as you go," said Wildenberg. He explained that the subscription model is more flexible especially when dealing with personnel changes or changing needs in software.

Currently, the tribe's Management of Information Services (MIS) Department is beginning its training phase for employees, and will fully implement the change before October.

"It's exciting from a technology standpoint for the organization that we're joining the ranks of a lot of other tribal governments, city governments, even state governments that have already moved to Office 365," said Wildenberg.

The City of Chicago, State of Minnesota and the Seminole Tribe are some of the organizations that have switched to Office 365.

The Oneida Mail Center is located at 2701 W. Mason Street and we are an internal service for the Oneida Tribe of Indians of Wisconsin. We currently operate with a total of four employees which includes three Mail Clerks and one Supervisor. The Oneida Mail Center has numerous responsibilities with our main focus being the processing all inter-tribal mail.

One of our most important responsibilities is processing all GTC mailings without delay. A GTC mailing can consist of as little as one hundred mail pieces per mailing up to fourteen thousand mail pieces per mailing.

The Oneida Mail Center assists the General Tribal Council in making sure the mailings

## The Iroquois Clan System and Blood Quantum

adopts a more Euro-American style of government.

Oneidas in Wisconsin voted to adopt an IRA government. From that time going forward, we began tracking the Oneida blood quantum.

Blood quantum is a way of identifying someone's lineage and measuring the portion of it that is Oneida. Under the IRA, we began "enrolling" ourselves as "members" of a tribe. Knowledge of the clan system and traditional understandings of identity were often set aside or forgotten.

It is ironic that the federal government intentionally encouraged Oneida and other Native nations to identify themselves through blood quantum considering nowhere in the United States Constitution does it encourage or even consider tracking blood quantum for American citizens. The concept was

borrowed from the past. European royal families struggled for centuries over the custom of intermarriage and designed systems to document bloodlines to prevent infighting and corruption.

Oneida, as a community and over time, adopted policies and ways of thinking that emphasize blood quantum. Today, enrollment is necessary to receive most of the tribe's benefits, and enrollment is contingent upon having at least 1/4 Oneida blood quantum.

This is a concept that would be foreign to our ancestors. Our ancestors identified fellow Oneidas by clan identity, by family connection, by a common language and by shared values, beliefs, and more.

The Oneida Nation cannot be sustained tracking lineage by blood quantum; it is a system destined to fail. In a few decades, the population

of the Oneida Nation will be only a fraction of what it is now. This crisis cannot be avoided unless we redefine ourselves according to our own terms; not those of the federal government. Whether we look to our past for a more traditional definition of identity, or look forward to something different, we cannot stay as we are. How do you identify yourself?

are processed in the most efficient and cost effective mailing method possible. This process is based on many variables including the weight of the mail piece, the due date, the quantity, the piece size, and the type of mail piece. With following the United States Postal Service (USPS) regulations a decision is made on how the GTC mailing will be sent out to the Oneida enrolled tribal members.

At times, the GTC mailings are sent out via United Parcel Service (UPS) for cost savings purposes; generally the USPS is the best option for the GTC mailings.

The Oneida Mail Center, on average, processes 350 mailings per year for all tribal departments, 20 of which are GTC mailings.

The form following this notice must be completed and returned to the Oneida Child Support Agency within ten (10) business days if you want federal income tax withheld before your per capita payment is attached. Once returned, the federal tax withholding will remain in effect until the Agency receives written notification stating otherwise. A member can also change one's voluntary tax withholding status at any time by submitting a written request to the Agency.

### Food for Thought

In the June 13, 2013 Kalihwisaks articles from the Treasurer, Cristina Danforth and Vince DelaRosa, Chairman of Community Development Planning Committee, it appears that both want to blame the Oneida Housing Authority for the lack of housing progress. Linda Dallas complains about rumors that attack her character, credibility and image by false statements that are very vicious and malicious rumors about her in the community. I find it ironic that these are the same people along with Ed Delgado who have spread false claims about me during OBC meetings and in the paper. Ed Delgado placed a restraining order against me in Brown County Court on September 14, 2012. Brown County Court has since dismissed that restraining order. I wish to thank the Vets and Elders who showed up to support my day in court.

### Facts about OHA under Dale Wheelock leadership

- OHA had an average of 22 new housing units each year for the past three years through new construction, and acquisition/rehabilitation.
- \$3.7 million was made available to OHA from HUD each year since 2009 in the Indian Housing Block Grant (IHGB).
- Dale Wheelock's leadership brought in over \$5 million in additional competitive grants since 2009. These grants included the \$3 million dollar ARRA grant, \$1.8 million in Indian Community Development Block Grants (infrastructure) and the \$243,000 ROSS Grant.

### Facts about OHA under OBC leadership

- The FY 2013 Indian Housing Block Grant was reduced by \$195,000. Check with OHA for verification of grant amount.
- The 2013 ROSS grant of \$243,000 was lost by Ed Delgado because he

failed to notify OHA of the two deficiencies in the grant application. I believe an internal audit is needed to determine accountability for that loss of housing funding.

- In September 2011 Dale Wheelock was notified by his supervisor Ed Delgado to stop the development of 22 units on County FF and 16 apartment units on West Mason St. This can be verified by Oneida Land Committee minutes which approved holding the land at these sites for OHA development.
- In December 2011 the Oneida Business Committee took action to stop OHA from the purchase of homes/land on the reservation. This can be verified in the OBC minutes of January, 2012.
- In March 2012, Vince DelaRosa proposed a joint venture with HomeWay Homes out of Peoria, Illinois. Read the April 5, 2012, page 2A article in the Kalihwisaks for verification of OBC debate on the housing proposal. Vince DelaRosa has been the OBC liaison to OHA for the past two years. He has traveled to Chicago and Milwaukee to meet with the new housing Czar, Fred Busch. Fred Busch reports to Vince and has not produced a single new housing unit this past year.

The OBC has accomplished going over budget in their travel and delayed housing progress. Housing development contracts were delayed for months by OBC involvement in day to day housing operations. No reorganization plan and no balanced budget as promised by the OBC.

### Shock and Gall

At the July semi-annual GTC meeting many were surprised to find the Treasurer's report did not mention the 7 Gens corporate report. A crime was committed by omission. Our Oneida Constitution requires it.

Article 1 section 4. Treasurer of the Tribal Council shall accept, receive, receipt for, preserve and safeguard all funds in the custody of the Council, whether they are tribal funds or special funds for which the Council is netting as trustee or custodian. He shall deposit all funds in such depository as the Council shall direct ad shall make and preserve a faithful record of such funds and shall report on all receipts and expenditures and the amount and nature of all funds in his possession and custody, at each regular meeting of the General Tribal Council, and at such other times as requested by the Council or the business committee."

Have any of you received the required report? Is the Treasurer violating the Oneida Constitution? You decide.

To hide behind a corporate board is wrong. The BC created the corporation. The corporate charter Article XIII reports section 3(b) states: disclosure report content: The disclosure report shall include, but not be limited to, the following detailed information: (a) Names and titles of all the Corporation's Board members' names, time in the position, ad date when position shall be up for renewal or replacement (if applicable). (b) Names and title if all of the Corporation's key management personnel, with length of service in that position, and if under contract, when that position is up for renewal or expiration of the contract term. (c) Summary of any financial or familial relationship between any of the people in part a. or part b. in this Section, as well as any relationship financial or familial with any current member of the Oneida Business Committee or any member of any regulating the Corporation's industry or activities. (d) Names of any other person whether it is a business in any legal form or an individual, doing business with the Corporation for purposes or mutual enterprise (i.e. including but not limited to: joint ventures; membership in an LLC together; acquisition as a subsidiary, partnership). (e) Summary of the financial transactions or relationship between those listed in d. above in this Section and Corporation, including the purpose of mutual enterprise, legal relationship, or other connection between the Corporation, its Board or its key management personnel and this other named entity or person.

I am outraged when I see our money being wasted. On May 5, 2013 the GTC voted against 7Gens. The BC had given them \$750,000. This abuse and inefficiency must stop.

You must pitch in and help the people trying to protect the tribe for your children and your grandchildren.

### Does It Matter Where You Were Born or Raised?

#### Should it?

Once again, Oneidas are under attack—but only certain Oneidas. The attack is not from an outside source either. Now our own people are attacking Milwaukee with petitions. Some individuals born and raised in Oneida believe that Oneidas in Milwaukee should not be entitled to, or receive the same things as those who are born, raised, and living on the reservation.

More disturbing is the fact that the individuals who submitted the petitions to possibly get rid of the SEOTS facility and the Milwaukee polling site work for the tribe. One heads up the Oneida Trust Committee as an elected position and the other is an employee working at the Turtle School. Isn't that a "conflict of interest"? I thought those individuals were supposed to be working on behalf of all Oneidas and not just a select few. Is this the same individual who headed up our Children's Trust accounts a few years back? Does anyone remember that? When your child turned 18 and was supposed to get their entire per cap distribution, did they get it all, or was there some missing because of bad investments? Remember, these are the same individuals who now want you to believe what they are saying—that by taking away having a permanent facility or removing the polling site is a positive thing because of its cost or some other lame excuse. A few in Oneida still feel Milwaukee should not get a new facility or have a new polling site even after 20 years.

I know—let's have all the Milwaukee elders drive up to vote, even if the weather is bad or they have medical issues. Or, better yet, let's have Milwaukee people take a day off of work and not get paid to drive up and participate in an election that is supposed to benefit everyone. Does that make sense?

The percentage of Oneidas who now reside off-reservation represents about 70% of the tribe. By taking away the Milwaukee polling site, is it simply voter disenfranchisement? Do certain Business Committee members support this idea, and, if so, which ones? Shouldn't Oneida be making it easier for individuals to vote and participate in elections?

Who stands to benefit from not having a permanent facility or polling site? Is someone trying to fix or rig next year's tri-annual election, again?

Will someone take the ballot box home in the trunk of his/her car, again? Will the wrong address of the polling site be used, again?

Some Oneidas who reside in Milwaukee now feel like we are nothing more than a whipping post for all of Oneida—being treated unfairly, differently, or cast aside like garbage. Based upon ideologies like the submitted petitions, we can now see the systematic erosion of our constitutional rights and liberties and "our ways". Only this time, it is not by the outside source but, some of our own people who believe we are "not all equal".

### Seven Generations Corporation is Not Your Friend

They pay themselves \$200 or more each time they meet (pg. 1 of the corporate report).

Last year alone they spent \$16,437 for their meetings (pg. 7). Check who is on their Board, who is getting all the money while the GTC cuts back on our per capita. Paying for projects even before they are approved and buying items has put them in the hole for 2012. Now in 2013, according to BC members, \$750,000 was set aside to fight a losing battle with Green Bay. Why? The BC also gave 7 Gens a Tribal grant for \$334,000 for a feasibility study (pg. 22). Why?

How many LLC's does 7 Gens have and who is each director, CEO, manager, what is the salary, how much did each receive, and how much did each spend? Who are the shareholders, who are the outside investors, how much did each receive for meetings?

BDO's Independent Auditors' Report says: "Management has omitted the Management, Discussion and Analysis that accounting principles generally accepted in the United States of America requires to be presented to supplement the basic financial statements" (pg. 4). It further states: Such missing information, although not a part of the basic financial statements, is required by the Government Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context" (pg. 4).

Because many years of insubordination, 7 Gens should be abolished in accordance with their By-Laws and their Charter (Article XV. Dissolution).

Why do we spend all that money for audits when 7 Gens does not provide all the information for a complete audit in accordance with their Charter (Article XIV. Audits)? Concerning 7 Gens "internal control over finance reporting" BDO said, "we express no such opinion" (pg. 3) and the Business Committee let them get away with it.

Let's not forget the 7 Gens calamities to the tune of \$4 million with not only Nature's Way, but that 7 Gens failure to collect on the large sum of back rent with Nature's Way also including others.

The BC reports this type of activity to the GTC, right? Should we, or do we have to have an outside audit, or should we just abolish the 13-year drain on the tribe? If 7G's ask the BC and/or Trust committee for money and getting it, it appears with very little accountability.

If it's true that 7 Gens refuses to provide detailed reports requested by the BC, and requests by the GTC, and do not comply with the auditor's recommendations, I believe that our attorneys ignore the constitution and provide wrong advice to the GTC.

All tribal members are entitled to this information. We need to bring this issue to the forefront of the GTC agenda before it's too late.

According to our constitution, the Treasurer: shall report on ALL receipts and expenditures and the amount and nature of ALL funds in his/her custody, at each regular meeting of the General Tribal Council, and at such other times as requested by the council of the Business Committee.

If we don't work together, if you don't protect our money, it may just be a matter of time before the tribe is hit by a devastating financial crisis. The tribal members giving out this information, handing out petitions, and questioning the activity by 7 Gens, are a group who have proven themselves to be politically engaged, well informed and have the ability to recognize the seriousness of these issues by being attentive.

The BC does not seem to be able to see it or the ability to grasp it that way. That is why we need to support the effort of all the GTC members to bring the 7 Gens' shady operation to the forefront of the tribal agenda.

The irresponsible action by those who left our tribe vulnerable to those willing to enrich themselves with our money and leaves the BC to appear fearful of taking action, only shows a reluctant BC in need of being forced to protect the tribe, unless the GTC forces them to chain their thinking of our children, grandchildren, our future, not just their families and friends.





Candice Skenandore, an enrolled citizen of the Oneida Tribe of Indians of Wisconsin, was recently selected to be a part of a cohort of 18 emerging Indigenous leaders from around the world to participate in a one of a kind leadership development initiative, the Ambassadors Program. Americans for Indian Opportunity (AIO) spearheads the program in the belief that today's Indigenous communities and tribal governments require strong leadership to ensure their

cultural, political, and economic growth and well-being. The Program is unlike any other leadership initiative in the country insofar that it draws upon traditional Indigenous values to empower a new generation of Indigenous leaders.

Candice Skenandore works as a legislative analyst in the Oneida Legislative Reference Office. She holds a B.A. in Political Science with a minor in International Studies from the University of Wisconsin-

Whitewater and an Associate's Degree and Post-Baccalaureate Certificate in Paralegal from Northeast Wisconsin Technical College. In pursuit of her B.A., Candice interned with the Oneida Legislative Affairs Office where she worked to build and sustain good-working relationships with local, state and tribal governments. She went on to intern for the PACE, LLP Government Relations firm in Arlington, VA where she assisted in federal lobby-

ing efforts pertaining to Native American issues. She has volunteered with the Girl Scouts of Northwestern Great Lakes and the Green Bay Packers' program First Down for Trees and actively volunteers for the House of Hope.

"Our applicant pool was especially competitive this year, especially with first ever cohort that includes international participants," said Laura Harris, Executive Director of AIO. "The 18 individuals chosen already exhibit exceptional leadership skills, so AIO's program aims to further strengthen their talents by reaffirming their cultural values, cultivating their community organizing skills, and building a network of people and resources they can utilize throughout their careers."

During the two-year Program, Skenandore will meet with leading Native decision-makers, national policymakers and international dignitaries. She will develop and implement a community-based initiative, explore family and tribal histories, expand her knowledge of personal medicine, and gain a more global perspective. "In today's globalized world, the challenges we face are complex and carry dangerous ramifications if we don't develop Indigenous leaders with the skills to build politically sustainable communities," said LaDonna Harris, President of AIO, who helped create the Ambassadors Program in 1993 to nurture culturally grounded Indigenous leaders and strengthen their self-determination capabilities. The Program is designed around four core cultural values: Relationships, Responsibility, Reciprocity and Redistribution.

## News Around Wisconsin

### Judge blocks new Wisconsin abortion law

MADISON, Wis. (AP) ~ A federal judge issued a temporary restraining order Monday evening to block enforcement of a new Wisconsin law that bans doctors who lack admitting privileges at nearby hospitals from performing abortions.

U.S. District Judge William Conley granted the order following a hearing in a lawsuit filed Friday by Planned Parenthood of Wisconsin and Affiliated Medical Services. It alleged the requirement would unconstitutionally restrict the availability of abortions in the state, violates the U.S. Constitution's due process guarantee and unconstitutionally treats doctors who perform abortions differently from those who perform other procedures.

The restraining order will remain in place pending a trial. "Moreover, the record to date strongly supports a finding that no medical purpose is served by this requirement," he said.

The bill was introduced in the Legislature on June 4, passed nine days later and signed into law Friday by Gov. Scott Walker. It took effect Monday. The law also requires women to obtain an ultrasound before getting an abortion, but that provision is not being challenged.

"This ruling is a step in the right direction for the women of Wisconsin who can now continue to make their own personal, private health care decisions," Terry Huyck, president and CEO of Planned Parenthood of Wisconsin, said in a statement. "We are confident that the Court will ultimately recognize if ACT 37 is not blocked, it would unconstitutionally restrict the ability of Wisconsin women, including victims of rape and incest and women who are in need of an abortion to preserve their health, to access safe and legal abortions."

Attorneys told Conley that if the law wasn't put on hold, dozens of women with abortions scheduled in the coming week would have had to cancel their appointments. Those appointments are at a Planned Parenthood clinic in Appleton and the Affiliated Medical Services clinic in Milwaukee, where doctors performing abortions do not have admitting privileges to hospitals within 30 miles as the new law requires, attorneys said.

### Wis. could be only state to have 1-term justices

MADISON, Wis. (AP) ~ Wisconsin could become the only state to limit its Supreme Court justices to a single term if a proposal put forward by a task force of attorneys becomes law.

The task force has recommended amending the state constitution to limit justices to a single 16-year term, in part as a way of stemming the flow of money into judicial elections. The amendment would have to be approved by the state Legislature and voters.

Sixteen years is about the average length Wisconsin justices have served in recent years.

No state currently limits justices to a single term, according to the American Judicature Society, which advocates for judicial ethics and merit-based appointments of justices.

"It would go some way to curing the perception that judges were looking for handouts," K.O. Myers, research and program director for the group, told the Wisconsin State Journal. "If they aren't up for election again, it removes the perception that they are ruling to get someone to donate in the future."

Sixteen years is longer than the set terms in other states, but Rhode Island appoints justices for life and Massachusetts and New Hampshire have appointments until mandatory retirement at age 70.

Joe Troy, a former circuit court judge who chaired the task force, said there has been no political support in Wisconsin for appointing, rather than electing, justices. However, he said political leaders from both parties have said they would consider term limits.

# GTC zips through agenda at semi-annual meeting

The General Tribal Council (GTC) rejected two referendum questions and a petition at the Monday, July 1 Semi-Annual GTC Meeting held at the Radisson Hotel and Conference Center. 1932 Oneida citizens attended the meeting.

A referendum question and petition were both about term limits for boards, committees and commissions and were presented together. The first referendum question from the 2012 election read "Should there be term limits for all board, committee and commission positions including the Business Committee?"

The question was disregarded by GTC and accepted as For Your Information (FYI) because adding limits to the Oneida Business Committee (OBC) candidates would take an amendment to the Oneida Constitution.

The petition, presented by Linda Dallas, read "Direct that all elected and appointed positions for all Oneida Boards, Committees and Commissions, excluding the Oneida Business Committee, shall be for a four (4) year term, with a term limit of two terms (totaling eight years), a two (2) year waiting period before running for the same board, committee or commission, and shall be effective for the elections of 2013 and all future elections." The motion was later amended to the 2014 elections and excluded the Oneida Nation Commission on Aging (ONCOA) and the Oneida Nation Arts Board as both programs receive state funds.

"People are in those

positions for a very, very long time, and elected and appointed position are not intended to be careers," said

Dallas in her presentation.

However, GTC member Elijah Hill stated he disagreed with the petition during discussion.

"People have the right to vote for whoever they want in a position," said Hill. "If you're in a position already, you've gained all that experience and then to me it seems it's almost got to work backwards to put someone new in."

The motion to accept the term limits would have needed a two thirds majority to pass, but OBC Chairman Ed Delgado stated it was clear during the hand vote that the petition didn't have enough support, and the motion failed.

The second referendum read "Should school board members have educational backgrounds?" Councilman Brandon Stevens told the GTC members that they would have to define "educational background." Stevens also noted that other area school boards had no such requirement, and it is currently difficult to attract people who want to serve on the school board. Currently the only requirements are that the nine member board all be Oneida citizens and that at least seven members are parents or guardians of a student in the Oneida Nation School System.

GTC member Linda Powless argued against the referendum during discussion.

"The whole point of parental involvement was to get control of our education so that we could support the cultural knowledge that we hold within our communities," said Powless.

The GTC denied the referendum.

Earlier in the meeting, the GTC approved

minutes for the July 2, 2012 semi-annual, the September 17, 2012 FY2013 Budget, and

the November 19, 2012 special meetings.

Treasurer Tina Danforth gave her semi-annual report. She explained that the tribe was working on paying down debt and had created set asides to do so.

The GTC accepted the Treasurer's Report, however, the body tabled a request to accept the 2013 Semi-Annual Report when some members of the GTC complained that they hadn't received the packet and didn't know what they were approving.

Secretary Patty Hoeft explained that Oneida citizens needed to return their postcard to receive the annual and semi-annual reports in the mail, and that the material was available online at the members' only website (<http://oneidasn.gov/MembersOnly.aspx>).

GTC member Diane McLester-Helheim admonished the other attendees to be prepared for meetings.

"Take responsibility and seek out the information?" she said.

Councilman David Jordan gave a report on plans to implement a new parent communications and grievance process for the Oneida Childcare Department. He stated that the policy was moving forward and they are creating a parent-teacher association. The report was accepted by the GTC.

Councilwoman Melinda Danforth gave status report on conducting a US Department of Interior Secretary election to vote on changes to the Tribe's constitution.

"We think we're close, but we've been close for a long time," said Councilwoman Danforth.

She pointed out that voting might be limited to people who live on the reservation, and that she was working to fight that limitation.

The five proposed changes to the constitution would be to change Oneida's official name from "Oneida Tribe of Indians of Wisconsin to "Oneida Nation,

lower the voting age from 21 to 18, remove language referring to the Department of the Interior (DOI) Secretary of Interior, include a judiciary, and remove the first Monday of January and July requirement for the Annual and Semi-Annual GTC meetings. The report was accepted by the GTC.

Councilwoman Danforth also gave an update on the Judiciary Act, stating that elections would be held in the July, 2014 election and the court would be in place in November 14 of 2014.

"We are on schedule," she said.

The GTC accepted the update and passed a GTC resolution that would allow language in existing laws to be changed from referring to the Oneida Appeals Commission or the Oneida Tribal Judicial System and replace with terms consistent with the Judiciary Law. The resolution passed with the required two-third majority.

## Dad in Indian child case seeks Oklahoma adoption

CHARLESTON, S.C. (AP) ~ The biological father of an American Indian child who is the center of a custody suit that went to the U.S. Supreme Court has now filed to adopt the child in Oklahoma.

The Post and Courier of Charleston reports that Dusten Brown and other relatives filed the court papers in Oklahoma on Monday.

The U.S. Supreme Court ruled last month that South Carolina courts should decide who gets to adopt the 3-year-old named Veronica. South

Carolina courts originally said the federal Indian Child Welfare Act favored her living with her father and Brown took custody in 2011.

Matt and Melanie Capobianco of James Island, S.C., who raised Veronica for the first 27 months of her life, appealed. Their attorney says the Oklahoma filing will further delay South Carolina proceedings.

## American Indian staff remains outside civic center

DULUTH, Minn. (AP) ~ The American Indian staff, vandalized three times, will remain outside the Duluth Civic Center until the city and tribal leaders can discuss its placement.

The staff is made of ironwood with eagle feathers and ribbons tied to the top. It's considered a flag to the Anishinaabe people and was planted during a rally in November of 2011. It was replanted

during a recent spiritual ceremony after it was vandalized for a third time.

Mayoral spokesman Daniel Fanning says questions have been raised about whether the staff's placement is legal. Fanning tells the Duluth News Tribune the staff won't be moved until a discussion is held with tribal leaders about what to do with it.




The play, edited and directed by CMN faculty



The following day was reserved for making sun catchers and designing their own puzzles, along with playing games to build their team skills.

Seven and eight year olds enjoyed trips to Bay Beach and healthy snacks at Oneida Recreation.


## New Oneida ID Cards Available

Beginning June 1st there will be a new Oneida ID card available at Enrollment office. The new card looks much like the old cards with one exception, it will have a bar code on the back of the card. This bar code allows for faster Gas Tax exemption service for the customers at the Oneida One Stops. It also a more accurate way of tracking the transactions so the Oneida Nation of Wisconsin can be reimbursed from the State more efficiently.

In the future it will also assist with the processing of tribal members who attend GTC meetings. Getting a new card today will require a fee of \$3.50 or \$1.50 if you are over 55. The only exception to the bar coded cards are youth 15 or younger who will not receive bar coded ID cards.

A new ID card can be obtained during regular business hours at the Enrollment office with the exception of Mondays – No ID cards are processed on Mondays between June 1- Sept 2.

If you do not need a new card right now, you may opt to wait until October 1, 2013, at which time, you may exchange your old card for a new card with bar code at NO cost to you.





On July 8, 2013, once again, the Supreme Governing Body of the Oneida Tribe of Indians of Wisconsin, the General Tribal Council spoke and the directive was swift and short leaving many, including myself, to ponder and reflect. The General Tribal Council, in accordance with all the rules of our governmental system, determined that an entire agenda would be dismissed. In effect, the mechanisms of the regulation of GTC decision making is continually "making history."

Three petitions sponsored by Linda Dallas and Kerry "Bug" Danforth were on the agenda for the GTC meeting addressing the issues of the Appeals Commission in decision making on child support, custody, transference of cases to Family Court in


the County circuit system, and the dissolution of the Appeals Commission. The impetus for generating the petitions was first and foremost for the "protection of Oneida children within the Family Court system in the Appeals Commission and the wishes of the signers to protect Oneida children were expressed in the support of the signers of the petition. As a Councilman and as Chair, my record and the record of the Business Committee on protecting the Oneida people and their resources is strong and the protection of our precious children is beyond a priority, it is the great act of love by parents and grandparents, and the entire extended Oneida family to "grow" and protect our children.

As a people, providing for the wellbeing of all our people is reflected in

our laws which govern all tribal members. Indeed, the passage of the Judiciary Act in January, 2013, to create a newer and better system to adjudicate matters for all Tribal members was a giant step forward in that effort to protect our people and our resources; it included the creation of a Family Commission and the dissolution of the current Appeals Commission process. In fact, the motion to dismiss the agenda by



Councilman Brandon Stevens was based on the position that all of the items in the petitions on the agenda had been addressed in the Judiciary Law passed in January, 2013. The General Tribal Council passed the motion to dismiss the agenda; The decision of the General Tribal Council is the law of our tribe.

In fact, the Legislative Reference Office is now working on refining and explaining the issue of transfer of cases under

the stipulations to the Counties, and this process has the support of my office and the matter will be closely followed by this Chair and staff and information transmitted to tribal families.

*Please note that the last three GTC meeting mail out booklets (May 5, July 1, and July 8, 2013) have contained the published petition and the names of the signers on the petition. While this falls under the Public records law, it was done without notice to the GTC and has caused questions regarding the fact that just because a record can be published, should the record be published. It is equally important to note that the tribal members should be advised that just because you sign a petition does not necessarily mean that you are going to vote for or against it; it signifi-*

cantly means that you as a tribal member see merit in the issue being brought before the GTC.

This power of the General Tribal Council and the work of the General Tribal Council is a binding commitment by all Tribal members and elected and appointed officials that this body is the highest authority of our Tribal government.

While our governmental processes are often cumbersome, the Oneida Tribe continues to remain steadfast in both the survival and the will to thrive as a strong and sovereign people. In the end, as we all, as a Tribe, humble ourselves to the power and the direction of the General Tribal Council, the Chairman and the Business Committee continue to work as directed to move forward in the protection and wellbeing of all of our people.

## Treasurer's Report

With a majority of General Tribal Council members not in receipt of the 2013 Annual Report I am taking the opportunity to highlight the Finance Division of the Tribe. The mission of the Finance Division is "to provide exceptional financial management and support while safeguarding the assets and ensuring financial integrity." These words are very important to us and we take our mission seriously.

Over the past year we have accomplished many things. Chief Financial Officer Larry Barton was named CFO of the Year

by the Native American Financial Officers Association. It was truly an honor to present this award to Larry as I know how diligently he works to ensure the Tribe is receiving the best value for our money.

Another accomplishment was being able to self-fund the new Larsen Road One Stop and Oneida Market meaning we did not have to take out a loan or bond to build the facility. Considering just how much it costs to build a building this was a great achievement. We did ask the organization to tighten their belts and complete more with less

which resulted in this new facility

Finance and Purchasing worked diligently together to keep the costs of the new Anna John Resident Centered Care Community project below budget. Rae Skenandore and Dave Bischoff were instrumental in ensuring all the project needs were met while working meticulously to negotiate the best prices possible. Through this joint effort, we were able to finish the project well below budget.

The Finance Committee meets twice per month on the first and third Friday's of each month. During these meetings we address requests from various departments as well as community requests. The Community Fund is funded through the rebate we receive from our soda vendor. Tribal dollars or Tribal contribution is not used for this fund. These dollars are used to pay for

a variety of events such as sport fees, music lessons, educational camps, special needs supplies and classes. The Community Fund does not pay travel expenses of any kind nor do they pay for anything related to personal business.

So far this year we have received thirty-six (36) requests in the amount of \$12,377 which is an average of \$343.80 per person. The limit is \$500 with a 10% participant match. For the complete guidelines of the Community Fund please visit the Tribe's website.

This same fund also allows us to donate soda and water. To date we have donated one hundred sixty-seven (167) cases of product to various Tribal events. These two funds are very important to many people throughout our community and we are very glad this opportunity is available to any Tribal member.

Over the past two years of this term, I could not be happier with the Finance Division as a whole. They are very ethical people who I can rely on for any financial information I need at any time. Combine that with how carefully they have worked to ensure we have the appropriate policies and procedures in place to ensure each department is treated fairly is essential. By mandating the three bid process, we have saved millions of dollars. The same is true with the changes that occurred to the Tribal Preference Law. While Finance cannot take the credit for those changes, we have implemented and enforced the new law which also has resulted in millions of dollars in savings. All these small things add up to heaps of dollars, dollars we used to fund the new Larsen Road One Stop, the Casino expansion and pay down over \$11M in debt.

All of these accomplishments would not have been made without the persistent attention to detail made by the Finance Division, namely Larry Barton, CFO, Ralinda Ninhamb-Lambries, Assistant CFO and Terry Cornelius, Chief Financial Advisor. They could not be as effective in their jobs without Denise Vigue, Administrative Assistant who not only coordinates them but everything relating to the Finance Committee. Without these individuals and their respective teams I truly believe our financial situation would not be as bright as it is today. Thank you for all your hard work!

On that note, I wish everyone a safe, happy, and healthy summer filled with fun and new experiences. Thank you all for your support at the July 1, 2013 GTC meeting and I look forward to our next meeting together.



The amendments would retitle the policy as "Board, Committees and Commissions" (Law) and enact it as a law. The amendments would also:

- Govern the creation and dissolution of boards, committees and commissions; and the appointment of persons to boards, committees and commissions;
- Set out the type of information required to be contained within bylaws;
- Determine how official records are maintained and compensation is paid;
- Limit a Tribal member to one (1) appointed position on a Board, Committee or Commission. Tribal members will not be allowed to hold more than one Board, Committee or Commission position and Tribal Corporation Board position at the same time.
- Limit a Tribal member to serve a maximum of two (2) consecutive full terms in any one (1) appointed position. Upon adoption of the Law, the resolution will contain a grandfather clause to allow all elected persons serving in an office on the effective date of this amendment to have their current term counted as their first term, regardless of the number of terms previously elected to that office.
- Prohibit Tribal members from serving as an elected or appointed official and as a Tribal employee.

**Summary of the Proposal**

The Amendments limit Tribal members to serving 2 consecutive terms per position; limit Tribal members to run for 1 elective seat per election; prohibit any Tribal member from serving in more than 1 any elected or appointed position at any given time; prohibit Tribal members from being Tribal employees while serving on an elected board, committee or commission; and include enforcement provisions for campaign violations. The Amendments also:

- Update the duties of the Election Board.
- Streamline the caucus process by making the Election Board, instead of the Business Committee responsible for calling a caucus and decreasing the time frame for when a caucus can be held.
- Clarify where campaign activities can occur.
- Require a polling site be located on the Reservation and in Milwaukee.
- Require video surveillance of all ballots and voting devices when the polls are open.
- Allow voters to have one person of their choice assist them with marking their ballots.
- Allow election observers and set out requirements regarding the observers' actions.
- Require the Election Board to document election day incidents and other irregularities and include them in a report to the Business Committee.
- Increase the time frame for filing a challenge of the election results – from 10 to 30 days. Amends the section on "Referendums" to clarify the parameters and process for referendum questions to be placed on a ballot



# Home Building Opportunity – Residential Vacant Land

If you are in the market to build a home and looking for land, you may want to consider the Home Building Opportunity (HBO). The HBO is a means for enrolled members of the Oneida Nation of Wisconsin, to obtain a Residential Land Lease for a vacant residential lot.

A good place to start the research for your home building project is to find out how much financing you will be able to obtain. A pre-qualifying letter from a financial institution is required at the time of application.

Lots 7, 14-17 of Green Valley are new postings therefore will be advertised for the 30 days above before applications will be accepted. *Applications for the Green Valley Sites will ONLY BE ACCEPTED*

from August 13 – August 27, 8AM – 4:30PM Monday – Friday, at DOLM front desk.

## **Home Building Opportunity (HBO) Build & Occupy Process**

### **1. Obtain Pre-qualify Letter from Financial Institution**

Financial institutions will provide a pre-qualify letter that will reflect a maximum loan amount and often a maximum

PITI (principle, interest, taxes, and insurance) payment.

### **2. Submit Complete HBO Application Packet to DOLM**

An HBO Application Packet consist of a Residential Vacant Land Request Application, Residential Vacant Land Request Letter of Intent, and a pre-qualify letter from a financial institution.

### **3. Obtain Residential Lease offer from Division of Land Management**

Pending a qualifying Residential Vacant Land Request Application, Division of Land Management will provide a Residential Lease offer letter that will reflect the desired lot and tax status of the property. The specified lot will be held for the applicant

pending formal loan approval.

### **4. Obtain Contractor Contract and Home Building Plan**

Finalize a home building plan with a contractor of your choice. Contractors and sub-contractors must be licensed and insured.

### **5. Obtain Formal Approval from Financial Institution**

A contractor's contract, building plan and Residential Lease offer letter are all required to obtain a formal approval letter from a financial institution. This letter ensures the applicant is confidently approved for the loan.

### **6. Resolve Any Unpaid Bad Debt with the Oneida Tribe.**

Repay any unpaid bad debt owed to the Oneida Tribe.

ing plans. For plans to be approved the applicant must submit the following: Residential Land Lease, Lot Survey, Home Building Plans, and Zoning Permit application.

### **7. Obtain Residential Lease from Division of Land Management**

With a formal approval letter from a financial institution, Division of Land Management will issue a Residential Land Lease.

### **8. Obtain Residential Lease approvals from Oneida Land Commission and/or Bureau of Indian Affairs (BIA)**

Financial institutions require that all leasing documents be signed and approved from Oneida Land Commission and Bureau of Indian Affairs.

### **9. Obtain Oneida Zoning Approval of Home Building Plan**

With a signed Residential Land Lease, Oneida Zoning can approve the home build-

### **10. Initiate Loan Proceedings**

This is the point where the loan is actually signed and accepted by the applicant. All of the above must occur before a loan can proceed and be finalized.

### **11. Commence Construction**

Ensure all necessary permits are obtained through Oneida Zoning Department and begin construction.

### **12. Obtain Occupancy Permit**

Oneida Zoning will provide an Occupancy Permit upon final inspection.

## Wis. lottery players targeted by scammers

MADISON — The Wisconsin Lottery and the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) are urging players to think twice before giving out personal information to anyone who contacts them and says they have won a lottery prize.

The Lottery has heard from several players who recently have been contacted about supposedly winning a special drawing associated with the Mega Millions jackpot game. The caller has attempted to get them to provide money and personal information in order to "process" their prize claim.

The special drawing does not exist. The caller is a thief.

"Be suspicious of calls out of the blue that seem too good to be true," said Mike Edmonds, Lottery Director. "Don't let the idea of a big prize cloud your judgment and lead you into a big mistake."

Lottery, prize notice and sweepstakes scams are a significant issue for Wisconsin consumers. Among all consumer complaints logged by DATCP in 2012, the "Contest / Sweepstakes / Prize Notices" category received the tenth most complaints of all categories.

"Identity thieves often pretend to represent an institution you trust, and trick you into revealing personal information by phone or email," said Sandy Chalmers, DATCP's Division Administrator for Trade and Consumer Protection.

"Legitimate sweepstakes and lotteries do not require winners to pay an upfront fee to collect a prize."

There are ways you can protect yourself from prize scams:

<sup>35</sup> Be wary of anyone who says you've won a prize in a game or drawing you never entered.

<sup>35</sup> Know that legitimate lotteries and contests will NEVER ask you to pay a fee to collect a prize.

<sup>35</sup> Think twice before providing bank account numbers, credit card numbers or Social Security numbers over the phone, especially to someone you don't know or on an unsolicited call.

<sup>35</sup> Be suspicious of "urgent" solicitations that suggest that you will lose a prize if you don't act immediately.

The Wisconsin Lottery will never contact players to tell them they've won a prize, unless they have entered a second-chance or special event drawing. The Lottery will never ask for personal bank information as a prerequisite to claiming a prize or require players to pay a fee or make special additional purchases to claim a prize.
