General Tribal Council changes July election ballot

Judges removed from ballot, will be elected at future special election

The July General Tribal Elections will see a change as the judges for the new judiciary have been removed from the ballot.

The General Tribal Council (GTC) took the action after the Judiciary Team misinterpreted qualifications of the Chief Trial Court Judge set by the GTC in January of 2013.

The GTC also took action to shift a Trial Judge position to a Family Court Judge position. The change was requested after a large caseload began to burden the current family court.

Currently, there is one Family Court Judge. The judge's pay scale was also approved by a GTC resolution.

The new Judiciary is tentatively set to open in November of this year. No date has yet been set for the special election that will select the new court system's judges.

A verbal report on the current status of the Oneida Seven Generations Corporation (OSGC) was accepted with minimal discussion. Dialogue was limited due to the pending lawsuit between OSGC and Generation Clean Fuels, LLC. Generation Clean Fuels, LLC filed a lawsuit seeking \$397.7 million in damages from Oneida


Seven Generations Corporation (OSGC), Green Bay Renewable Energy LLC (a subsidiary of OSGC), and the Oneida Tribe for breach of contracts regarding OSGC's waste-to-energy plants. The GTC voted to dissolve OSGC last December.

A referendum question requesting names and financial figures be made public by the Audit Committee in each audit report was voted down. A land use plan referendum question increasing home construction on tribal property was passed by the GTC. It calls for the Oneida Business Committee to develop the plan with more housing opportunities and present it to the GTC no later than October 31, 2014.

The remaining agenda was tabled until the July 7 Semi-Annual meeting. Petitions calling for the tribe to pay real estate taxes for all tribally-owned property, not having names and addresses of individuals who signed petitions printed in GTC meeting packets, presenters who submitted petitions have the ability to respond to questions and comments from the floor of GTC meetings, and the creation of a stall mall at the former Tower Foods location on Water Circle Place will be added to the Semi-Annual meeting's agenda.--

On June 20, 1782, the President of the United States, George Washington, proclaimed the American Bald Eagle as the official national emblem of the U.S.A. For 232 years, there has never been an official observation of this day until this year. On June 20, 2014, the Oneida Veterans of Foreign Wars held an inaugural program in observance of the State of Wisconsin's American Eagle Day. While Governor Walker sent his regrets, Major James K. Overman, the origi-

nator of the celebratory salute was present. Major Overman, retired, is the recipient of the Distinguished Flying Cross and 18 Air Medals for actions during the Vietnam War. Other distinguished guests included Donald E. Loudner, National Commander of the National American Indian Veterans Association, who presented a medal to Larry Kutschma, Wisconsin Board of Veterans Affairs, for his diligent service. Other distinguished guests included John Wolfe, Department Vice Commander Wisconsin American Legion; Bruce Sorenson, Wisconsin

Representative to the VFW National Legislative Committee in Washington, D.C.; Mark Reiling, State Commander 2014-15 AMVETS; and Tim Thiers, State Legislative Director AMVETS.

DeMain running for Wisconsin's 29th Senate Seat

Managing editor and CEO of News From Indian Country (NFIC) Paul DeMain is breaking new ground as he runs for Wisconsin's 29th State Senate District seat. DeMain stated his main motivation for seeking office was his 12 grandchildren.

"The reason I want to run is because I want them to have the same kind of an opportunity that I had in life, and that means making sure that there's good educational opportunities," said DeMain.

DeMain, an enrolled Oneida citizen, is running as a Democrat against incumbent Sen. Jerry Petrowski who has served in the State Assembly in and State Senate for 16 years.

"A lot of contemplation going in to the whole idea of running for public office and whether or not you're going to be able to stand up against an incumbent who's been in office for over 16 years, has money in the bank, has the support of deep pockets on the Republican ticket," he said.

DeMain was also motivated to run for the position after seeing the influence of outside special interest groups on Wisconsin politics, particularly concerning the proposed iron mine in the Penokee Hills in Ashland County.

"It angers me to the bottom of everything that I believe in

when I see legislators legislating for special interests in the state of Wisconsin like we've had here in a divisive way that does not serve the public and the citizens of this state," he said.

DeMain hopes to call on his experience working for Wisconsin Governor Anthony Earl from 1982-1986 helping to develop landmark legislation concerning tribal law enforcement, burial ground protection and cigarette tax refunds for tribes.

"Governor Anthony S. Earl made it clear what when I walked out the door to help lobby positively for these pieces of legislation ... that the

idea was to go down the middle called the Wisconsin way," said DeMain. "You had a much broader consensus than by simply ruling by 50% plus 1 vote. That's how the GTAC bill got through."

While DeMain has spoken out against the proposed mine in Penokee Hills, he insists that he's not against all mines.

"I'm not anti-jobs, I'm against jobs that damage the future health needs of children and grandchildren, because it's not about just gratifications for today, it's about what we're going to give to our children in the long run," he said.

Long active in Native

American and journalism organizations, DeMain plans to call on his leadership experience when representing the people of northern Wisconsin. He's also been motivated by his adoptive mother Margaret Stieglitz who told him to run for office.

"My mother in Wausau said 'you said you were going to run for office 30 years ago after you got out of the governor's office, I'm 91 years old now, and there had to have been a reason that I've lived this long was to see you actually run for office,'" said DeMain.

A primary will be held August 12, 2014 and the election will be November 4, 2014.







Father's Day weekend had many celebrations planned. Kirby Metoxen, a member of the Oneida Tribe of Indians of Wisconsin, tried something completely new for him. He was the whip or driver for the 15th annual Columbus Horse & Carriage Festival in Columbus Wisconsin.

This American Driving Society two day event is a very popular show as drivers love to be at the history and beautiful grounds of the Fireman's Park.

Being this was Kirby's first American Driving Society show for both himself and the horse he showed in the Novice Horse Division. Each Division has six classes that they show in over the two days. Three are ring classes where the

Turnout, Reinsmanship or Working pleasure are evaluated. The other three classes are timed cones events where the speed and accuracy are recorded. Points are given for the placing's and at the end of the show and the turnout with the most points are the Champions. While the horses in the Novice Horse Division are new to this type of competition many of the whips were some of the top driver from throughout the Midwest.

Kirby's unit was pulled by Shooter a 58" Gypsy Vanner Cob put to a Slat Sided Natural Phaeton. This type of turnout would have been used for country driving for sport. There is room for two people to ride facing forward but the back can be opened up so two additional people can ride facing to the rear. The Phaeton was bought through Frey Carriages, a

leading carriage maker and dealer in Columbus WI. Although the leather harness was custom made to Shooters measurements by the Iowa Valley Carriage Company. Following American Driving Society rules the whip must wear gloves, hat, driving apron and jacket with the correct length of whip. Walter Carlson was in the role of a groom, whose job is to get out and hold the horse when they stop.

Shooter, Kirby and Walter spent a lot of time and effort in preparing for this event with coaching and lessons by Andrew Halbach, located at Peep Ridge Farm in Westfield, WI. Placing in most of the classes the turnout was a popular people's choice as well. With beautiful weather and many positive outcome plans are in the works to attend the BIGGEST American Driving Society show of the year in Wisconsin at the Villa Louie History Site in Prairie du Chein this coming September the weekend after Labor Day. You are all invited to join in the fun.

Red Raider Country launched



ONCEC offers summer reading program

What is "summer slide"? During the summer months when children are out of school there is a tendency for them to forget some of the skills they have learned. On average, children will lose about 2 months of ability in reading and 2.6 months of ability in math skills.

Children from low income families appear to be more impacted for a variety of reasons including access to resources, their home experience, and planned summer activities. The loss that occurs is not instantly regained when they go back to

school, it must be relearned and the loss is cumulative and by middle school some children may be as much as 2.5 years behind their peers.

How does income affect the setbacks kids are experiencing? Better-off children were more likely to have parents that encouraged reading and engaged in reading on their own. Children look at their parents as behavioral role models and are much more likely to read when parents do. They are also more inclined to go to the library, attend concerts and go on field-

trips. Parents may arrange vacations to new places, or enroll their children in activities such as sports, music lessons or other enhancing activities. Overall they had a more expansive realm of experiences. This is important because summer learning loss accounts for about two-thirds of the difference in the likelihood of pursuing a college preparatory path in high school.

Summer slide can be prevented or at least combated fairly easily with parent and community involvement. Setting time

aside each day for math and reading activities can make huge difference. Activities can be fun such as cooking, educational games, and building projects can all be part of the process. A child that reads one minute a day will learn about 8000 new words by the sixth grade. A child that reads 20 minutes a day will learn almost two million words in the same time.

When choosing reading material for children it is important that the content is both interesting and not overly challenging. A good way to test this is to have the child read a page out loud and if they encounter five or more words that are unknown to them they will have difficulty reading it on their own. Parents can take an active role helping their children with more challenging material and enjoy the one-on-one time, even for half an hour to make a big difference in their futures.

This summer the Oneida Nation Community Education Center is providing reading enrichment time for children that have completed first grade and beyond. The program which began on June 17, 2014 will last throughout the summer, from 2:30PM – 4:30PM on Tuesdays, Wednesdays and Thursdays.

Changes To Community Support Services Fund

This fund was amended through OBC Resolution #12-11-13-D and will go into effect March, 2014. Funds for this program are based on the Tribe's economic status.

Requests for assistance from the Community Support Services Fund must be the result of a **catastrophic event, illness or injury**.

The main changes include **elimination** of Stabilization Assistance (examples include shelter, auto repair, appliance repair/replacement, D.O.C. re-entry assistance, legal fees, home renovations to accommodate handicap access, student assistance, basic eyewear/dental needs, or basic home medical equipment).

Other changes include:

Eligibility Criteria:

- Services are available only for enrolled members of the Oneida Tribe of Indians of Wisconsin.
- Services will cover catastrophic events, illness, or injuries only.

- Services will assist with an emergency situation that poses an immediate risk to health, life or safety.

- Requests for assistance must be made within thirty (30) business days from the catastrophic event, illness or injury.

- Applicants must satisfactorily provide the program with required documentation and/or verification before funds can be released.

- Application for assistance shall be made within a reasonable time period, not to exceed thirty (30) business days of a catastrophic event or illness or injury.

Applications made after thirty (30) business days of the event will not be considered.

the applicant will be required to pay a portion (cost-share) unless the person falls below the Federal Poverty Level limit. The Federal Poverty Level limit is used by Economic Support Services (Center for Self-Sufficiency) and determined by the Federal government.

The Amendment to the Community Support Services Fund requires Economic Support Services (Center for Self-Sufficiency) to set caps on the amount of assistance each person or household may receive, per event.

A copy of the Resolution can be obtained by calling the Tribal Secretary's Office (869-2214), downloading a copy from the Tribe's website - www.oneidanation.org (Select Government, scroll to **Oneida Laws**, click on **BC Resolutions**), or pick up a copy at the Economic Support Services (Center for Self-Sufficiency) office.

- Severity of event, illness or injury
- Life-threatening emergency requests
- Emergency medical travel



almost two million words in the same time.

When choosing reading material for children it is important that the content is both interesting and not overly challenging. A good way to test this is to have the child read a page out loud and if they encounter five or more words that are unknown to them they will have difficulty reading it on their own. Parents can take an active role helping their children with more challenging material and enjoy the one-on-one time, even for half an hour to make a big difference in their futures.

This summer the Oneida Nation Community Education Center is providing reading enrichment time for children that have completed 1st grade and beyond. The program which began on June 17, 2014 will last throughout the summer, from 2:30 pm - 4:30 pm on Tuesdays, Wednesdays and Thursdays. Artist Development Awards - are available to artists in the community



NFL team in Washington DC loses trademark on name

The professional football team in Washington D.C. no longer holds trademark rights to the term "Redskins" after the U.S. Patent and Trademark Office's Trademark Trial and Appeal Board (TTAB) cancelled six of the team's trademarks.

"The term "Redskins" was disparaging of Native Americans, when

used in relation to professional football services, at the times the various registrations involved in the cancellation proceeding were issued. Thus, in accordance with applicable law, the federal registrations for the "Redskins" trademarks involved in this proceeding must be cancelled," said the ruling released this morning.

Pro Football, Inc., who owned the trademark, argued that too much time had passed before an appeal was filed and

the patent was "subject of significant investment".

The Washington Redskins did appeal the ruling and are showing confidence they will retain the rights to the six trademarks lost. The team was denied the trademarks in 1999 but a District of Columbia federal judge ruled in 2003 in favor of the team.

"We've seen this story before. And just like last time, today's ruling will have no effect at all on the team's ownership of and right to use the Redskins name and logo," said Bob Raskopf, the team's trademark attorney.

"We are confident we will prevail once again, and that the Trademark Trial and Appeal Board's divided ruling will be overturned on appeal. This case is no different than an earlier case, where the Board cancelled the Redskins' trademark registrations, and where a federal district court disagreed and reversed the Board."

The Oneida Tribe of Indians of Wisconsin has stood firm in their stand against Native American mascots. The Oneida Business Committee passed resolution 07-28-10-A which states, "the Oneida Business Committee continues to assert that race-based mascots deliberately, and in a derisive manner, portray Native Americans, Tribes, Tribal governments and Tribal cultures and should be rejected on all occasions and in all uses."




Keep safe around fireworks

An average of 200 people visit the emergency room every day with firework related injuries in the month around the 4th of July Holiday.

Firework Safety Tips to reduce the risk of injury:

- Never allow young children to play with or ignite fireworks.
- Avoid buying fireworks that are packaged in brown paper (a sign that they were made for professional displays).
- Always have an adult supervise firework activities, including sparklers. Sparklers burn at temperatures of about 2,000 degrees - hot enough to melt some metals!
- Never place any part of your body directly over a fireworks device when lighting the fuse. Back up to a safe

Schools offer free summer lunches to poor families

GREEN BAY, Wis. (AP) — Caring for two extra children this summer has put a financial strain on Corinne Frey's budget.

In addition to her 3-year-old daughter, Frey is also looking after her 10-year-old twin siblings who are visiting from Pennsylvania during their summer break.

"I've been going over our budget for feeding all three of them and I'm going, 'Oh man, it's about \$100 extra every two weeks just to add in that lunch meal and an extra snack,'" Frey told Press-Gazette Media. "That's a lot for us."

Frey said she was delighted to learn about the Summer Food Service Program, a daily free service that provides lunches to children up to age 18.

Recently, Frey took the three children to the Brown County Southwest Branch Library, just a short walk from her home. The child-

dren sat through a reading program inside the library before heading outside to receive a lunch that included soft pretzels, carrots, cranberry raisins, granola and milk.

"We're not low, low income, but that still affects our lives because it's less fun stuff we get to do, like taking them out to the zoo," said Frey, who added that she plans to take advantage of the free meals two to three times a week.

The program, which started in 1999, is designed to feed low-income children throughout the city during the summer months when they're not in school, said Kathy Walker, food director for the Green Bay Area School District.

This year's program started June 16 in many area locations.

Meals are distributed at 71 locations across Green Bay — including schools, parks and community centers. Parents don't have to be present for a child to receive a meal and everyone is eligible for a meal during serving hours, Walker said.

"Without this program, so many of these kids wouldn't be eating healthy meals or eating at all," Walker said. "The more healthy meals they have, the healthier habits they're going to have in life."

According to Walker, three out of every five students in the Green Bay Area School District qualify for a free or reduced lunch during the school year. In May, an average of 7,308 free meals per day were served to students who qualify throughout the district.

"The poverty rate is just going up in this area," she said.

The Summer Food Service Program served 113,148 meals last summer and that number is expected to be higher this year, Walker said. More than 4,000 lunches were served through the summer program on Monday.

Becky Phillips is the coordinator for the Summer Food Service Program at the Southwest Branch Library. That location served 75 meals the first day, she said.

"The goal is to ensure that every child gets fed at least one healthy meal a day," Phillips said. "When school's not in session it's harder to ensure that."

Low income levels or limited parental supervision throughout the day are factors that influence access to nutritious meals during the summer, she said.

Most of the participating serving locations will run Monday through Friday until Aug. 15 except for July 4.

The meals are prepared the night before at the school district's food service center and delivered the next day in refrigerated trucks to the participating locations, Walker said. Many schools will also serve free breakfast and snacks throughout the summer for students attending summer classes.

"The kids in the Green Bay School District are really lucky to have such a great program," Walker said. "The school district and families have to work together."

Dispute over Wyoming tribal boundary stirs debate

RIVERTON, Wyo. (AP) ~ Representatives of Wyoming tribes and a national group dedicated to ending tribal sovereignty held a lively but civil debate over a boundary dispute involving the state, a federal agency and the tribes.

The Citizens Equal Rights Alliance was holding a conference in Riverton this weekend despite objections from some tribal members who question the group's intentions.

The group came to Riverton because of a dispute over a U.S. Environmental Protection Agency decision saying that lands around Riverton are legally Indian country. Wyoming is challenging the EPA's decision, which granted a request from the Northern Arapaho and Eastern Shoshone tribes to treat their joint Wind River Indian Reservation as a separate state under the federal Clean Air Act.

During a meeting Friday with government officials and the media, members of the alliance encouraged local leaders to stand up to the EPA and urged them to fight for the state's constitutional rights, the Casper Star-Tribune reported.

"Our enemy is the federal government, in terms of being able to overreach like this," said Lana Marcussen, the group's legal adviser.

Officials from the Eastern Shoshone and Northern Arapaho tribes voiced their side at the meeting.

Shoshone Business Council Chairman Darwin St. Clair Jr. said expressing different opinions is essential to

moving forward in solving the boundary dispute.

"I know not everyone has read up on Indian law," he said. "I hope that people who are presenting this information are presenting it in the right context. A lot of times, especially with legal opinions, you can read it however you would like in your interpretation. As humans, we may have different interpretations, and that's OK, too, but that's where the question lies."

Citizens Equal Rights Alliance board members and city managers from across the country also decried what they consider federal overreach in Indian policy in general.

Treating Indian reservations as sovereign states is unconstitutional, board member Elaine Willman said.

"It is a de facto creation of a state within a state," Willman said. "If I were going to be treated equally with someone here, we would be treated similarly without intruding on each other's lives. Treatment as states replaces state authority, and that's the conflict."

Obama: More US can do to help Native Americans

CANNON BALL, N.D. (AP) ~ President Barack Obama on Friday became only the third U.S. sitting president in eight decades to set foot in Indian Country, encountering both the wonder of Native American culture and the struggle of tribal life on a breeze-whipped afternoon in the prairie. Amid snapping flags and colorful dancers, Obama declared that there was more the U.S. could do to help Native Americans.

Obama drew attention to inroads his administration has made with tribes even as he promoted the need to help reservations create jobs, strengthen justice, and improve health and education.

"Young people should be able to live, and work, and raise a family right here in the land of your fathers and mothers," Obama told a crowd of about 1,800 during a Flag Day Celebration at the Standing Rock Sioux Reservation.

Citing legendary tribal chief Sitting Bull, Obama said: "Let's put our minds together to build more economic opportunity in Indian country. Because every American, including every Native American deserves a chance to work hard and get ahead."

The president and first lady arrived by helicopter under sunny skies as native songs and

dances at the Flag Day Celebration were already underway. The couple first met privately with tribal youth about their challenges growing up on the reservation that was home to Sitting Bull.

Tribal government Chairman Dave Archambault praised Obama for helping correct "historic wrongs" involving tribal land disputes.

"If Sitting Bull were here today, he would be honored, as I am, to have a president here talking to us," he said.

Obama and Michelle Obama appeared delighted as children, adolescents and adults in face paint and costumes stepped to native dances on the reservation's powwow grounds. Obama nodded to the music and greeted some of the performers before speaking.

Obama, who was adopted into the Crow Nation during his 2008 presidential campaign, said he found common cause with the young people he and his wife met in a reservation elementary school Friday.

"They talked about the challenges of living in two worlds of being both native and American," Obama said, an echo of his own observations in the past about being the son of a Kenyan father growing up in a white society.

"Some bright young people like the ones we met today might look around them and sometimes wonder if the

United States really is thinking about them, caring about them and has a place for them, too," he said. "I said, you know, Michelle and I know what it feels like sometimes to go through tough times. We grew up at times feeling like we were on the outside looking in."

As he entertained the crowd before Obama's arrival on the powwow ground, master of ceremonies Anthony Bobtail Bear Sr. raised a hot-button issue in both the nation's capital and among Native Americans - the name of the city's professional football team.

"How many of you like the Washington Redskins?" he asked Obama's entourage. "Eeeehhh. Kill 'em off right away."

Today, the 2.3 million-acre reservation is home to about 850 residents who struggle with a lack of housing, health care and education, among other problems familiar on reservations nationwide. The Bureau of Indian Affairs reported in January that about 63 percent of able workers on Standing Rock were unemployed.

With Native American poverty and unemployment more than double the U.S. average, Obama promoted initiatives to spur tribal development and create new markets for Native American products and services. The Department of Housing and Urban

Development announced Friday that it would make \$70 million available to improve tribal housing conditions, including money for mold removal.

Interior Secretary Sally Jewell was also in Standing Rock on Friday to promote a plan to overhaul the Bureau of Indian Education, which is responsible for educating 48,000 Native American students in 23 states and is lagging behind other school systems by nearly every measure. Native American students have low scores on assessment tests and the highest dropout rate of any racial or ethnic group.

Obama was visiting North Dakota en route to a weekend away in Palm Springs, California. In 2008, then-candidate Obama pledged to expand health services, improve education, combat methamphetamine dealers, promote economic development and improve housing on reservations.

Democratic North Dakota Sen. Heidi Heitkamp, who accompanied Obama to the reservation, said Obama's trip was a "major step forward in our efforts to elevate the issues facing our Native American citizens to a national level."

Problems linger with child protection

WASHINGTON (AP) ~ The chairman of the Spirit Lake Indian Tribe says problems remain with how his reservation handles child protection issues

Leander R. McDonald also says his community struggles to find the resources to meet its

needs.

McDonald says the Spirit Lake Indian Reservation in northeastern North Dakota is trying to change its culture but has been unable to fill key positions and found help from the federal government limited.

McDonald spoke at a House subcommittee hearing Tuesday. The hearing was requested by U.S. Rep. Kevin Cramer.

The North Dakota Republican says he's trying to gauge whether Congress needs to act to improve conditions at the reservation.

Spirit Lake's had numerous cases of child abuse and deaths. Federal prosecutors successfully prosecuted two cases involving child deaths on the reservation last year.

Oneida artists recognized at Eiteljorg show

2014 marks the 25th anniversary of the Eiteljorg Museum of Indian and Western art. The museum is located in downtown Indianapolis, Indiana next to White River Military State Park and the Indiana State Museum. The Museum was founded by Harrison Eiteljorg and houses one of the finest collections of Western and Native American Art in the United States. In addition to the permanent collection, year long rotating exhibitions are sponsored by the museum. This year the Eiteljorg is host to an exhibit of Ansel Adams black and white photography of the Western United States and Blake Little's "Photographs from the Gay Rodeo."

The weekend of June 20-22, 2014 also marked the 22nd annual Indian

Market and Festival sponsored by the Eiteljorg Museum. 130 artists from more than sixty Indian Nations brought their artwork to Military Park for the Market. The Indian Market began with a juried Art Contest on Friday afternoon, followed by a "Patron's Reception" on Friday evening. On Saturday and Sunday, Artists set up their work under three white circus tents and sold their artwork to the general public. Once inside the park, artists and visitors entertainment included food, family activities, Hoop Dancing by Tony Duncan, a free concert by Joanne Shenandoah and much more.

The Art Competition consisted of ten Divisions ranging from Painting and photography to Fine Art Sculpture, Jewelry, Cultural Items and Beadwork. Each

Division had multiple sub-categories. Five Judges examined the entries to determine category winners as well as Best of Division and Best of Show winners. The judges were all Native and ranged from practicing artists to museum curators. This year's Best of Show was awarded to Ronni Leigh and Stonehorse Goeman of the Onandaga Nation for their collaborative black ash basket entry, "He Takes His Place."

Our Wisconsin Oneida community was well represented during this year's Art Contest. Mark Fischer traveled from Green Bay to attend. Raised Beader, Karen Ann Hoffman drove to Indianapolis from Stevens Point, WI to exhibit. Residents of Oneida, WI: Judy Jordan, Sandra Wescott-Gauthier and Betty Willems received grant money from the Oneida Arts Board to travel to the

show, sell their wares and show their work.

This year our Oneida artists were awarded ribbons in three categories.

Mark Fischer won both first and second place in the Fine Art Sculpture Metal category. Mark's blue ribbon was awarded for a detailed sculpture of a bison titled "Ancient Dignity." Judy Jordan received a second place ribbon in the Contemporary Dolls category for "The Clan Mothers" as well as an award in beadwork for her Collar and Cuffs. Raised Beader, Karen Ann Hoffman was awarded a blue ribbon in the beadwork category for her art piece: "Sky Woman" an 1880's folding child's rocking chair she re-upholstered and beaded with our Creation Story. A Sandra Wescott-Gauthier received a second place ribbon in the beadwork category for the "Wedding Regalia"

Prison parents stay connected to kids by reading

WAUPUN, Wis. (AP) ~ Before he opens the copy of "Basil the Barn Cat" in front of him, Steven Reynolds takes off his identification badge - the one that reads "OFFENDER."

He's been practicing for this moment.

Sitting at a table in a small conference room at the maximum-security Waupun Correctional Institution, Reynolds says he's been working on the animal voices in the story he's reading for his son, a 16-month-old named Gabe.

"I don't want to make it boring," Reynolds says.

Sister Ruth Poochigian focuses a video camera across from Reynolds and hits "record."

The 29-year-old father then puts his practice to work.

He rhymes his way through the story, doing each animal's voice. As he turns the pages, Reynolds holds the book up to the camera, like he would if his son were sitting there.

Gabe was born not long after Reynolds was arrested for selling 3 grams of cocaine to a confidential informant in Marathon County, the Wisconsin State Journal reported. When authorities searched Reynolds' home, they found 4 more grams of cocaine, and he was charged with a slew of drug and bail-jumping offenses.

Last November, a judge sentenced him to 10 years at Waupun.

Gabe lives in Wausau with Reynolds' wife, Stephanie, and stepchildren. He's also reading books for them today.

He met Gabe once, also while he was locked up. He knows it will be a long time before Gabe sees him anywhere else.

That's one of the reasons Reynolds jumped at the chance to make this video, and why he's been practicing for it.

"He'll get a chance to know me a little bit," Reynolds said. "That's one of my biggest worries about being in prison: My son not knowing who I am."

"He'll know, 'That's my dad.' So I'm not a stranger coming home to my family."

Poochigian has been recording these videos in Wisconsin prisons for years, as part of a program called Reading Connections, letting incarcerated parents do something they might not be able to otherwise: Read a book to their children.

"It's an intimate moment," Poochigian said, "and it's a privilege to be there."

Of the 2.3 million people incarcerated in the United States, 1.1 million are fathers, according to a 2010 report from the Pew Center on the States.

In Wisconsin, nearly 8,000 of the state's

20,600 prison inmates say they are fathers, according to the Department of Corrections.

Some 2.7 million children in America are growing up with a parent behind bars, the Pew report found, or one of every 28 kids.

If you're not in one of those families, Poochigian said, those can be very easy statistics to ignore.

"Unless you've been there for some reason you don't even think about (prisons)," Poochigian said.

Each month, she and others from Madison-Area Urban Ministry make trips to Waupun and the Taycheedah Correctional Institution, a women's prison in Fond du Lac, to record videos.

The parents also write a letter for their child, which is sent along with the video on a DVD and a copy of the book.

Reading Connections is one of many Madison-Area Urban Ministry initiatives designed to help families with incarcerated parents. It grew a decade ago out of another program that took the children of Taycheedah inmates on monthly bus trips to visit their moms there, Poochigian said.

A Dominican nun, she has been recording fathers at Waupun since last fall, and she said similar programs exist at some Wisconsin jails.

The goals of Reading Connections are to help children get through the tough process of growing up with a parent in prison and encourage reading as a way to keep the relationship with their mom or dad strong. By maintaining those relationships, organizers say, ex-offenders have a better chance to stay on the right track once they get out.

"Even though this is a (maximum security prison), a good percentage of them will be going home," Laura Bonis, the prison's social services director, said of the inmates. "That's one of those hard things to go back into, is being a dad."

On the day Poochigian and a volunteer record Reynolds and a handful of other fathers, she leaves Waupun satisfied but says there are dozens of names on waiting lists at each prison.

She knows there are fathers left waiting for her to come next month, and plenty more after those.

A few weeks after Poochigian visited Waupun, a package arrived at Terry Blom's house in Burnsville, Minnesota.

It contained a handwritten letter, a copy of "The Tales of King Arthur" and a DVD of her son, Scott Blom, reading the book for his son, Scott Jr.

In 2003, Scott Blom Sr.

shot a man twice during a home invasion robbery in Hudson. Prosecutors charged him with attempted murder; a jury found Blom guilty of aggravated battery, burglary while armed and being a felon in possession of a gun.

His son was born on New Year's Eve 2003. Four months later, Blom was sentenced to 30 years in prison.

Terry Blom knows her son made bad choices but tries to make sure her grandson, "Little Scott," can still know his father.

The two write and talk on the phone often, Terry Blom said, and a few times a year she takes Scott Jr. to Waupun so he can see his dad.

Every time "Little Scott" has seen his dad, she said, it's been in a prison visiting room.

"He's never known it any other way," she said.

Soon after the video arrived at Terry Blom's house, Scott Jr. came to see her and got to watch his dad read him the famous King Arthur story of the sword in the stone. The next day, on a lengthy drive to Iowa City, he watched his dad read the story again.

At a hotel that night, Terry Blom asked Scott Jr. if he wanted to read another chapter from the book his dad picked out for him. He wasn't interested in anything but the sword in the stone.

"I just want to read the parts that he reads to me," he told her.

When Terry Blom watched the video herself, she saw Scott Sr., 35, sitting in a pale blue chair in front of a cinder block wall at Waupun. He read steadily, pausing on the medieval English names and skipping a French one.

"EAST SIDE" is tattooed across Blom's knuckles, "St. Paul" over

DNR urges disabled hunters to sign up for season

MADISON, Wis. (AP) ~ Wisconsin wildlife officials are reminding disabled hunters to sign up for the state's special fall deer hunt.

The hunt is scheduled to run from Oct. 4 through Oct. 12. The hunt will take place on 73,000 acres across 39 counties that property owners have offered up.

Hunters have until Sept. 1 to contact a property owner and enroll in the hunt. A full list of property owners is available on the Department of Natural Resources' website.

Wisconsin DNR, trappers offer wolf classes

MADISON, Wis. (AP) ~ The Wisconsin Trappers Association and the state Department of Natural Resources are planning a series of wolf trapping classes around the state this fall.

The classes will cover the wolf season framework, wolf ecology, trapping ethics and responsibility and hands-on trap demonstrations.

The courses are scheduled for Sept. 13 in Iron River; Sept. 20 in Grantsburg; Sept. 27 in Madison; Oct. 4 in Milladore; and Oct. 11 in Rhinelander.

The classes won't satisfy the DNR's requirement that wolf trappers complete a state trapper education course, however. The agency considers the classes voluntary.

Biting fly explosion affects loon reproduction

MILWAUKEE (AP) ~ Swarms of biting flies are attacking loons in northern Wisconsin this season like never before, causing the birds to abandon their nests in record numbers, according to researchers.

The explosion of the black fly population just as the loons began incubating their eggs has caused more than 80 percent of the loons to abandon their nests in Vilas County and more than 70 percent of nests in Oneida County, according to the wildlife scientists who track the tuxedoed birds with the mournful cries.

A cold spring in Wisconsin and rapid warm up in May caused the black flies to arrive en masse, said Walter Piper, a researcher at the School of Earth and Environmental Sciences at Chapman University in Orange, Calif.

"There's always a burst that comes out in May. This happens to be one that is particularly devastating," said Piper, who spends six weeks in Oneida County studying the loons each year.

A species of black flies, Simulium annulus, has a particular attraction to loons, according to research by Michael W. Meyer, of the Wisconsin Department of Natural Resources. His 2012 study published in the Journal of Vector Ecology found the fly species was chemically drawn to the loons.

"It's one of the most exclusive relationships documented," Meyer said.

The fly species has always pestered the loons in the past, but this year it was an all-out assault.

Take-and-bake pizza subject to Wisc. sales tax

MADISON, Wis. (AP) ~ Take-and-bake pizzerias in Wisconsin are now subject to sales tax.

The extra expense for pizza-lovers will be \$2.7 million a year as the state collects 5 percent for every sale, the Wisconsin State Journal reported Sunday.

The change results from a ruling by the national Streamlined Sales Tax Governing Board. The Wisconsin Department of Revenue had asked the board whether Papa Murphy's should charge the sales tax on its pizzas, which are assembled at stores but baked at home.

The Westby-based SST is a 24-state organization created to simplify and bring uniformity to sales tax rules.

The board decided that take-and-bake pizzas count as prepared foods, which are not exempt from Wisconsin's sales tax. The pizza-makers had said they didn't because the pizzas aren't ready to eat until they come out of the oven.

The ruling had the potential for a broad impact because states participating in the SST in some cases must adhere to uniform standards, but the board gave the states an option in this case. States that want to tax take-and-bake pizzas "need to pass legislation or adopt some sort of written policy" so businesses know what to do, said Craig Johnson, executive director of the SST.

and down his arms, and a ski mask-covered head and cross-bones is on his throat.

But that's not what Terry Blom noticed.

"I could see how scared he was," she said. "He wanted it to be perfect."

Reynolds has had plenty of run-ins with the law - for battery, damaging property, selling drugs.

He was in prison six times before the sentence he's serving now.

This time is different, though, with a family back home and a son growing up without him.

"It's always been nothing to me," Reynolds said of being incarcerated. "Before, I wasn't missing nothing."

"Now I know I'm

missing (his) first walk, first words, first day of school."

On those other trips to prison, Reynolds said, all he thought about was selling dope once he got out. This time, he says he's done with that.

Reynolds' letter was sent to a two-story house in Wausau, where his son, stepchildren and wife, Stephanie Reynolds, live with her mother.

On a recent evening, Gabe ambled around the house in blue and green shorts before picking out his pajamas for bedtime. Steven Reynolds, meanwhile, was back in Waupun unsure when he'll next see his son.

Gabe doesn't really pay attention to the TV, his

mother said. But as he gets older, she'll show him the video more, so he knows the man on the screen - the one doing special voices for each animal and holding up the book's pages to the camera - is his father.

Steven Reynolds is grateful for the chance.

"I can show him, 'I'm trying. I care,'?" he said. "I'm not just giving up on you."

Native Hawaiians voice anger at federal officials

HONOLULU (AP) ~ Dozens of Native Hawaiian speakers expressed anger and mistrust with the federal government Monday during the first of a series of meetings that could lead to the group being recognized similarly to an American Indian tribe.

Interior Department officials hosted the public hearing, prompted by a push to include the ethnic group among the more than 560 tribes that hold such status, with federal considerations on issues from land manage-

ment to social services.

The discussion didn't cover potential benefits of federal recognition for Hawaiians, as department officials said it was premature to discuss specifics. The main purpose of the hearing Monday, they said, was to listen to Native Hawaiians about whether they want to pursue an official relationship.

"I'm hearing a lot of 'No's' so far," said Sam Hirsch, an Interior Department spokesman.

About 140 speakers opposed the move, with many saying it would be a barrier to their goal of returning the Hawaiian Islands to the indigenous community that ruled before Hawaii became the nation's 50th state.

"We do not need you here. This is our country," said Ao Pohaku Ku, of the Spiritual Nation of Ku Hui Ea Council of Sovereigns.

The emotional hearing at the Hawaii Capitol was punctuated by outbursts from those shouting that representatives from the Department of the Interior weren't welcome.

For more than a decade, former U.S. Sen. Daniel Akaka pushed in Congress for federal recognition. And many

Native Hawaiians have urged for such status, to protect locally established school and land rights.

Colette Machado, chairwoman of Hawaii's Office of Hawaiian Affairs, spoke to "strongly urge the federal government move forward with a process" of recognition. But, she said while detractors shouted over her, "I also urge that it be a pathway that is open to us, but that the decision of when and how to walk down that path is left to our people."

Other speakers, however, voiced suspicion and called for autonomy.

"We're not subservient," said Leona Kalima, who has challenged the state over Native Hawaiian land rights. "We're not stupid anymore. We cannot trust."

Federal officials said after the meeting the feedback was important. They encouraged more participation through written comments and attendance at hearings over the next two weeks.

"We want the broadest possible public input," Hirsch said. "This is just the start of a long and extensive public input process."

WX alerts available on mobile phones

MADISON, Wis. (AP) — When parts of Wisconsin were under tornado warnings last week, many state residents, including Gov. Scott Walker's wife, learned of the severe weather danger through their cellphones.

Wisconsin Emergency Management spokesman Tod Pritchard said the system that provides those weather alerts has been a "game changer" when it comes to keeping people safe.

"It gets (information) to a device that is right on millions of Americans," Pritchard said.

The Wisconsin State Journal reported that tornado warnings and broadcast alerts might have been enough to get a severe weather warning out to the public 10 years ago. But an aging popu-

lation might not hear those warnings, and a person watching Netflix wouldn't see an alert on television, said Laura McLay, a University of Wisconsin-Madison professor and systems engineer.

Pritchard and others said the cellphone alerts are a good supplement to warning systems that are already in place.

Today's phones come with the emergency alert system built in. When there's an emergency — such as a tornado, a missing person or a hazardous materials spill cellphones buzz and ring with special tones. Because the messages are sent to every cellphone in the affected area, a resident will get information even if he or she is away from home.

- c) Adopt, modify and repeal rules governing how lists of individuals, conclude to be eligible for appointment to law enforcement officer and promotion, are established.
- d) Approve competitive examinations used to judge suitability for appointment or promotion of law enforcement officers.

- k) Review contracts, and forward to the Oneida Business Committee for approval, concerning cross-deputization, dispatch function and mutual aid pacts which are made between the Oneida Police Department and a non-tribal agency.
- l) Approve Standard Operating Procedures of the Oneida Police Department.

Qualifications:

- a) Must be an enrolled member of the Oneida Tribe
- b) Must be at least twenty-five (25) years of age.
- c) Must submit to a complete background investigation and shall not be found to have convicted of the following:
 - 1. Shall not have been convicted of a felony in the state of Wisconsin or convicted of any crime in another state that would be considered a felony had the offense and adjudications occurred in the state of Wisconsin.
 - 2. Shall not have been convicted of a misdemeanor due to a plea arrangement for a felony arrest.
 - 3. Shall not have been convicted of any ordinance violation that could bring discredit to the Oneida Police Commission.
 - 4. Shall not be considered exonerated by a pardon granted by the state of Wisconsin or the Oneida Tribe for any conviction listed above for the purpose of serving on the Oneida Police Commission.
 - 5. Shall submit to drug testing prior to appointment and on an annual basis.
 - 6. Shall not be an employee of the Oneida Police Department.
 - 7. Must be a person of known good standing in the community.
 - 8. Shall attend applicable training.
 - 9. Shall serve a full term of five (5) years unless appointed to fill a vacancy created by resignation or removal, then shall be remainder of term.

of members. If an individual can receive these dollars for studying the English language and culture to become a teacher, they should be able to study the Oneida language and culture that they may not have daily access to.

Health Care

First and Foremost we need to really determine the meaning of good Health Care. I feel it should be a combination of Healthy Life Styles as well as Healthy Foods. Our Health Care staff has been very good at making changes that have a positive impact on our membership's health care issues by enhancing programs that educate our community members on how they can avoid negative health care issues such as diabetes and high blood pressure by improving their diet. These are great steps our professionals are taking in order to bring positive changes in the Health Center outcomes and goals for our community. Another part of Health Care is our natural medicines. Many of our membership understand them and use them consistently and yet many have never been given the opportunity to learn about the value of our Natural World and the Plants the Creator has given us. The Old Ones say...Everything you need is just outside your house. What most of them were referring to was Our Medicines. The plants, the waters, the fish...All the things we need to survive. We used to make teas from the plants that would help with coughs, (mullein) or belly aches, (peppermint); we would make salves and lotions for burns and cuts. We knew which plants to harvest and when so that they could provide us with the best potency and not damage their roots or base so that they would be there for all time...We have put aside a lot of that knowledge due to an easier life style of modern day society but we need to keep it in tact. We need to pass along the knowledge...knowledge isn't ours to hold, it's ours to pass along...holding on to it creates Greed...passing it on creates Wisdom.

Areas like Tsyunhenkwa can do this along with the Health Care professionals and the Oneida School System. These are all Great things we can do to get our People to a healthier place in both Body and Spirit. The Land can provide us what we need....But we have to take care of it.

Economic Diversity

Economic Diversity should include the ability to supply ourselves with what we need such as Food; like table crops as well as a daily meat. We all eat so our growth in the food industry could spread throughout the country once we fill our needs here. Some of you remember the Rez here when there were a few stores and a few small businesses and yet there was no tribal budget dollars to contribute to keep them going. Although they were not all tribal members that owned them, there was a solid relationship by many. We should strengthen our economy by using our land in a more meaningful way. We can begin this by planting crops for human consumption. We can become 'suppliers' instead of just 'consumers'. This would also lead to more jobs instead of downsizing our workforce. This would also initiate a healthier diet for our children, our Elders, and our community.

We should also focus on Eco-Friendly manufacturing of supplies that are becoming more and more needed by society such as solar panels or wind turbine parts for residential use. People are realizing the need to become friendlier to the environment. This is an area that we should begin capitalizing on. It could start a great economic return as well as allow us to be good stewards to Mother Earth. Whatever it is that we decide to begin manufacturing to better serve our needs and create jobs, we should include the collaboration with other tribes as well as other environmentally responsible groups that are trying to make a difference in their communities. After all, as you all know we have Family and Friends on Reservations all across the country as well as member that live everywhere in the world

As Green Bay grew and more money was generated by Gaming, the people from Oneida began to do all their shopping in Green Bay and Seymour. We need to start keeping our money and support within our own community. If we can start with a few businesses and support them together we can grow our Downtown Oneida to fill the needs we all have...by growing in the manufacturing field within our Trade Zone and Business Parks we can create jobs and stability within our membership that can then Help Us All Grow

the ONEIDA ECONOMY.

Housing

"Housing" I truly believe our housing efforts should be looked at long term...maybe 100 years, after all were not going anywhere. I think it could really address a lot of issues we are faced with, such as Training in all aspects of skilled trades, plumbing, electrical, carpentry, architectural, road building and the list goes on. We are a Self-Governance Tribe so we need to take that ability and enhance it... Job creation, A lot of jobs could be created in building the required infrastructure such as roads, drying areas, processing areas, housing, store fronts, etc. using workforce development dollars or grants for skill trades. Jurisdiction in zoning and permits, training and education for OUR NEEDS is parts that we can blend together in our Housing area.

As far as the type of Housing and the efficiency for energy savings and alternative heat...we have a lot of that knowledge already. We just need to align it in a better way. We need to encourage each other to believe in each other ...I have been given the opportunity to work with some of our youth in the past on building their skills in the Trades and I was always thoroughly impressed with many of them and their natural abilities of problem solving, team work and hand and eye coordination...many just need the opportunity. We should look down the road and create a strategy that gives Everyone the opportunity to contribute and to become part of the "Fabric" that we call Oneida.

As we grow our capacity to provide jobs, better housing, careers and so on we can help other Tribes that may not have the capacity to provide training, housing and solutions to the struggles that are faced throughout Indian Country...That is our responsibility as well...To Give Back. We have so many professionals in our Grants Dept., Housing Dept., Land Office, Development Division and other areas that can bring us all Forward if they are given the support and opportunity. We just need to Work together.... Support each other... Encourage each other and...

THANK THE CREATOR FOR ALL HE GIVES US.

Now What?

There are so many things we could or

should do. I think one of the major problems we face is the loss of financial creativity and the related focus on strengthening our Tribal members' ability to become self-sufficient. Some past GTC directives that requires the Tribe to keep providing money to the membership in ways that do not create long term opportunity to the membership need to be reviewed and talked about with the GTC using the Good Mind.

I heard sometimes if you take a real deep breath and hold it, you can get rid of the hiccups. Perhaps that is what we need to do take a deep breath, followed by some real good conversation without accusations and finished with some encouragement without discouragement and we will "get gooder" at recognizing how much we have to give thanks for and how much more we can give each other that doesn't have a dollar amount attached to it by using the Good Mind.

Let's begin to create long term opportunity for the membership instead of "cost control". We have been focused on staying in 'cost control' instead of focusing on how to get out of it.

We have weakened our trust with the employees and membership with

"cost control" rather than strengthen our relationship.

We have eroded relationships with other tribes and other business partners due to 'cost control' rather than taking the opportunity to grow.



class is taught throwing and falling techniques. The class also covers submission holds and locks and counters to submission holds and locks. This class is for ages 12 and up.





Department works on acquiring Kansas Claim apps

When I was first elected as Oneida Tribal Secretary in 1967, I heard mention of the Kansas Claims. I had

never heard of them prior to that time. I wondered about them and inquired about them from the older folks. One person told me about an old trunk in his family that was purchased with Kansas Claim money.

The Treaty of Buffalo

acterized as one of the most flagrant land swindles in New York history by historian Lawrence M. Hauptman. As a result of some of the treaty provisions, all tribes in New York were to remove to a strip of land just on the north

Territory consisting of 1.8 million acres. Some few of the Cayugas and Senecas migrated from New York. Some of the Oneidas, Stockbridge-Munsees and Brothertown people who had previously migrated to new homes in

Wisconsin now left for the Kansas Strip.

The 1838 Treaty of Buffalo Creek was a failure and was amended in the Second Treaty of Buffalo Creek in 1842.

Many of the folks who left for Kansas returned to New York or Wisconsin. Some of the leaders were busy assisting tribal members to go to new homes in the west.

The tribal members were often disillusioned because the climate was hot and dry and not like their homes in the east where they had plenty of water in streams and rivers.

The goals of the United States to remove all the Hodenosaunee (Six Nations) people from New York and Wisconsin were not realized.

The tribal members were to exchange their ancestral lands in New York and the lands some of them had settled on in Wisconsin for the Kansas Territory.

The U. S. Government sold the 1.8 million acres and opened it up for settlement to non-Indian families. Some of the applicants had actually moved to Kansas. Two of my great grandfathers did with their families.

Others never left New York. And still others had removed to Wisconsin.

Culture Heritage has copies of many of the applications. They are called the Kansas Claim applications.

These applications are rich in genealogical information because the applicant is asked for the names of his/her parents and grandparents, as well as siblings and children and grandchildren.

Many of the Oneida women, from Oneida, Wisconsin, were denied because they could not prove their Oneida heritage through their mothers.

If they were deemed eligible to participate in the settlement, the applicant received two payments between 1901 and 1904 of a little over one hundred dollars each.

Culture Heritage does not have copies of all the applications. We are currently working with an intern in Washington, D.C. who will acquire the remaining documents to complete our files.

Museum to highlight Haudenosaunee influence on United States government

The adoption of the Declaration of Independence in 1776 is an important event in United States history and is a holiday celebrated every year on July 4th. It is a reminder of the time we declared our independence from the Kingdom of Great Britain. Eleven years after the Declaration signing, another important event occurred: the signing of the U.S. Constitution in 1787. The Constitution was signed by George Washington and 38 other Founding Fathers. The Constitution is considered the supreme law of and provides a framework for the United States government.

Unbeknownst to much of the general public is the influence the Great Law (a Haudenosaunee document which is much, much older) had on the framework for the U.S. government. Several of the Founding Fathers felt a strong connection to the Haudenosaunee. John Adams, who would later become the second President of the U.S., discussed the "fifty families of the Iroquois" as a model for the American states to follow in his writings defending the Constitution.

Both frameworks include provisions for a federal government with sovereignty held by member states or nations respectively. Similarities between the Great Law and the U.S. Constitution also include: the concept that the office is more important than the person who holds the office; the ideal of servitude, rather than



lordship, of the office-holders; representation and open debate; checks and balances to prevent too much power from being vested in one person or one branch of government; and government through persuasion rather than coercion.

The Founding Fathers also adopted Haudenosaunee symbols including the bald eagle (similar to the eagle that keeps vigil atop the Tree of Peace) carrying 13 arrows in one talon, denoting the unity of the several states. News from the Oneida archives:

Brothertown collection

The Brothertown Indian Nation (BIN) moved this territory along with a group of Oneida and Stockbridge-Munsee in 1832 after the Oneida negotiated with the Menominee for a portion of land south of the Bay of Green Bay in 1822. The BIN was allotted a portion of this land on the Eastern/Southeastern shore of Lake Winnebago and is currently headquartered in Fond du Lac, WI. The BIN has been seeking federal recognition since 1978 when guidelines for regaining tribal recognition by the

federal government were established.

Otto Heller, a non-native man, started gathering various items both from Brothertown tribal members and other Native American tribes, which were purchased by the Oneida Tribe of Indians of Wisconsin on behalf of the BIN in 2010. The Oneidas currently have care and custody of the collection which has been inventoried, preserved, and is currently housed by the Oneida History Department. The BIN regularly makes payments to the Oneidas for the collection. The Brothertown Collection consists of land deeds,


documents, genealogies, books, ledgers, photographs (including tin types), and letter correspondents (some from civil war veterans)—totaling more than 1000 pieces.

Once a year Oneida archivist, Reggie Doxtater, and Oneida tribal historian, Loretta Metoxen, are invited to a BIN council meeting to update the Brothertown council members on the collection. There are plans to create a display of the Brothertown collection so Brothertown and Oneida members can view some of the objects that are important to BIN history and BIN-Oneida relations.

Initiative to Hire More Indian and Alaska Native Veterans to Work for Indian Affairs

WASHINGTON, D.C. ~ On the heels of President Obama's historic visit yesterday to the Standing Rock Sioux Tribe of North and South Dakota, Assistant Secretary - Indian Affairs Kevin K. Washburn today announced the implementation of a new initiative to hire more American Indian and Alaska Native veterans to work for Indian Affairs.

"In building a 21st century workforce, we recognize the importance of attracting and retaining veterans in this organization," said Assistant Secretary Washburn. "Individuals who have served in the Armed Forces have a proven track record for integrity, discipline and leadership, and are highly qualified candidates in a variety of occupations throughout Indian Affairs."

To achieve the goal of hiring more American Indian and Alaska Native veterans throughout Indian Affairs offices and bureaus, Washburn announced plans to increase the number of Indian veterans hired from the current rate of 9 percent to 12.5 percent.

Indian Affairs bureaus, regional offices and agencies provide a wide range of direct services to American Indian and Alaska Natives and already utilize an Indian Preference policy in hiring. Nearly 100 percent of the positions in the Office of the Assistant Secretary - Indian Affairs, the Bureau of Indian Affairs and the Bureau of Indian Education are staffed with American Indian and Alaska Native employees through Indian Preference. Indian Affairs officials are interested in hiring veterans prior to their discharge from the Armed Forces and are actively seeking members of the National Guard and reserves who are looking for careers that serve Indian Country.

Steps that will be taken to achieve the new initiative include:

- Increasing participation in job fairs targeting veterans;

- Establishing a presence on the Fedshirevets.gov website to highlight success stories of veterans already working in Indian Affairs;

- Utilizing social media such as Facebook and Twitter to promote accomplishments of veterans in Indian Affairs and alert prospects of the availability of open positions;

- Leveraging resources with other DOI agencies that have been successful in recruiting veterans to develop new strategies for attracting veterans to employment opportunities within Indian Affairs;

- Working with local veterans groups, especially Native American veterans groups, in the field to publish employment opportunities with Indian Affairs;

- Using the USAJobs.gov website to highlight positions of interest to veterans that will utilize their skills gained in military service; and

- Developing a Senior Executive Service (SES) performance element targeting increases in veteran hires in positions within Indian Affairs offices and bureaus.

I have spent the last 3 years trying to thoroughly request the Local, State and Federal Representatives that I have been in conversations and meetings with to understand that we are a recognized Government by the United States; therefore it is their responsibility to address us as such. Along with that relationship and encouraging words to them I have been able to assist in solidifying some key relationships between our professional staff and theirs. Many have sat at our table and had valuable conservations with us and other tribes in order to allow them to understand that we have the capacity to assume many of the jurisdictional responsibilities on our reservations.

We need to start creating our own economy. The only way to do that with an assured return is to invest in ourselves. We have been in cost containment for as long as many of you have been employed by the tribe, this has severely weakened our ability to maintain the support of our employees. The one-way street of cost containment is focused downward at the employees, and the growth of our Nation. We can no longer think that by simply controlling the spending it is going to lead us to a better place. We need to invest in our people, in a positive way, not as an organization but as a community and encourage OPPORTUNITY instead of CONTROL. That begins with each one of us individually and leads to us as a family and ends with us as a Nation.

This 3 year term my attendance at OBC meetings has been 90 %

OBG Treasurers attendance has been 64%

As Vice chairman my travel cost for 3 years has been \$ 12,869.80

OBG Treasurers travel cost for 3 years has been \$ 45,521.69

As Vice chairman my re-imbursement for mileage has been \$ 0

These are just a few examples that reflect my ambition to lead by example. This is public record in the annual reports as well as the weekly meeting minutes.

Sovereignty

Oneida people have always maintained their sovereign right to govern themselves. This has always been; it is inherent.

No one gave the Oneidas their sovereignty we have always had it and have exercised it since the formation of the Haudenosaunee. The current existence of our Oneida people continues today and is most broadly used in our ceremonies, our political structures and our daily lives. This doctrine is the sovereign power that is vested in the people (General Tribal Council) and those chosen to govern (Oneida Business Committee) as trustees of such power who must exercise it in conformity with the general will of the people; the General Tribal Council (GTC).

Current Affairs

On December 15, 2014 GTC voted to dissolve Seven Generations Corporation. This was an act of sovereignty giving direction to its trustees, the Oneida Business Committee (OBC). This action has many implications. A legal, political, financial, policy and public communication strategy must be developed to address this GTC directive. As a result of the dissolution the OBC hired an agent, Sagestone and two law firms to represent their law suits. In Green Bay regarding the conditional use permit and in Illinois regarding the ACF/ Generation Clean Fuels for lost business opportunity. Both suits are against subsidiaries of Seven Generations Corporation, the OBC action to dissolve the Seven Generations Corporation BOARD and not the CORPORATION puts the Tribe at risk. This is why an agent(s) and legal counsel are needed to represent Oneida's interest. Neither the OBC nor Seven Generations Corporation has waived their right to be sued. This is known as sovereign immunity. It is our belief that sovereign immunity is our first line of defense.

Positive Change

With my leadership, I have worked to create positive financial decisions that put the Tribe as a whole in a sound fiscal condition. This was accomplished with a clear vision and clear direction to the finance staff. The changes directed to my staff were implemented as a team. Finance worked on projects whose outcome had a strong balance sheet, credit worthiness, and improved financial capacity to fund operations and self-fund capital improvements.

Furthermore, changes to create set aside to pay off debt, the process of bidding out banking services, renegotiating our credit facility with Bank of America and monitoring the \$30 million bond to improve our governmental infrastructure. If chosen as Chairwoman I will work to strengthen our sovereignty.

Vice Chairwoman Candidates

Melinda Danforth

The most important issue facing Oneida today is to have effective leadership operating in an effective government structure.

Our Melinda Nation, like many Tribal Nations, face a unique challenge in that they operate in a system of government that is foreign to our historical and cultural way of life. Many tribal Nation's government structures were handed down by the federal government and Tribes recognize that those systems are not culturally relevant and that system promotes chaos rather than harmony and unity amongst our people. Indian Country is trending to change those forms of government in so that bureaucracy is not first and foremost, but that the people are. Oneida is embarking upon that future, as we await a Secretarial Election on our constitutional amendments that will allow us to gain control of our own constitution and begin to reshape our form of government.

This translates directly to Oneida and our leadership. The Oneida people have many expectations of leaders including being able to defend and expand the jurisdiction and powers, make good decisions based on our future generations, negotiate with local, state and federal agencies to our benefit, understand and keep atop of legislation and any court cases that impact our Nation, address tribal members complaints, be the solution to issues such as the diminishment of our culture and language, health, employment, housing, community development, access to resources, sustainability, economic development and many important issues. In my view, tribal leadership isn't just the elected leaders, it is those people involved in decision making at all levels including GTC, community members, tribal members and the organization. It is all of our responsibility to ensure that the issues the Tribe faces every day is all of our concern and that we do our part to tackle those issues in a strategic and

unified manner.

I agree with the candidates that expressed that the number one issue we face is that our language and culture is endangered. I agree that there needs to be a much more focused and dedicated strategy to move forward and accomplish goals that we set out. However, we also have to change our structure and our leadership, and more importantly we need to begin to change the conversation about what everyone's role is, not just the elected body. It is my hope that we have a set of leadership that is willing to do so, as I am.



1. Have General Tribal Council approve all future economic development projects to ensure there are no more failed businesses;
2. Create partnerships with local trade programs to ensure job training opportunities for all Oneida's;
3. Hold employees accountable for their actions;
4. Create stability by sticking to the established Tribal budget;
5. Maintain communication with the GTC regarding pending litigation;
6. Adhere to ALL General Tribal Council directives as YOU the GTC is my boss.

In my review of the Treasurer's Reports for the years 1999-2013, the

Oneida Tribe paid \$128.7 million dollars in debt payments, including principle, interest, and fees. During this time period, the Oneida Tribe was spending money we did not have. In the fiscal year 2015 budget we have \$10.9 million in debt payments, including principle, interest, and fees. We are also facing a \$25.8 million dollar deficit.

GTC, the decision is in your hands. Ask yourselves about the current candidates, "Do you want a Treasurer who will use the power of the pen for personal gain?" Or do you want a Treasurer who will stand up for the tribe by keeping a close watch on the Tribe's finances.

If elected Treasurer, my priorities will be:

- To maintain employment for Tribal member and enforce Indian Preference in hiring;
- To adhere to all GTC mandates;
- To maintain fiscal responsibility; and
- To continue programs and services for the membership.

Remember GTC, failed businesses are not good for the Oneida Tribe. Economic development without a clear plan, purpose, GTC approval, transparency and a high level of due diligence is not good for the Oneida Tribe.

The questioned posed by the Kali staff to each of us is, "what is the most important issue facing Oneida?" Answers to this question will be varied depending backgrounds, education, what we know individually from the memberships' points of view, and where we envision us going futuristically. With so many potential views on the question, it is my observation that it is prudent the next elected team of leaders commit to answering this question again after inauguration in a collective and consensus-driven manner.

With this understanding in mind, described herein is an example of preliminary decisions reached as a candidate. The information shared with you in the May 1 edition of the Kali describes the grass-roots process utilized to identify the initial framework.

One primary goal is to incorporate principle-based governance concepts into the operations of the Secretary's office and the Business Committee. These concepts are generally recognized as eight (8) areas, including:

Participation, Rule of Law, Transparency, Accountability, Responsiveness, Equity & Inclusiveness, Consensus-Orientated, and Effectiveness & Efficiency.

Setting aside individual objectives, the Secretary also has a role as one (1) of nine (9) BC members.

In this capacity, a primary responsibility includes making decisions in a way that ensures our inherent sovereignty is protected and/or enhanced to the best way we can. The Secretary

also has many pre-defined duties and responsibilities identified in tribal law. This information can be found in several documents such as Oneida's Constitution, the Open Records and Meetings Law & Pardon and Forgiveness Law to name a few.

Taking these many roles into consideration, and again utilizing the tribal members' input gathered last fall, seven (7) categorical areas have been identified which can be address from the Secretary's office over the next 3 year term. Each area is accompanied by its own action plan, including:


- Incorporation of Good Governance Principles
- Inter-office Design
- Personnel Relations Strengthening
- Centralized Response System
- Standing BC Meeting Support
- Policy proposals on BC Infrastructure
- Board, Committee & Commission Reporting Alignment, and
- Budget Alignment with Comprehensive Plan

Our number one priority is to insure our Tribe is adequately funded to complete our mission of providing for the next seven generations.

We have been in cost containment for almost the whole fiscal year. A large part of this is due to the recession and the government shutdown, but also to some of the entities in forecasting revenue that did not pan out. We seem to have bit off more than we can chew. If you only have

80% income, you can't fund the 100% expenditures that were budgeted.

With that in mind, those departments who do not have a revenue source had to tighten their belts and in doing so, membership services were either downsized or completely eliminated. Many of our members saw their health care eroded with decreased medical professionals as well as clinics that were completely shuttered and members given no chance at seeing an alternate provider for some of the lost services.

The new budget season is upon us again and we need to have better revenue forecasts and further scrutinize some of the expenditures that are being requested from those entities who rely on the budgeted income. We need to stop some of the silly purchases some of these departments are continuously doing as well as the inappropriate spending. Why are we buying sweatshirts or polo shirts for people to wear at work? Why are we allowing 11 people to travel out of state and then paying mileage for nine of them?

Why are we giving gift cards away to have individuals volunteer their services? The last time I looked, volunteer meant giving up one's time for the betterment of others, not so I could reap some benefit or perk. You should be volunteering out of thoughtfulness or compassion, not to be paid.

I believe we need to do some belt tightening in all of our departments and do away with some of the "nice to have" expenditures that have been put in the budget. We need to look at what is the bare minimum we can get by with and then budget accordingly. Take a look at your own household budget. Do you overspend? Do you buy items you know you cannot afford? No, none of us do and after everything is paid and there is some money left over, then yes go out and have some ice cream, you deserve it.






