New York Land Claim highlights semi-annual GTC meeting

Locklear approved to attend meeting to provide status update

The Semi-Annual Meeting for the General Tribal Council started out with adopting the agenda, approving Attorney Arlinda Locklear, not enrolled in Oneida Tribe of Wisconsin, to attend the meeting to present the status of the New York land claim. Arlinda Locklear is the first Native American woman to argue in front of the Supreme Court. Locklear discussed the history of the land claim, lawsuits involved with Oneida, and what our options are now. In the meantime of a settlement with Oneida Nations (New York, Thames, and Wisconsin), other Iroquois tribes filed for their claims to land. The Cayuga lost their case in 2005 to a defense called ‘latches’ that says too much time has passed to recover land or money damages for losses. This lead to the dismissal of Oneida Nations case going off the same defense. In order to combat the courts and voice to them their decision will not be accepted, Oneida Nation has the option of going to Congress. Congress has plenary

power giving them the authority to regulate commerce between the United States and Indian tribes. Last fall the Business Committee initiated the first step in the process by requesting an oversight hearing on the subject of Iroquois land claims where we can prove the justice of the claim, and propose possible solutions. It was suggested in the discussion that a settlement could clear up taxation issues with surrounding counties or towns, and other border issues and lawsuits. The Gaming Enterprise Division report summarized construction suc-

cess on the casino starting with Countryville Bar & Grill opening on Mason Street casino location. Vince Lombardi’s opening next to the Main casino, along with adding the largest non-smoking section in the mid-west. The Poker room was also renovated, and a new electronic message center put on Highway 172. The Gaming Enterprise Division would also like to remind everyone this weekend the 10-13 is the 20th year anniversary celebration; there will be free entertainment, promotions and free ice cream sandwiches. Information posted on

the website. The Retail department reported new and innovative renovation plans for Oneida highway 54 One Stop on top of the hill. Pedestrians will have a safer pathway coming from the round-about, and the gas pumps will be expanded to organize the traffic that builds up. Spaces for community fundraising will be made available, as well as local Oneida food products. The General Tribal Council voted on including the casino area in the update of the station, as well as adding a hot food option.

Interior transfers nearly \$3M from Buy-Back program to Cobell Education Scholarship fund

WASHINGTON, DC – The Department of the Interior today announced that \$2.9 million has been transferred to the Cobell Education Scholarship Fund. The Scholarship Fund was authorized by the historic Cobell Settlement and provides financial assistance through annual scholarships to American Indian and Alaska Native students wishing to pursue post-secondary education and training.

The American Indian College Fund (the College Fund) administers the Scholarship Fund and has extensive experience in providing students the resources to succeed in tribal colleges, technical and vocational certifications, and traditional undergraduate and graduate programs. Twenty percent of the Fund’s portfolio will be directed to support graduate students through the American Indian Graduate Center (AIGC).

“This funding for the Cobell Education Scholarship Fund will help open doors for the next generation of Native American leaders through higher education,” said Interior Solicitor Hilary Tompkins, who negotiated the Cobell Settlement on behalf of the Department of the Interior. “This Fund is an important tool to help students across Indian Country to pursue their dreams and have success in the 21st Century workplace.”

Cheryl Crazy Bull, President and CEO of the American Indian College Fund, said, “The American Indian College Fund is thrilled with the news that these resources are being forwarded to support Native student scholarships. Thanks to the Cobell Education Scholarship Fund, current and future generations of Native college students will have the financial ability to obtain a higher education, helping to give them, their families, and entire communities a better future.”

Sam Deloria, Director of AIGC, said, “We are grateful to all involved for the opportunity to administer the graduate portion of the Cobell Scholarship program and enable countless Native students to pursue post-graduate education. The rapidly-increasing cost of higher education makes this program even more important, and we are eager to begin its implementation.”

The Cobell Education Scholarship Fund is funded in part by the Land Buy-Back Program for Tribal Nations (Buy-Back Program). The Buy-Back Program was created to implement the land consolidation component of the Cobell Settlement, which provided \$1.9 billion to purchase fractionated interests in trust or restricted land from willing landowners. Consolidated interests are transferred to tribal government ownership for uses benefiting the reservation community and tribal members.

Interior makes quarterly transfers from Buy-Back Program sales – up to \$60 million – to the Cobell Education Scholarship Fund based on a formula in the Cobell Settlement that sets aside a certain amount of funding depending on the value of the fractionated interest sold. These contributions do not reduce the amount that an owner will receive for voluntarily consolidating their interests.

To date, the Buy-Back Program has sent more than 33,000 purchase offers to owners of fractional interests. The Program has successfully concluded transactions worth over \$72 million and has restored the equivalent of more than 203,000 acres of land to tribal ownership.

Offers are currently pending for landowners with fractional interests on the Pine Ridge (deadline: July 21, 2014) and Rosebud Indian Reservations (deadline: August 16, 2014).

Landowners can contact their local Fiduciary Trust Officer or call the Trust Beneficiary Call Center at 888-678-6836 for more information or to register as willing sellers. More information is also available at www.doi.gov/buyback-program/landowners.

Individual participation in the Buy-Back Program is voluntary. A decision to sell land for restoration to tribes does not impact a landowner’s eligibility to receive individual settlement payments from the Cobell Settlement, which are handled by the Garden City Group.

2008 Oneida Reservation Comprehensive Plan

Land Policy Framework – Article I of a series on the Land Use plan element

When the Oneida Business Committee approved the Oneida Reservation Comprehensive Plan on December 10, 2008 it included Section 3, The Land Policy Framework as a working draft and it includes descriptions of planned uses of the different types of places that make up our community. This information will consist of a series of articles that will focus on the Land Use plan element.

You may recall that the 2008 Oneida Reservation Comprehensive Plan (Comp Plan) was a multi-year planning process involving Tribal Leadership, Departments and community members. The process represented the “voice” of the People and was developed through a grassroots approach of numerous public meetings such as “Coffee with the Planners”, membership questionnaires and summits. The Comp Plan is used as a long range land use document to guide decision-making on the physical and social growth and development of our community.

The Comp Plan contains 16 interrelated areas of focus including: health, education, housing, commu-

nity design, parks and recreation, utilities, community facilities, transportation, public safety, government coordination and regulations, economic development, agriculture, natural resources, environmental protection, culture and land use.

In this year’s update of the Comp Plan the Land Use goal is to “Maintain a balance between the natural components and the built environment of our land”. As we review the Land Policy Framework you will see evidence that a lot of thought and planning goes into making land use decisions that support the land use goal to maintain a balance where we co-exist with the natural world.

The Land Policy Framework section of the Comp Plan includes a map illustrating neighborhoods, districts and corridors of the Oneida Reservation. The section also contains narrative along with a table describing desired uses and activities for each area. The Land Policy Framework provides guidance regarding the desired future character of the different geographic places in and around the Oneida Reservation.

Along with the Land Policy Framework, there has been an organizational process established over a period of ten years that allows for a consistent way to assess the condition of the land and to help define

potential uses. This process requires a delicate relationship between the areas of Land Management, Environmental Health and Safety, Geographic Information Systems and Planning and the many Land Use laws, resolutions, compacts and ordinances of the Tribe.

Our next article will introduce the series of places on the Reservation including neighborhoods, districts and corridors and the generalized types of uses such as residential, commercial, industrial, institutional, recreational, agricultural, environmental preservation and conservation.

Our third article will focus on the cross-functional organization process that is used to help define potential uses of land. It is called the Land Use Technical Unit (LUTU) process.

Our final article will specifically address neighborhood development with housing sites and potential sites to be developed intended to provide a variety of housing opportunities to address Tribal member needs.

Renovations ramping up at the Oneida Nation Longhouse

The Oneida Nation Longhouse has re-launched a construction project on the cookhouse (kitchen area) and bathrooms located on the Longhouse grounds. Thanks to funds raised from the community through a variety of fundraisers, the Community Fund, Oneida Department of Public works, a \$500.00 donation from the Oneida Sportsmen’s Club and a generous \$5000.00 donation from OTIE we are able to make improvements to our facilities.

Construction on new indoor bathrooms began two years ago, but has been a slow moving process. The cookhouse had an insect infestation and needed to be demolished so the infestation didn’t spread to the adjacent dining room area. A new cookhouse will be built, in its place. The new cookhouse and indoor bathrooms are handicap accessible with indoor plumbing and running water.

The re-launch began

with a small tobacco burning to give thanks for the land that will be altered and for the safety of all people involved in this project. After permits were obtained, the electrical service panel was moved from the cookhouse into the new bathroom area. A crew of community volunteers cleaned out the cookhouse and tore it down. We are ready to begin pouring a concrete slab where the new cook-

house will be built. We are looking forward to finishing both the cookhouse and bathrooms simultaneously.

The Oneida Nation Longhouse hosts a variety of events for the Oneida community. In addition to carrying out our responsibilities to annual ceremonies, we also host weddings, funerals, birthdays, and a meeting space for the community. Our facilities must be safe and conve-

nient for all people who visit the grounds.

“We thank our all of our supporters, particularly OTIE, who allows us to lead the community development side of the project” said Art Skenandore, Volunteer Project Manager. “We are excited to finish this project, and provide a safe environment for all Oneida people. We invite you to visit our gathering place, once construction is complete”

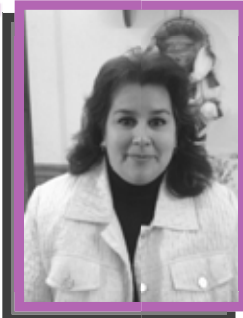

Access to Care Wait Times

Recently, there have been a number of issues, comments and concerns raised within the community regarding the “long wait times” to get in to see a provider whether it be in the Medical, Dental, Optical and Behavioral Health areas. One of the Comprehensive Health Division’s key values is to provide responsive leadership. To address these concerns, the Division Directors want to provide the following explanation to the Oneida Community.

Over the past several months, we have seen an increase in the number of patients in all areas of the Division requesting access to care. There has been some turnover of staff in all of these areas for various reasons of which some include retirement, changing jobs, leaving the profession, moving out of the area, inability to adjust to implementation of an

electronic record etc. In addition, we experienced the Government Shutdown, Sequestration earlier in the fiscal year and Cost Containment. All of these things put together have resulted in longer wait times and strains on access to care in all areas of the Division. Our staffing has been strained which has been an issue throughout the entire organization. However, the Health Division has been reviewing our processes in all areas to address your concerns and looking at the feasibility of increasing provider staffing to improve your access to care. Unfortunately, we must compete with the surrounding health care entities for providers as well as deal with national shortages of doctors, p s y c h i a t r i s t s , optometrists, dentists, therapists etc.

With the implementation of the electronic health record, schedules have had to be adjusted to allow providers more time to learn the electronic system, be ade-

quately trained on the system and make adjustments in their schedules temporarily to accommodate the additional time needed to review your electronic health records. This will improve as the providers become more accustomed to the new systems. It is extremely important to keep your assigned appointment times or if you cannot make it, simply call to cancel so someone else may utilize your appointment time. We do maintain lists of patients who request that we notify them in the event of a cancellation. Don’t let your scheduled appointment become a ‘no show’ or ‘broken’ appointment because this also impacts your access to care! All of these issues, in addition to the fact that we need additional space in all of the areas as well as the need for additional providers to accommodate the increasing demand have placed an even greater strain on the Health Division and the Oneida community.

As we move forward in the coming fiscal year, the Division has begun the Tribes process to look at expansion of the facility as we continue to strive to meet our Strategic Plan Initiatives which includes Improving Access to care across the Health Division. Thank you for your comments and concerns. We ARE listening to your concerns ad comments and continue to strive to make improvements within our system. Please continue to bear with us. We sincerely appreciate your patience and understanding.

# CMN's Theatre Production Discusses Tribal Enrollment

The College of Menominee Nation (CMN) invites the public to an original one-act play staged in the Norbert Hill Center Auditorium in Oneida, by students in the College's Summer Theatre Production course.

The play, "Blood Quantum: Fifty Shades of Red", is a comedy that discusses the origins and complications of using Indian blood quantum for tribal enrollment. It was written by CMN students Carol Brunette, Karen Cimicud, Yetsitsehewe Danforth, DJ Denny, Mason Powless, and Melissa Wilber in a playwriting course at CMN in the Spring semester 2014. This

production also marks the seventh time CMN has collaborated with the Oneida Arts Program's Dollars for Arts Program, which provides funds to support excellence, innovations, and the development of the arts in Oneida for individual artists and community groups.

The play, "Blood Quantum: Fifty Shades of Red", is set at an Oneida General Tribal Council meeting where the tribe is debating enrollment issues. Some members want to lower the blood quantum requirement, others want to raise it, and some see no reason to alter a system that benefits their family. Of course some people just want to change the subject, more

simply want their hundred-dollar payment for attending the meeting, and everyone in the room wants their turn at the microphone.

The play is first and foremost a comedy, but it does bring up some concerns expressed by tribal members throughout Indian Country. The play is a mixture of fiction, American history, Oneida history, and stories from individuals and tribal publications, but any similarities between the fictional characters and the humorous circumstances in the play are coincidental and unintentional. CMN is an institution that encourages the exchange of ideas, and CMN's theater program looks forward to sharing hilarious takes on serious issues every summer. This year is no exception.

CMN students and

community members involved in the play include the following: Tyrone Barber, Krysanda Bissonette, Louis Cottrell, Shayla Danforth, Yetsitsehewe Danforth, Kiara Dorner, Marlow Dorner, Lloyd Freison, Timothy Hock, Crete Kasee, Geoffrey Madsen, Nathaniel Madsen, Elizabeth Rice, and John Vasquez.

The play, edited and directed by CMN faculty member Ryan Winn, has two showings, one on Wednesday, July 30, and the second on Thursday, July 31. Both shows begin at 7:30 p.m. Admission is free. The production runs just under an hour in length. A reception following both shows enables the audience to meet and greet the production's cast and crew. The play is perfect for all ages.

## Oneida Y.E.S. Program offers different options

The Green Bay Y.E.S. Advocates and the Oneida Experiential and Adventure Department have collaborated to develop and pilot the Native Crossroads Y.E.S. Student Transition Program for Y.E.S. Program youth attending Green Bay's King Elementary, Lombardi Middle School and Southwest High School. The goal of the program is to help provide connections to other Native students at each school as they transition from elementary to middle school and then middle school to high school. Some of the activities will include the sharing of personal stories of transition, school tours, celebration events, and guest storytellers. More details will be provided as we get closer to the start of the school year.

### Seymour Community High School Summer School Program at Flying Leaf Community Center

In June, the Seymour Community School District partnered with a host of Tribal departments

including the Oneida Housing Authority, Oneida Higher Education, Oneida Y.E.S. Program, Cultural Heritage Department, and Oneida Experiential and Adventure Department to bring fun and learning to middle and high school students from Oneida. The Seymour Summer School Program took place at the Flying Leaf Community Center. Students learned Oneida Language, valuable social and life skills, and academics including Math, Reading, and Science. Kip Miller from Experiential Ed taught the students how to build a fire using a bow drill, flint and steel. This took great patience and persistence and the kids were very proud of their accomplishments! The final celebration was capped off with an Oneida Social. Thanks to everyone who helped make the summer school program at the Flying Leaf Community Center a success!

### Seymour Community School District – Oneida Language Classes

The Seymour Community School District has applied for a grant to assist with expanding Oneida Language classes. Oneida Language is currently offered for credit at the high school level. A grant application has been submitted that would allow Seymour to hire a half time Oneida Language Teacher. A half time teaching position would allow Seymour to provide a language exploration class at the middle school level and introduction of the language at the elementary school level.

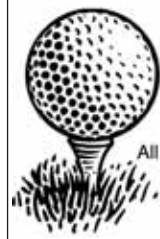

# West Elected Chairman of State Independent Living Council

Stephen “Corky” West, Director of the Oneida Nation Job Training Program has been elected Chairman of the Independent Living Council of Wisconsin, for a two-year term, beginning July 1, 2014. The Independent Living Council of Wisconsin is the statewide independent living council under Sec. 705 of the Rehabilitation Act of 1973 as amended. It was created by Executive Order 6 of Governor Scott Walker and Executive Orders of previous Governors.

Members of the Council are appointed by the Governor. Duties of the Council include:

- Develop a State Plan for Independent Living jointly with the Department of Workforce Development, Division of Vocational Rehabilitation;
- Review, monitor and evaluate implementation of that plan; and
- Coordinate activities with the Wisconsin Rehabilitation Council and other disability councils in Wisconsin

under federal law.

The Independent Living Council of Wisconsin has established “Full Inclusion of People with Disabilities in Society” as its vision.

Corky has been director of the Oneida Nation Job Training Program since 1995. His current responsibilities include oversight of the operations of the WIA Employment and Training Program and the Vocational Rehabilitation

Services Program.

This is Corky’s second go-around on the Council. He was first appointed by then Governor Tommy Thompson in 1999, and later re-confirmed by Governors Scott McCallum and James Doyle, leaving the Council in 2005 at the end of the regulatory term limitation. Most recently, Corky was re-appointed to the Independent Living Council of Wisconsin by Governor Scott Walker.

# Food-stamp changes to begin in Racine County

RACINE, Wis. (AP) – About 2,000 Racine County residents in the state's FoodShare program will soon have to work or enroll in a worker-training program to continue receiving food stamps.

The change was part of Gov. Scott Walker's 2013-2015 budget. Republicans said it would give people an incentive to find work and eventually move off the program, while Democrats called it a mean-spirited attack on poor people.

The new law, which takes effect statewide on Jan. 1, is being rolled it out in Racine, Kenosha and Walworth counties Tuesday to help work out any kinks, The Journal Times of Racine reported.

A federal requirement mandates that healthy adults with no dependents do some kind of work for 20 hours per week to continue receiving food stamps. Wisconsin used to have a waiver exempting it from the requirement, but the state eliminated the exemption in 2013.

The change will generally affect those between the ages of 18 and 49 who have no children in their home and who are physically able to work. People in that category account for about 2,000 of the nearly 17,000 Racine County residents in the FoodShare program.

About 62,700 Wisconsin residents are on food stamps. The non-partisan Legislative Fiscal Bureau estimated that half won't be able to meet the requirement and will be forced off FoodShare.

Racine County doesn't expect such a steep drop-off in FoodShare participants but is ready to help residents who can't fulfill the work requirement, said Jonathan Delagrave, the director of the county's Human Services Department.

## Wisconsin museum to honor Anishinaabe tribes

MADISON, Wis. (AP) – A state museum on Wisconsin’s far northern tip is planning to honor Anishinaabe culture.

Madeline Island Museum in La Pointe will host Anishinaabe Cultural Days on Sept. 27 and Sept. 28. The event is designed to commemorate the Treaty of 1854, which was signed in La Pointe and established the first Anishinaabe reservations in Wisconsin and stipulated tribal members’ right to hunt, gather and fish in the so-called ceded territory, a huge swath of northern Wisconsin the tribes handed over to the federal government.

The event will feature Anishinaabe music and art demonstrations, a treaty rights exhibit and films.

The Anishinnaabe are also known as the Ojibewe or the Chippewa.

## Wisconsin logger frees bear from milk can

RICE LAKE, Wis. (AP) – The video of a western Wisconsin logger who saved a black bear who got its head stuck in an old milk can is getting hundreds of thousands of YouTube hits.

Garrett Smith used the grappling hooks on his logging machine to free the struggling bear after spotting it in a cornfield while he was logging last month on a farm near Rice Lake. After consulting with the landowner who videotaped the rescue, Smith drove his machine out in the field. After a few attempts, he got its hooks around the milk can. The bear pulled his head out and bolted for the woods.

Smith figures there was something in the milk can that the bear was after.

## Catholic hospital asked to cut ties with doctor

LA CROSSE, Wis. (AP) – A La Crosse couple says they want a local Catholic hospital to sever ties with a doctor who they say performs abortions.

Leif and Karen Arvidson say Dr. Carl Rose advised them of the option of an abortion at a visit to Mayo Clinic Health System-Franciscan Healthcare in La Crosse in 2012. Karen Arvidson also says she was told later she could have an abortion at the Mayo Clinic in Rochester, Minnesota.

Franciscan Healthcare spokesman Rick Thiesse said Tuesday that Rose doesn't do abortions there.

The Mayo Clinic in Rochester, Minnesota, didn't directly respond to an inquiry about whether Rose performs abortions there.

Diocese of La Crosse guidelines say doctors cannot provide abortion services. Spokesman Jack Felsheim says there's no evidence that Rose violated those guidelines.

A message left at a home number listed in Rose's name was not immediately returned Tuesday.

## Injured woman sues deputy who ran stop sign

MILWAUKEE (AP) \_ A woman who broke her neck when a Milwaukee County sheriff's deputy ran a stop sign and slammed into her vehicle has filed a federal lawsuit against the deputy and several colleagues.

Tanya Weyker filed suit Tuesday against Deputy Joseph Quiles, Sheriff David Clarke and others. She says Quiles caused the collision, and his colleagues arrested her for drunken driving even though she had no alcohol in her system.

Surveillance video shows Quiles running a stop sign just before midnight on Feb. 20, 2013, and slamming into Weyker's vehicle. Weyker suffered multiple neck fractures and her passenger had a lacerated spleen.

A message left with the sheriff's department seeking comment from Quiles was not immediately returned. Department spokeswoman Fran McLaughlin says the lawsuit contains no evidence of the claims.

## Oregon man gets year in prison for tax evasion

MADISON, WI (AP) – An Oregon man who co-founded several self-help and personal development companies in Wisconsin was sentenced Tuesday to a year in prison for failing to file federal income tax returns.

Eric T. Plantenberg, 42, of Bend, Oregon, failed to pay taxes for 2006, 2007 and 2008, when he co-owned three companies based in Madison \_ Personal Freedom Development, Freedom Professional Services and I-Kinetic – and earned \$1.3 million, Wisconsin State Journal reported (http://bit.ly/TQZHYW).

“I made an epic mistake, and it's hard for me to verbalize,” Plantenberg said. “I grew up in an incredible family. I should have known better.”

His lawyer, Lawrence Brown, had asked for probation.

But U.S. District Judge Lynn Adelman said prison time was needed to deter others from taking part in tax scams.

Plantenberg had faced up to 2 1/2 years in prison, but Adelman noted he had no previous criminal history and had filed his tax returns regularly since 2008.

Assistant U.S. Attorney Timothy O'Shea said Plantenberg moved money through about a dozen accounts at about a dozen financial institutions to avoid paying taxes.

“This wasn't just bad judgment by a young man,” O'Shea said. “This was a crime.”

Plantenberg could owe close to \$1 million in taxes, penalties and interest once he files all his back returns, Brown said. He said Plantenberg and his wife are selling an Oregon beverage company to help pay off the debt.

# “Card Services” Robocalls Return with a New Hook

Madison, WI – It has been nearly two years since “Rachel from Cardholder Services” was Public Enemy No. 1. The automated robocalls using “Rachel’s” voice were an illegal nuisance, falsely promising consumers nationwide that they could lower the interest rates on their credit cards for a fee. Similar operations are still calling, and now they are using a local angle to entice Wisconsin consumers to pick up the phone.

“Consumers are reporting an increase in robocalls from ‘Card Services,’ ‘Cardholder Services,’ and similar callers that offer lower credit card interest rates,” said Sandy Chalmers, Trade and Consumer Protection Administrator. “In this latest round of calls, the consumers’ caller ID displays are showing the incoming call as almost identical to their own number.”

For example, a call to a resident at 555-555-5555 may show on the caller ID display as coming from 555-555-5570. The similarity in numbers is causing consumers to pick up the calls for three reasons:

- The calls appear to be local
- The similarity in numbers piques consumers’ interests
- Because the displayed number is similar in structure to a consumer’s own number, it may belong to another member of the community. That community member’s name may appear with the number on the caller ID display rather than a business or general name like “Card Services.”

“Criminals can use technology to make a caller ID system show whatever number or message they choose, so don’t trust the name or number on the display,” said Chalmers.

If you receive a robo-call about lowering your credit card rates, hang up immediately. Taking any action by pressing a key on your phone will likely lead to increased robocalls, regardless of what the automated message tells you. Also, remember that these calls are part of a scam. The “service” being advertised in the call cannot save you money. In most cases, the real goal of the call is to collect your number to sell to other scammers or to charge your credit card with phony fees.

# More adults learning to swim for 1st time

**MADISON, Wis. (AP)** ~ Just relax. Sometimes it's the hardest thing to tell anyone, particularly an adult. But getting a person to listen and learn about relaxing in the water can, literally, make the difference whether someone sinks or swims.

Summer is swim lesson time for kids, yet many organizations are targeting adults to get them in the pool to learn, too.

"It's a huge population of people who either want to learn swimming for fitness or a triathlon," said Katrina Caulfield, team leader for the swim program at UW Health's Sports Medicine Center. "Or they want to get into swimming because their kids are in swimming and they want to get in the water with their kids or grandkids."

In April, the Centers for Disease Control released a report about drowning deaths in the U.S. From 1999 to 2010,

an average of 3,868 people died of unintentional drowning each year. Death rates decreased over time for all age groups except ages 45-84. In the 45-84 age group, death rates increased nearly 10 percent.

In May, the American Red Cross launched a national campaign to reduce the drowning rate by targeting 50 U.S. cities that report the highest incidence of it. A survey conducted for the Red Cross reported that while 80 percent of people said they could swim, only 56 percent of them reported that they could do the basic skills needed to survive in the water. Those include swimming 25 yards, entering water above your head, then emerging and treading water for a minute.

In the Madison area, where lakes and rivers call to people on a regular basis, there are myriad opportunities for

adults to learn how to swim. They can take one-on-one lessons through UW Health or Madison Area Technical College. They can learn in group classes at a variety of places, including the three area YMCAs, at the West Side location of SwimWest, through Madison School and Community Recreation, or at community/school pools in Verona or Middleton.

"Some just never had the opportunity," said Becky Whiting, aquatic director at the Northeast YMCA. "They'll call me wanting to swim and say, 'Well, I've never taken lessons.' I say, 'Come on in.'"

Many didn't get the opportunity because they grew up in rural areas without a pool. Others latched onto other sports as a child and never swam much. In addition, many of the students are here from abroad for the university and never

learned back home.

For Swetha Gurajala, when she began to take lessons at the YMCA Northeast in Sun Prairie, it was the first time she'd ever been to a swimming pool. She had been to a beach but didn't know how to swim. There is less value placed on children being active in India than in the U.S., Gurajala said, so she never learned. But she wanted to exercise.

"For me, working out in a closed room is something I don't like," said Gurajala, who moved to Madison in September. "I like to be outside and I love water, so for me it was an easy way to exercise."

Marta Tzorin of Madison had tried to swim when she was a child, but it turned into a traumatic experience. She was in a lake, and tried to swim on her own despite not knowing how to.

"I almost died," she

told the Wisconsin State Journal. "I was always scared after that."

That isn't uncommon, swim instructors say. But, as the years go by people who can't swim feel left behind or they are in water-related situations in which they want to feel safe. Caulfield finds a theme with students who are over the age of 50.

"They're going to go on vacation with their grandkids, or they're going to be watching their grandkids over the summer and they want to get in the pool or lake with them," she said. "Part of it is safety, but part of it is because they feel they are missing out."

The fear is very real, but if would-be swimmers make the commitment to learn, they find a way to get over it. That's where the maturity and logic of being an adult kicks in.

"I was a little afraid the first time," Gurajala said. "But it's a swimming pool; it's only 3 feet. It's not going to hurt me."

Overcoming that fear, for adults, is mostly a matter of relaxing.

"As adults, they know it will be OK, but sometimes they still panic," Whiting said. "Adults can almost be more tense. To float, you have to relax. One woman, I worked with her for a long time. She really wanted to float but she was so afraid and always so stiff."

From there, the biggest challenge — as it is with kids — is teaching the rhythm of the breathing. First off, there's the tiny matter of sticking ones face in the water, followed by a pattern of inhaling above the water and exhaling into it.

"It seems simple, but to someone who isn't comfortable with the water, it's such a foreign feeling," Caulfield said.

With adult lessons, instructors ask students what it is they want to learn. There is no specific skill curriculum as there might be for kids'

lessons.

"A lot of adults just want to learn how to jump into deep water without freaking out," said Rachel Bird, pool manager for the Middleton-Cross Plains Area Indoor Pool. "I had a couple ladies who could float and tread water for a minute, but they had a fear of deep water."

Bird said the adult lessons at her pool are expanding. They had originally been designed for people who wanted to sharpen their skills for fitness or triathlon training, but staff kept getting calls from adult beginners.

One father came to the pool to sign up his daughter, and signed himself up, too.

"He didn't know how to swim and wanted to take her on a Florida vacation," Bird said.

Students do see progress, and vary in how quickly they pick it up.

"It was hard for me to float, and it just came to me on the second day," Gurajala said. "I could swim and float. It's because of the technique my teacher told me."

Yet Gurajala is envious of the stamina of the swimmers, many of them seniors, who she sees doing laps in the pool. It's her goal to be able to do that, too.

For Tzorin, success came with a jump into the deep end. At a class at YMCA West, Tzorin let others go ahead of her when they all practiced jumping in the deep end. Even with a belt with flotation devices around her waist, she hesitated time and time again. Finally, she jumped. And then quickly got out of the pool and did it again.

"The more I work with adults and kids, the more I learn they're really not that different," Caulfield said. "The fears are the same."

"Not everyone wants to be an Olympic swimmer," she said.

## Navajo Nation wildfire now 90% contained

**ALBUQUERQUE, N.M. (AP)** ~ A wildfire that has burned nearly 23 square miles of terrain on the Navajo Nation just east of the Arizona-New Mexico border is almost fully contained.

Fire officials say Assayii (UH'-saw-he) Lake Fire was 90 percent contained by Wednesday night.

Crews say they are securing the last of necessary fire lines around the southwest area of the

wildfire west of Long Lake.

They say passers-by will continue to see smoke as some spots within the fire area are still smoldering.

Authorities say anyone driving in the area should proceed slowly for firefighter and public safety.

The human-caused fire began June 13 and forced evacuations from the rural communities of Naschitti (NAZ'-chit-ee) and Sheep Springs.

## Cherokee citizen to be honored at White House

**TAHLEQUAH, Okla. (AP)** ~ Cherokee Nation citizen Daryl Legg of Sallisaw has been named a "Champion of Change" and will be honored during a ceremony at the White House.

Legg has gone from a three-time convicted felon to a college graduate and is now director of

the Cherokee Nation's vocational programs. The programs include one Legg started called "Coming Home" that helps former prisoners find jobs and housing.

Legg is one of 15 people who will be honored at the White on Monday with the "Champion of Change" award.

Treasurer’s Report...

The budget review process began on June 12, 2014. Meetings are scheduled in advance so specific departments know when it is their time to present their budgets to the Oneida Business Committee (OBC). Departments also make requests for Capital Improvements (CIP) and Capital Expenditures (CapX) during their designated meetings. Seven (7)

meetings have occurred since June 12 with an average attendance of 3.5 OBC members present at each session. Besides me, Councilman David “Fleet” Jordan is the only other OBC member to attend 100% of the budget meetings. This has been the lowest turnout of OBC participation in my six (6) years as Treasurer. This is unfortunate because without OBC participation the budget packet will not be ready to present to the GTC during the scheduled September 22, 2014 GTC Budget meeting. This speaks volumes to the dedication and commitment the current OBC has to balancing the budget. Currently adjustments need to be made to reconcile the \$25M budget deficit. If the current OBC makes the budget a priority than I am confident we will reconcile

the deficit and propose a balanced budget to the General Tribal Council (GTC) for FY 2015. If not the meeting will be delayed and we will not begin FY 2015 with an approved budget. This could potentially cause problems for some departments. There is a lot of work that goes into budget preparation. Each department must determine what their financial needs are as well as what they expect to spend on labor, equipment, supplies, maintenance, and large ticket items such as remodeling, major repairs, and upgrades to current systems such as fire suppression. All of this work takes an immense amount of time and planning. After the numbers are determined, each fund unit must enter the amounts into our computer system where the amounts are com-

pared by the Finance Department and a clear and concise budget is presented to the OBC. With the budget deficit it is necessary to make cuts. We have done all that we can to preserve jobs and services by implementing cost containment. Despite the negative comments made about cost containment it has been instrumental in helping us maintain our current level of employment. While most departments understand we must do more with less there are still those areas who think we have an endless supply of money and continually ask for increased jobs. These honored requests have contributed to our current budget deficit. The question has been asked why the OBC continues to approve these requests knowing they are contributing to the deficit. The answer is

simple some OBC members feel it is more important to allow certain areas to continue spending while others are required to go without. No matter how hard some of us fight against this we do not have enough votes to counter the situation. The budget process is very cumbersome and I recognize all the work that goes into each and every department’s budget. Some areas are not as familiar with the electronic component of the budget process and rely on Chad Wilson from the Environmental Department for assistance. This is an unusual request but Chad is always willing to help wherever he can. This type of dedication and commitment to the organization is impressive and deserves recognition. He exemplifies an employee who goes

above and beyond. With one budget meeting left before elections my hope is the current OBC will take the initiative to complete the jobs they were elected to and finish the budget. This may be wishful thinking and if it is, the new OBC will have a lot on their plate in the first few weeks in order to meet the GTC deadline. Councilman David Jordan, the Finance Department and I have done all that we can to prepare the budget appropriately. Now it is time for the rest of the OBC to step up and do their jobs. Thank you to everyone for trusting me as your Treasurer for the past six (6) years. It has been a great learning experience that I will keep with me always. Yaw’ko.

Shekoli Swakwek,  
I hope that you are all enjoying your summer and took time to enjoy the Annual Oneida Powwow. This event continues to bring our community together to celebrate Native American culture. The current Business Committee has worked diligently to update the laws and policies of the Oneida Tribe. The Legislative Operating Committee (LOC), which I serve as Vice-Chair, has successfully adopted 28 laws and 7 policies, making this one of the most successful terms as far as legislative development. I extend my gratitude to the Legislative Reference Office staff for supporting our efforts. The following are a short list of my current priorities:  
• **My Brother’s Keeper** – I have been asked by White House staff to participate in this National Policy Work

Group to promote more opportunities for disadvantaged young men. My role with this national initiative is to highlight the struggles of Native American men and to promote programs that Oneida can participate in.  
• **Youth Council** – We are in the development stages of supporting a Oneida Youth Council initiative to promote leadership skills and capacity building for our youth and young adults. We hope to continue to participate in this working group which brings various departments within the tribe together to strategize how we can work together to provide more leadership opportunities for our youth.  
• **Native American Mascot Issue** – The small amount of time we have been working with the mascot issue has opened doors and created opportunities to meet with high level federal staff to discuss issues that are important to the Oneida people such as health care, housing, and education.  
• Meetings with the Secretary of the Interior  
• Meetings with the Secretary of Education Susan White, Trust and Enrollment Director, has been working diligently on the Mascot issue repre-

sending the Oneida Tribe.  
• **Meetings with Congressional Representatives** – My office has been able to build relationships with federal officials and staff in order to ensure Oneida has a voice in federal issues that impact the tribe. As an example, I coordinated a meeting with WI State Representative Paul Ryan and the National Congress of American Indians to lobby for the 2014 Omnibus Bill. As a result of my participation this and additional meetings in Washington, D.C., the Omnibus Bill was passed and this resulted in an additional \$1.6 million dollars in federal funds returned to the Oneida Health Center budget in February 2014.  
• These funds restored the Contract Health dollars at the Oneida Health Center.  
• These dollars make it possible for enrolled Oneida members to be referred out of the Oneida Health Center for health services.  
• The contract health budget had been ceased from December 2013 to February 2014.  
• The direct communication between tribal leaders and federal policy mak-

ers were an important factor that helped to educate Congress regarding how the loss of federal dollars at the tribal level impacted the ability of tribes to provide services to their members.  
• It is important for Oneida to be at the table with federal leaders when issues are discussed so that the impacts felt by the nation are heard by those who are making the decisions. Participation in each of these issues helps to highlight and promote solutions to issues faced by the Oneida Nation. I would like to also extend congratulations out to the Class of 2014, whether it is head start, kindergarten, high school, or college I am very proud of all of our graduates, good luck in all your future endeavors and make Oneida proud! I would also like to congratulate the incoming Lil Miss, Jr. Miss and Miss Oneida. Good luck in your year representing the Oneida Nation. # Changes To Community Support Services Fund

This fund was amended through OBC Resolution #12-11-13-D and will go into effect March, 2014. Funds for this program are based on the Tribe's economic status.

Requests for assistance from the Community Support Services Fund must be the result of a **catastrophic event, illness or injury.**

The main changes include **elimination** of Stabilization Assistance (examples include shelter, auto repair, appliance repair/replacement, D.O.C. re-entry assistance, legal fees, home renovations to accommodate handicap access, student handicap access, basic eyewear/dental needs, or basic home medical equipment).

Other changes include:

**Eligibility Criteria:**

- Services are available only for enrolled members of the Oneida Tribe of Indians of Wisconsin.
- Services will cover catastrophic events, illness, or injuries only.

Services will assist with an emergency situation that poses an immediate risk to health, life or safety.

Requests for assistance must be made within thirty (30) business days from the catastrophic event, illness or injury.

Applicants must satisfactorily provide the program with required documentation and/or verification before funds can be released.

Application for assistance shall be made within a reasonable time period, not to exceed thirty (30) business days of a catastrophic event or illness or injury.

Applications made after thirty (30) business days of the event will not be considered.

**Priorities for Assistance:**

- Severity of event, illness or injury
- Life-threatening emergency requests
- Emergency medical travel

**Cost-Sharing:**

One of the other changes for the fund is the applicant will be required to pay a portion (cost-share) unless the person falls below the Federal Poverty Level limit. The Federal Poverty Level limit is used by Economic Support Services (Center for Self-Sufficiency) and determined by the Federal government.

The Amendment to the Community Support Services Fund requires Economic Support Services (Center for Self-Sufficiency) to set caps on the amount of assistance each person or household may receive, per event.

# Oneida Arts Program Dollars for Arts

**Application Deadline – Friday, July 25, 2014**

The Dollars for Arts Program (DAP) is a re-granting program funded by the Wisconsin Arts Board and the Oneida Tribe of Indians of Wisconsin. DAP provides funds to support excellence, innovations and the development of the arts in Oneida. The arts include both traditional and contemporary styles in dance, literature, music, theatre, and visual arts. There are three funding areas in DAP:

**Oneida Fellowship Award** - is a \$1,000 cash award to an Oneida artist for artistic excellence in the Oneida community. There is a maximum of one Fellowship available per fiscal year. If you have received a Fellowship from the Oneida Nation Arts Program in the last three years or received an Artist Development Award in the current fiscal year, you are not eligible for this award in fiscal 2014.

**Community Awards** - are available to community groups or tribal programs for arts projects that are new and innovative or significantly enhance an existing program in the Oneida community.

**Artist Development Awards** - are available to artists in the community who have identified a special project that will enhance their professional development and benefit the Oneida community.

The deadline for submitting grant applications is **Friday, July 25, 2014**, for activities occurring October 1, 2014, through September 30, 2015. Criminal Justice Professionals met with Leaders from Trucking Industry about Child Sex Trafficking

MADISON — Attorney General J.B. Van Hollen’s Crime Victims Council hosted a meeting today at the Radisson Hotel -- Menomonee Falls to engage the efforts of trucking companies and travel/truck plazas and their employees to join the fight against child sex trafficking. The meeting was organized by the Council in partnership with the U.S. Attorney’s Office -- Eastern District of Wisconsin, the Federal Bureau of Investigation (FBI) Milwaukee Field Office, and the national nonprofit group, Truckers Against Trafficking (TAT). Approximately 80 attendees, representing law enforcement, prosecutors, victim service agencies and Wisconsin trucking companies and truck stops, received information from local, state and federal law enforcement about human trafficking in Wisconsin.

“Members of the trucking industry are in a unique position to see and report child sex trafficking,” Attorney General Van Hollen said. “We are grateful to everyone who took time today to meet and discuss how we can work together to help children who are being trafficked.”

Kylla Leeburg, the Deputy Director of TAT, spoke to the group about opportunities for collaboration between law enforcement and the trucking industry to protect trafficked children.

Sex traffickers are known to take children to truck stops to solicit truckers. Leeburg described the impact the industry is having on the fight against human trafficking due to increased awareness about the plight of trafficked children. According to TAT, truckers rank 19th overall in the number of calls to the National Human Trafficking Hotline, operated by the National Human Trafficking Resource Center.

Representatives from the trucking industry were given information about how to report suspected human trafficking and resources for training owners and employees to spot and report human trafficking. Law enforcement and prosecutors received resources to improve the investigation and prosecution of human trafficking in Wisconsin.

The meeting was made possible through the financial support of the Department of Justice Children’s Justice Act Grant Program and Truckers Against Trafficking. The Radisson Hotel donated lunch for the event.

United States forward Chris Wondolowski has helped his team reach the knockout stage. About 300 Kiowa got together for a watch party to see the United States tie Portugal during group stage play, and many will

watch as the U.S. plays Belgium on Tuesday.

Wondolowski grew up in California, but he is connected to his people in southwest Oklahoma. His Kiowa name, Bau Daigh, is tattooed on his right rib cage.

The 2012 MVP of Major League Soccer was becoming increasingly popular well before the Cup. About 150 kids showed up to the tribe's first soccer camp last year, where the awards for excellence are called the “Wondo Awards.”
