## Danforth wins second term as Oneida’s chairwoman

Oneida Business Committee (OBC) Treasurer narrowly beat out Vice Chairman Greg Matson for Chairperson with 838 votes to 811 in the 2014 General Election for Oneida Business Committee.

This will be Danforth’s second term as chairwoman and sixth term overall on the OBC. She plans to spend the next three-year-term building Oneida’s relationships internally and externally.

“We need to be more visible and more proactive. We’ve spent a lot of

time over the years reacting and responding to things, and I don’t think that’s a good position for a tribe as big as ours to be in. We really need to be out ahead of things,” she said.

Danforth said she was motivated to seek the chair’s seat after being approached by other Oneida citizens.

“I had been lobbied well over a year to consider, even after I accepted my nomination for treasurer, people were still coming up to me and asking me ... even people I didn’t know, that’s what really surprised me,” she said.

Danforth said she

wants to improve the legal, economic governmental standpoints of Oneida.

“The resources of the tribe are at a delicate balance right now. We’re at a point where we can’t afford everything that we have given the revenue stream that we have,” she said. “There needs to be changes within the organizations to the effect of having more efficiencies with what we do and having a priority to that.”

Danforth thanked the community and is looking forward to working with the new OBC.

“I appreciate the support of the people who voted for me, and I appreciate the opportunity to serve again,” she said.

## 323 athletes travel to Saskatchewan for NAIG

The NAIG (North American Indigenous Games) started in 1990 hosted first in Edmonton, Alberta, and have continued to be hosted throughout the years in the United States and in Canada. The closest that the NAIG games were held in the states was in 2011 in Milwaukee and in 2006 over 10,000 athletes competed in the NAIG games held in

Denver, Colorado with over 1,000 tribal nations represented.

This year Team Wisconsin sent 323 athletes plus coaches and chaperones from all over Wisconsin after a long journey of many fundraisers, practice sessions and different inter-mural tournaments throughout the year. These youth could not have succeeded without the help from their tribal nations, communities and their family’s support.

Different competitive athletic categories include soccer, cross country, badminton, softball, lacrosse, archery, swimming, athletics, basketball, canoeing, kayak, golf, reckless shooting, wrestling, and volleyball.

Softball athlete Arianna Guerrero, was featured in a quick television interview spotlighting Team Wisconsin.

At the time of print for the Kalihwisaks, the Team Wisconsin 19U Girls Soccer won 2-1 against Team Manitoba;

Wrestler Rashawn Bell won his first two matches; and U16 Boys Basketball won against Team Saskatchewan, 71-54, with Griffin Summers as the lead scorer with 23 points.

Suffering close losses, the 14U Girls Basketball team, which included Oneida members Skylee Elm and Aundria Hackett, lost 40-41 to Team British Columbia and 29-32 to Team Alberta.

(6) medals - U16 Girls Basketball coached by Allen Grignon (Gold), Wrestling - Curtis Waupoose (Silver), Nick Metoxen (Silver) and Cameron Skenandore (Silver), Wrestling - Kyle Komanekin (Bronze) and Everett Menore (Bronze), and the U14 Girls Basketball won in a consolation game.

The U16 Boys Basketball team, coached by Jamison King, was set to play for the Gold medal against British Columbia.

If the U19 Boys Basketball wins their SemiFinal game against Manitoba, they will advance to take on Team Colorado.

Most retirees look forward to the days of relaxing and down time but most retirees aren’t Dewey Schanandore. Schanandore, 68, recently finished ninth in his age bracket at this spring’s Cellcom Marathon. “The gun went off. I started way in the back of the pack and I used (Olympic Gold medal winner) Billy Mills’ psychology of coming from behind and I did,” said Schanandore. Health and fitness have always been a priority in Schanandore’s life. “When I was raised on Menominee Reservation I would get up before everybody and the place was quite. I was running up the trail, down the trail. This started in grade school,” he said. Then in Schanandore’s

early 30’s health drove him to an even healthier lifestyle. “My father died from cancer. I became aware of high cancer rates and I did some basic research and I made a priority to prolong my life. I want others to know you can roll back the attack of all the diseases and aging. You don’t have to lose your youth and vitality,” he said. “You can’t imagine at 68 feeling 30-35 years old, that’s how I feel. I haven’t slowed down at all. That is so surprising to be able to get up every morning and do my daily training schedule.” Schanandore wakes up every day at 5 a.m. and after completing household tasks hit the pavement with a three or four mile run. “I then get something to eat and get on my bike. I come out to Oneida and the four sides of Green Bay. Then I really bear down so I can open up and feel the gears. At the

end of the day I’m terribly hungry,” he said. Schanandore estimates he puts on about 20 miles daily. Schanandore’s fitness quest has also put him in the right frame of mind for a healthier lifestyle and less stress. “Some people call it the loneliness of the runner. I just turn every concept of this world around. I plug into my music and the most important part is the spiritual essence of what the Creator gave us. I do a lot of meditating when I run and bike and I give thanks to the Creator, and I can’t thank that Guy enough. It takes my mind off the world around me,” Schanandore said. Schanandore hopes eventually he can win his age group and he also has his sights set on the New York City Marathon. “I just hope my health holds. I really want to raise awareness of Holistic healing and approach to life.”

For 20 years the United States Environmental Protection Agency (EPA), Tribal, state and local governments have used revitalization efforts at contaminated properties (brownfields) to promote redevelopment. Brownfields reuse is a proven smart growth approach to improve environmental health, community pride and economic development opportunities.

Owning this property is a step toward the Oneida Tribe implementing the "Vision Oneida" concept plan approved by the Business Committee on July 24, 2013.

#### Purchasing the Property

- 2006 originally listed for \$1.3 million dollars

- 2012 Tribe made an offer to purchase that was rejected

## Back to School Savings Tips

Summer may be in full swing, but fall will be here before you know it. That means back to school shopping is on its way. Have you budgeted for school supplies and new clothes yet? Here are a few tips to keep your back to school shopping from squeezing the family budget.

### Shop Smart

Sometimes quality trumps price. One example: backpacks. Spending a bit more upfront to purchase a good backpack will save you money in the long run, because the higher-quality item will last for years, whereas a cheaper one may need to be replaced in a matter of months. Clothes and shoes are on the other end of the spectrum, however. Children outgrow clothing so fast it doesn't make sense to spend extra money on brand names.

**Start looking for sales and coupons early**

Going back to school shopping last minute is a sure-fire way to spend more than you need to. Start going through that pile of "junk mail" flyers you get every week for school supplies you'll need. Spreading out the shopping over several weeks not only makes it easier on your budget, but is a good way to make sure you buy as many items as you can while they're on sale, rather than getting everything in one giant trip and only buying a few discounted items.

### Make a list and stick to it

Before hitting the stores, make sure you actually need everything on your list. Many items on teachers' supply lists for the year may be lying around your home office. Common items like scissors, rulers and simple calculators don't wear out enough in one year to justify buying new ones annually. The same rule applies to clothes. Go through the closet before deciding what needs to be replaced. Once you've narrowed down your shopping list to what you actually need, stick to it when you shop. Extra supplies and unlisted

items, while they may be popular with the kids, will probably never get used and just leave your pockets empty.

### Organize a back to school swap

Round up a couple of other families with kids the same gender as yours but different ages, and host an annual clothes swap. You can trade toys and books, too, for additional savings. Many schools that have uniforms organize this type of event, so be sure to check with the school office to see when and where the swap will take place, as well as the condition requirements for clothing to be swap-able.

### Have the kids help

You can use back to school shopping as an opportunity to teach your kids about budgeting and price comparing. Give teens a set budget for their items, and then go through their list with them to separate the "wants" from the "needs" before shopping. Have younger children participate by decorating plain binders, folders and notebooks (which are cheaper than character-decorated items) to personalize them.

## Invite extended to interested tribal members

NARF will hold its Executive Committee meeting in Oneida at the Radisson Hotel & Conference Center, on Thursday evening, July 31, 2014. Chairpersons and Presidents of the Wisconsin Tribes have been invited to attend the presentation on current activities that NARF is engaged in. The meeting is set to convene at 8 PM.

This invitation is also extended to interested tribal members to attend to learn about NARF's activities throughout Indian country.

The Native American Rights Fund (NARF) is the national Indian legal defense fund whose primary work centers on the preservation and protection of Indian rights and resources. NARF began its work in 1970 with a planning grant from the Ford Foundation and through the years has grown into a reputable and well-respected advocate of Indian interests.

One of the initial responsibilities of NARF's first Board of Directors was to develop priorities that would guide the organization in

its mission to preserve and enforce the legal rights of Native Americans. That Board developed five priorities that continue to lead NARF today:

- Protection of tribal existence
- Protection of tribal natural resources
- Promotion of Native American human rights
- Accountability of governments to Native Americans
- Development of Indian law and educating the public about Indian rights, laws, and issues

As his term as Chairman on the Native American Rights Fund Board of Directors comes to an end in 2014, Jerry Danforth, of Oneida, called attention to a startling shift in funding at NARF.

NARF was founded in 1970 through a grant from the Ford Foundation, and has relied heavily on institutional funding through-

out its history. At the NARF Board meeting last fall, the Development Director reported that gifts from tribes now comprised the single largest source of NARF funding.

"The shift is clear," he stated as he pointed to a recent study by Native Americans in Philanthropy (NAP) which suggest that over the last decade, funding for Indian Country from mainstream foundations has declined by 40%. He said, "This has affected NARF too, but more than 40 tribes have stepped up to fill NARF's gap in foundation funding. It is gratifying to receive support from the constituency we serve!"

"The need for NARF to serve those who are unable to afford legal counsel has never been greater," he added as he urges those in Indian Country to contribute financially to an organization whose main priority is to protect and preserve tribal existence.

# Patient Portal enables patients to view records from comfort of home

## New additions to your electronic health record

When the Electronic Health Record was first implemented two years ago, we explained that the record system would be implemented into various stages throughout the Division as it was developed.

We are now about to enter a new stage of the record called the Patient Portal which will happen within the next couple of months.

**What is a Patient Portal?**

The Patient Portal is essentially a part of your electronic health record which will allow you to access your record from where ever you are either from your smart phone, your I-pad, or Tablet or from your home computer.

As the patient, you will be able to access your record while sitting in your pajamas watching television from your living room. You will have the opportunity to take control of your health information.

The system will allow you access that is:

- Secure
- Efficient
- Convenient

You will be able to:

- View your medical chart
- Communicate with your health care team
- Review lab tests
- Order medication refills
- Check on your immunizations
- Verify your health care provider or doctor's instructions
- Ask your health care team a question

You will be provided with information on how to register to gain access to your Patient Portal as well as simple instructions on how and when to use the portal.

Eventually, you will also be able to verify

appointments and even request to schedule your appointments with your provider.

This process will become much more efficient, convenient and secure for you as a patient in working with your health care team! Dental, Optical, Physical Therapy, and other areas of the health division will be added at a later date which we will inform you of as it develops.

As your Oneida Comprehensive Health Division, we will keep you informed as this system gets closer to full implementation.

# Hand, Foot and Mouth Disease

Hand, Foot and Mouth disease is a contagious viral illness which occurs mostly from spring to fall. Children younger than 5 years of age are mostly effected, however anyone can get the disease. Symptoms usually start with fever, decreased appetite and sore throat. Painful sores can start in the mouth on the tongue and gums, which cause difficulty for a person to eat and drink. A skin rash can develop on the palms of the hands and soles of the feet which could also blister,

but won't itch. Since it is a viral illness, there is no treatment or cure, however treating the symptoms with Tylenol or Ibuprofen along with drinking enough fluids to avoid dehydration will help.

The hand, foot and mouth virus is found in the infected person's nose and throat secretions, fluid filled blisters and stool. The person who has the disease can spread it through close contact, coughing, sneezing, contact with stool (such as changing diapers), contact with the fluid filled blisters, and touching areas in which the virus is present.

People who have hand, foot and mouth disease are most contagious during their first week with the illness up to weeks after symptoms go away.

Prevention of the illness includes hand washing, avoiding touching your eyes, nose or mouth. Avoid close contact with people who are ill, disinfect frequently used items such as toys and don't share utensils or cups. If you do have questions regarding your or your child's symptoms, please contact your medical provider over the phone to discuss your concerns incase further medical care is needed.

# Loretta Says... In the Good Old Summer Time

Ongoing Column • Providing a connection to the past

I've been planning to write about Eleazor Williams for some time, now. He is very interesting and the person who is responsible for the Oneidas migration to Wisconsin. But some events came up recently that impact or could impact the Oneida Community immediately. Friday, July 18, a great number of Oneida youth boarded a bus in the evening at the Fitness Center to participate in the Indigenous Games in Saskatchewan, Canada. I was very disappointed to learn that there was no

send off—no Business Committee, no Communications, nor anyone from the Kalihwisaks present. Usually, there is a tobacco burning with prayers to wish our young athletes a safe journey and good luck in their individual events. Each and every one of them deserves to be highlighted in our paper.

Conversely, the Menominee Color Guard had all the flags flying, the Community was there and the Menominee Police accompanied the bus for a distance.

My understanding is that our Tribe, the Oneidas, did not support the coaches of these young people. A rhetorical question that surfaces

with me is: how can we be talking about being proud of who we are and at the same time ignore our young people who are going out there and giving everything they have to make us proud? Where was our Police Department which often talks about gang prevention but was not present for the send off? The maxim here is: an ounce of prevention is worth a pound of cure.

My hope is that the reception home from the Indigenous Games for our young athletes will be one humdinger of a celebration that we will all remember for a long time to come.

I attended the Pulaski Polka Days with my son,

granddaughter and her boyfriend last Sunday. The parade was about four miles long with four high school bands. That brought back memories of when I marched in the Seymour High School Band about sixty-four years ago. My great nephew was doing his part in the Seymour Band. There was every kind of farm equipment on exhibit, from huge brand new combines to ancient restored tractors.

I believe all the politicians running for some office took advantage of the crowd and displayed their names and intentions in bold format.

Of course, there were a number of military units represented—about twelve, I would say. They

came from all the surrounding towns and villages, except ours. I don't know why the Oneida veterans' organizations were not present. It could be that they were not invited or it could be that they were not interested. It seems to me that it would be good public relations to participate. Many of the older veterans rode on conveyances of one kind or another. Our veterans' participation would surely lend diversity to the affair. And I think we would be very cordially accepted. Among the thousands attending, we did see one Oneida member there thoroughly enjoying himself.

## EPA seeks proposals to protect Great Lakes

MILWAUKEE (AP)—The U.S. Environmental Protection Agency is seeking proposals for projects that help restore and protect the Great Lakes.

The EPA plans to award a total of \$27.5 million for up to 30 projects, which must involve work in the Great Lakes basin.

Those eligible to apply include states, municipalities, tribes, universities and nonprofit organizations. The EPA is specifically looking for projects that involve controlling invasive species, managing watersheds and reducing sediment.

The agency will hold a webinar Tuesday morning to explain the process for applying for grants.

## Get youth immunized against Meningococcal Meningitis

Meningococcal meningitis is a serious disease where a person can develop swelling around the brain or spinal cord, a severe blood infection, pneumonia or even die. The symptoms of this illness are extremely close to that of a viral illness, but progresses quickly and could cause death within 24 hours.

Symptoms include high fevers, severe headaches, stiff neck, confusion, vomiting, exhaustion and a rash. This disease if caught soon enough can still cause serious medical problems such as amputation of arms, legs, fingers or toes, neurological problems, deafness and kidney damage.

Anyone can get meningitis, however infants, teens, young adults and people 65 years and older

are at increased risk. The bacteria is spread through respiratory droplets and contact with respiratory secretions. Certain behaviors such as sharing utensils or drinking out of the same water bottle spread the illness between people. Along with being in close living conditions such as in dormitories, and summer camp facilitate the spread of the disease.

The best way to pre-

vent this disease is for children ages 11- 18 to get vaccinated with the Meningococcal vaccine. The first dose is recommended at 11 years of age with a booster dose at 16 years. This vaccine isn't required by the schools, but is highly encouraged to stop the spread of the disease. Please contact your medical health provider if you have further questions or concerns. The

### Update on petition

Dear Oneida Business Committee:

I submitted a petition Dec. 18, 2013 to reconsider the GTC's Dec. 15, 2014 action regarding dissolving the Oneida Seven Generations Corporation. It was my belief that the action of the GTC would cause irreparable harm to the Tribe and the assets of the corporation as it was proposed by the petitioner.

The Chairman also submitted a request to call a special GTC meeting for that same reason under his constitutional authority. He was also concerned about the GTC action causing financial harm to the Tribe.

I have since learned that the Chairman has withdrawn his request because he believes the GTC's motion can be carried out without detriment to the

Tribe's finances. When he withdrew his request, he stated that he had the ability to bring another request forward if it appeared that harm to the Tribe would occur in the process of dissolution.

Because of these statements and the Chair's ability to call a special GTC meeting if need arises, I have withdrawn my petition. It is my understanding that the Chair will protect the Tribe in regards to this action in consultation with the remainder of the Business

Committee and their greater knowledge of the dissolution process.

However, like the Chair, I still have the ability to bring forward a petition on this subject if I feel that one is needed to protect the Tribe. It is my opinion that this is not needed now. I thank everyone who signed the petition and who talked with me about it.

# Land use law update

On May 15, 2014, the Oneida Business Committee adopted the Public Use of Tribal Land Law and Public Use of Tribal Lands Schedule of Citations. This law goes into effect on Tuesday, July 15, 2014.

The law creates four categories of access to Tribal Lands and designates the Environmental Resource Board as the entity responsible for adopting a Land Access Map. The Map can be found on the Tribal Website at <https://oneidan.nsn.gov/Laws>. (Scroll down to Public Use of Land Law.) The four categories of Tribal Land Access are:

**Limited Access**  
**Definition:** open to all persons who are granted land access permission by the Tribe through a permit or lease for specified purposes. All lands are considered Limited Access unless otherwise designated.

**Examples:** none at this time.

**Requirement For Access:** Permit or Lease, issued by Division of Land Management.

## Oneida Community Access

**Definition:** open to Tribal members, and their spouses and descendants; members of other federally recognized Indian tribes, bands or communities; persons who are accompanied at

all times by a Tribal member, or the spouse or descendent of a Tribal member; or authorized employees of the Tribe.

**Examples:** Quarry Park, Osnúhsa? Lake, Where the Water Birds Nest, and Fox Tails

**Requirement For Access:** Tribal ID or Oneida Land Use ID, issued by the Enrollment Department. Oneida Land Use ID are only required if an individual is not accompanied by a Tribal member.

## Oneida Tribal Member Access

**Definition:** open to Tribal members only.

**Examples:** Coyote Run, Suamico River Headwater Wetland, Ray Road Natural Area, and Edge of the Woods.

**Requirement For Access:** Tribal ID, issued by the Enrollment Department.

## Open Access

**Definition:** generally open to all persons for the land’s designated use and enjoyment.

**Examples:** Sledding Hill, Oneida Buffalo Overlook, Duck Creek Trail

**Requirement For Access:** None

## ENFORCEMENT:

Failure to abide by the requirements may result in a citation issued by a Conservation Warden or Oneida Police Officer as outlined in the Public

Use of Tribal Lands Schedule of Citations.

Tribal ID cards and Oneida Land Use ID cards are issued by the Enrollment Department.

## Issuing Hours:

Monday through Friday 9:00 a.m. to 4:00 p.m. or by appointment.

## Cost:

\$3.50 – Tribal ID  
\$5.00 – Oneida Land Use ID

# ONCEC Offers PI5.09 HSED Option

The Oneida Nation Community Education has been authorized by the Wisconsin Department of Instruction (DPI) to provide the PI5.09 option of High School Equivalency Diploma (HSED). This comes at a critical time because the State has modified the requirements of this program. People that have started the PI5.09 HSED must complete it by September or start over with the new version.

This type of HSED is for individuals that would not be able to complete a traditional GED because they may have learning disabilities, attention deficit disorders, anxiety or other similar barriers. The PI5.09 offered at the Oneida Nation Community Education Center (ONCEC) is a project-based, almost paperless program, infused with Native

American values and materials. All assignments and project instructions (with the exception of math) are accessible on a jump-drive supplied by the ONCEC. Students submit their completed projects via email to their teacher and receive feedback as soon as possible. It is important to note that some assignments can be completed within an hour while others will take more than one day to complete.

The classes are self-paced so students can use the time they need to learn and, utilize the teachers and other resources at the Oneida Nation Community Education Center. Students complete their assignments within the CEC (unless they are working with a tutor from Adult Literacy of Brown or Kewaunee County). Students may also do some of their reading and research where ever they have internet access.

The ONCEC provides

access to the internet, email, and Microsoft Office programs that are necessary for completion of the courses. Students are strongly encouraged to complete all assignments on site and work directly with teachers in order to have access to the technology and receive accommodations when needed.

The staff at the ONCEC must assess and monitor student progress throughout the process. To recertify, the ONCEC will need to show the Department of Instruction the quality and success of this program. Factors that will impact this decision will include value provided to the participants, change in knowledge level and, number of participants that gain employment or go on to higher levels of education.

The ONCEC is operated by the Oneida Tribe but will provide PI5.09 HSED opportunities to any person that qualifies. More information call **(920) 496-5234**.

# The Power of Money - ONCEC Offers Financial Literacy Classes

Financial literacy is the level of understanding of how money works and how to grow money resources. Basic skills would include understanding the value of money, creating a budget, and money management. Smart management of money can greatly reduce stress and anxiety in a person’s life. At younger ages smaller amounts of money can be set aside to create greater reserves for when they are needed, such as in emergencies and in retirement.

The world is rapidly changing and people are living longer. Employers are shifting the burden of retirement saving back to their employees. Stock markets and other investments have become less certain with tons of conflicting view points from

business and political experts. In Indian County, the stakes are much higher. Some tribes have extremely limited resources and others have huge amounts of resources which are wasted because of limited financial expertise and financial education resources.

Beginning in August, Goodwill will be providing two new services to our community at the ONCEC. Each quarter they will hold a two-part workshop called The Power of Money. This workshop teaches proven techniques to understand the emotions of money, learn where your money is really going, and set achievable financial goals. This workshop has the power to change the way you think about money. The instructor, Dana Berger is Native American and is able to share financial education in a meaningful way to

our community. People that attend one of these workshops will leave with a plan to meet their short-term and long-term financial goals. The first workshop will be on August 20th and 27th at 4:45 pm – 6:15 pm.

The second service that will be offered is personal financial consultations. Each month, people will be able to sign up for one hour sessions with Dana or one of her partners. Normally, there is a charge for these services, but we will be able to provide them at no cost. These financial counseling sessions will be offered on August 27 from 12:30 pm -4:30pm. The one-on-one consultations are strictly by appointment only.

## Wisconsin DNR warns permit deadlines approaching

MADISON, Wis. (AP) ~ Wisconsin wildlife officials are warning hunters, trappers and sturgeon spearkers the application deadline for fall and winter season permits is approaching. Anyone planning to participate in fall turkey, bobcat, fisher, otter, wolf or upriver lakes sturgeon seasons must submit their permit applications by Aug. 1. People can buy applications through the DNR's online licensing center, authorized license agents or at DNR service centers. They also can call 1-877-LICENSE.

## US military award sent to girl stabbed 19 times

WAUKESHA, Wisconsin (AP) ~ A girl stabbed 19 times, allegedly by classmates trying to please a fictional online character, has received a military award from an anonymous donor. The girl's family had asked that well-wishers send her purple hearts, reflecting her favorite color and shape, and the 12-year-old was inundated with paper hearts from across the country. Then one person sent her the real thing. The girl's family said Tuesday that the medal came with a card that read: "The only heart I could find! Be strong!" The military awards the Purple Heart to veterans wounded or killed in action. Investigators say the girl nearly died in May after being lured to a park and attacked by two 12-year-old girls after a sleepover outside Milwaukee. She's now recovering at home.

## Wisconsin feed mill fire causes extensive damage

PULASKI, Wis. (AP) ~ A Green Bay-area fire chief says a livestock feed mill has sustained more than \$1 million in damages from a fire. The Pulaski Tri-County Fire Department chief tells Press-Gazette Media there were no reports of injuries at the Nutrition Service Co. grain processor fire near Pulaski on Monday. WLUK-TV reports at least 16 local agencies helped battle the flames from a soybean dryer. About 20 fire trucks from local agencies worked to extinguish the flames from early afternoon into the night.

WASHINGTON (AP) ~ President Barack Obama announced a major expansion of his initiative to improve the lives of boys and young men of color, with educators, star athletes, companies and foundations announcing partnerships to help minority boys in conjunction with his "My Brother's Keeper" program.

Obama, who first announced his initiative in February, said Monday they plan to continue to build support for the program around the nation to ensure those who are the most risk will get the help that they need.

"This is a movement that we're trying to build over the next year, five years, 10 years, so we can look back and say we were part of something that reversed some trends that we don't want to see," said Obama, who made the announcement at initiative at the Walker Jones Education Center in Washington, D.C.

Obama unveiled the "My Brother's Keeper" program at the White House in February. Under the initiative, businesses, foundations and community groups coordinate investments to come up with or support programs that help keep young people out of the criminal justice system and improve their access to higher education. Several foundations pledged at least \$200 million over five years to promote that goal.

Obama also signed a presidential memorandum creating a government-wide task force to evaluate the effectiveness of various approaches so that federal and

local governments, community groups and businesses will have best practices to follow.

Some of the commitments announced Monday include an effort by the National Basketball Association to recruit 25,000 new mentors and work with at-risk students to increase attendance and performance. AT&T is also announcing an \$18 million commitment to support mentoring and other education programs.

The Emerson Collective is committing \$50 million to collaborate with school districts and educators to launch a competition to find and develop the best designs for next generation high schools. The Emerson Collective was founded by Laurene Powell Jobs, wife of the late Apple founder Steve Jobs, along with partners from Silicon Valley.

Obama also said leaders of 60 of the nation's largest school systems have pledged to expand minority boys' access to better preschools and advanced classes and to try to prevent grade retention, suspensions and expulsions. The College Board is also investing over \$1.5 million all African-American, Latino, and Native American students with strong educational skills enroll in at least one advanced placement class before graduation.

Phi Beta Sigma, one of the nation's biggest black fraternities, also announced last week during its centennial celebration in Washington that it would train 10,000 men to become mentors.

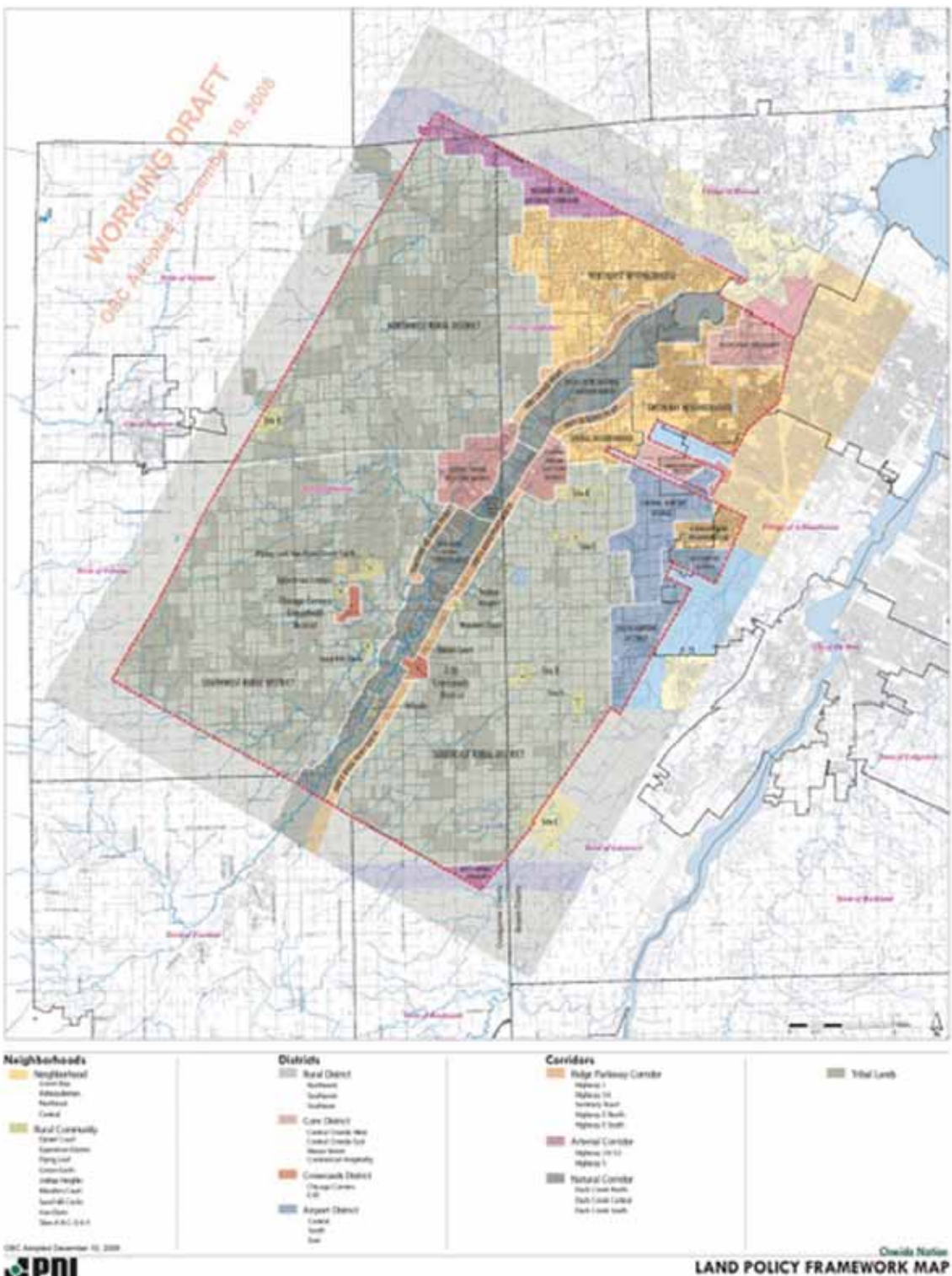
# 2008 Oneida Reservation Comprehensive Plan

## Land Policy Framework – Article 2 of a series on the Land Use plan element

### Submitted by Oneida Planning and Statistics Department

In review, article 1 was to create awareness that the Land Policy Framework is found in section 3 of the 2008 Oneida Reservation Comprehensive Plan (Comp Plan) that was approved by the Oneida Business Committee on December 10, 2008. The Land Policy Framework (LPF) is a working draft, meaning it would be tested by the Land Commission to make land use decisions based on requests for land use by all other plan elements, organization units or any individuals requesting land. The LPF includes desired uses of the places that make up our community and are intended to facilitate discussion. The LPF is flexible and not a strict regulatory tool. All land use decision-making guidelines coincide with community input to keep the rural character of the Reservation. The current natural resource management practice of the Tribe also carries out the wishes of the People, to protect Oneida's rural character. Recurring themes from the People include preserving and protecting natural resources by cleaning up polluted sites, establishing a national forest, protecting waterways and increasing hunting and fishing opportunities. In this year's update of the Comp Plan, the Land Use comprehensive plan element goal is to "Maintain a balance between the natural components and the built environment of our land". The Land Policy Framework includes a map illustrating types of places such as neighborhoods, districts and corridors of the Oneida Reservation, as well as, descriptions of desired uses and activities of each area. Some of the general uses

include areas for residential, commercial, industrial, institutional, recreational, agriculture, environmental preservation and conservation. Neighborhoods are mainly residential in nature, but may contain a number of supporting uses and activities that serve residents. Examples may include schools, parks, and/or small shops and restaurants. The LPF classifies neighborhoods as urban or rural. Urban neighborhood development and redevelopment should follow traditional neighborhood patterns and consist of a mix of housing types on ¼ acres or less, with access to small-scale, neighborhood retail and a variety of services including health, education, and social services. The urban neighborhood should have a variety of public open spaces (parks and green spaces) with storm water management, pedestrian streetscape (trees, lighting, benches), served by sewer and water services, and regular transit services. Rural neighborhoods should have an emphasis on the preservation of natural features and resources. They should allow for a variety of housing unit types and should consider the context of the site and be designed to enhance the character of the natural and physical environment including trees, water ways and topographical (contours, slopes, grade, and drainage) features. Districts generally focus on a special single use or purpose, such as agriculture, industrial, or commercial purposes, but may also contain a number of other uses and activities. For example, a shopping district may have primarily commercial uses with a few small-scale industrial uses mixed in. Corridors are linear edges and connectors of neighborhoods and districts such as roads, railways, rivers, or parkways. Corridors can be blocks



of undeveloped land that provide for viable populations of many species of plant and animal life. Corridors are most often associated with natural stream watersheds and much emphasis is placed on protecting Reservation environments and expanding opportunities for community members to hunt, fish, and recreate. As the Land Policy Framework evolves, the

boundaries can be amended or places may be added or deleted to reflect the current status of the Reservation. Our next article will focus on the process that is jointly used by the areas of Land Management, Environmental Health and Safety, Geographic Land Information Systems and Planning in concert with the many Land Use Laws, resolutions, compacts and ordinances

of the Tribe. Vice-Chairman’s Corner...

A Simple, Basic Plan. That’s what we need. I have been approach dozens of times over the last few months from Tribal members that have concerns about the actions, behavior and accountability of some of our elected officials. This is not out of the ordinary, it happens all over the country at different levels whether it’s Federal, State, or local politics we can see it on the news or the internet...but it should not be happening here. I have asked for action and improvement on many issues and topics and I get very little response. So, I just want to bring some thoughts to you and let you know that some elected officials are trying to put the people first ... In a good way

1. We need to increase clear, concise information to the membership as we increase our use in the social media area. I think we can improve communication between the BC and the membership with simple efforts. One thought is that this could be done by utilizing individual pages similar to

FaceBook or You tube on the members only site that is on the Oneida Tribes main webpage. The individuals participating would need to take ownership of statements or activities which would increase accountability and let the members get to know their BC members individually.

A “question of the day” could be formulated by members or staff and be addressed by the BC members on a regular basis which would again increase individual accountability. Currently there seems to be no clear way to hold individuals responsible for their individual behavior or actions. On a similar note there needs to be some accountability within the membership that can provide accountability for individual members that continue to focus on disruption or distortion of the facts. Our current system does not have a code of ethics for members. We can only encourage each other with our Core Values as Oneida People.

2. We should strengthen our economy by using our land in a more meaningful way. We can begin this by planting crops for human consumption. There is effort being done right now to get this started and followed through instead of just talking about it and sending out memos. By initiating this we will become ‘suppli-

ers’ instead of just consumers. This would also lead to more jobs instead of downsizing our workforce. A lot of jobs could be created in building the required infrastructure such as roads, drying areas, processing areas, housing, store fronts, etc. using workforce development dollars or grants for skill trades. This would also initiate a healthier diet for our children, our Elders, and our community. I disagree with the thought of downsizing ... I believe my job and responsibility as an elected official is to create opportunity for the membership to become employed not threaten lay-offs. I feel if we are not growing, we’re dying...and I like many others refuse to accept that as an option. With that said please let me encourage you all to help... it will take all of us to continue our growth. We can no longer wait for the problems to go away, we need to ALL improve our understanding of our responsibilities to each other and do it with a Good Mind.

3. Create our own customer base at areas of retail such as 29/32 center, by building apartments in these areas as well as establish new businesses that are focused on everyday needs, not cutting edge technology. There is opportunity to develop in so many areas such as food, consumer goods, and service providers

that would build a solid foundation for us to grow from, rather than relying on a limited revenue source that we are currently faced with. These efforts are also being worked out on various topics from various BC members, because that’s what we should do as elected officials.

4. Aggressively begin meaningful conversations with the Federal Government to transfer Jurisdictional oversight on entire Oneida Territory in regards to EPA standards, and DNR regulations by acquiring “Management Unit status” within our Reservation boundaries. This type of effort also needs to be done in providing mail service to the entire Reservation. This would result in jobs, a savings to the Federal Government, as well as improve jurisdiction. I bring this topic up each and every time I meet with Federal Representatives, because that’s my job.

5. Begin a solution formula to all Indian Housing insufficiencies by partnering with component building companies... training our own people, ... and buying in bulk with other Tribes. All infrastructure should be done with Higher Ed dollars or training dollars. Possibly allow the membership to invest with Per Cap dollars. Once a training crew is established it can become available to other tribes

throughout Indian Country and other areas that request service. Because that’s what Indian’s do... help and support each other, not undermine each other.

6. Build, or create partnerships with other tribes to start light manufacturing within the trade zone as well as assign a focus group (tribal) to develop a master plan of business in our business parks. Because that’s what Indians do...help and support each other, not undermine each other.

7. OBC NEEDS: restructure the GM position with a Financial Officer, a Strategist, and a Legal Counsel. This would be the barrier of day to day between the OBC and the Division Directors and it could also serve as the CDPC (community development planning committee). It would then be made up of individuals that understand the subjects being discussed as well as free up the BC to be more effective in their daily responsibilities....which is to Legislate, and Protect, the rights of the Oneida People.

8. Develop districts to better collect the voice of the Oneida people. Example: based on population, all BC members serve as district managers and meet once a month at places like OLC, County H Building , Civic Center, and Thornberry to listen to

the concerns of the members and bring those concerns to GTC twice per year. ( the annual and semi-annual meetings) Throughout the year the concerns could be vetted at the monthly meetings. The members that choose to collect a stipend would be paid that stipend at the semi-annual and the annual if they participate throughout the yearly meetings. Details need follow up. The goal would be to talk things out to the point of a solution, because that’s what we should do .... Solve issues not create more confusion due to the lack of communication.

9. There should be a way for members access to the BC members travel schedule. Example: Load up the individual BC members schedule for the following week on the web page. This would allow the members to know if the BC is in their area or where they can participate in meetings with their elected officials. The typical conference attended by BC members end around 4pm so their time could be spent with membership in the area. This will create accountability as well as better communication throughout the structure.

10. Create an immersion camp for language and culture with the ability to use Higher

I want to thank Shirley Hill and the entire Gaming Commission for the positive experience I had when attending their monthly meetings to keep me informed of the inner workings of the Casino and the Commission. The group

as a whole is to be commended for their fine work and I know they will continue this in the future.

My congratulations to the Director of the Head Start Program Joan Christnot and her staff for keeping the program at the forefront in activities for our children and pioneering new ways for keeping parents informed of their children’s progress in the program throughout the year. During my second year in office the Head Start Program was given an evaluation by the Office of Head Start personnel from Washington DC and Joan and her staff was given a rave review for their work. As part of this liaison duty I also had the opportunity to interact with the Head Start Policy Council on a monthly basis. Those parents and community members prove to be a vital part in making the Head Start Program what it is today.

My liaison duties with the Land Commission have been enlightening. By sitting in on their monthly meetings and acquisition meetings I have learned some of the complexities involved when determining the occupants for DREAM homes as well approving THRIL Loans for those who want to improve their homes. In this same light, a huge accomplishment by the commission was the lowering of interest rates for home owners this past term. Another aspect was the actual discussion of which homes or vacant land was available for purchase and the reasons why or why not the commission should buy the land and/or the home. Every one of the commissioners takes pride in their job to reacquire land that was part of our original reservation.

My dealings with ONCOA have been sparse as another BC Member, Melinda Danforth, usually attended their meetings. My one area I had contact with ONCOA over the past three years has been the Elder Christmas Party. I want to commend Florence Petri and her staff for making this annual event a success and a premier outing for our elders. I know this year due to cost containment the event has been delayed, but the BC finally did release the funds so this event can go forward and it will take place on Thursday,

August 8th.

Some of the committees I have been associated with these past years has been the Audit Committee, Community Development Planning Committee, and as a member of the Legislative Operating Committee.

My role with the Audit Committee was Vice-Chair and I have seen real progress in clearing up many audits that have come before us. Donna Christensen is a dedicated individual and long-time employee of the Tribe working in the Audit Department for most of her tenure. She and her staff are on top of their game when doing the investigation and compiling the findings for the BC to approve. During this term the Department and Committee closed out several high findings in the audits, something that has not been done in the past. I would also like to say a big thank you to Jim Skenandore, one of the community members who serve on the Audit Committee and he has proven to be a major asset.

The Community Development Planning Committee was tasked with making this reservation a better place for all of our members. Through various projects and programs the individuals involved showed their enthusiasm for the adoption of these projects. I know that I thanked them previously

but I would like to again say a big “thank you” to Michelle Mays, Layatalati Hill, Candace Skenandore, Lynn Franzmeier and Taniquelle Thurner for all their hard work.

The Legislative Reference Office was instrumental in providing superb analyses as well as well written drafts of new and revised legislation throughout this term. I was the sponsor of at least eight of these legislation projects and as evidenced in an earlier column think very highly of the staff in this office. They have shown they are an asset to our organization.

My hat goes off to the entire Gaming Division. Under the leadership of Louise Cornelius and her staff, the casino has consistently shown progress throughout the year in increased revenues and decreased spending. They are to be commended for the completion of the renovations and new design to the Main Casino and the West Mason Street facility. I know there were some pitfalls earlier in this project, but with perseverance they came through.

During this term I have worked with Michele Doxtator from Retail on several interests including the opening of the Larsen Road One Stop as well as the remodeling of the West Wind One Stop. Michele and her staff are to be commended for the hard work they have dis-

played in operating our retail locations as well as working with vendors to improve our bottom line in generating revenue for the Tribe.

I would also like to thank Larry Barton, Ralinda Ninham-Lamburies, Terry Cornelius and Rae Skenandore in the Finance Department for their hard work and dedication in providing current strategies and up-to-date information on the financial position of the Tribe. This team has given the BC an insight into where our money is coming from and where it is being spent throughout the nation. It has been with their expertise in handling finances that this Tribe continues to operate in a positive mode.

I am proud of the many accomplishments that have transpired in the past three years such as the opening of the Anna John Resident Centered Care Community facility; the purchase of a new facility for SEOTS; the improvement of Thornberry Golf Course through the hiring of an agent as well as releasing several of the board members who were not working for the betterment of the facility and the ultimate hiring of a new general manager; restructuring of the Radisson entity; and the passage of an employee

# Changes To Community Support Services Fund

This fund was amended through OBC Resolution #12-11-13-D and will go into effect March, 2014. Funds for this program are based on the Tribe's economic status.

Requests for assistance from the Community Support Services Fund must be the result of a **catastrophic event, illness or injury.**

The main changes include **elimination** of Stabilization Assistance (examples include shelter, auto repair, appliance repair/replacement, D.O.C. re-entry assistance, legal fees, home renovations to accommodate handicap access, student assistance, basic eyewear/dental needs, or basic home medical equipment).

Other changes include:

### Eligibility Criteria:

- Services are available only for enrolled members of the Oneida Tribe of Indians of Wisconsin.
- Services will cover catastrophic events, illness, or injuries only.

- Services will assist with an emergency situation that poses an immediate risk to health, life or safety.
  - Requests for assistance must be made within thirty (30) business days from the catastrophic event, illness or injury.
  - Applicants must satisfactorily provide the program with required documentation and/or verification before funds can be released.
  - Application for assistance shall be made within a reasonable time period, not to exceed thirty (30) business days of a catastrophic event or illness or injury.
- Applications made after thirty (30) business days of the event will not be considered.

### Priorities for Assistance:

- Severity of event, illness or injury
- Life-threatening emergency requests
- Emergency medical travel

### Cost-Sharing:

One of the other changes for the fund is

the applicant will be required to pay a portion (cost-share) unless the person falls below the Federal Poverty Level limit. The Federal Poverty Level limit is used by Economic Support Services (Center for Self-Sufficiency) and determined by the Federal government.

The Amendment to the Community Support Services Fund requires Economic Support Services (Center for Self-Sufficiency) to set caps on the amount of assistance each person or household may receive, per event.

I think a big problem we face is the loss of financial creativity and the focus on strengthening our Tribal member's ability to become self-sufficient. Some past

GTC directives that requires the Tribe to keep providing money to the membership in ways that do not create long term opportunity to the membership need to be reviewed and talked about with the GTC.

Our CFO, Larry Barton and his staff do a wonderful job of maintaining our dollars, they know how to keep them flowing but we cannot expect his staff or Louise King's talented staff throughout Gaming to fix our financial 'hiccups' that we bring upon ourselves. I heard sometimes if you take a real deep breath and hold it, you can get rid of the hiccups. Perhaps that is what we need to do, take a deep breath, followed by some

real good conversation without accusations and finished with some encouragement without discouragement and we will "get gooder" at recognizing how much we have to give thanks for and how much more we can give each other that doesn't have a dollar amount attached to it.

Remember we all have eight hours to work, eight to play, and eight to sleep everyday single day. Let's try to do that. For ourselves and for each other.
