Raise approved for staff earning \$65k+

Employees making \$65,000 or more were left out of the \$0.99 raise passed at the special General Tribal Council (GTC) meeting on June 1. That will change as the Budget Core Team reached an agreement on June 8 to include them in the pay increase.

A \$0.99 raise to all tribal employees making less than

Budget Core Team approved pay increase June 8

\$65,000 was proposed at the June 1 meeting. An amendment failed on the floor to include those earning more than \$65,000. The raise will start October 2, 2015.

The GTC passed raise will cost nearly \$5.7 million and affects about 2,600 employees while the new raise will add \$300,000 of cost for approximately 125 employees to the fiscal year 2016 budget. This is the second pay increase in four years that the GTC directed. In July of 2011 the GTC passed a \$0.75 raise

for all employees making less than \$60,000.

"All employees provide value to the Tribal organization, community, and Nation. Therefore, the Budget Core Team requests you to include the \$.99 per hour increase for employees who earn more than \$65,000; and where an increase is not already part of an employee's contract," said Treasurer Trish King in a June 8 email.

King hopes that even though the GTC did not include those employees

making more than \$65,000 that they will rally behind this decision.

"The Budget Core team encourages General Tribal Council to support the decision to plan the \$.99 per hour increase, in the FY 2016 budget, to those employees who earn over \$65,000. It is important to note that the Budget Core Team is continuing their work to adopt a wage compensation program," said King.

Art show puts focus on Native American art

Native American artists from all over Indian Country recently had the opportunity to showcase their wares from June 12-14 at the 2015 Woodland Indian Art Show & Market. The ninth annual event, held at the Radisson Hotel and Conference Center, featured a variety of activities including a collector's luncheon, the Oneida Smoke Dancers, a performance by Grammy Award winning Native American singer-songwriter Bill Miller, a silent auction, art

classes and an awards presentation.

Renowned Oneida Chef Arlie Doxtator's culinary expertise was on full display as he kicked off the three-day event by preparing a traditional Oneida meal for the collector's luncheon. The menu, which consisted of bison salad, roasted vegetables, white corn and dumplings, and dessert which featured maple flavored corn mush and corn shoots, was selected because of its cultural significance. "These are our foods and this is what I do," Doxtator said. "We say this is the path that is given to us, and if we accept that path then we

have the responsibility to do everything we can to stay on that path. I know what my path is, and this what I have to do."

Following the collector's luncheon, which also featured a speech by Ho-Chunk sculptor and University of Wisconsin-Madison professor emeritus Truman Lowe, guests in attendance were treated to a sneak peek of the Art Market. The Art Market displayed numerous paintings, sculptures, weavings, and other works produced by Native American artists from various woodland tribes. Rae Skenandore, president of the Woodland Indian Arts Board, said this is a distinct type of art-

work and it needs to be showcased. "All of this is really done to draw the public in to meet the artists so they can learn more about woodland Indian art," Skenandore said. "The criteria for artists to enter the show are it must be woodland Indian art, they must submit an application and photos of their work because they have to be juried into the competition, and they have to participate in the market."

Many of the artists with works on display at the

Canvassing to begin for smoke detector aid

The American Red Cross along with the Oneida Nation Emergency Management Office are teaming up to ensure homes on the reservation are properly protected against fires.

Saturday, June 20 teams will canvass the Oneida Reservation to prep community members for smoke alarm installation set for June 27.

"I have a list of homes that don't have hard wired fire suppression systems and we're going to hang flyers on doors letting them know

they can call or go online to sign up if they want a new smoke detector installed," said Kaylynn Gresham, Deputy Director Emergency Management for the tribe.

Along with smoke detectors teams will be testing batteries, and educating people on maintenance and operation instructions for smoke alarms.

"We will also be helping develop a safety plan with the families," said Gresham. "That safety plan helps everyone know what to do and where to go."

According to Gresham, four percent of homes without smoke alarms account for 40 percent of home fires.

"Smoke detectors can double someone's chances of surviving a fire. (Smoke detectors with non-working batteries) are a bigger concern than people realize," Gresham said.

The free smoke alarms will have five-year lithium batteries that can't be removed. If needed, additional smoke alarms can be added to a home.

Gresham is looking for volunteers to help canvass and notify community members of the planned smoke detector replacement. She is also looking for volunteers to do actual installs. If you are interested in helping you can register at https://volunteerconnection.redcross.org/?nd=form_4122

Installation volunteers are asked to be 18 years of age. "We're just really looking to reduce the number of deaths by fires and make the community more safe," said Gresham.

Radisson are often involved in art shows across the country. “I participate in art shows from here to Arizona and California,” Mick Escamea, an Oneida artist, said. “I’ve been to Hawaii and Puerto Rico, and I was pretty much the first artist to get set up here at the Oneida Casino back in 1993.” A lot of art works are a labor of love for the artists, Escamea said. For example, a memorial stone sculpt of Miracle, the revered white buffalo that gained national attention in the mid-1990s, took a full ten years for Escamea to complete. “I started working on it in 1996 and finished in 2006, so it took me quite a while,” Escamea said, “so this is

a memorial, and I told myself I wouldn’t let it go for anything less than \$5,000, so I’ll probably have it for a while.” By far the most popular piece of art on display at the show was a large copper buffalo constructed by Oneida artist Mark Fischer. Named Ancient Dignity, the work weighs approximately 1,000 pounds and is adorned with various tribal symbolisms. Fischer won the Best of Show prize of \$1,000 for Ancient Dignity, as well as the \$200 People’s Choice Award. Closing out the week-end events were the Oneida Hymn Singers along with the Oneida Youth Singers. Introduced by Music from Our Culture

Cultural Teacher Dylan Benton, the Youth Singers performed several traditional songs and dances, opening with the Rabbit Dance. They then sang three songs together with the Hymn Singers, with the youth singing in English and the Hymn Singers in Oneida, before concluding the show with a traditional Round Dance. 2016 will mark the 10th anniversary of the Woodland Indian Art Show & Market, and with all of the previous success the show has experienced, next year’s show promises to be the best yet. “We have something very special and spirited in the works for next year,” Skenandore said, “but for now we’re keeping it under wraps!”

OBC eventually supports youth LAX

The Oneida Business Committee (OBC) debated how to spend freed up funds at the Wednesday, June 10 OBC meeting.

Present: Chairwoman Tina Danforth, Vice-Chairwoman Melinda J. Danforth, Secretary Lisa Summers, Council members: Fawn Billie, Tehassi Hill, David Jordan, Jennifer Webster; Not Present: Treasurer Trish King

Vice Chairwoman Melinda Danforth asked that the OBC reallocate \$2900 to Oneida Community Lacrosse and \$4100 to be used towards a Rights of Passage initiative orga-

nized by Cultural Heritage. The funds come from the OBC's special projects budget which was budgeted for the Oneida Housing Authority's culture camp. The camp was canceled due to an employee shortage. Oneida Community Lacrosse, which organizes youth lacrosse teams, would use the funds for a planned trip to Wisconsin Dells.

Chairwoman Tina Danforth voiced opposition to the proposed spending as the proposals were unplanned.

"I'm not sure if we have special projects money, if it's appropriate to use it for just certain groups that are designated versus opening it up to whoever would like to

participate," said Chairwoman Danforth.

According to Secretary Lisa Summers, the funds for the lacrosse program would encourage community involvement and volunteerism.

"This is a really good demonstration of the collaborative effort that we've been seeking in the community between the tribe and community members and community operations and organizations, and really trying to help us bring back a sense of ownership into the things that we're doing in the community," she said.

After over 40 minutes of discussion, the OBC approved the \$2900 for the lacrosse program, but asked for a budget to be brought back for the

Rights of Passage initiative.

Councilman Brandon Stevens went over changes to the investigative leave policy which would include reducing how long an employee can be put on leave for investigations from 30 calendar days to 15. However, the item was deferred to the next OBC meeting in response to an email asking for language changes regarding allowing employees to get a copy of the investigation.

The OBC approved the creation of an administrative court with an action plan to be brought back in 60 days.

"We would consolidate many of the hearing authorities into the judiciary," said Stevens.

Case of bacterial meningitis confirmed in Milwaukee

MILWAUKEE (AP) ~ The City of Milwaukee Health Department says Milwaukee has a confirmed case of bacterial meningitis.

Officials on Monday would not say the gender or age of the patient. But officials say the person was diagnosed at a hospital in the Milwaukee area “and is receiving appropriate care.”

The Milwaukee Journal Sentinel (http://bit.ly/1R1BITr) reports the health department has identified close contacts to the patients and has provided medical resources, including antibiotics.

The disease is spread through the exchange of respiratory and throat secretions, most often through direct, close contact with an infected patient. Close contact would include kissing, sharing a drink or lip balm and eating with the same utensils.

Symptoms include a rapidly developing fever, headache and stiff neck. Bacterial meningitis can be treated with antibiotics.

What do I need to develop a budget?

What should be included in a budget?

You will include your necessities like food, and living expenses. Your expenses may include

rent, groceries, utilities, and perhaps vehicle expenses. In addition, you should include savings as a necessity. After your necessities are budgeted you can include personal purchases like clothing and entertainment.

Generally rent can be as little as \$500 to \$700 and utilities \$120, groceries \$400, savings should be a minimum of \$50, and miscellaneous expenses \$200. Conservatively you should budget \$1,270 monthly.

I want to buy a car!

There’s a lot of excitement brewing when you anticipate your first major vehicle purchase. So you want a nice shiny new car with big tires and shiny rims and a fine

looking paint job. But is that what you need? Can you afford it? Have you included the cost of insurance? Have you thought about gas and maintenance?

What about insurance? Insurance on a vehicle that is about 10 years old and is classified as automobile can average \$120 per month. A newer vehicle or high performance vehicle can be double that. Men can plan on paying more for insurance than women in most cases.

What about gas and maintenance? Cost of an oil change averages \$30-\$40. Filling up your gas tank can be \$40 - \$75 depending upon the size of your tank. How long will a tank of gas last? If you are lucky, a tank of gas will last a week.

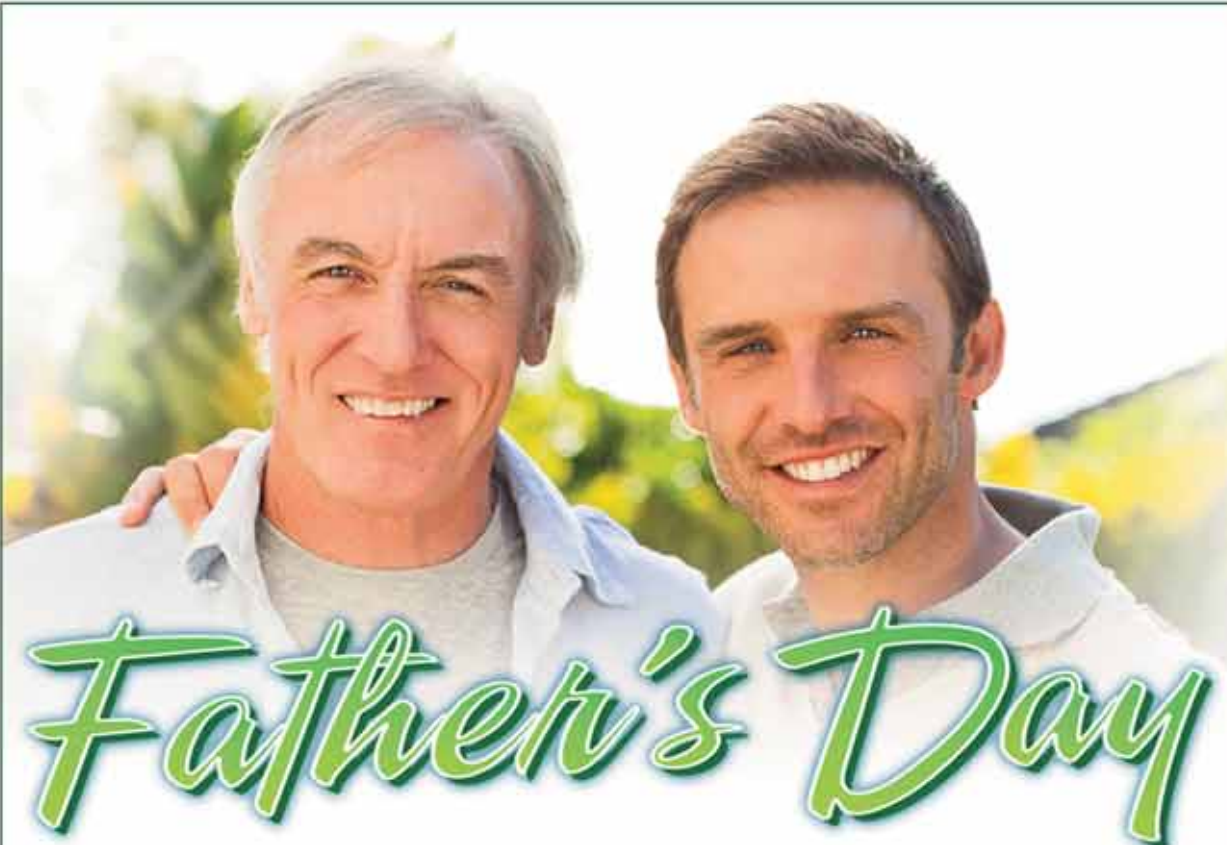

- Reduce Child Heatstroke Deaths by Remembering to ACT:**
- Avoid heatstroke-related injury and death by NEVER leaving your child alone in a car, not even for a minute. And make sure to keep your car locked when you're not in it so kids don't get in on their own.
 - Create reminders by putting something in the back of your car next to your child such as a diaper bag, purse or a cell phone that is needed at your final destination. This is especially important if you're not following your normal routine.
 - Take action. If you see a child alone in a car, call 911. Emergency personnel want you to call. They are trained to respond to these situations. One call could save a life.

- Is the leading cause of non-crash, vehicle-related deaths for children
 - On average, 38 children die in hot cars each year from heat-related deaths.
 - Young children are particularly at risk, as their bodies heat up three to five times faster than an adult's
 - On average during the summer months, the temperature rises in a vehicle 19 degrees F in 10 minutes, 29 degrees F after 20 minutes, and cracking a window has little effect on cooling the vehicle.
 - Studies show vehicle heatstroke deaths are due to the following circumstances: 53 % child "forgotten" by caregiver, 29% child playing in an unattended vehicle, 17% child was intentionally left in vehicle by adult, 1% circumstances were unknown.

Oneida Trust Scholarship

THE PURPOSE of the Oneida Higher Education Trust Scholarship Fund is to establish a trust resource that provides financial aid scholarships to assist with higher education financial needs not being met by tribal contribution, and to assist eligible enrolled Oneida Tribal members in securing higher educational opportunities based on established criteria.

1. Eligibility

Requirements:

- Be an enrolled member of the Oneida Tribe of Indians of Wisconsin.
- Have a high school diploma or equivalency.
- Applicants shall be seeking post-secondary acceptance/opportunities through required pre-requisite accredited classes, post-graduate preparation, preparatory/examinations, or related preparatory courses.
- Applicants must be in good standing with the Oneida Higher

Education Department and abide by the Departments established guidelines.

- Applicants who are in default with previous student loans will not be eligible to receive this scholarship fund until all accounts have been remedied with proper documentation.
- Applications completed after the class(es)/term/examination ends are not eligible.

2. Application Requirements:

- Oneida Trust Scholarship Application.
- A letter of intent, explaining career goal(s) and how Oneida Trust Scholarship funds will assist you in meeting your goals.
- A copy of your most recent "transcript" of grades.
- A copy of detailed information confirming official costs.

3. Funding Details:

- Lifetime Trust Scholarship up to \$3,000. Applicants who received prior assistance shall have that amount applied against the lifetime amount.
- Individual students may not receive funding a subsequent time for the same pre-requisite classes, post-graduate preparatory/examination fees, or related preparatory course they previously received funding for.
- Scholarships will be processed in the order the Department receives a completed

application and shall be subject to the availability of funds.

- Approved scholarship awards will be sent directly to the school/provider or to the student if reimbursement applies. Checks may be sent to the student to accommodate their applications.
 - The final decision to make an award is the responsibility of the Department.
 - Any applicant denied has the right to appeal, see ONEIDA TRUST FUND POLICY; article VI for the appeal process.
 - Upon completion of your class(es), examination, etc., you are required to submit verification that you completed the activity for which the Trust Scholarship was intended.
 - The Oneida Trust/Enrollment Committee respectfully requests that all recipients of the Oneida Trust Scholarship keep in mind the prospect of returning to the Oneida Tribe to share their acquired knowledge, experience, and education. (Oneida Trust Scholarship Fund Policy Amendment-BC-12-11-13-E)

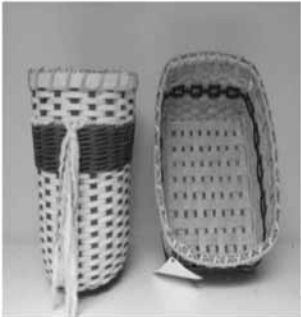

Harvard bound Cornelius tours OCHC

The Oneida Community Health Center (OCHC) is once again helping pave the road to success for young medical students and professionals. Racheal Cornelius, 21, a Harvard College pre-med student, recently had the opportunity to shadow several members of the OCHC medical staff at the facility as she prepared for her senior year of college.

One of six siblings, Cornelius grew up in Orlando, Fla., and first gained an interest in the medical field during her formative years. “I was originally interested in science, and as I got more into it, I began having more and more experiences with family members and other people’s health issues,” Cornelius said, “I started to get a better understanding of the world and saw how much suffering there is, particularly in minority communities, and how little health care there actually is in these communities. This was when I realized I really want to become a medical care provider in a way that helps relieve that suffering and to really serve the underserved.”

During her two-week stay in the Oneida community, Cornelius had the opportunity to meet and visit numerous people, attended barbeques, and even played kickball with children. “It was so adorable,” Cornelius said, “It turned into a boys versus girls game, and the girls were winning. Then the parents kept trying to tell them the game was over, but the boys weren’t having any part of it, they were going to keep playing until they won.”

While at the OCHC, Cornelius shadowed a variety of the health care providers. “While I worked primarily with Dr. Vir, I also worked with Tim Moureau, Dr. Flood, Dr. Wells, Dr. Kinnard and Dr. Eberhardy,” Cornelius said. “In terms of their patient care they all have their own ways of going about it, but the biggest thing that they all seem to share is that they all really care about their patients.”

Becoming a primary care physician in the

areas of pediatrics and internal medicine are her career goals, Cornelius said. “I want to take care of a variety of patients including children, adults and elders. I want to become as good of a physician as I possibly can to help relieve suffering as best I can to the best of my ability.”

Her upcoming senior year of college is going to be very challenging, Cornelius said. She will be required to write her senior thesis, and part of that thesis requires she conduct research the summer prior to returning for her senior year. “In addition to my senior thesis, I will also be taking my Medical College Admission Test (MCAT) and applying to various medical schools,” Cornelius said. “Hopefully I get accepted. Harvard Medical School is my goal, so I’m keeping my fingers crossed.”

Before entering the rigors of medical school, however, Cornelius plans to take a year off. “I haven’t decided yet what I’m going to be doing in that time frame,” Cornelius said. “I may pursue my master’s degree in public health or education, or just go dabble in something else, I’m not really sure yet.”

While she still has more challenges to face before she can fully realize her dream of becoming a primary care physician, Cornelius says her experience at the OCHC has been a positive one. “I want to thank everybody I’ve met, they’ve been absolutely amazing,” Cornelius said. “Everybody has been exceptionally generous and made me feel so welcome like Debbie Danforth and Norbert Hill who helped organize all of this, Dr. Vir, and all of the people who let me shadow them as well as all of the people who opened their homes to me. But mostly I want to thank my parents who have always been there for me and have always been supportive of me. I couldn’t be doing any of this if it weren’t for them.”

A 2012 graduate of Lake Highland Prep High School in Orlando, Cornelius is the daughter of Rex and Linda Cornelius, also of Orlando, and granddaughter of the late Carl Cornelius, of Oneida.

Operation Service with a Smile

Community Interviews: Part I



This series of articles is designed to inform Oneida citizens about enrollment issues. The total number of Oneida enrolled members is

expected to decline within the next 10 years. The goal of these articles is to generate community conversations about citizenship and belonging so that we may explore our options.

Sustain Oneida is conducting an ongoing series of community interviews. Oneida citizens, tribal council members,

and youth groups shared their ideas about community, engagement and enrollment. To maintain anonymity, responses are grouped together.

1. What does community engagement mean to you?
“Depends on what part of the tribe, employee or member. For a certain amount of time each year I am engaged as a full-time employee.”

“I think about the seven generations. Only I see us as being in the middle so we look back three generations and look forward three generations. Connection to the land is a big part. We don’t have much of a connection to the New York Oneida, they are seen as the past. For me, being Oneida is being Haudeneshonee; there is no separation of the three Oneida reservations.”

“We are getting into a system to capture our voices. The voice of both employees and non-employees. We didn’t have a 75 person quorum at GTC (General Tribal Council) meetings for years, but now we have many people showing up because of the \$100 incentive. Is this good or bad for engagement? Is it worth all this money to hold a meeting? There is an entitlement mentality to engagement. That’s a white person’s system.”

“We’re so busy trying to be second class white people that we forgot how to be Indian. People get offended by that, but it gets at the psychological.”

2. What is a time you felt engaged in the Oneida community?
“When I go to powwows, Move It Oneida, Sexual Assault Awareness Event.” “When I go to ceremonies, dancing, going to the Wise Women Gathering Place.” “When I got my Oneida name at Longhouse.” “When they used to have the carnival behind the Norbert Hill Center.” “Going to powwow.” “Picking strawberries.” “School tapping maple trees.” “Hunting for elders.” “Wise Women.” “Domestic violence walk.” “Zumba.” “Fry bread.” “Corn soup.” “Races.”

“Being involved is just a way of being. Living in Milwaukee it’s different because there’s a lot of

different Native people. Some days I’m doing Oneida things and other days doing bigger Native stuff. I made a career change because I wanted to provide more direct services to people. For me that engagement is one-on-one with people.”

3. What is a time you felt you did not belong in the Oneida community?
“I don’t have a clan (my mom is a west coast tribe, not Oneida) so I don’t know where to sit at longhouse. We sit with the wolf even though we are not wolf clan.”
“They teach Spanish and Hmong at our high school but not Oneida. Wish we could take it there.” “When I don’t know tribal government stuff.” “When I try to think of an Oneida word and only Spanish words come to my mind. Because that’s the language we are taking at school the most.” “When I couldn’t compete in powwow because I’m not enrolled.” “I’m a different tribe (Osage/Ponca) so I feel different.”

4. How much would you say you are engaged with the Oneida tribe? / What do you do to stay engaged with the Oneida tribe?

“When I can carry on my grandparents last name.” “When I know community events going on like the powwow at UW-GB.” “When you can introduce yourself and say hello in Oneida.” “When you can teach someone something about your culture.” “When I can hear the powwow drums from my house.”

“I see the bigger picture, I am an Oneida national. That keeps me engaged.”

“People may go visit other reservations but not be active here. I always ask people, ‘What do you

want’? It’s a hard question and people get tired of it and say, “Just gimme something!” Engagement is key to every community. With Sustain Oneida what are you trying to sustain? What do you want? Are we a community or a corporation? Which comes first in our efforts? We need to get people to understand this. We need to separate the corporate from the community.”

“I don’t look at the tribe as the res. I look at the tribe as the people. This is one of the evolutions of my thinking. I see beyond the res. Take care of people even if they live off the res. There are three different Oneida tribes. Historically we are one. We should move toward that. Some say we are already one and some say we’re separate. I say, “Oneida is my home, but I’m from Milwaukee.” I miss home. In an ideal world I would live in Oneida.”

“There’s many levels to [staying engaged]. On the personal level, I am educating my boys about what it means to be Oneida since they won’t grow up on the res. Getting them involved culturally; learning the language, music. On a work level I try to build bridges between Milwaukee and Oneida. People say, “I’m a Milwaukee Oneida” or “I’m an urban Indian.” But we are all Oneida.”

Wisconsin Indian tribes developing tourism show

MADISON, Wis. (AP) ~ The head of tourism for Wisconsin's 11 American Indian tribes is trying to develop a series of TV shows that will highlight the reservations as attractive places to visit.

Ernie Stevens is executive director of Native American Tourism of Wisconsin. Stevens is shooting video of the reservations' lakes and rivers, festivals and more. He says the organization is putting together a pilot program that he hopes will lead to addi-

tional shows. Wisconsin Public Radio (http://bit.ly/1LERXz3) says the tourism group is trying to raise \$25,000 by early August to launch the project.

Wisconsin has the largest number of Native American tribes east of the Mississippi River. Their reservations include more than one-half million acres.

Green Bay to consider allowing food trucks on city streets

GREEN BAY, Wis. (AP) ~ City leaders in Green Bay are set to consider allowing food trucks to operate on city streets.

Press-Gazette Media (http://gbpg.net/1IEw4C) reports an ordinance that would let food trucks operate almost 24 hours a day, seven days a week is scheduled to go before the city's Common Council on Tuesday. A first vote on it is set to take place.

Green Bay currently all but prohibits food trucks

and trailers from operating, with the exception of doing so on private property. City officials say they would like to see more food trucks in the city as they try to draw people downtown.

The ordinance would also add new regulations for food trucks, including barring them from parking within 150 feet of restaurants.

Baldwin aims to reduce VA narcotic prescriptions, deaths

MADISON, Wis. (AP) ~ Democratic U.S. Sen. Tammy Baldwin has introduced a bill that would reduce the prescription of narcotics in Department of Veterans Affairs hospitals.

Baldwin said Tuesday that the measure could prevent possible deaths from narcotic over-prescribing practices like those reported at a VA medical center in Tomah. Baldwin named the bill after 39-year-old Marine Jason Simcakoski who died of mixed-drug tox-

city in the hospital's inpatient intensive care unit in August. Multiple probes into the facility are ongoing.

The bill would also broaden the use of complementary pain-relief services like yoga and massage. It would further require increased training and education for doctors who prescribe narcotics.

Republican Sen. Ron Johnson says he hasn't seen the bill, but has worked with Wisconsin legislators to push for change in the VA system.

West Nile virus case confirmed in Jefferson County

JEFFERSON, Wis. (AP) ~ Health officials say a dead bird has tested positive for West Nile virus in Jefferson County.

It's the first reported case since the county began tracking the virus last month. The virus is transmitted by a bite from an infected mosquito. Health officials say you can cut your risk of an infection by getting rid of standing water on

your property and using mosquito repellant.

The Wisconsin Department of Health Services says an estimated 80 percent of people infected with the virus never experience symptoms. Most of the remaining 20 percent will develop symptoms such as fever, headache, muscle pain, a skin rash, swollen lymph nodes and sensitivity to

Oneida Tribe Appoints New Managing Agent to Oneida Seven Generation Corporation

The Oneida Business Committee took action to contract King Solutions, LLC as the Managing Agent for the Oneida Seven Generation Corporation. Pete King III, CEO of King Solutions, a former project manager for Oneida Seven Generations Corporation, was instrumental in the successful development of various commercial real estate projects within OSGC, which include Badger Sheet Metal, Bellin Health, and Schneider National.

December 15, 2013 the

General Tribal Council voted to dissolve the Oneida Seven Generation Corporation (OSGC) in a special meeting. Sagestone Management LLC was tasked by the Oneida Business Committee with closing down OSGC in a financially efficient manner in order to protect the assets of the corporation; this was anticipated to take a short time. The litigation has precluded making any changes to OSGC until such time as the dismissal of OSGC and the Tribe from that lawsuit

has been through any final appeal. The Oneida Business Committee is determined to refocus OSGC intent, which is to concentrate on real estate development and leasing, and believed this effort would be best achieved under the leadership of King Solutions, LLC. Since early 2014, Sagestone Management LLC has been the Managing Agent of OSGC. King Solutions, LLC will be the Managing Agent for OSGC effective June 2, 2015, and the change will have no impact on cur-

rent business partners of OSGC.

Secretary Lisa Summers encourages feedback from the members. "With this move we hope to provide information and clarification to our stakeholders in a more pro-active manner. Our goal in this action is to strengthen and promote the growth of the revenue-generating businesses as well as protect and preserve partnerships we value," said Summers.

Minnesota PUC approves certificate of need for pipeline

ST. PAUL, Minn. (AP) ~ Minnesota regulators approved a certificate of need Friday for the proposed Sandpiper pipeline from North Dakota's Bakken oil fields to Superior, Wisconsin, but will hold separate proceedings on exactly which path it should take across northern Minnesota.

While the Public Utilities Commission agreed 5-0 that the \$2.6 billion, 610-mile pipeline is necessary and in the public interest, commissioners didn't foreclose the possibility of rerouting it away from environmentally sensitive lakes, streams and wetlands. Enbridge Energy will still have to go through a lengthy review of its proposed route and a proposed alternative for part of the route that avoids some lakes and wetlands.

Calgary, Alberta-based Enbridge argued that Sandpiper is needed to move the growing supply of North Dakota crude safely and efficiently to market. The company said it would also ease rail congestion and create about 1,500 construction jobs.

But environmentalists and tribal groups said the risk of leaks is too high, including where the route would run through the headwaters of the Mississippi River.

"The commissioners put the needs and profits of a private, foreign company ahead of Minnesota's pristine, historically and economically valuable headwaters of the Mississippi," said

Richard Smith, a founder of Friends of the Headwaters, which pushed for a more southern route.

The PUC added requirements for the environmental review of the pipeline's route, including a study of the cumulative impacts of both the Sandpiper and Enbridge's proposal to replace its aging Line 3, which carries oil from Alberta's tar sands region to its terminal in Superior, and run the replacement pipeline partly along the Sandpiper route.

North Dakota regulators have already approved Sandpiper.

The Mille Lacs and White Earth Ojibwe bands held their own hearings against Sandpiper on their reservations this week. The tribes said they felt shut out of a decision that affects sensitive watersheds where they hold treaty rights to hunt, fish and gather wild rice.

The PUC decision came a day before a planned march by climate change activists from the St. Paul riverfront to the State Capitol for a rally that they say will draw thousands of people.

The "Tar Sands Resistance March" aims to keep Canadian crude in the ground instead of piping it across the state via an expanded Alberta Clipper pipeline. Organizers including the Sierra Club and 350.org say tar sands oil is especially dirty because more fuel must be burned to extract it than other forms of oil, so more carbon dioxide is produced in the process, aggravating climate change.

SD Indian tribe to begin selling recreational pot by Jan. 1

FLANDREAU, S.D. (AP) ~ An Indian tribe in eastern South Dakota plans to start selling marijuana for recreational and medicinal purposes by Jan. 1, becoming the first tribe in the state to legalize the sale of cannabis across its whole territory.

Leaders of the Flandreau Santee Sioux Tribe said Tuesday that marijuana will be cultivated and sold at a single, indoor site on the reservation, after the tribe's council last week approved it to be grown and sold on tribal land. That follows a federal decision last year that gave tribes the power to grow and sell pot under some conditions.

"It looks like it's getting a lot of momentum," tribal president Anthony Reider said. "The more we dug into it we realized that for us to be able to get ahead of it and get into it early would be a good thing."

While some tribes view marijuana as an economic opportunity, others fear it could lead to negative public safety and health consequences. A district within the Pine Ridge Indian Reservation in western South Dakota legalized the use and cultivation of marijuana this year, but has made no further plans. The tribal council on Pine Ridge - which is in dire need of economic opportunities but also has high rates of violence and alcohol addiction - rejected a

proposal to legalize pot on the full reservation last year.

The Flandreau Santee Sioux Tribe, which already operates a casino on its land, is looking at this business operation as a source of revenue that would allow the community to develop housing, build an addiction treatment center and improve the local clinic, among other projects. Tribal leaders estimate a monthly profit of up to \$2 million a month.

But for all the hype that the decision may create among pot enthusiasts or individuals who have a prescription for the drug, South Dakota Attorney General Marty Jackley has warned that non-Native Americans would still be breaking the law

if they consume pot on the reservation.

Jackley said there are some reservations growing and selling pot in states where either recreational or medical marijuana is legal. But he said he is not aware of any other state attorney general dealing directly with the legalization of pot in a state where marijuana is against the law other than Oklahoma and Nebraska, which have jointly filed a lawsuit on the matter.

Reider said the tribe is working with a company that has growing facilities in Colorado and California that will develop the cultivation site on the reservation and advise the tribe on the operation. Reider declined to name the

company.

This all comes after the U.S. Justice Department outlined a new policy in December allowing Indian tribes, which are considered sovereign nations, to grow and sell marijuana on tribal land as long as they follow the same federal conditions laid out for states that have legalized the drug. The Justice Department had no comment on Tuesday on the decision by the Flandreau Santee Sioux Tribe.

But for non-Native Americans, "it's against law everywhere in South Dakota on tribal land or otherwise" to smoke marijuana, Jackley said, and "any changes in tribal laws wouldn't affect any non-Indians or any non-tribal lands."

The Finance Committee sends our greetings to all tribal members. We also want to update the community about the Community Fund that is administered through the Finance Committee. As many still may not know about the Community Fund its purpose is to serve the Oneida community members by offering funds and Coca-Cola products. The Community Fund is available to all enrolled Oneida member and is designated specifically for:

1. Self-Development initiatives for youth and adults,
2. Oneida Community Events and
3. Fundraisers that benefit Oneida individuals or the Community

Along with the categories listed above all funding requests require the requestor to provide a 10% match. Any travel or travel related requests are excluded as are requests that can be obtained from another tribal program. So far in FY 2015, The Finance Committee is pleased to report that approximately \$24,925.90 in funding from 52 requests has been provided. The majority of the funding being requested was for youth enrichment activities such as sports, art, and fitness camps. The FC also provided approximately 515 cases of soda and water from 23 requests for community fundraising activities and Oneida community public events and activities. Amendments to the Motor Vehicle Registration Law

On April 22, 2015, the Oneida Business Committee (OBC) adopted amendments to the
Oneida Tribe's Motor Vehicle Registration law, which will become effective June 1, 2015.
The changes include:

- ⇒ Removing specific fees that are listed the Law. Instead, the OBC will adopt a fee
schedule by Resolution, based on recommendations from the Oneida Licensing
Department. (This change is being made so that in the future, the fee schedule can be
amended without needing to amend the entire Law. At the time this Resolution was
adopted, the Oneida Business Committee also adopted the existing fee schedule by
Resolution.)
- ⇒ Tribal members that reside on the Reservation are no longer *required* to register their
motor vehicles with the Tribe, as long as the motor vehicles are registered in another
jurisdiction;
- ⇒ The Law will be enforced through the issuance of citations by law enforcement.
- ⇒ Additional minor changes were made to update the Law, including removing language
address the processes used to implement this Law.

Last year we had a large budget deficit that resulted in a 12% cut across the board for all departments. This year that number has almost doubled due to the creation of new departments and/or new initiatives. I am not in support of either because they do not provide a benefit to our community. Creating these initiatives will result in substantial across the board cuts further reducing budgets for existing programs and services.

One area that was severely cut last year was Recreation which provides after school programs and other activities for our children. Included in Recreation is the maintenance of many, if not all, of our parks utilized by our children and families. Last year’s budget cut resulted in lay-offs and/or furloughs to that specific area. Services to our children should not be reduced. Cancellation of last year’s Breakfast with Santa due to budget cuts was successfully rescued at the last minute by volunteers who provided the much awaited food and gifts. While it is great to see more of our community involved in the creation of these types of events, what is going to happen this year? I have not heard any discussion about this year’s

Breakfast with Santa. Creating these types of events take time and planning. The same instance of budget cuts occurred with the Elders. Unfortunately, a volunteer event was not held for them.

Our Elders, our most valuable resource, are not in a position to have their budget severely impaired again either. Doing so will result in further reductions of services to our Elders and that I do not support. As a vulnerable people of our Tribe, it is necessary for us to protect them as best we can as they cannot do it alone. The general attitude about this reflects that the younger generation, not the Tribe, should provide for our Elders. This sentiment does not sit well with me. Our Elders looked out for us and grew our Tribe from meager means to the community we have today. Our Elders made sacrifices and created opportunities to allow us to continue to grow with the hopes we would use their knowledge to further our Tribe. Their vision of building our own community has come to fruition. Severely impairing elderly services provided is not the way to say thank you!

Historically, Elderly Services has been cut and the reason behind

that, in my opinion, is because no one speaks up. Very few Elders speak at our General Tribal Council (GTC) meetings and even fewer participate in community meetings. This is unfortunate because they are a wealth of information for us to draw upon. Yet they take whatever comes their way in stride with the adage that this is how it is. Many Elders had nothing growing up and many faced poverty. They walked to the one room school, survived on government issued commodities and often wore hand me down clothes. Their foresight created economic advancements and we have grown into the wonderful community we share today. All I ask is that we think about protecting the services already in place for our children and elderly vs. reducing services.

The last few GTC meetings have included comments about housing

and the lack of housing opportunities on the reservation. These comments are valid and true. We do not provide enough housing opportunities for our tribal members in general. The Dream Home program through the Department of Land Management has limited housing availability. We only have eighteen (18) apartments available for rent and twenty-nine (29) Elderly Apartments which are not income based. It is my understanding there are waiting lists for all our apartments so the interest from the community is there but insufficient housing units available.

There are income based homes for our community members and Elders through the Oneida Housing Authority. However these units serve only a small sector of our people. With the baby boomers getting older the demand for housing

and health care continues to increase. We simply do not have the capacity to house everyone. Rather than looking into developing new departments or new initiatives we need to address our housing needs with designated housing not just “land acquisition”.

The twenty-nine (29) Elderly Apartments we have are simply not enough. Originally these units were intended to be Assisted Living which is why they were designed the way they are. For whatever reason this did not happen and they became Elderly Apartments. More often our Elders need a caregiver and the apartments are only one bedroom so there is no room for a helper. Combine that with the staff having limited ability to help residents and we are providing insufficient service to our Elders. Our goal should be to construct apartments for the Elderly, two bedroom units with attached garages for those who can provide for themselves and allow the Elderly Services Apartments to be utilized as an Assisted Living facility as originally intended.

Lacking the support of this Business Committee, no matter how logical or rational my ideas are, they will

never come to fruition without the support of the General Tribal Council. With the proposed budget deficit, cuts will need to be made and that is reality. GTC has the authority to make their own changes to the budget so if Elderly Services are cut, it is within the power of GTC to increase their budget by reducing something else. Currently there are new initiatives on the table. They include: development of a new facility, a new building that will service less than 100 people, development of a whole new department and new job creation. Personally, I believe they should stay on the table. I do not believe we need any of the new ventures being proposed. I believe we need to stop and really look at what we have and what makes sense for us. Funding business ventures that do not provide a benefit to our entire community is unwise. I support what GTC has been saying and am asking for your support in protecting our Elders and providing more housing opportunities for our tribal members.

Let’s take care of the basics for our Elders by providing safe affordable housing options. “Respect your Elders” shall not be reduced to verbiage but practiced in how we allocate our

Yaw^ko

A big Yaw^ko to all the Tribal departments and community volunteers who helped out at our annual Household Clean Sweep held June 3, 2015. There were a total of 328 registered attendees and 99 Elder pickups for a grand total of 427 served! The collaboration and cooperation is outstanding.

Budget Update

On May 28, 2015, the Finance Department pro-

vided the Oneida Business Committee with a “first round” of budget numbers for Fiscal Year 2016. Preliminary numbers show a negative “gap” between revenues coming into the General Fund, and expenses going out. On June 3, 2015, the “first round” of budget numbers was communicated to senior management and Chairpersons of Boards, Committees, and Commissions. Senior Management and the Chairpersons were requested to review their projections and re-submit their budget requests so that the “gap” is closed and a balanced budget is provided to the General Tribal Council for consideration in September,

2015.

Revenue

The gap will continue until additional and new revenue is realized. As Treasurer, I take this responsibility extremely serious. We are working on plans to create opportunities for Community Development, Economic Development, and ultimately a system which will support Sustainability. Sustainability is the responsibility of leadership to ensure future Oneida citizens an equal quality of life, or better, that our current generation experiences.

\$.99 Increase

The \$.99/hour wage increase approved by G.T.C. has a total cost of

\$3.4M, impacting 95% of the employee base. Approximately 125 employees including management positions and front line employee positions, earn an annual salary exceeding \$65K. The Budget Core team reviewed and assessed the fiscal impact. The Human Resource Department also reviews language within employee contracts so that the organization may plan for a \$.99 wage increase to employees earning over \$65K (5% of the employee base). The additional fiscal impact is approximately \$300K. The message to include all employees (100%) is that all employees provide value to the organization, the community, and the Nation.

The Budget Core team encourages General Tribal Council to support the decision to plan the \$.99 per hour increase, in the FY 2016 budget, to those employees who earn over \$65K. It is important to note that the Budget Core Team is continuing their work to adopt a wage compensation program.

As a member of the Oneida Business Committee, there are two issues which are constantly on my mind: fiscal responsibility, and the future of this Nation. Often these issues go hand-in-hand, and nowhere is this more

apparent than it is with the topic of per capita payments.

I know that this can be a sensitive issue, but I am hoping that if I can get a discussion started. I would like to get a better understanding of how everyone feels about the per capita payments and what we should do in the future. I welcome each and every member to contact me to have a conversation about this topic – I would like to hear from as many people as I can so that I can have the broadest perspective. To get people thinking about this issue, let me provide the following information:

- The Tribe began making per capita payments to individual members in 1994.

- As of last year, we have paid out a total of \$389,627,096 in per capita payments to individual members.
- Over the past five years, we have paid out \$113,901,078 in per capita payments. With minor fluctuations, but the average annual payout over the past five years has been \$22,780,216.

If we had taken all of the money that we spent on per capita payments and invested it instead, earning a conservative 3% compounded annually, this Tribe would have had over a half a billion dollars this year (\$501,975,458). And staying with that

If we focus on the food systems, our community will have many additional opportunities to live healthier, happier lives.

A good mind

As always I would like to express how productive people can be when they work together. I encourage our community to work with one another in order to meet the needs of our Oneida Nation. Having a good mind and keeping that mind open to other ideas, opinions and beliefs will help make our Nation stronger and will allow

us to better understand and address the needs of our community members. In order for a government to be successful, the constituency must have trust in its government and its leaders. In Oneida, we elect our government officials every three years and it is my hope that everyone votes for leaders who have the highest degree of moral, ethical, and respectful standards. This Oneida Business Committee has taken the responsibility to put forth recommendations on all matters going before the General Tribal Council (GTC). These recommendations are well researched and a lot of thought is put into them, in an effort to provide GTC with enough information to make the best possible decisions. I find it disheartening to hear comments from the GTC floor such as “the

educated and dangerous.” For many years now, Oneida has invested in its people by providing funding to obtain an education. This has allowed our people to rise out of poverty and obtain a career path that supports them and their families. I know things can get emotional on the GTC floor, but take a step back and look at the logic of what is being said. Is this the path we want to continue to go down? The have vs. the have nots? Arguments like this only serve to divide us as a people, a tactic used by the Federal government. This tactic is now used by a few of our own people to hold our Nation

back. I encourage all to keep a good mind and have respect for our brothers and sisters who are courageous enough to speak out our GTC meetings. I also encourage new speakers to step forward, let your voice be heard. I know there are a lot of good ideas shared throughout our community, yet sometimes they do not get heard. It is now the time to speak those words and we must listen with respect and keep an open mind.

ervative 3% annual interest, if we had continued to contribute at the same rate to that investment money, we would have had over a billion dollars by 2027 – just twelve years from now.

One billion dollars.

What could we have done for this Nation with a billion dollars? At the conservative 3% interest rate, that would have meant \$30 million in interest every single year without ever touching the principal. What could we have done with \$30 million in annual revenues?

But right now, instead of investing that money, we are paying out over \$22 million per year in per capita payments. Of course, this has benefits, too. I know that for many members, that money is necessary, and there is no question that this money helps to improve the quality of life for many of us. But what I am trying to understand, is whether this is the best way to spend all of that money. I

honestly don’t have any answers yet, but I hope that individual members can provide more insight into this dilemma.

OLIPP Update

I just wanted to provide an update on Oneida Life Insurance Plan Plus (OLIPP). The Oneida Enrollment Department continues to make diligent efforts to encourage the membership to complete and update their Oneida Beneficiary Forms. We've attempted through direct mailings to the individuals, ran several special “incentives” where great prizes were awarded if the member submitted a form. To date, over 5500 members have not submitted their form. This benefit is for you! It's intended to pay your final expenses when you pass away. For those unfamiliar with a life insurance policy - it's simply a contract with a life insurance company and in exchange for the premium (which comes at no cost to the member) the insurance company then provides a lump-sum payment to your designated beneficiary(ies) after a member passes on.

- OLIPP is a group term life policy valued at \$15000.
- It's intended to be used for final expenses, which can
