Wisconsin schools were well represented at the 2010 Indian Education Renewable Energy Challenge. The Oneida Nation High School (ONHS) took top honors on the high school level while the College of Menominee Nation (CMN) shared first prize with Southwestern Indian Polytechnic Institute on the college level. The awards were presented by Secretary of the Interior Ken Salazar and Assistant Secretary-Indian Affairs Larry Echo Hawk at an awards ceremony held in Washington, DC on Friday, April 8.

"I am proud to announce the winners of the first annual Student Energy Challenge and I

A presentation on amendments to the Oneida Constitution leapfrogged petitions from Floyd Wayne Silas and Cathy L. Metoxen on the agenda at a Special General Tribal Council (GTC) meeting held Saturday, April 10 at the Radisson Hotel and Conference Center.

Councilwoman Melinda Danforth stated in her presentation that the amendments have been in the works for several years.

"The overhaul, had failed for a number of reasons. One, some of the amendments that were brought forward were actually too controversial for the community to take up at the time.

And then two, the Secretary of Interior actually referred some of those amendments back to the tribe because they felt that the changes we were proposing weren't substantial enough for them to consider holding a secretarial election. And then finally he found that none of the amendments or the overhaul of the constitution ever came before General Tribal Council for consideration at all," Councilwoman Danforth said.

The current proposed amendments include removing Department of the Interior (DOI) Secretary from the Constitution, changing the voting age from 21 to 18, allowing absentee voting for the tri-annual elections, changing

the tribe's official name from the Oneida Tribe of Indians of Wisconsin to the Oneida Nation, and formally authorizing a tribal court.

GTC member Loretta Metoxen expressed support for removing the DOI Secretary from the constitution as an exercise in sovereignty.

"A nation is a nation is a nation," said Metoxen.

Others expressed concern about removing the DOI Secretary. Sherrole Benton stated that turn-outs for elections in Oneida are low, while under the current Constitution, ballots are required to be sent to every GTC member to make Constitutional changes.

"We need to have a lot of people involved in our elec-

## Cost of GTC Meetings

Many General Tribal Council (GTC) members may not know the true cost of holding a GTC meeting. Many behind the scene costs may not be computed or known about.

According to information obtained from the Oneida Business Committee's Secretary's office there were five GTC meetings held in 2009 with the highest stipend amount going to the July 11 meeting where a potential \$10,000 per capita payment was discussed. That meeting paid out \$199,300 in meeting stipends alone.

The July 11 meeting also included \$57,315 for printing and mailing of the meeting packet, \$5,130 for audio/video assistance, \$800 for room rental, \$875 for shuttle service, and \$17,116 for food. The total cost of the meeting totaled \$282,259.

In 2009 printing costs per meeting averaged \$23,682 per meeting, mailing averaged \$5,609, food averaged \$12,253, room rental averaged \$740, shuttle services averaged \$586, audio/video assistance averaged \$4,152 and the average stipend total was \$147,060.

An additional hidden cost not always calculated in the cost of a GTC meeting is the preparation each petition carries. The tribal Secretary verifies the signatures on the petition, a legal opinion is completed by the Legislative Reference Office, a financial impact is done by the Chief Financial Officer and the petition is examined for any administrative impact.

With tight budgets and the GTC's ability to call a meeting at any given time, the Oneida Business Committee (OBC) is exploring ways to bring down costs of GTC meetings.

## Oneida Constitution takes center stage at GTC

tions and changing our Constitution," said Benton.

Madelyn Genskow recommended a change in the required annual and semi-annual meeting days. Currently, the Constitution requires the meeting be held on the first Monday of January and July which occasionally lands on a holiday. Also, she stated Monday meetings are inconvenient for many employed Oneidas.

"I would hope that we would change that to a different day in July and January so that the meeting could be held on a Saturday," said Genskow.

The GTC asked the Oneida Business Committee

leaders in developing renewable energy resources for their tribes and the reservation economies."

ONHS Science Instructor Becky Nutt stated the design phase of the project began in October.

"We were fortunate to be one of five schools whose design was selected to be built," she said. The school received a \$1300 grant to build the prototype for phase II of the competition.

The students needed to create a wind generator that would charge batteries to operate a water pump that would power a water wheel to light a bank of LED lights.

The class experimented with different propellers and water storage devices before deciding on PVC piping.

"The thing we're most proud of is our actual water storage unit. The kids did all of the construction on this," said Nutt.

Students involved in

the design were Robert Lagest Jr., Tracey Stevens, Dawn Stevens, Damon Danforth, Cody Grignon and Evan John. The construction team was made up of Johnny Big Medicine, Randy Moore, Shanica Hill and Mary Powless.

The student enjoyed the hands-on experience of building the wind generator.

"I like it more than books, because you get to actually know what you're doing instead of reading it and know what someone else did, you get to experience it yourself," said Powless.

The students were proud that their school along with CMN was selected for the top prizes.

"We took first, and that wasn't too easy to do," said Moore.

"We do work hard, and that shows," said Powless.

"They did an excellent job and represented the

community well in Washington and did a nice job with the project.

The CMN team was made up of Dean Davis, Darwin Shawano, Arnold Tepiew and Kyle Grignon.

"I think that it is outstanding that tribes in Wisconsin can lead the way for all Native Americans in learning renewable energy," stated Davis in an email correspondence.

Nutt expressed gratitude to the Oneida Department of Public Works (DPW), Fondy Electric, Seymour Machine and Scott Marck's Trucking for their help with materials for the project.

"Finding materials was one of the biggest challenges we had," said Nutt.

The winning schools received a \$5000 grant which Nutt said would go towards the ONHS Science Club and would be used towards next year's challenge.

## NIGA honors early leaders



"If you don't have the revenues you cannot protect sovereignty, and in these trying times sovereignty needs to be protected," Crooks said.

Crooks said that NIGA was instrumental in fighting adversarial legislation during the advent of Indian gaming, and that NIGA's work has helped to make gaming a major contributor to the economies of



Indian nations. He also announced a \$100,000 gift of support from the Shakopee Mdewakanton Sioux Community to NIGA.

At the conclusion of the address, NIGA Chairman Ernie Stevens, Jr. gave Crooks the Chairman's Leadership Award and wrapped him a buffalo robe.

NIGA was founded in 1985 as the court case, California v. Cabazon Band of Mission Indians, wended its way to the U.S. Supreme Court. The court ruling issued in 1987 affirmed tribal sovereignty, and strengthened the ability to continue building their economies through tribal government gaming. Indian gaming—despite the current econo-

my—has continued to provide jobs, basic government services and has become in 2010 a \$26.2 billion industry.

The awards luncheon now in its eighth year grew out of the commitment of NIGA Chairman Ernie Stevens, Jr., in recognizing meritorious service by individual leaders in the areas of gaming and business development. The luncheon was held Wednesday during the NIGA Convention. Stevens told the nearly 5,000 convention goers, "The chairman's leadership award luncheon has evolved into a great event."

Stevens gave the Chairman's Entrepreneur of the Year Award to Dave Anderson, the founder of

the NASDAQ-traded restaurant chain Famous Dave's of America.

Stevens gave the Chairman's Leadership Award to Rick Hill, chairman of the Oneida Nation in Wisconsin. Hill asked the audience, "Who is here from the 1993-1994 NIGA tour? We bonded on that magnificent tour that took us from coast to coast. We were saying, 'We need to get our act together to build this industry.'"

At one point in the early days of Indian gaming, Hill said, 49 of 50 governors were fighting against it, and Congress was considering legislation that went against the very fabric of Indian Country. But when the time came for hearings, 100 chiefs came

to testify to the sovereign right of Indian nations and the profound economic needs across Indian Country.

"Chairman Crooks quietly gave us the money to run operations and start the organization (NIGA) as we see it today," Hill said. "I think for the future you will accomplish the mission of the Indian Gaming Regulatory Act, which is to build strong tribal governments, economic development and self sufficiency."

NIGA Chairman Stevens, who is also Oneida, remarked, "Chairman Hill walked the walk, and fought the fight. He continues to do so from the front lines. We are so proud of our great leader."

death by an infant child, by her parents, her siblings; Wayne Peters, Finley Peters, Bob Peters, and Mary Ann Peters.



# Indian Reservation Roads program

In the last edition of the Kalihwisisaks, the Law Office provided a brief overview of the Tribe's efforts to improve the water quality on the Oneida Reservation. This week's article will address the Tribe's participation in the federal Indian Reservation Roads ("IRR") Program administered by the Bureau of Indian Affairs ("BIA") and the Federal Highway Administration.

The IRR Program addresses transportation needs of tribal governments by providing funds to tribal governments for planning, designing, construction, and maintenance activities for new and existing roads. Tribal governments may receive federal funding through the IRR Program

for all public roads that provide access to and are located on Indian reservations, Indian trust land, restricted Indian land, and Alaska native villages. Tribes work cooperatively with state and local governments to use IRR funding for construction and maintenance of tribal, BIA, state and local roads.

The IRR Program offers two types of funding. First, appropriations through the Department of Interior fund maintenance of existing BIA roads. Tribal, state and local roads are not eligible for this funding. Second, the Department of Transportation provides funding for construction and maintenance of tribal, BIA, state and local roads. Funding per mile for state and local roads is less than funding for trib-

al and BIA roads. However, if state and local governments acknowledge that they are unable to fully fund maintenance or upgrades to their existing roads, then those roads generate the same level of funding as tribal and BIA roads.

Outagamie County, Brown County, Town of Oneida, City of Green Bay and Village of Ashwaubenon have all acknowledged that they are unable to fully fund maintenance or upgrades to their existing roads. Because of these acknowledgments, the Tribe is eligible to receive additional federal funds which the Tribe uses to assist these local governments in constructing and maintaining roads.

In 2009, the Tribe received approximately \$50,000 for maintenance

of BIA roads and approximately \$1,000,000 for construction and maintenance of tribal, BIA, state and local roads. The Tribe used these funds for various Planning, Engineering, and Construction projects listed in The Tribes Transportation Improvement Plan (TIP) under the BIA/IRR program. These Tribally approved projects consist of pathway construction, subdivision road construction, and co-op projects with local municipalities.

The next article will provide an update on the Tribe's recent lawsuit challenging the Village of Hobart's storm water charges on tribal trust land. The Village has until April 20, 2010, to file its response to the Tribe's filing.

## Oneida Life Insurance Plan Plus (OLIPP) Update

It has been 6 months since OLIPP has been put into place. So far over 3,000 Beneficiary Designation Forms have been returned. The following information is being provided to assist the membership when filling out the Beneficiary Designation form:

### A. Member Information (Required)

- Name
- Date of Birth
- Enrollment number
- Address
- Marital Status

### B. Primary Beneficiary(ies)

- The Primary Beneficiary is the person(s) you would like to receive the proceeds at the time of your death. This person(s) would also be responsible to pay your funeral expenses.
- The Percentage section is the percent or amount you would like assigned to the beneficiary. If there is more than 1 beneficiary, the total percentage amount must equal 100%. For example, if there are 5 Primary Beneficiaries listed and each are assigned 20%, the total would be 100%.
- The percentage has nothing to do with blood quantum.

### C. Contingent Beneficiary(ies)

- The Contingent Beneficiary is the person(s) who will receive the proceeds if the Primary Beneficiary(ies) listed is deceased before the insured member. For example, a member lists the spouse as Primary Beneficiary, they both die in a car accident, the Primary Beneficiary is no longer alive therefore the proceeds would go to whomever is listed as the Contingent Beneficiary.
- The Percentage section is the percent or amount you would like assigned to the beneficiary. If there is more than 1 beneficiary, the total percentage amount must equal 100%. For example, if

there are 5 Primary Beneficiaries listed and each are assigned 20%, the total would be 100%.

c. The percentage has nothing to do with blood quantum

### D. Member Signature (Required)

### E. Spousal Waiver Information

a. By signing on the spousal waiver signature line, a spouse is basically waiving his/her right to the life insurance monies. This would be necessary if the spouse is not listed as Primary Beneficiary.

b. In the event the box is marked for the Enrollment Department to be Primary Beneficiary, if married, the spouse should sign the Spousal Waiver in order for the Enrollment Department to pay the funeral home bill in full. The remaining balance will then be

sent to the Primary Beneficiary listed.

c. If the Spousal Waiver is not signed and the Enrollment Department is designated as Primary Beneficiary, the Enrollment Department can only pay up to \$7,500 because by Wisconsin's Marital Property Law the spouse is entitled to 50% to all proceeds.

### F. Other Information

a. The Enrollment Department can be designated as Primary Beneficiary to pay the funeral expenses by checking the box located under section B on the Beneficiary Designation Form.

b. Beneficiary forms that are not complete will be returned to the member. If completed form is not received by time of death, the naming sequence will be used:

- Spouse
- Child(ren)

iii. Parent(s)

iv. Brother(s) & sister(s)

v. Grandparent(s)

vi. Member's estate

c. Members are eligible for a Living Benefit option to withdraw 50% of the proceeds, if:


i. Member is diagnosed with a terminal condition, and

ii. Life expectancy is

12 months or less, which must be documented by a licensed physician.

Baking for others has been something Yuma Thomas and his family have been doing for years so the transition into the food service industry was natural.

Thomas is the owner of Sister's Bread and its derivatives - Sister's Deli and Sister's Deli at the Skenandoah. Sister's Deli at the Skenandoah opened for business on Monday, April 5 inside the Skenandoah Complex and is open to the general public.

Sister's Bread started inside the current Social Services building and employees inside that building kept asking Thomas if he had other food available.

"People would smell our bread and ask if we had anything to eat," said Thomas. "We started offering chili, Native American corn soup and tacos and then it just grew from there."

The bread shop and deli remained in the Social Services building until four years ago when Thomas moved to 2425 O Conner Road in Green Bay. The deli is currently closed for remodeling and is scheduled to be open again in about one month.

Sister's Deli at the Skenandoah will feature a daily change in hot food items, a salad bar, and Sister's Deli staples chili and fry bread. The deli also offers free coffee and donuts every morning.

"Our menu is posted monthly so people know what I am going to be having," said Thomas. "We've had a really good start and we are open

from 10 a.m. until 2 p.m. every day."

The Skenandoah location has two staff members with Thomas and Carrie Casey.

"We want to wow people," said Casey. "We want people to feel important when they eat here and have real conversations with their co-workers."

"We've heard people are happy we are here (inside the Skenandoah Complex)," said Thomas. "People have been very receptive in the Skenandoah Complex and I know people have been waiting a while for (a food option)."

Thomas prides himself on offering a balanced meal and acknowledges it hard to compete against fast food restaurants. "Everywhere you look it's five dollars this and five dollars that," he said.

"Most of our meals are health conscious and everything is homemade. I want to feed the community and help them eat properly."

Thomas even has taken his business on the road serving food at Oneida community events along with other festivals in the area. "More than likely everyone has had our food somewhere in the community," he said.

For larger events he calls in help from his family and close friends. "I wouldn't be able to do what I am doing if it wasn't for the backing of my immediate family," Thomas said.

Sister's Deli at Skenandoah is located at 909 Packerlandxs Drive and can be accessed by using the rear entrance of the building.



## Chairman's Corner...

The Annual and Semi-Annual General Tribal Council meetings of the Oneida membership are required by the Oneida Constitution.

The Annual GTC is the first Monday of each year, and the Semi-Annual GTC is the first Monday of each July. These are meetings that are constitutionally-required to be held each year. All other GTC meetings are upon GTC member request or as called by the Chairman.

The Oneida

Constitution allows a GTC member to petition for a GTC meeting upon obtaining 50 verified signatures of enrolled tribal members age 21 and over. The same section of the Oneida Constitution also allows the Chairman to call a special meeting of the GTC.

In the FY2010 budget, tribal management and staff made significant cuts to achieve a balanced budget. The balanced budget presented to and approved by GTC on January 31, 2010, maintained the current levels of programs and services, maintained current levels of employment within the organization, and maintained the fulfillment of GTC mandates such as per capita and other budgetary obligations required by GTC action.

General Tribal Council meeting costs have been budgeted at approximately \$160,000 per meeting for seven meetings until the current fiscal year ends on September 30, 2010. This is a total of

\$1,120,000 for seven GTC meetings. So far, we have had four GTC meetings since the beginning of this fiscal year and have three meetings remaining.

The first meeting was the continuation of the July 2009 Semi-Annual meeting. The second meeting was the January 2010 Annual meeting. The third meeting was the FY2010 Budget meeting, and the fourth meeting was the most recent meeting on April 10, 2010, to address budget and management concerns. There is the July 2010 Semi-Annual yet to happen, which leaves two GTC meetings that are currently budgeted for.

Cost containment measures implemented throughout the tribal organization reflect Oneida's diligent efforts to conservatively manage and allocate its financial resources so that we can preserve current levels of programs and services, and current levels of employment. We have done this and will continue to do so while seeking new revenue streams to support the tribal government that supports the membership.

It is prudent that we exercise our constitutional rights and duties in a manner that best serves the tribal membership. We have limited financial resources because we have budgeted for a limited number of GTC meetings. We owe it to ourselves and our nation to seek those GTC actions that will serve the membership as a whole and make the best use of our budget dollars.

In the coming months, Administrative Procedure Act amendments, Personnel Policy and Procedure amendments, the Judiciary Act, and Constitutional amendments, will be brought to the Oneida membership for GTC action and approval. These are actions that best serve the Oneida Nation, the Oneida membership and the tribal organization. These are actions that make the best use of our financial

resources and budgeted dollars that have been set aside for GTC meetings this fiscal year.

Adopting these proposed laws that will be forthcoming to the GTC is being sovereign because we have the authority to make our own laws and be governed by them. This is GTC authority at its strongest, to adopt laws that have followed the processes and procedures that GTC itself has established through the Administrative Procedures Act.

To ensure that GTC petitions, and actions being sought through the petitions, are following tribal laws and policies that have been adopted by the GTC and OBC, the Oneida Business Committee is being encouraged to develop a GTC Petition policy or ordinance. In this way, we as elected officials fulfill our oaths of office to uphold the laws and regulations of the Oneida Nation on behalf of the Oneida membership, and to uphold the Oneida

Constitution.

This proposed policy or ordinance would ensure that GTC member due process rights under the Constitution are protected, that a procedure be established to process GTC petitions in a consistent manner, and that any proposed GTC action does not violate or conflict with existing Oneida laws. Through this proposed policy or ordinance, we can make the best use of our tribal and financial resources as we continue to exercise our sovereignty to create the laws we use to govern ourselves.

Finally, at one of the upcoming GTC meetings I encourage an open discussion about our Oneida laws so that we as a Nation can understand the processes for how we adopt our laws and change our laws. More importantly, by understanding what our laws mean we can understand the role of those laws and how they guide the tribal government and tribal organization that serve the Oneida membership.

## OBC Forum...

### Shekólih,

For this article, I will provide you with a brief update on the constitutional amendments. As you are aware, there was a special GTC meeting on Saturday, April 10th and one of the items on that agenda was a request to approve moving forward with the proposed constitutional amendments. I am very pleased to share the GTC did agree to move forward, so now more in-depth work can begin.

As I have been sharing with you, there are 5 amendments to the constitution up for consideration. The amendments are to: 1) remove the Secretary of Interior; 2) lower the voting age from 21 years-old to 18 years-old; 3) allow for absentee balloting in the triennial elections; 4) change the Tribe's official name from the "Oneida Tribe of Indians of Wisconsin"

to the "Oneida Nation," and 5) formally embed a tribal court into our constitution.

This past fall, over 7,000 surveys were sent out to those who wish to receive tribal mailings. The survey that was mailed to tribal members asked your opinions about the amendments and also left room for additional comments and/or concerns you may have. About 1,700 surveys were returned and from those surveys returned, information has been compiled and we are in the process of preparing that information for distribution to you. Our goal is to have the information ready for the next series of community forums.

This second round of community forums will

be scheduled for May and June (the first set of community forums took place in January & February). Please watch for information on the locations, dates and times in the paper, in flyers and in emails.

Also, during the GTC meeting a 6th amendment was brought forward by a tribal member. The additional amendment is to change the mandate of having our annual and semi-annual meetings on the first Monday in July and January, and while this amendment was not specifically approved on Saturday, it was given back to the Business Committee for a decision on whether or not to include it with the

current amendments. Once a final decision has been made by the BC to include this new amendment along with the others, we will include it in our work as we move forward. As I shared with the GTC, we anticipate having the final language on the amendments, as well as the fiscal and legal impacts ready for the July semi-annual meeting.

Wahstets'ihiy! I recently received an e-mail asking what we are doing for our children in the community. The safety, encouragement, and future of our children is something that is very important to me and is a top priority. I would like to use this opportunity to shed light on some of the positive things currently being worked on.

As Chairman of the Community Development Planning Committee, I have the opportunity to learn about the many projects that are occurring in the community as well as provide direction for the development of Oneida. Currently there are several projects involving the development of central Oneida that directly impact youth.

I noticed that some of the trees and brush have been cleared out of the woods across from the Norbert Hill Center. This is part of the Trail Project. This project involves the development of biking and walking trails in central Oneida as well as possible future trail connections to other areas of the reservation.

Currently the team is working on expanding the current paved walkway that runs along Seminary Road to Hwy 54. This will provide a safe way for the community to access central Oneida.

### Community Events Area

The project is still in

the planning stages but the intent is to develop a multi-use community events area next to the Turtle School. This events area could include: Pow Wow Grounds, sports fields, outdoor theater and restrooms / changing rooms. This area will provide a fun and enjoyable place for the community to gather. The team is currently seeking bonding in the amount of \$1.5 million as well as pursuing grant funding opportunities for this project.

### Trail Hub Parkway, Farmer's Market

As many of you know, the Farmer's Market is a highlight of the summer. It provides a way for

local vendors to share their produce and products as well as contributing to the healthy diets of the community. With this project, we would like to make the Farmer's Market area attractive while supporting the cultural and historical sense of place.

Currently, the Farmers Market space is part of the Duck Creek Trail parkway and Trail Hub. What we would like to accomplish with this project is the incorporation of several components of the Farmer's Market area, which include: vendor spaces off the blacktop, shade and landscaping, a food/music area, a multiuse building for storage, bathrooms, and food preparation; a play area for children, connections to the Duck Creek Trail, and parking lot safety improvements

### A little Customer Service, please!

I am a proud Oneida enrolled tribal member. I moved away from Oneida about 15 years ago, but I come home to Oneida two or three times annually. My visits are mostly on the weekend so I rarely have an opportunity for contact with Tribal Offices. However, on my most recent visit, I had the chance to visit the Oneida Housing Authority, Enrollment, Health Center and the Casino. Sadly, I was disappointed with the service provided at each of these offices and believe that some MAJOR customer service training is in order.

Not only do I visit the Casino whenever I am in the area, I even worked there years ago. When I was employed at the Casino, there were, I believe, at least five blackjack pits and the dealers and the other casino employees seemed more youthful and happier. While the current dealers were not terrible - they were probably the friendliest of all of my Tribal

encounters - in my professional opinion (I have over 20 years of marketing and customer service experience), I felt they lacked any sense of vibrancy. I would at least expect to see smiling faces! The overall culture of the Casino as exhibited by these employees failed to reflect the true face of the Oneida Tribe. After all, these employees represent our Tribe's tourism dollars.

Also on my last visit I sat in the Oneida Housing office and the Health Center for about an hour or so waiting. While there, I had the opportunity to observe several customer service interactions. If I was an outsider, I would come to the conclusion that we are not a friendly Tribe, not even to other Tribal members. I cannot recall once in the five days I was there an employee smiling or appearing to be happy or friendly. And it goes without saying that no one went above and beyond, thus giving me a reason to tell others how great my interac-





## Multi-Hazard Mitigation Plan

Across the United States, natural disasters have led to increasing levels of death, injuries, property damage, and interruption of business and services. The time, money, and efforts to recover from these disasters exhaust resources and divert attention from important programs. With several presidential disaster declarations in recent history, the Oneida Tribe of Indians of Wisconsin recognized the impact of disasters on their community and concluded that proactive efforts needed to be taken to reduce the impact of hazards.

If the tribe experienced a large natural disaster, where would our

vulnerabilities be? How do we plan ahead so that we have transportation, communication, medical facilities, and food and water when disaster strikes?

Those are questions that the Oneida Office of Emergency Management/Homeland Security (EMHS) sought to answer with the development of the Oneida Nation of Wisconsin 2010-2015 Multi-Hazard Mitigation Plan. ### Process to view an audit report

Dear editor:

Oneida tribal members, you now have a right to read the internal audits of the Oneida Nation.

The internal audits tell if a part of the tribe is following sound business practices and Standard Operating Procedures.

When you view the internal audits look for the term FINDINGS. You can not make copies of the audits, but you can take notes so that you remember things correctly.

To get a copy of the list of the audits that have been done or to request that a certain audit be done, send your request to the Audit Committee, which is currently chaired by BC council-

men Ed Delgado.

Follow these steps

Process to view an audit report

Step 1 – GTC member submits an email, letter or Request Form (available on Tribal website) to view an audit to the Audit Committee Chair in person, by email, postal mail or fax. All requests must bear the name of the requestor and a phone number where they can be reached.

Step 2 - Request is forwarded to the Internal Audit Director

Step 3 – The Director of Internal Audit/Internal Audit will contact the requestor within 5 business days after receipt of the written request, in order to schedule an appointment.

Step 4 – Requestor must provide photo identification, sign in with their name, roll number, date, start and end time.

Step 5 – If the requestor is a tribal employee, a government official, or administrative staff person, he/she must acknowledge in writing that they have read the Tribe's Code of Ethics Law and agrees to abide by the conditions contained in the law.

The requestor is allowed to take notes during the review, but will not be permitted to make a copy, photograph, videotape, transcribe or verbally record the report.

## From 1A/GTC hears two petitions

(OBC) to move ahead with researching the proposed amendments. The final language of the amendments and financial and legal impacts will be presented at the Semi-Annual meeting to be held Monday, July 5.

Before discussion could start on the petition from Floyd Wayne Silas, there was debate over whether the 1991 Administrative Procedures Act (APA) was followed. Sharron House brought the challenge forward.

"I believe there are processes available that need to be dealt with before (a petition) ever gets to this point," said House.

Chief Legal Council and meeting parliamentarian Jo Anne House said the APA didn't apply to the Silas and Metoxen petitions.

"If that petition proposed to amend the law of the tribe, to violate a portion of the constitution, or to overturn an action that was previously taken by

the General Tribal Council, there are certain steps that must be taken, and under the APA in regards to a law, that requires public notice. My opinion in short was nothing in the two petitions presented today appears to violate the Administrative Procedures Act," said House.

The Silas petition asked "That the Business Committee make no out-of-budget expenditures for 2010 and that there shall be no job loss retroactive to Oct. 1, 2009,"

"It is intended at this time to stop the spending and support the 3000 employees of the Oneida Nation," said Silas.

"The Business Committee's goal was Wayne's goal," said OBC Chairman Rick Hill.

Language was added to exempt grant spending from the petition. A March 10 OBC resolution echoing Silas' petition but leaving open the possibility of layoffs as a last

option was added as an amendment. The petition and amendments were approved by the GTC.

Metoxen's petition asked to "Direct the review of various reports and information about JET (Joint Executive Team)."

"The General Tribal Council has a right to review any decision made by (the OBC)," said Metoxen referring to the Oneida Constitution. Metoxen voiced concern that the JET team contracts weren't included in the meeting packets.

Job descriptions were included in the mail out, however contracts were not.

"I don't think that's allowable under the Blue Book Policies and Procedures as it relates to the confidentiality for those members who do sign contracts," said Chairman Hill.

The petition was accepted as information and the meeting was adjourned.

## Cherokee's Wilma Mankiller remembered as humble leader

TAHLEQUAH, Okla. (AP) — One of the most influential American Indian leaders in recent history, former Cherokee Nation Chief Wilma Mankiller was widely known for strengthening her tribe and drawing the accolades of U.S. presidents.

But it was her humble, tender nature - a refusal to squash a bug, an affinity for opera - that defined her, friends and family said Saturday.

Mankiller, among the few women to ever lead a major tribe, was remembered during a memorial in Oklahoma that drew more than 1,200 mourners, including dignitaries from other tribes and governments, as a respected leader who earned the nation's highest civilian honor.

But she was also a mother who turned her

daughters onto Motown records, an avid poker player and dancer with an affinity for movie star Johnny Depp. A tender heart who brought home stray animals, including an emaciated pig she found along a county road.

A Boston Red Sox fan, she could recite the stats of any member on the team's roster.

"She always saw you a little better than you were, so you became better," friend and women's rights activist Gloria Steinem, who was with Mankiller in the final weeks of her life, said during the outdoor service at the Cherokee Nation Cultural Grounds, about 70 miles east of Tulsa.

Mankiller died Tuesday after a bout with pancreatic cancer. She was 64.

Mankiller led the Cherokee Nation, which now has about 290,000 members, from December 1985 until 1995, when she decided not to seek re-election.

Under her guidance, the tribe tripled its enrollment, doubled employment and built new health centers and children's programs.

She received the Presidential Medal of Freedom - the highest civilian honor in the country - from then-President Bill Clinton in 1998.

Yet she was always without pretension, whether she were with dignitaries in Washington

or sitting on a porch at home in Oklahoma, friends said.

"Her strength was absolute humility," said current Cherokee Nation Chief Chad Smith. "That humility made her approachable rather than aloof ... and made her lead rather than follow."

About 170 dignitaries were among those who attended her memorial, where dozens of people lined their cars along the already-clogged entrance hours ahead of the 11 a.m. service. Some brought their own lawn chairs and blankets.

They were told that Mankiller, even with her cancer diagnosis, never stopped living to the fullest, planning the next day's events or making peace with her final days.

Just days after receiving the presidential award, Mankiller was back in Oklahoma playing with her nieces and nephews on the porch of a church, Smith said.

Her husband, Charlie Soap, said that on their first date, they ate hot dogs from a Tulsa fast-food joint and watched a Rambo movie. She didn't like either.

"I feel like she's not gone," Soap said, trying to hold back tears. "She's still here."

Her daughter, Felicia Olaya, ended the service by reading a note her mother wrote before her death. Mankiller said she wanted people "to know what an incredible life I've had. I want them to be encouraged by it."

## Wis. Senate cracks down on Indian mascots, logos

MADISON, Wis. (AP) — The Wisconsin state Senate has approved a bill that could subject school districts that don't drop American Indian logos and team names to thousands of dollars in fines.

The measure passed Tuesday 17-16 allows any school district resident to file a complaint with the state superintendent alleging the use is discriminatory.

If the superintendent

agrees, the district could be ordered to stop using the mascot or face fines up to \$1,000 a day.

Schools could keep the mascots if they can prove the name refers to a specific tribe and it gave permission for the name to be used.

The Assembly passed a similar version of the bill in February. Both houses must pass an identical measure before it can go to Gov. Jim Doyle.

## From 1A/GTC Cost

"Cost is such a concern," said OBC Councilwoman Trish King. "We do have meetings to mitigate and address concerns of the petitioner. We want to get to the heart of what the petitioner is trying to do and get a better understanding of what the issue is."

According to King, the fiscal year 2010 budget accounts for seven GTC meetings with the policy of grouping petitions on already established agendas.

King would like to see a series of meetings held annually that can be planned for financially and physically.

"I would like the GTC to support a series we could budget for. We have the semi-annual, annual, and budget. Then, we could schedule meetings on a quarterly basis," King said.

King would like to see topics with a lot of necessary dialogue to be spread out over multiple meetings with discussions taking place during one meeting and actions taking place in a later meeting.

"People would know when the meetings are and we could handle the budget and makes it convenient for everybody," she added.

Technology may offer relief but to what extent and how soon is up for debate. "The internet is a good source but not the best yet and we are trying to figure out how to use it and what the cost savings could be," said King. A tribal-member only portion of the current tribal website is also being discussed and may offer relief in the printing and mailing costs for the tribe.

### Oneida Nation Historical Collections are Secure with Sara Summers!

**A**sistant Museum Director, Sara Summers has worked for the Oneida Museum for three years and in that time, many policies and procedure changes have occurred. Sara received an undergraduate degree in Anthropology from University of Wisconsin-Milwaukee and then a Masters in Native Studies with a focus on Museum Studies from University of Kansas. She brings valuable experience from different museums that she had worked at, including the Museum of the American Indian in Washington DC.

The result of Sara's work is the museum collections are getting to the point of being properly preserved. The museum collection consists of

around 1,500 artifacts, 4,000 photos and 400+ manuscripts.

Sara has created a process where the majority of the objects have been properly housed with archival materials or mounted correctly. This includes items in the museum and those that are housed off site. This also includes photo inventories and making sure the data base is updated with proper accession numbers, and supporting information about the objects. Sara commented, "We have a great start but there is a lot more work to do."

The museum staff is excited that they will be moving the museum collection into a better building that will offer an environment that won't fluctuate in temperature and this will vastly

improve the preservation of the collection.

Under the Nation's Balance Scorecard efforts, Sara has taken the lead for the Initiative of Preservation. Sara believes that this initiative will clearly define what we are collecting. This will also help avoid collecting duplicates or collecting items that are not a central part of our mission. She will also help create policies and procedures for collections and tribal archives, as well as, develop a training element for staff to learn how to do proper preservation.

One of the biggest challenges that Sara and other staff are not trying to deal with is the community perception that if people donate their photos or objects to the museum they will be lost.

There may have been problems in the past but with new procedures in place, there is a new assurance that donated photos and objects will be safely preserved for generations to come.





LIVE SUSTAIN GROW

As part of the Live, Sustain, Grow initiative, we are attempting to inventory species that live on the reservation. In conjunction with the Wisconsin Salamander Survey, EH&S staff conducted surveys in three Reservation locations. We were successful in finding salamanders in two of those areas.

They are seldom seen, however salamanders serve as good indicators of environmental health. Salamanders breathe through their skin, making them extremely vulnerable to water and air pollution. They require ponds that contain water until at least mid August in order for their offspring to lose their gills and move onto the land. They also must find logs or other woody debris in damp areas to maintain moisture throughout the summer season. Living in water as nymphs, they feed on aquatic invertebrates including mosquito larvae. Along with frog tadpoles, young salamanders help control mosquitoes in ponds that do not contain fish.

Throughout their adult lives, salamanders typically stay in an extremely small area (home range) for all but a week or two each year. Their strategy of ambush hunting and

staying within a tiny area during much of the year protects them from predators but it makes them extremely vulnerable to habitat fragmentation. If populations in a given area are lost through pollution, drainage, or land use practices, these animals will not likely be able to re-inhabit that area when conditions improve. When Oneida land managers look at options for lands being rehabilitated for native environments/species it will be important to know what species to consider for reintroduction. Salamanders will likely be on that list.

So far, only blue-spotted salamanders have been found in the northwest portion of the reservation. Adult blue-spotted salamanders are approximately 4 to 6 inches long. The males are typically smaller than the females but their claws are better developed to grip the females during breeding.

Other species may also occur here but have yet to be recorded. The spotted salamander (yellow spots) inhabits areas very similar to those preferred by the blue-spotted salamander. The Tiger salamander, which may reach over a foot in length, typically uses larger, more permanent,

water bodies for breeding. They also go to water in the fall where they burrow into the mud to overwinter. The red-backed salamander, relatively common under the spruce/pine forests on the Menominee reservation, does not require water in which to breed. The mud puppy does not lose its gills, living in water

throughout its life. They may occur in Duck and/or Trout Creek.

Additional information on locations of salamander sightings would be greatly appreciated to

include in future survey plans.





## Dads come together to Promote Awareness of Alcohol Abuse

Town Hall meeting set for April 29 at NWTC

Green Bay, WI – The Partners in Education Drug Alliance will host a powerful town hall meet-

ing entitled, "A Tale of Two Dads: The Tragic Side of Alcohol Abuse" at 7 p.m. on Thursday, April 29, at the Northeast Wisconsin Technical College Lecture Hall.

David Brandt and Mike Knetzger will share how their lives were irrevocably changed by the deaths of their daughters. Brandt, from Door County, will focus on the loss of his daughter, Amanda, who was killed in a car crash after a day of drinking with her friends. The family's story is featured in the documentary film, "With Whom Will It End," which has been sent to all families in Door County as a tool for parents to use to talk to their children about the dangers of alcohol abuse.

Mike Knetzger, a member of the Green Bay Police Department, will present about the loss of his daughter, Ashley J. Britsch-Knetzger, who was killed by a drunk driver in 2008. Since his daughter's death, Knetzger has become a leading advocate in Wisconsin on the need to change laws regarding OWI. He and his family established the "Ashley Knetzger OWI Enforcement Award," presented annually to the Green Bay Police Officer who has the most OWI arrests.



## Gardasil vaccine now approved for males

Did you know that more than half of all sexually active men and women are infected with genital human papillomavirus (HPV)? You may be thinking, what is HPV? HPV is a viral infection spread through sexual contact and can cause warts in the throat and genital area for both men and women. HPV can also cause anal, rectal or penile cancer in men and vaginal, vulvar or cervical cancer in women.

At present time, there is no cure for the viral infection of HPV. Therefore, vaccination is the only way to prevent the spread to HPV. Gardasil has been approved for use in females since early 2006 and has recently been expanded to protect males as well. Gardasil is a three dose series


given over 6 months time to males ages 9-26 years of age. The FDA has stated that Gardasil is 90% effective in preventing genital warts caused by infection with HPV types 6 and 11.

Gardasil is safe to schedule with your adolescent's other vaccines. Risks include soreness or redness at the injection site, low-grade fever and possible headache. These vaccines, along with all other childhood immunizations are provided at no cost to tribal members at the Oneida Community Health Center.

## N. Dakota campus resigned to 'Sioux country' end

GRAND FORKS, N.D. (AP) ~ The last college to challenge an NCAA edict against American Indian mascots and images began Friday to pick up the pieces from a four-year legal battle that ended quietly with a North Dakota Supreme Court decision.

The ruling supported a Board of Higher Education decision nearly a year ago to retire the University of North Dakota's Fighting Sioux nickname and logo, which has adorned the school's uniforms for about 80 years. The move is expected to open the door for admission into the Summit League, which said it wouldn't consider UND for membership unless the nickname issue was resolved.

The NCAA in 2005 and 2006 listed 19 schools with American Indian mascots and images it considered "hostile and abusive," and banned them from postseason play pending name changes. Nicknames the NCAA deemed offensive ranged from Indians to Braves to the Fighting Illini.

Some universities, like Florida State (the Seminoles) Central Michigan (Chippewas) and Utah (the Utes), were allowed to keep their nicknames by getting permission from local tribes. The University of Illinois was

allowed to keep its Fighting Illini nickname, though a mascot dressed in buckskins and headdress, Chief Illiniwek, was banned.

But most of the schools changed their nicknames - leaving UND as the lone holdout.

"We got away from what it was supposed to be about, and it was supposed to be about hearing the wishes of the Native American people in North Dakota," UND hockey coach Dave Hakstol said.

In a settlement with the NCAA ending a North Dakota lawsuit to keep the name, the state Board of Higher Education said it would retire the nickname by Nov. 30 if it didn't obtain permission from the Spirit Lake and Standing Rock tribes. Spirit Lake endorsed the nickname; Standing Rock has not.

The board decided not to wait until November after UND athletic officials said it would hurt their efforts to join the Summit League.

One notable alumnus, Los Angeles Lakers coach Phil Jackson, said he had been concerned about other schools' resistance to playing North Dakota in athletic competition because of the Sioux moniker, so he believed the right decision had been made.

"I believe so, even though it's not a consensus among the Native Americans in the state,"

Jackson said.

UND students appeared to be resigned to the change. Sophomore Anthony Johnson, who supports the nickname, said Friday there wasn't much emotion around campus because the move came as no surprise. He believes most people understand both sides of the issue. "I can see how American Indians can take it as a derogatory term," Johnson said. "But we tried to use it with the utmost respect. We are proud to be the Fighting Sioux."

Across campus, at the office of American Indian Student Services, senior BJ Rainbow said he had mixed feelings about the end of the dispute. Rainbow, who has ties to both of the state's Sioux tribes, said he's happy for the change, but worries about retaliation.

"My hope is that, of course, the backlash will be minimal," Rainbow said. "Realistically, I don't think that is going to happen."

No timetable has been given for choosing a new nickname, but UND teams will remain the Fighting Sioux until the 2011-12 school year.



## VA Recognizes “Presumptive”

### Illnesses in Iraq, Afghanistan

#### Decision Simplifies Application for Disability Pay

WASHINGTON

(March 18, 2010) — Secretary of Veterans Affairs Eric K. Shinseki today announced the Department of Veterans Affairs (VA) is taking steps to make it easier for Veterans to obtain disability compensation for certain diseases associated with service in the Persian Gulf War or Afghanistan. This will be the beginning of historic change for how VA considers Gulf War Veterans’ illnesses.

Following recommendations made by VA’s Gulf War Veterans Illnesses Task Force, VA is publishing a proposed regulation in the Federal Register that will establish new presumptions of service connection for nine specific infectious diseases associated with military service in Southwest Asia during the Persian Gulf War, or in Afghanistan on or after September 19, 2001.

“We recognize the frustrations that many Gulf War and Afghanistan Veterans and their families experience on a daily basis as they look for answers to health questions, and seek benefits from VA,” said Secretary Shinseki.

The proposed rule includes information about the long-term health effects potentially associated with the nine diseases: Brucellosis, Campylobacter jejuni, Coxiella burnetii (Q fever), malaria,

Mycobacterium tuberculosis, Nontyphoid Salmonella, Shigella, Visceral leishmaniasis and West Nile virus.

For non-presumptive conditions, a Veteran is required to provide medical evidence that can be used to establish an actual connection between military service in Southwest Asia or in Afghanistan, and a specific disease.

With the proposed rule, a Veteran will only have to show service in Southwest Asia or Afghanistan, and a current diagnosis of one of the nine diseases. Comments on the proposed rule will be accepted over the next 60 days. A final regulation will be published after consideration of all comments received.

The decision was made after reviewing the 2006 report of the National Academy of Sciences (NAS), titled, “Gulf War and Health Volume 5: Infectious Diseases.” The 2006 report differed from the four prior reports by looking at the long-term health effects of certain diseases determined to be pertinent to Gulf War Veterans.

The 1998 Persian Gulf War Veterans Act requires the Secretary to review NAS reports that study scientific information and possible associations between illnesses and exposure to toxic agents by Veterans who served in the Persian Gulf War.

Because the Persian Gulf War has not officially been declared ended, Veterans serving in Operation Iraqi Freedom are eligible for VA’s new presumptions. Secretary

Shinseki decided to include Afghanistan Veterans in these presumptions because NAS found that the nine diseases are prevalent in that country.

Noting that today’s proposed regulation reflects a significant determination of a positive association between service in the Persian Gulf War and certain diseases, Secretary Shinseki added, “By setting up scientifically-based presumptive service connection, we give these deserving Veterans a simple way to get the benefits they have earned in service to our country.”

Last year, VA received more than one million claims for disability compensation and pension. VA provides compensation and pension benefits to over 3.8 million Veterans and beneficiaries. Presently, the basic monthly rate of compensation ranges from \$123 to \$2,673 to Veterans without any dependents.

Disability compensation is a non-taxable, monthly monetary benefit paid to Veterans who are disabled as a result of an injury or illness that was incurred or aggravated during active military service.

Do you know what a census is and why we should take it? In 2010, the Census Bureau will define who we are as a nation with the decennial census population count. It is vital that the 2010 Census have an accurate count of our Tribal nation and American Indian and Alaska Native communities.

A census is basically the procedure of recording information about a member of the given population. It is a regularly occurring and official count of the people in a particular population. The United States Constitution mandates that a census is to be taken at least once every ten years. It is a count of everyone residing in the United States: on tribal lands, the 50 states, Washington D.C., Puerto Rico, U.S. Virgin Islands, American Samoa, Northern Mariana Islands, and Guam. This includes citizens and noncitizens of all ages, tribes, races, and ethnic groups. The 2010 Census will create and provide hundreds of thousands of temporary jobs across the nation. The census is used for federal funding for many of the social and economic programs. A census records the name of the head of the household and the number of people living in each household. It is very important that not only you, but your friends as well, take this census so we can have an accurate count of residents. This will make sure there is more money for schools and healthcare services.

In recent times, there have been two different forms of questionnaire, long and short. The long form that had additional

questions about matters such as daily commute times, housing unit factors, etc. has been replaced by the American Community Survey. Computer algorithms determine which form was mailed to a given household, with 1 in 6 receiving the long form. Completing the 2010 Census questionnaire is simple, easy, and safe. The 2010 Census questionnaire asks only a few questions of each person- name, relation, gender, age, date of birth, and whether the respondent own or rents his or her home. This questionnaire only takes about a few minutes to complete; just return by mail or to a census taker. Your responses are completely confidential and protected by law. All census workers, including tribal members working for the Census Bureau, take an oath for life to protect the confidentiality of census responses.

Want to know why we should put "ONEIDA TRIBE OF WI" instead of "Oneida Nation"? Many Oneida Tribal members from Wisconsin were counted as Oneida Nation of New York, because they just wrote "Oneida" or "Oneida Nation" on the Census form questionnaire. Question 6 of the census questionnaire asks for Tribal Affiliation but only allows for a 19 character response. That is why it is very important we fill out the questionnaire correctly in the section; putting in "ONEIDA TRIBE OF WI". This will surely guarantee that the Census receives the accurate information from our own Tribal members. That way we have a fair and accurate count and do not get mistaken as the Oneida Nation of NY, the 2010 Census is approaching very quickly and we need to ensure that the Oneida Tribe in Wisconsin is accurately counted. This count is how we are allocated for various Federal grants and aids. It also establishes the federal boundaries for Federal Legislatures. Census workers will be going door to door on the reservation; there will also be flyers and posters throughout the commun-

ty. Tribal members should participate in this census because it will shape the future of your tribal community; define your voice in congress and impact economic development and other opportunities for your tribal citizens. The federal and state agencies depend on census data to determine funding allocations for tribal programs. This data can assist tribal leaders in their planning decisions about economic development projects and community service programs. As an American Indian/ Alaska Native, you will play a very important role in making the 2010 Census successful by encouraging people in

your community to take part in the count.

Why is this census important to me? The census is important because 1.) It affects the funding in our community; in which 300 billion dollars is distributed per year in the United States. 2.) It affects the planning for future projects in developing, such as neighborhoods, schools, community centers, roads, and health facilities. 3.) It affects the distribution of congressional seats to states and Legislator districts. In fact, the information the census collects helps to determine how more than \$400 billion dollars of federal funding each year is spent on infrastructure and services like:

Hospitals, job training centers, senior centers,

bridges, tunnels and

other public work projects, and emergency ser-


vices. If you need to know, the community needs to know that an accurate count of residents means fair government representation for all of us, including me. It also means more money for our schools, transportation, healthcare, housing and a lot more.

Three hundred billion dollars a year will be allocated annually throughout the United States. That means 3 trillion dollars will be distributed to municipalities over a 10 year span. The more people counted means more of that money will be distributed into your community. That's why your help is so vital in getting the word out.

I'm asking you to take the Census Questionnaire for our community and for ourselves. It is important that you fill in the form and promptly mail

it back. People from many walks of life use census data to advocate for causes, rescue disaster victims, prevent diseases, research markets, and locate pools of skilled workers and more. I think that this census is very important for everyone. It is safe and protected, which always is a good thing to me. I encourage everyone, including all tribal members to take this census on behalf of our community. When you do the math, it is quite easy to see what an accurate count of residents can do for our community. Better infrastructure. More services. A brighter tomorrow for everyone and possibly a better future for all. I thank everyone for taking their time in reading this essay and thank everyone who took the census questionnaire.

funding for our community will go to other places. Also, it is important to show how many Oneida people of Wisconsin there really are.





### Meet the Oneida Food Distribution Staff

The Oneida Food Distribution Program opened its doors in the old Oneida tribal bldg. On July 1, 1980. It operated under the umbrella of the Great Lakes Indian Tribal Council (GLITC) until Sept. 30, 1983.

It was at that time that the Food Distribution Program on Indian Reservations (FDPIR) was officially activated here in Oneida on Oct 1, 1983 to the present time.

The program is administered at the federal level by the Food & Nutrition Service (FNS), an agency of the U.S. Department

of Agriculture, or USDA as we know it. FDPIR is managed locally by either Indian Tribal Organizations (ITO's) or an agency of a state government. Currently there are approximately 257 tribes receiving benefits under FDPIR through 98 ITO's and five state agencies.

The agreement to administer the FDPIR is between the state agency, in this case the Oneida Nation, and USDA. Therefore, we are required to operate within the USDA guidelines as well as Oneida policies & procedures.

or contract requires the ITO's to order, receive, warehouse, and distribute USDA commodities according to the USDA 501 handbook of regulations. Also to offer nutrition education with the help of state, federal, and Oneida nutritionists, as well as outreach to potentially eligible households with information of the services we provide, and finally, referral to other entities that can meet needs that we in the Food Distribution Program cannot satisfy.

Our service area is the rural areas of Brown and Outagamie counties as well as those of Door, Kewaunee, and Manitowoc. Inside the reservation boundaries any eligible household can receive our services. Outside the reservation only eligible Indian households can be serviced. We cannot service any city or town that has a population of over 10,000 with the exception of Green Bay that is based on a waiver agreement reached with USDA in 1992. This allows our program to service Indian households if they meet pro-

gram eligibility criteria. The prevailing rule of eligibility maintains that low-income American Indians, and non-Indian households residing on a reservation, and those Indian households living in approved areas near a reservation, that contains at least one person, who is a member of a federally recognized tribe, are eligible to participate in the Food Distribution Program.

Those communities that we cannot service directly are Allouez, De Pere, Ashwaubenon, Appleton, Kaukauna, and Grand Chute.

Households are certified based on income and resource standards set up by the federal government, and must be re-certified as often as necessary, or at a minimum of every 12 months.

Households may not participate in the Food Distribution Program and the Food Stamp Program (SNAP) in the same month.

Each month, participating households receive a food package to help them maintain a nutritionally balanced diet. We offer a nutritious food package consisting of fresh fruits and veg-


ables as well as wholesome meat products of frozen ground beef, chicken, turkey hams, and roast beef, and when available, ground buffalo and regular hams during the fall season. We also have a full line of canned fruits and vegetables in addition to an assortment of fruit juices, cereals, and other wholesome products.

The Oneida Food Distribution Program is actively involved and an integral part of OCIFS (Oneida Community Integrated Food Systems) originally established in 1994. OCIFS was formed to develop a strong food infrastructure for the Oneida Nation. It includes Tsyunhe'kw<sup>A</sup>, Oneida Nation Farms, Apple Orchard, Oneida Comprehensive Health Division, and Food Pantry.

### Fruit/Veggie of the Month... Cherries

#### Did you know...?

Cherries are drupes or stone fruits related to plums and more distantly to peaches and nectarines. There are two types: sweet and sour. It is the sour cherries that are lower in calories and higher in vitamin C and beta carotene than sweet



#### Selection:

Buy cherries that have been kept cool and moist so that the flavor and texture are best. Cherries with stems will keep longer. Look for firm, plump cherries with green stems. A brown stem is a sign that the fruit is not fresh. Wash cherries when ready to eat them.

#### Storage:

Loosely pack unwashed cherries in a plastic bag or pour them into a shallow pan in a single layer to minimize bruising. Store in a plastic bag in the refrigerator for 2-3 days. Cherries may be frozen with or without the pits for up to 1 year (rinse, dry and place in zip-lock bag - close all but 1 inch, insert straw & suck out air; then fully seal)

#### Nutrition Benefits:

Fat-free, sodium-free, cholesterol-free, good source of vitamin C & potassium, low in calories (~90 calories/cup), and
