### OSGC claims opposition using misinformation campaign

After the Green Bay City Council agreed to conduct an inquiry on the grounds used by Oneida Seven Generations Corporation (OSGC) to obtain city permits to construct their waste-to-energy plant OSGC's Chief Executive Officer Kevin Cornelius states the opposition to the plant is using untruthful tactics.

through a misinformation campaign," Cornelius said.

"We find it appalling that the opposition steadfastly refuses to accept the facts and the findings and has chosen to misrepresent the project and its impacts," added Cornelius.

According to OSGC, the plant will be in full compliance with all local, state, and federal laws and regulations.

Cornelius also questions the group's true motives when opposing the plant.

"We find it noteworthy that they have only tar-

geted our development as an incinerator, which we are not, yet when there are actual incinerators proposed for this area they do not object. We can only speculate on their true motives in going after an Oneida business project," Cornelius said. "OSGC, and those working on the project, are offended by the continuing harassment of this business development."

During the April 10 Green Bay City Council meeting the alderman



## OBC Wrap: April 11 meeting

The Oneida Business Committee (OBC) ended blanket travel for themselves at the Wednesday, April 11 OBC meeting.

Present: Chairman Ed Delgado, Vice Chairman Greg Matson, Treasurer Tina Danforth, Secretary Patty Hoeft, Council members Melinda J. Danforth, Vince DelaRosa, David Jordan, Paul Ninham, Brandon Stevens

### Oaths of Office

The OBC administered oaths of office for Sandra Dennett to the Oneida Personnel Commission; Tom Oudenhoven, Judy Cornelius Hawk, Richard Baird, and Gerald Jordan to the Oneida Environmental Resource Board; and Sylvia Cornelius and Nicholas Reynolds to the Oneida Arts Board.

The OBC also swore in new Oneida Police Department (OPD) Officer Edward Metoxen.

### Minutes

The OBC approved the March 28, 2012 OBC minutes.

### Directors and Managers quarterly reports

Oneida Housing Authority (OHA) Director Dale Wheelock presented the OHA report. Wheelock discussed opening the construction bid process to get lower cost bids. Chairman Ed Delgado agreed with that assessment.

"If we want to build and develop this community, we need to be able to afford it," said Delgado. The OBC accepted the report, and also accepted a report on Self-Governance from Chris Johns.

Ombudsman Dianne McLester-Heim presented a report concerning training she's undergoing and certification she's seeking for her position. The report was accepted by the OBC.

**E m e r g e n c y** Management Director Marty Antone gave an overview of his department's activities which include an increased emphasis on earthquake training in light of the minor tremors reported in Clintonville located 40 miles from Oneida. The OBC accepted his report.

Director of Environmental Health Division Pat Pelky highlighted the progress his department has made in eliminating non-point pollution in the Duck Creek watershed. The

OBC accepted his report. **Boards, Committees and Commissions**

The OBC posted one parent vacancy for the Oneida Tribal School Board.

Reports for the Oneida Election Board and the Oneida Gaming Commission were deferred. The OBC accepted reports from the Environmental Resource Board and the Oneida Personnel Commission.

There was discussion concerning employees showing up to hearings without an advocate. Susan Daniels of the Oneida Personnel Commission stated employees were being turned away from services at the Legal Resource Center (LRC) because they don't meet the criteria. Senior Attorney Charlene Smith of LRC disputed the statement.

"Every time we referred to somebody, we will take them on. In the last three months we have received no referrals," said Smith.

"We're taking these small steps towards improvement, but you still will have employees out there that are struggling for some type of advocacy," said Daniels.

### Standing Committees

The OBC accepted the Legislative Operating Committee (LOC) quarterly report and April 9, 2012 minutes. The committee also forwarded approval forth Personnel Policies and Procedures amendments relating to capping vacation and personal time accumulation to the General Tribal Council (GTC).

The committee accepted the April 9, 2012 minutes for the Finance Committee as well as an e-poll.

### General Tribal Council

The OBC set a May 5 date for the caucus and July 7 for the GTC special election. The committee deferred setting a time and place for the July 2 semi-annual GTC meeting. The date lands on a work day, and there was discussion on whether to start the meeting at 10:00am or 6:00pm and whether to split the topics over two meetings.

"I believe this agenda is too long, and there's too many issues on here. We can't reasonably expect General Tribal Council to address this kind of agenda," said Delgado.

If a second meeting was added, research into

## Oneida plans 16th annual RFL event

Oneida community members constructed bowls of chili at an informational meeting for the 16th annual Relay for Life (RFL) of Oneida which will take place July 27-28. The theme of this year's relay will be "Constructing a Cure."

Lisa Metoxen has been participating in the area fundraiser for the American Cancer Society for the past 13 years.

"We had so much fun and we camped for free. It was a family event that I just started coming back every year, and I got roped into the committee and I just love it," she said.

Doris Yelk-Wilber was asked to chair the first Oneida RFL, but later event got personal.

"The second year I was in it, one of my friends got cancer, so from there on I started doing a team with her, and I've had Margaret's Marchers ever since," she said.

Metoxen also knows people affected by the disease.

"My sister in law has cancer, she's a survivor, she's gone through a lot of stuff, and I just lost an aunt to cancer," she said.

The relay starts the evening of Friday, July 27. Teams and individuals take turns walking around the Norbert Hill Center powwow grounds throughout the night and into Saturday morning. There's a lap honoring cancer survivors. At night, the track is lit up with luminary bags purchased and decorated to

honor cancer survivors and those who've passed.

"We always have the luminary ceremony and that's probably the most touching part of it," said Yelk-Wilber. "Just the feeling of lighting all the bags and walking around the track with all the lit candles bags it's heart wrenching."

While the serious cause has its serious moments, most people turn out for the competitions, music, movies, and Dude Looks

Like a Lady contest.

"Once you're there you'll find that there's so much fun, there's something from zero to 100 years old. There's always something going on, there's so many community members that go there, you'll be shocked," said Metoxen. "So much support and love from the community."

voted 9-2 to review the process OSGC obtained their permit and if the company mislead the council when presenting the project to the city.

One of the main areas of concern opponents of the project have are the exhaust vents the plant uses. Opponents call them smokestacks while OSGC labels them as exhaust pipes.

"OSGC has always stated that there will be no smokestacks such as those associated with power plants or paper mills. There will be exhaust pipes, which are referred to as stacks in WDNR permitting, which are common to almost every industry," Cornelius said.

Project critics feel the technology is untested and bound for failure, which in turn would lead to it polluting the area and releasing toxins into the atmosphere.

But, state and federal officials disagree. After more than a year of review the facility received air and waste permits issued by the Wisconsin Department of Natural Resources, and a

Finding of No Significant Environmental Impact from both the U.S. Department of Energy and the U.S. Bureau of Indian Affairs.

"It won't matter what scientific-based evidence we produce, or what government agency experts say, the opposition will not believe it," Cornelius said. "It won't matter how many public comment periods or public meetings are held, they will not be satisfied."

The facility will be located on Hurlbut Street in Green Bay. It will take municipal waste through a gasification process that will create power that will be sold to Wisconsin Public Service. OSGC claims the 60,000 square foot plant will decrease waste from going into landfills, increase recycling and create jobs. Construction is set to begin this spring.

"What is being lost in all of this nonsense is that this is a green energy project that is good for the environment and good for the local economy," said Cornelius.

## And the beat goes on...

And the beat goes on... At least that is the consensus of a core group of organizers who managed to bring back the traditional powwow on the grounds of the University of Wisconsin Green Bay Campus after a three year hiatus.

The 15th Annual Powwow which was held on Saturday, April 14 was coordinated by the Intertribal Student Council (ISC) of UWGB.

The ISC is the Native student organization on campus, explained Luanne Funmaker, one of four executive members. Other members include Donald Keeble, Jose Villa, and Annette Wilber.

Co-advisers, Deb Rezac and Dave Turney (Napos) assisted with the student organized event.

"The powwow is the biggest multicultural event on the UWGB campus," she added.

It had been discontinued in 2008. It had been held on campus for 14 consecutive years. According to Funmaker, the reason students had stopped planning and hosting the powwow was due to lack of support from administration.

"The students who had worked diligently to make the powwow a success were never recognized as the University

took full credit for the event," she explained. "This year however, the University has been extremely supportive, especially in providing monetary support," she added.

### Powwow highlights

Connie Danforth served as head female dancer and Alan Caldwell as the head male dancer.

The Host Drum was Bear Creek of Rankin Reserve, Ontario. Other invited drums included Smokey Town, Young Firekeepers, Ho-Chunk Station and Chief Hill. A total of eleven drums participated in the event.

John Teller Jr. was the arena director while Dan King served as emcee.

Porky John, Oneida, was recognized for 28 years of Sobriety and was given an eagle feather by Wes Martin. A dance was held in his honor thereafter with those in attendance coming forward to congratulate him on his sobriety.

Other performances included the Oneida Social dancers who were able to dance to Charlie Doxtator's smoke dance songs.

A men's dance competition was also held during the evening festivities. Dana Warrington and Mike Fish, both Menominee, took first and second place honors

respectively. The ISC (Donald Keeble) was able to collect donations to have a mens all category competition. "We never expected to have either of the opportunities so it was a really great treat for us and the audience," said Funmaker.

### Will the Tradition continue?

When asked by another source what the prospects were for holding a UWGB powwow next year? Funmaker said the following:

The Intertribal Student Council did get approved from SUFAC for a budget that includes the powwow. But we really need Native students to step up in order for another successful powwow like this passed year. Donald Keeble and myself will be graduating in December, so since we were the main students responsible for organizing, planning, and facilitating the event, we are worried about it continuing.

The Intertribal Student Council is comprised of Native students who attend UWGB. Some tribes represented in Intertribal are Menominee, Oneida, Potawatomi, Ojibwe, and Quileute. "We also have non-Native members who are very active in Intertribal," said Funmaker.

Others who played an instrumental role in the current relationship with Native students/faculty were recognized and include: Bernadine Vigue, Selma Buckwheat, Reanne Skenadore, Kathy Newbanks, Alicia Waupoose, Nichole Merckes and Angi Moon.

These individuals were the last ones to put the powwow together in 2008. Due to the strenuous relationship with the administration back then, These individuals provided current Intertribal members with a strong history. This is the reason why the organization has the strong and healthy relationship today with the University and administration.

We would not be able to have hosted such a successful powwow without the struggles past students and faculty endured. This is where Intertribal came up with the theme: *Honoring Those Who Came Before Us.*

None of the organizers of this years 15th annual UWGB powwow have ever organized a powwow before. "This event has been by far one of the hardest and most difficult endeavors I have ever accomplished," she said.

The success of the event is a testament to their dedication to bring back a native tradition.

The OBC passed a resolution which authorizes submission of a 2012 Coordinated Tribal Grant Solicitation (CTAS) grant. The grant from the US Department of Justice would provide funding for public safety and community policing, justice systems and alcohol and substance abuse, tribal sexual assault services program, violence against women tribal governments program and tribal youth program. The grant could add up to over \$2 million over three years with no matching funds required. Plans for the grant would include increasing services at the LRC to include legal counsel for individuals facing drug and alcohol charges for little or no cost. Smith explained her department

often refers individuals to Oneida's Alcohol and Other Drug Abuse (AODA) programs.

"It seems to me that most of the people that come to me for criminal defense representation have an alcohol or drug problem; that even extends into family law," said Smith.

In the April 5, 2012 OBC Forum, Paul Ninhm suggests that the OSGC and OBC know more than UK and EU legislatures which classify pyrolysis and gasification as incineration (Directive 2000/76/EC), that the OSGC has no duty to prove that the impacts of new technologies are safe for seven generations, that not signing a petition against their project is somehow evidence of support, and that anyone who shares the concerns of long term environmental activists such as Rebecca Katers is simply a racist.

The US Department of Energy has approved technologies resulting in the ongoing Gulf oil disaster as well as problems at Fort Calhoun, San Onofre and other nuclear power plants, and now OSGC's bumbling hubris might provoke a conscientious boycott of Tribal enterprises.

Will Green Bay's burgeoning downtown business community and ventures such as the Children's Museum join efforts opposing harmful emissions from OSGC's toxic endeavor to protect their employees and customers? OSGC is gam-

bling Oneida's resources and reputation to find out.

I should be known that OSGC now has a "full care, custody and control Operations and Maintenance agreement" with PIC, a subsidiary of Marubeni Corp. which recently "agreed to pay a \$54.6 million criminal penalty to resolve charges related to the Foreign Corrupt Practices Act for a decade-long scheme to bribe" government officials to obtain energy con-

tracts.

## Payday Loans Equal Very Costly Cash: Please Consider the Alternatives

*"I just need enough cash to tide me over until payday."*

**"GET CASH UNTIL PAYDAY!...\$100 OR MORE...FAST."**

The ads are on the radio, television, the Internet, even in the mail. They refer to payday loans, cash advance loans, check advance loans, post-dated check loans, or deferred deposit loans. Regardless of their names, these small, short-term, high-rate loans by check cashers, finance companies and others come at a very high price.

Here is how they work: A borrower writes a personal check payable to the lender for the amount the person wants to borrow, plus the fee they must pay for borrowing. The company gives the borrower the amount of the check less the fee, and agrees to hold the check until the loan is due, usually the borrower's next payday. Or, with the borrower's permission, the company deposits the amount borrowed-less the fee- into the borrower's checking account electronically. The loan amount is due to be debited the next payday. The fees on these loans can be a percentage of the face value of the check - or they can be based on increments of money borrowed: say, a fee for every \$50 or \$100 borrowed. The borrower is charged new fees each time the same loan is extended or "rolled over."

The federal Truth in Lending Act treats payday loans like other types of credit: the lenders must disclose the cost of the loan. Payday lenders must give you the finance charge (a dollar amount) and the annual percentage rate (APR-the cost of credit on a yearly basis) in writing before you sign for the loan. The APR is based on several things, including the amount you borrow, the interest rate and credit costs you are being charged, and the length of your loan.

A payday loan-that is, a cash advance secured by a personal check or paid by electronic transfer is a very expensive credit. How expensive? Say you need to borrow \$100 for two weeks. You write a personal check for \$115, with \$15 the fee to borrow the money. The check casher or payday lender agrees to hold your check until your next payday. When that day comes around, either the lender deposits the check and you redeem it by paying the \$115 in cash, or you roll-over the loan and are charged \$15 more to extend the financing for 14 more days. If you agree to electronic payments instead of a check, here is what would happen on your next payday: the company would debit the full amount of the loan from your checking account electronically, or extend the loan for an additional \$15. The cost of the initial \$100 loan is a \$15 finance charge and an annual percentage rate

of 391 percent. If you roll-over three times, the finance charge would climb to \$60 to borrow the \$100.

### Alternatives to Payday Loans

Before you decide to take out a payday loan, consider some alternatives.

1. Consider a small loan from your Bank. A local community-based organization may make small business loans to people. A cash advance on a credit card also may be possible, but it may have a higher interest rate than other sources of funds: find out the terms before you decide. In any case, shop first and compare all available offers.
2. Shop the credit offer with the lowest cost. Compare the APR and the finance charge, which includes loan fees, interest and other credit costs. You are looking for the lowest APR.
3. Contact your creditors or loan services as quickly as possible if you are having trouble with your payments, and ask for more time. Many will be willing to work with you if they believe you are acting in good faith. The may offer an extension on yours bills; make sure you find out what the charges would be for that service-a late charge, an additional finance charge, or a higher interest rate.
4. Contact your local

consumer credit counseling service if you need help working out a debt repayment plan with creditors or developing a budget. Non-profit groups in every state offer credit guidance for no or low cost.

5. Make a realistic budget, including your monthly and daily expenditures, and plan, plan, plan. Try to avoid unnecessary purchases: the costs of small, every-day items like a cup of coffee add up. At the same time, try to build some savings: small deposits do help. A savings account - however modest - can help you avoid borrowing for emergencies. Saving the fee on a \$300 payday loan for six months, for example can help you create a buffer against financial emergencies.
6. Find out if you have overdraft protection on your checking account. If you are using most or all your funds in your account regularly and you make a mistake in your account records, overdraft protection can help protect you from further credit problems. Find out the terms of the overdraft protection available to you - both what it costs and what it covers.

The bottom line on payday loans: Try to find an alternative. If you must use one, try to limit the amount. Borrow only as much as you can afford to pay with your next paycheck - and still have enough to make it to next payday.

Shekoli,

When she was 10 years old, Morningstar Skenandore said while crossing the Fox River

with tribal elder Yvonne Metiver, "My poor river, look what they've done to you." Today Morningstar is a young adult, mother of a very handsome son; Yvonne is still a tribal elder. Most people, Indian and non-Indian, do not eat the fish from the Fox River because the water is polluted.

When the Oneidas came here nearly 200 years ago, the Fox River was clean as we settled around its banks and the banks of Duck Creek. Now, Duck Creek is so polluted that people do not even swim in it. The Oneidas did not pollute the Fox River, nor did

we pollute Duck Creek. Dean Hoegger, President of Clean Water Action Council of Northeastern Wisconsin, in his recent letter in our tribal newspaper, appears to be saying that the Tribe is now a polluter because we own a company that is proposing to build what he calls a "gasification incinerator." Surely, if I would say Dean Hoegger's people polluted the Fox River and Duck Creek, some would say that I would be out of line and I would agree. But the Oneidas are not polluters of our Mother either, and I want Dean Hoegger and his people

to know that. The environment that we all live in, both Indian and non-Indian, is sacred to the Oneidas. The environment is part of who we are, how we pray, and how we conduct ourselves on a daily basis. The gasification project Mr. Hoegger is concerned about has only gone forward after the Wisconsin Department of Natural Resources and the United States Department of Energy has deemed it to be safe for the environment. With the endorsement from those agencies and the Federal government, the project not only

would never have reached the construction phase it is now at, but, the Oneida people would never have endorsed it and supported it, because as Oneidas, our Mother remains sacred. It appears that the Oneidas and Mr. Hoegger and his people have something in common after all. Regarding the people who signed the petition and the residents of the Mather Heights neighborhood, they appear to be concerned that the true environmental facts about the gasification project were not included when the project applied for a conditional

use permit. Nothing wrong with that! Better safe than sorry and always better to have healthy children. The Oneida Business Committee is currently in the process of acquiring all the conditional use permits documentation that was submitted to Green Bay City Council. I think all of us want to get all the facts for the betterment of all our communities. I think Dean Hoegger and his people would agree. ## OBC Forum...

This has been a wonderful start to spring. It has been great to continue to get out and talk to tribal members and tribal employees over the last few months. There is a spirit of renewal in the community to make things happen and make positive change. Thanks to everyone who has contributed their ideas to the discussion.

### DNA Testing – Better Living through Science

I am following-up on a proposal I made some five years ago to the Oneida Health Center and to the Oneida Tribe. The question back then was can DNA assessments targeting gene/nutrient connections actually occur? The answer then and now is yes; DNA testing can be and is being used in this manner.

For many years I have been a proponent of using a form of advance DNA testing to pursue

our understanding of potential and/or future health risks due to a lack of nutrients. The goal of this project is to try and enhance the lives of Oneida tribal members by using good science and intuitive nutritional delivery models; I call it better living through science.

The essence of this project comes from inspiring thoughts and techniques using science to help assert a laser approach towards addressing some of our health needs. The idea of accurately utilizing our own DNA, micro-nutrients and good eating habits to reverse some stubborn health trends is truly an inspiring concept for the Oneida people.

Extending the quality of life for all tribal members has continued to be a goal of mine. American Indians (Oneidas) and Alaska Natives are at greater risk for diabetes along with other health

concerns. We are spending over \$30 million dollars a year on our local self-funded health care costs. The idea that we may be the largest distributing pharmacy of pharmaceuticals in the entire State of Wisconsin should alarm all of us. In Oneida we really should aim our attention at tearing down barriers so we can improve health care for our tribal members; that's my goal here. I look forward to presenting an extensive plan for tribal member review in the near future.

### Housing

Substantial work has been done in the housing area since my last Kalihwisaks article. I

have continued to work on a proposal to bring not only additional housing opportunities to the reservation but also the opportunity for job creation.

When it comes to housing on the Oneida Reservation, we are embroiled in an ongoing emergency. To help manage the overbearing need for housing for our tribal members I have proposed that a housing plant be built here that will do what we already do, build homes. However, we would be building these homes at an incredible level, while saving costs. Moreover, this plant would operate under the direction of master craftsmen who will guide and teach Oneida Tribal members how to build these homes.

Part of the overall goal is to build top-of-the-line master crafted homes; create new jobs for the Oneida people; and tighten the costs of building new homes, in turn we can service more Oneidas and get more for our money. The proposal will also involve a new housing funding mechanism which will help ensure that we are helping tribal members who desperately need new housing options and assistance.

At a recent ONCOA meeting, I was able to discuss my housing proposal. As a follow up to the ONCOA meeting, I met with GLIS to identify possible LUTU property for a future housing plant. I have also met with the Chief Financial Officer to discuss funding and investment options. Although I am

at times frustrated at the slow moving process for getting my housing plan up and operational, I am still optimistic that it will come to fruition in the near future.

### Community Development Planning Committee (CDPC)

The CDPC has continued to meet monthly to address a variety of community development projects, initiatives and ideas. We have begun to hold a few very productive and informative work meetings as preparation for future meetings. These meetings have proven to be productive and informative. Some of the topics we have addressed from an overall strategic standpoint have been retail opportunities, the potential of moving the Farmer's Market, and the development of a comprehensive strategic plan to address how tribal buildings are occupied. There is still much work to be done but we have taken positive steps towards planning versus reacting. I'd like to personally thank the Tribal Secretary for taking the initiative to begin these types of discussions.

### Policy Update

As a reminder, there will be a public hearing on the Legislative Procedures Act (LPA) Tuesday, April 17th. Comments regarding the LPA can be submitted to the Legislative Reference Office up to 10 business days after the public hearing for consideration. I encourage everyone to review the LPA and look forward to your honest and frank opinions and comments, not only on the LPA, but on all legislation and policy matters my office is working on. In keeping with my

housing initiatives, I have also submitted my recommendations for prioritizing housing related legislation for this term to the CPDC for consideration. As a follow up to that discussion I've submitted a request to the LOC for research and analysis work to begin on a comprehensive housing law.

Some of the other legislative initiatives I have been working on include a new rule making law to compliment the LPA and updating the SEOTS bylaws which has included work with the SEOTS Board and tribal members on amendment recommendations.

### Outreach

Since my last article I have visited with seven elders and over twenty other tribal members on a variety of topics. Overall, I have attended more than 35 meetings with entities and tribal members over the last three weeks as follow-ups on policy and governance issues. In particular, the budget meetings have prompted some very good discussions with entities. I thank everyone for their time and attention to detail as we move through the next budget process.

Also we need to outline the funds that would allow us to do this venture.

**For the record:** Melinda J. Danforth stated I support the concept as well. I support Councilman DelaRosa's presentation and information, however without a project plan or without the projected financial project cost I just sincerely cannot enter into a \$40,000 contract with a law firm, to move forward a project plan that has no substance to it.

### Purpose: Tribal Environmental Response Law

The intent of the Tribal Environmental Response Law is to direct the Environmental Health and Safety Division (Division) to create a Tribal Environmental Response Program (TERP) which will address situations where the discharge or potential discharge of a hazardous substance has occurred and may have contaminated the environment. In order to regulate the identification, investigation and remediation of discharges of hazardous substances, this law:

- Requires individuals who are responsible for or aware of a discharge of a hazardous substance to notify the Division and, in most cases, to be responsible for the remedial action necessary to restore the environment to the condition it was in before the discharge occurred.
- Makes the Division responsible to:
  - o Adopt standards for environmental quality that are protective of

public health and the environment. Business Committee approval of these standards is required, except when the standards are consistent with federal standards.

- o Conduct investigations of sites and facilities that are, or are suspected of being, contaminated from the discharge of a hazardous substance.
- o Identify parties that are responsible for the clean-up of contaminated sites and facilities.
- o Require appropriate remedial actions be taken when contaminated sites and facilities are identified.

### Purpose: Canons of Judicial Conduct Response Law

These Canons are intended to govern the conduct of Judges and Judicial Candidates under the Judiciary Act. These Canons also apply to law clerks, Judiciary staff attorneys, paralegals, court administrators, and others who are in close and constant working relationship with a Judge. The Canons establish overarching principles of judicial ethics; create a base from which all Judges are expected to strive; provide guidance and assist Judges in maintaining the highest standards of judicial and personal conduct; and establish a basis for the regulation of conduct through disciplinary measures. Specifically, the Canons require:

- A Judge to uphold and promote the independence, integrity, competence and impartiality of the Judiciary and avoid impropriety and the appearance of impropriety.
- A Judge's judicial duties to take precedence over all of the Judge's personal and extrajudicial activ-

ities, which shall be conducted in such a manner as to minimize the risk of conflicts with the obligations of judicial office.

- A Judge to avoid financial and business dealings that tend to reflect adversely on his or her impartiality or interfere with the performance of his or her judicial responsibilities.
- Judges and Judicial Candidates to affirm and display the respectful integrity and dignity of a person qualified to hold a position on the Judiciary and recommends they refrain from any political activity which might interfere with the performance of his or her judicial duties.

### Former Ho-Chunk legislator pleads guilty to bribery

**Madison, WI (AP)** – A former Ho-Chunk legislator has pleaded guilty to bribery in federal court. Fifty-three-year-old Clarence Pettibone, of Black River Falls, was accused of supporting Trinity Financial Group for a \$250,000 housing study in exchange for a Pontiac Firebird. Two representatives of Trinity Financial are also charged with bribery conspiracy. They face trial in July in the Western District of federal court. Pettibone was a Ho-Chunk government official from 2000 to 2009. He's facing a maximum 10 years in federal prison when he's sentenced July 11. The FBI and Internal Revenue Service investigated.

### National Guard unit helping farmers in Afghanistan

**Madison, WI (AP)** – A Wisconsin National Guard unit has taken over the mission of helping farmers in Afghanistan. The 82nd Agribusiness Development Team is the Wisconsin National Guard's first such unit. It has taken over the mission of improving civilian skills crucial to agricultural success in Kunar Province. Team commander Col. Darrel Feucht says it has been a long road in assembling the unit and training its members, but it's now ready to provide guidance to the Afghan farming community. The Wisconsin National Guard learned it would get an agribusiness development mission in 2010. The unit trained for 12 months before reporting for active duty in February and completing mobilization training at Camp Atterbury, Ind. The mission was transferred from the Illinois National Guard in a ceremony last week.

### Rising failed drug tests limit employers' hiring options

**Manitowoc, WI (AP)** – The president of a group that supports Wisconsin's business industry says employers are stymied in the search for skilled workers by failed drug tests. Wisconsin Manufacturers and Commerce Foundation president Jim Morgan says more companies are drug testing potential employees, especially in manufacturing because of safety issues. Morgan says the long-term concern for a shortage of skilled workers is causing communities like Manitowoc to address the issue. The coordinator of the initiative Healthiest Manitowoc County 2020, Annie Short, says employers are telling her as many as half of potential employees are failing drug tests. She tells the Manitowoc Herald Times Reporter it seems to be a vicious circle – some people may be using drugs because they're depressed about being unemployed. But, they can't get a job because they can't pass a drug test.

### Appeals court hears Arizona tribe's casino project

**San Francisco (AP)** – A federal appeals court on Monday took up an Arizona Indian tribe's complicated legal fight to build a massive casino and resort near a Glendale, Ariz., neighborhood, on property the tribe owns 160 miles from the headquarters of its sprawling reservation. The three-judge panel of the 9th U.S. Circuit Court of Appeals in San Francisco gave no hint of how or when it would rule after sharply questioning lawyers on both sides for nearly an hour. At issue is whether federal law permits the Tohono O'odham Nation to convert property it quietly purchased in 2003 into an Indian reservation, which would strip authority from state and local officials who argue the casino project clashes with zoning and state laws. The suburban property is in an unincorporated island of Maricopa County and bordered on

three sides by the city of Glendale. Local and state officials argue that the proposed 150,000-square-foot casino will require them to beef up fire, police and other civic requirements in an area not equipped to accommodate a Las Vegas-style resort. The tribe says it bought the property with congressionally allocated money it was given after a federal government dam caused extensive flooding of the original reservation. The Department of the Interior declared the Glendale property a reservation in 2010. The tribe had received \$30 million to replace nearly 10,000 acres of ancestral reservation land damaged by the dam. Glendale, the state of Arizona and another tribe filed a lawsuit to overturn the Department of the Interior decision. Several other tribes submitted so-called friend-of-the-court briefs opposing the casino. A

## Smithsonian opens new, diverse US history timeline

**Washington (AP)** – Dorothy's ruby slippers from "The Wizard of Oz" have a new home with a diverse set of artifacts in a new timeline of American history that includes a piece of Plymouth Rock, a slave ship manifest, Alexander Graham Bell's telephone and Kermit the Frog at the Smithsonian Institution.

The National Museum of American History will open the exhibit Thursday featuring iconic objects from pop culture along with items dating to the Pilgrims' arrival in 1620 in Plymouth, Mass. "American Stories" will be a new chronology of U.S. history from the early encounters of Europeans and Native Americans to a Barack Obama campaign button written in Hebrew in the 2008 presidential election. Dorothy's famed shoes from the 1939 movie will help show the emergence of American pop culture and its significance in forming our shared memories. Mixing items from pop culture into a broader timeline is a big change for the museum. For more than 20 years, the slippers have been shown in a separate gallery of memorable items from the movies

and entertainment history. Now they will join other items that explore the nation's founding, growth and reforms, innovations and contemporary society. "We're so getting away from the time when history was all about white men on horses," said Marc Pachter, the museum's interim director. "This is a broader definition of what is important to remember." This is the museum's first major exhibit with a Spanish translation, which can be accessed online or with mobile smartphones. The museum also developed a mobile app with fuller descriptions of each object on display in English and Spanish. Curators also are asking visitors to suggest objects that should be part of the American history collection. They can make suggestions in the exhibit or on the museum's website. "We know that there are millions of untold American stories out there," Pachter said. "We will never tell them all, but we can do better in the range of what we collect and display." Near the start of the timeline layout is Plymouth Rock and its mythic place in U.S. history, along with wampum beads made from shells that were prized by

American Indians for their value as trading currency. Nearby is Ben Franklin's walking stick and three-piece silk suit worn at the Treaty of Alliance signing with France in 1778 during the Revolutionary War. The suit is on loan from the Massachusetts Historical Association. An 1830s slave ship manifest from Alexandria, Va., was recently acquired by the museum and is being displayed for the first time. It records the sale of 83 enslaved Americans, their names and their descriptions to bring humanity to the horrors of slavery, said curator Bill Yeingst, who directed the "American Stories" project. The timeline continues with President Abraham Lincoln's gold pocket watch, an 1864 medal from U.S. Colored Troops, Bell's Big Box Telephone from 1876, a baseball autographed by Babe Ruth around 1929, Jonas Salk's polio vaccine in a vial from the 1950s, Roberto Clemente's batting helmet from the 1960s, and an Apple II computer from the 1980s. Some of the museum's newest acquisitions expand the diversity of the collection, curators said. There is a prosthetic leg socket from a U.S. soldier wounded in 2003

during the Iraq war. Curators also collected a pink gown from a 2006 Quinceanera, a Latin American tradition of celebrating a girl's 15th birthday as the transition to adulthood. Natalia Flores of Chicago, who is now 20, donated the gown to add a piece of Latina history to the Smithsonian. "It's my own American story here in America," she said while visiting the museum Wednesday. "It's a representation of many other stories of Latinas." The museum also is featuring a purse carried by Camilla Gottlieb that was filled with about 250 of her family's life documents as they left their home in Vienna and were taken into concentration camps during the Holocaust. Eventually Gottlieb immigrated to the United States. Her family later found the purse in a closet. A newer relic in the collection isn't so old but is already starting to show its age. The museum acquired a fourth generation iPod in 2004 from a young Washington resident to show the evolution of music technology from the 1950s to the 2000s. Pachter said an iPod from 2004 already is considered "ancient technology" and will have a place at the Smithsonian.

## Judge asked to resume cleanup of Fox River

GREEN BAY, Wis. (AP) ~ Federal prosecutors were expected to ask a judge Thursday to restart the cleanup of contaminated sediment from the Fox River in Brown County, a project that could cost more than \$1 billion.

Earlier this week, Judge William Griesbach removed Appleton Papers Inc. as a defendant in the lawsuit over who should bear the cost of cleaning toxic chemicals from the lower part of the river. The company, in partnership with NCR Corp., has already spent \$300 million to rid the river of sediment contaminated by the discharge of paper-making waste chemicals years ago.

State and federal environmental officials are seeking to speed up the dredging operation, and have asked the judge to force NCR to resume full-scale dredging.

In his ruling Tuesday, Griesbach removed Appleton Papers as a defendant in the lawsuit because he said the company had no direct liability for dumping polychlorinated biphenyls, or PCBs, into the river. NCR and several other parties remain defendants.

Appleton Papers is still responsible for certain indirect costs of remediation.

Appleton Papers and NCR formed a limited partnership that has spent about \$315 million so far to have contractors clean the lower Fox River. But the work came to a halt last summer when the companies refused to spend an additional \$50 million on dredging last year.

Cleanup was supposed to resume last week, but it was delayed until Griesbach issued his decision.

Appleton Papers was formed in 1978, when it bought the facilities of the former Appleton Coated Paper Co. and the Combined Locks paper mills from NCR. The purchase came well after NCR stopped producing PCB-coated paper, so Appleton Papers had argued it shouldn't be held liable for PCB cleanup costs.

## Crane population calls Oneida home

The International Crane Count was Saturday, April 14, 2012. Spotters counted about 250 cranes in Oneida on three sites.

The Crane Count is one of the largest citizen-based wildlife surveys in the world. One of the primary purposes of the Crane Count is to monitor the abundance and distribution of cranes in the upper Midwest. Each year, the Crane Count involves over 3,000 volunteer participants spread over 100 counties in six states (Wisconsin and portions of Illinois, Indiana, Iowa, Michigan, and Minnesota).



## Public meeting scheduled for WIS 29 improvements in Brown Co.

The Wisconsin Department of Transportation (WisDOT) NE Region office in Green Bay is announcing a public information meeting to discuss WIS 29 improvement project from County U to County FF in Brown County. The meeting is scheduled for Thursday, April 26 from 5 p.m. to 7 p.m. at the Hillcrest Elementary School, 4193 Hillcrest Drive in the Village Hobart. A brief presentation has been scheduled for 5:15 p.m.

The Wisconsin Department of Transportation began studying this stretch of highway several years ago, completing a corridor preservation study in 2008. The corridor preservation study identified interchange locations at County VV and County FF. It also recommended building overpasses at County U and at the extension of North Pine Tree Road along with closing the Sunlite Drive and Woodland Road intersection.

Construction funding has been allocated to build the County FF interchange and to close the Sunlite Drive and Woodland Road at-grade intersection. Construction at this interchange is planned to begin in late 2013 and be completed by August 2014.

Construction funds have not yet been allocated for the County VV interchange or the County U and North Pine Tree Road overpasses. To improve safety in the interim, J-turns will be constructed at County VV and County U will be modified to eliminate left

turns from County U onto WIS 29 (similar to the County J intersection to the east). Construction is expected to begin on these intersection improvements in early 2013 and be completed by mid summer.

Additionally, WisDOT is evaluating the conceptual plans prepared during the corridor preservation study for the County VV interchange or the County U and North Pine Tree Road overpasses and completing preliminary designs for these interchanges and overpasses. The improvements are being refined to reduce impacts to residential properties, wetlands, and other features along WIS 29. Alternatives have been developed for the County U overpass, for the Milltown Road realignment, and for the North Pine Tree Road extension.

The public is encouraged to attend this meeting. It will be held in an open-house format. Individuals can stop by at their convenience during the meeting, talk with project staff, learn more about the project, review the project displays, and ask questions and share comments.

The hall is wheelchair accessible. Those who are hearing impaired and require an interpreter should contact WisDOT project manager Jeremy Ashauer prior to Friday, April 20. The Oneida Nation Farm is deeply concerned about the health of the people in our area. That is why education is of extreme importance to the folks at the Oneida Nation Farm. As diseases continue to spread, and health continues to decline, you will see a change in our views from just eating plain food to eating healthy food. As people start becoming more aware of how they are fueling their human gas tank they will understand the need to eat good healthy food.

With more and more of our youth becoming disconnected with the land, and not understanding the importance of healthy foods, it has never been more important to discover new ways of bringing them back to the earth both physically and spiritually. On April 12th, of this year the Farm and Apple Orchard participated in Youth Day on the Farm. They took thirty-one youth from the Oneida Elementary 6th grade and gave them a 'hands-on' tour of the Oneida Apple Orchard, Buffalo Corral, Oneida Nation Farm and Ver Hasselt Farms LTD.

At the Oneida Nation Farm the youth learned some Veterinarian skills such as what it is like to give an animal a shot by practicing on oranges. They also learned about the importance of computer skills in relation to today's farming, soil testing, nutrient management, and equipment usage and care. They toured the livestock operation as well as the cow/calf operation and some of them were lucky enough to touch a buffalo and see a couple of very young buffalo calves.

The group then had lunch, which was made up of delicious Black Angus burgers right from the Oneida Nation Farm and locally made desserts. After lunch there were informational tables for the youth to visit: the Seymour FFA officers were present, along with



## Lacrosse coach looks to build structure, maximize program

Lacrosse is one of the United States' fastest growing sports, especially in the amateur ranks. The game's origins belong to early Native Americans and even factors in to parts of Native culture. However, the Oneida high school lacrosse team remained stagnant until recently. But if new head coach Matt Myke has his way the Oneida program will be very respectable very soon.

Myke is originally from Six Nations, Ontario, Canada and has been playing lacrosse since he was five years old. He went on to play college lacrosse in Syracuse, then box lacrosse in a semi-pro league and was good enough to be drafted by the Minnesota Swarm professional team.

"I spent a year with the Minnesota Swarm and then I blew out my knee for the second time and figured the best way to be in the game from then on is to coach," Myke said.

Myke then moved on to coaching the Iroquois Nationals under 19 team.

Having moved to northeast Wisconsin within the past few years Myke looked for an opportunity to offer his knowledge of lacrosse to

an area team.

"I moved here a few years ago and recently got married, had a baby, and bought a house here so I was settled here. After being around a few years I learned there was an all-native high school lacrosse team, I knew then that I wanted to come here and help the boys," said Myke.

He then was able to secure the head coaching position for the Oneida Thunderhawks lacrosse team. The first thing Myke looked to improve was the program's structure or lack thereof.

"I noticed when I first arrived that the program didn't really have any structure. We have all this talent here because we are just born with that talent for the game. I just saw a lot of raw talent that needed to be molded and given direction and structure," Myke said.

Coaching three attributes that benefit not only the players' lacrosse game, but also their character as young men creates this structure.

"I've always coached with the motto Heart, Work Ethic, and Desire. Those three things, no matter what you apply it to, will always go you good. Those three things will eventually build your character; in lacrosse character is what

wins championships," said Myke.

Myke also believes that by demanding the best of the players on the field and in the classroom will greatly improve the student-athletes and the program.

"I want to recognize their abilities and push them to their max. So I'm not just teaching them basic things; I'm teaching them at a college lacrosse level and they're soaking it up like a sponge," Myke added.

The change in team philosophy has gotten the players attention.

"There is definitely a different style of play this year but its good to be learning how big time lacrosse players play the game. But it is also harder work but we are better in games," said Oneida junior Diego Metoxen.

Fellow junior Devonte Pointer also added, "Practices are more focused. We don't just run around and play like a gym class, we learn the right roles each position has to play."

Myke cites his history of playing for great coaches growing up as his reason for many of his highest moments in life. They taught him to always reach for your highest potential and that is what he would like to pass on to his players.

"When I coach I always reach for the highest goal possible. My first goal is to make this year the best year possible so that we can join a league and stay on top of that league. Be one of the teams that are on top of this area. As far

as we can go and as high as we can go that's always my goal," Myke said.

Oneida Police Officer Matthew Ninham also volunteers his time as assistant coach.

Registered Nurses (RN) are available for patient phone calls – 24 hours a day/7days a week. When the clinic is closed the RN is home. They do not have access to medical records or pharmacy information.

### When to call and speak with the RN After Clinic Hours:

- You/your child have an urgent health care need/question that cannot wait until the next open day of the clinic.
- Don't call the RN when you are having a life threatening issue. For example, chest pain, difficulty breathing, or bleeding profusely from a wound. Access the nearest emergency department to get medical attention as soon as possible. Call 911 as needed for intervention. Call the Contract Health Services Department to report the visit within 72 hours to ensure coverage.
- The RN's on call also work 40+ hours per week at the OCHC medical clinic, in addition to providing on call services. Calling in the middle of the night with a concern that is not urgent is not appropriate.
- On call staff does not determine Contract Health eligibility. You need to contact the Contract Health Department when the clinic reopens to check on eligibility.
