

General Tribal Council meets for special meeting

GTC focuses much of meeting attention to Oneida Seven Generations Corporations renewable energy project set for the city of Green Bay

A spirited General Tribal Council (GTC) put a small dent in a packed agenda during the April 11 Special GTC Meeting.

A resolution seeking discussion on the Oneida Tribe's relationship with Seven Generations Corporation (OSGC) and

possible action was moved to the front of the agenda.

The submitted resolution asked that the GTC direct the (Oneida) Business Committee (OBC) to report on potential damage to government-to-government relationships as a result of corporate actions with discussion on how as a government we will respond to it.

It also asked that the GTC request discussion on the terms of the tribe's agreement with OSGC and the potential of changing that agreement to bring about reporting to the OBC and the GTC

on legal, political, and fiscal matters.

At the center of the discussion portion of the meeting was the history and current status of OSGC's proposed renewable energy project in Green Bay.

Staff from OSGC presented a detailed outline of activity that lead to the project moving locations multiple times and the financial terms of the project.

Chairman Rick Hill ruled multiple motions out of order after he found them to pierce the corporate veil that protects the tribe from any liability regarding OSGC

projects. The motions were requesting financial reports and audits along with action by the GTC to determine the retention of OSGC. After a legal opinion was formed by the tribe's legal counsel Hill proceeded to rule the requests out of order.

A motion was then overwhelmingly accepted by a voice vote to accept OSGC's presentation.

The remaining agenda was tabled, which included tabled items regarding Indian Preference in hiring along with amendments to the Vacation and personal Day Accumulation policy. It

also included the Trade Back for Cash of Vacation and Personal Time policy changes and resolutions that ask that GTC voting will not require two-thirds majority to change law and a request to double the size of the grass-fed beef herd at the Tsyunhehkawa farm were tabled. No date was set to have the items not heard brought before the GTC.

The next GTC meeting is scheduled for Monday, May 23 at 6 p.m. at the Radisson Hotel and Conference Center. The tabled items along with two petitions are on the meeting agenda.

Bad River Chair gives State of the Tribes address

MADISON, Wis. (AP) ~ A Chippewa tribal leader warned state lawmakers Tuesday about the dangers posed to the environment by a proposed mine in northern Wisconsin.

Mike Wiggins Jr., the chairman of the Bad River Band of Lake Superior Chippewa Indians, said during the annual State of the Tribes address that a push to mine for iron ore in northern Wisconsin could have drastic effects on ground water and other aspects of the environment.

"The tribes are compelled through a unified value system ... to see beyond ringing endorsements and ultimately well beyond industrialization. Especially industrialization with unquantified and undetermined environmental risks."

Gogebic Taconite wants to spend more than \$1 billion to develop an open-pit iron ore mine. It

State of the Tribes

Agreement reached with Ashwaubenon

The Oneida Tribe made a service agreement with the Village of Ashwaubenon official by signing the document on Friday, April 15 at the Radisson Hotel and Conference Center.

The three-year agreement will pay the village \$305,209 during the first year with the remaining two years determined by an equation set out in the agreement. Funds for the agreement will come from the tribe's gaming compact with the state. It calls for no opposition from the village regarding the tribe's desire to place land into federal trust status and that the tribe agree not to permit any gasification or waste-to-energy facilities within the village boundaries.

According to tribal chairman Rick Hill, the Oneida Tribe was one of the first tribes to compensate local municipalities for services utilized by tribal members that are offered by municipalities.

The agreement outlines payments to the village for governmental services they provide to the tribe. The agreement also acknowledges governmental services provided by the tribe to the village.

"In this case there is overlapping jurisdictions here and that it's been recognized through our treaty of 1838 and this document here that the Oneidas have this territory," said Hill. "I really appreciate the leadership (Village of Ashwaubenon President) Mike (Aubinger) and his people have provided and the people that negotiated this out (came) to reason for what's best for all constituents."

Aubinger recognizes the benefit of having a

positive relationship with the Oneida Tribe.

"I the big scheme of things what happens in the Oneida Tribe of Indians can benefit the Village of Ashwaubenon and what happens in the Village of Ashwaubenon can benefit the Oneida Tribe of Indians," he said.

Currently the tribe has similar agreements in place with Brown and Outagamie Counties, and the City of Green Bay. Negotiations are currently underway to replace a

past-expired agreement with the Town of Oneida.

The two remaining municipalities with overlapping jurisdiction with the tribe, the Village of Hobart and the Town of Pittsfield, have no agreement with the tribe.

"This serves as a really good example of government-to-government relationships. We are honored and pleased to have such good neighbors as Ashwaubenon," Hill said.

Oneida Business Committee Wrap: April 13, 2011

Controversy from the National Indian Gaming Association (NIGA) Convention held in Phoenix, Arizona April 3-6 led to a lively Oneida Business Committee (OBC) meeting on Wednesday, April 13 at the Norbert Hill Center.

In attendance: Chairman Rick Hill, Vice-Chairwoman Kathy Hughes, Treasurer Tina Danforth, Secretary Patty Hoeft, and Council Members Ed Delgado, Melinda Danforth, Ron Tehassi Hill and Brandon Stevens.

Excused: Councilwoman Trish King.

The OBC passed a resolution to retro-approve the appointment of OBC Chairman Rick Hill as a NIGA Delegate. Treasurer Tina Danforth was the original delegate who would have voted for the NIGA chairperson on behalf of Oneida.

In a February 9 OBC meeting, for which Treasurer Danforth was excused, the OBC voted to endorse Oneida Nation of Wisconsin citizen

Ernie Stevens, Jr. as NIGA chairman.

Despite the endorsement, Treasurer Danforth was seen by others attending the convention wearing a campaign button supporting Ivan Makil for NIGA chair.

Councilman Brandon Stevens, son of Ernie Stevens, Jr., stated at the OBC meeting that Treasurer Danforth failed to answer a NIGA roll call held on the first day of the conference on the first call. Councilman Stevens answered the second call as alternate. Danforth stated she answered the second call simultaneously with Councilman Stevens.

Concerned that Treasurer Danforth would not vote for Ernie Stevens Jr., the OBC passed a resolution on April 5 via electronic polling (e-poll) to appoint Chairman Hill as the delegate to NIGA.

At the April 13 OBC meeting, Councilman Ed Delgado objected to the use of the e-poll.

"We're not supposed to be making important decisions like this through email. We're

supposed to meet in public to make these decisions," said Delgado.

Chief Council Jo Anne House stated e-polls have been used in the past to make decisions in a time sensitive manner such as letters and grants.

"This would have been an appropriate action to take by the Business Committee. It followed the precedent for taking e-polls for the process," said House.

OBC Secretary Patty Hoeft made a motion for the Law Office draft rule to prohibit e-polls and retroactive action by the OBC.

"Many governments across the globe actually are dealing with this same thing ...the rise of new technology ... and the past practice of this Business Committee, even before 2005, found it very easy; it was a convenient way to get something done with, rather than having to wait," said Hoeft. "But I think because of this incident ... we can't allow it, there's not enough trust in this organization."

The resolution passed. On a side note, Ernie

Stevens Jr. won the NIGA councilman seat by a vote of 121-14.

The OBC made quick work of several other agenda items.

Secretary Hoeft gave the oath of office to Election Board Alternates Sunshine Skenandore, Raeann Skenandore, Henrietta J. Cornelius, Vicki Cornelius, Michele Doxtator, Lori Hill, Lisa Liggins and Susan House.

The OBC passed a resolution accepting the 2012-2014 Transportation Improvement Plan.

Board, Committee and Commission quarterly reports

The OBC accepted reports from the Environmental Resource Board, Oneida Election Board and the Oneida Gaming Commission.

Standing Committees

The OBC approved the March 16 minutes of the Legislative Operating Committee (LOC) along with amendments to the Per Capita Law, the Child Custody,

Placement and Visitation

Law, Indian Preference Law. Guardians Ad Litem, Zoning and Shoreland Protection law, PP&P reinstating Personal Day Accumulation, Domestic Animals Ordinance, and the April 2011 LOC quarterly report.

The Per Capita Law amendments are intended to create a process to penalize individuals who submit fraudulent proof of a high school diploma to claim their trust account funds. Anyone attempting to do so could be fined one-third of the balance of their account.

The OBC took a moment to congratulate Senior Attorney Scott Wilson on his appointment to Governor Scott Walker's administration as administrator of the Division of Intergovernmental Relations, and to thank him for the work he's done for Oneida.

"We look forward to working with you in the future and Governor Walker and wish you all the best," said Chairman Hill.

The OBC accepted the

April 8 Finance Committee minutes, and the March 3 Community Development Planning Committee minutes.

Travel

A travel report from Vice Chairwoman Kathy Hughes about MAST Impact Week in Washington, DC was accepted, as was a request from Treasurer Danforth to travel to the Native American Bank board meeting April 20-21 in Denver, Colorado.

General Tribal Council

The Committee approved scheduling a special General Tribal Council (GTC) meeting for Monday, August 29 for the FY12 Budget, and approved an agenda packet for the May 23 GTC meeting.

Follow-ups/BC directives

The OBC accepted a report on potential sites for the placement of the Oneida Enrollment Office, and a report on the Secretarial Election

Passing On...

Budice Jr., Edward 'Ed,' 'Eddie' Rocco

January 22, 1966 – March 16, 2011



Edward ("Ed," "Eddie,") Rocco Budice Jr. (age 45), died unexpectedly in his sleep on Wednesday, March 16, 2011. He was born January 22, 1966 to Mary "Rags" Cornelius (Neenah), and the late Edward R. Budice Sr. (Chicago).

Edward lived with his family in Chicago until he was 11 years old at which time they moved to the Neenah/Menasha area where he graduated from Neenah High School. Edward became a professional Industrial Sandblaster & Industrial Painter and had his own business. Edward ran a Limousine business during his off-season and escorted many famous Packer players around the state and various high rollers from casino to casino. He lived in Aspen and Telluride Colorado, for many years, and became a professional Bull Rider, as well. Edward enjoyed being physically fit and liked to body build. He also liked to train others in the sport. He began to be a body guard from time to time, and spoke of some famous people for which he worked. He also learned to be a chef while in Colorado and prepared weight loss meals for private clients and also worked at some high-end spa type restaurants in the area. Edward loved the life in Colorado.

Edward loved his dogs, which were "the kids." They went everywhere with him. He is survived by three of his dogs, Nibbles, Kid, and Buster. He was preceded in death by his dog Bo whom he tried desperately to save from a severe illness. He rescued three of his dogs as strays in need of immediate medical care and one from a rescue shelter. Other than his dogs, Edward was an eternal bachelor, vowing never to settle down. He went where his work took him. He was too much of a free spirit to be tied down to a traditional family.

Governor Walker approves improvements in Brown County

Work on WIS 54/172

roundabouts has begun

(Green Bay) As part of his efforts to create jobs and make sure Wisconsin is open for business, Governor Scott Walker, recently signed a \$2.2 million contract to construct dual-lane roundabouts on WIS 172 at the entrance to Austin Straubel Airport/Oneida Casino/Radisson Hotel and at the intersection of

WIS 172 and WIS 54. Construction began on Monday, April 18.

The contractor is RC Excavating, Inc., Suamico.

The approximately \$2.2 million project will improve safety and operational efficiency at both of these intersections. Work will be done in two stages. Stage one will

involve building the WIS 172/airport/casino roundabout, expected to be completed by mid-July. The WIS 54/172 roundabout is being built from mid-July to mid-September.

Traffic will be impacted during this project. Approximately 21,000 vehicles travel through the WIS 172/airport entrance daily, while approximately 16,300 vehicles travel through the WIS 54/172 intersection.

Starting April 18 during stage 1, WIS 172 will be closed from 0.5 miles west of South Point Road to 1 mile east of the County GE. Eastbound WIS 172 traffic will be detoured from the WIS 54/172 intersection eastbound on WIS 54 and southbound on County EB to the WIS 172/County EB intersection. Westbound WIS 172 traffic will be

process. The Committee also accepted a report on the 2011 US Indigenous Games that will take place in Milwaukee July 10-14.

New Business/Requests

Councilman Delgado made a motion for the secretary to bring back a report on putting GTC meeting videos on the Oneida website. The new website will have a login for Oneida citizens. He also asks that video of the judiciary meeting from February 5 be made available. The motions were approved.

The OBC also approved a sub-agreement with the Nature Conservancy; to change the deadline of the voluntary resignation severance pay program from April 15 to April 19; approved the appointment recommendations of Marlene Garvey, Chris Cornelius and Al Manders to the Oneida Environment Resources Board;

approved Lois Strong to the Oneida Police Commission; changed the terms of the Oneida Powwow Committee from one year terms to three year terms and extended the term Tonya Webster; approved an evaluation of Community Synergies, LLC; and approved the RJ Reynolds Retail Marketing Plan.

Additions

The OBC approved a deal with the tribes insurance provider UMR that will save money on organ transplant surgeries by going through an in-network provider.

Executive Managers Reports

The Committee accepted a bi-monthly report from Chief of Staff Bill Gollnick and approved a service agreement with the Village of Ashwaubenon.

The OBC also accepted reports from the Oneida Land Claims

Commission, and the Chief Council report.

New Business/Requests

Councilman Delgado's motion was passed to review the job descriptions of the Legislative Aides and Executive Assistants within 30 days.

The OBC also approved a one year contract for Attorney Arlinda Locklear; accepted banking services summary,

approved the Wisconsin State Transportation Cooperative Agreement; and addressed concerns over the Oneida Community Health Center. Councilman Delgado made a motion to identify equipment that was used by the now defunct urology, allergy, and ear nose and throat departments and see that it's sold properly.

A request for the Oneida Veterans Colorguard to Haskell's graduation ceremony was sent to the finance committee.

Vice Chairwoman Hughes made a motion to send a complaint from a tribal member about the use of the Southeastern Oneida Tribal Services (SEOTS) facilities to the General Manager Debbie Thundercloud for follow up which was approved.

The OBC approved contracts for Attorneys Rebecca Webster and Patricia Stevens Garvey.

The OBC accepted a presentation on Treaty to Trust to Carcieri: The Economic Future of Indian Lands as FYI.

There was no support for a Visa credit card which was sponsored by Tina Danforth.


The OBC approved relinquishments of tribal citizenship.

Hobart board denies cemetery tax appeal

The Village of Hobart denied an appeal made by the Holy Apostles Church for recovery of unlawful tax of a cemetery at a Village Board Meeting Tuesday, April, 12.

The issue came before the board during a meeting on March 7 when a decision was tabled for the April 12 meeting.

Village assessor Mike Denor determined in his 2007 assessment that all but four acres of the 27-acre cemetery was not being used exclusively for cemetery use. "If it is

clearly plotted for future grave sites and clearly a continuation of burial plots then it is exempt. This is more about the area that's primarily woods with trails in it," Denor said as he clarified his reasoning behind his decision to deem the land taxable.

Diocesan administrator for the Episcopal Diocese of Fond du Lac, Matthew Payne, challenged that argument by stating that trespassers walking on the land had created the trails. Payne further stated that the land was bought as cemetery land and has

never been intended otherwise, "As we continue to add graves as time goes on and we move further and further back into that land, that doesn't show any other purpose than use as a cemetery. We haven't used it for any other purpose at all since we purchased it in 1908."

"When the initial assessment was made, there was no change ever shown as to what made it taxable. Which was a violation of the statute," Payne said referring to the previous attempts at taxing the land. The land had been assessed for

taxes in two previous occasions, once in 1950 by Brown County and again in 1983 by Hobart. In both cases the diocese appealed the decision and the land was returned to tax-exempt status.

After much deliberation Village Board Trustee David Dillenburg stated that he trusted Mike Denor's assessment of the land and made the motion to deny the appeal. The board voted unanimously to deny the appeal and the motion carried.

From 1A/State of the Tribes

has purchased an option to lease the mineral rights on 22,000 acres in Ashland and Iron counties. A NorthStar Economics study commissioned by Gogebic Taconite claims the mine would create thousands of jobs, including many long-term jobs.

The Bad River Band reservation is located on more than 125,000 acres of land in Iron and

Ashland Counties, just north of the proposed mine.

Wiggins said job creation must be balanced with environmental preservation to save state treasures for future generations. He urged lawmakers to keep the lines of communication open to ensure cooperation between tribal and state government on economic development.

"The tribes are hopeful that we can find a balance between bringing an end to this recession while still exemplifying the environmental stewardship that is intertwined in our history - from Chief Buffalo and our ancestors who signed our treaties to John Muir, Aldo Leopold, Gaylord Nelson and Sigurd Olsen."

Wiggins also thanked

the Legislature for resolving past issues, citing a bill passed last year that allows the state Superintendent to ban American Indian mascots at state schools. He also said the Legislature has taken tribal input on a measure that would require all voters to show photo ID at the polls. Wiggins said he believed the final bill would allow tribal ID to be used at the polls as well.

Tuesday's speech was the seventh State of the Tribes address, which updates the Legislature on the status of Wisconsin's 11 tribal reservations.

through family," said Kendrick.

"We felt scared for a long time because like we were trying to organize and edit things, and then it all fell into place ... first place," said Kanani as Kendrick and Noelle started laughing.

According to Studee, the judges praised the originality of the student's video.





Mother and daughter expand expertise

Oneida Homespun Harvest, Inc. fills niche in crafting world

Mother and daughter team Amelia Cornelius and Kim Nishimoto are branching out with their new business Oneida Homespun Harvest, Inc. to expand their vast crafting repertoire.

"It was a business that was already formed, and we were going to get a really good deal," said Nishimoto.

The duo purchased an industrial hem stitch machine that punches holes in fabric while simultaneously sewing around the holes to keep the fabric from fraying.

"The purpose of it is for crocheters to add an edging ... to make it more like it's homemade and something you personally did. It's just now coming back, but most of the companies are based in Utah," said Nishimoto. "We're the only ones out in this area in the Midwest."

Oneida Homespun

Harvest creates bibs and baby blankets with decorative crocheted edgings, and also sells kits for people to crochet themselves.

"If (the fabric's) not hemstitched, then they would have to punch a hole through with a crochet hook, and that just takes a lot more time. This is tons easier," said Cornelius. "It could be used for (powwow) shawls, because the holes are already there."

Nishimoto does most of the crocheting, though Cornelius contributes.

"Every time I go shopping, I'm looking for something that looks like it would be really cute for a baby," said Cornelius who found a pattern with little green turtles.

"Perfect for around here," she said.

The new business incorporates other items the two are known for, specifically their cornhusk dolls.

"I've been doing them since I was 12," said Cornelius who learned from her grandmother.

In 1987, Cornelius and Nishimoto worked together to create dolls for the University of Wisconsin-Stevens

Cornelius stated Nishimoto does most of the sewing on the doll's outfit, and then Cornelius does the beading.

"And then they come back to me, and I put hair on them" said Nishimoto.

Their dolls can be seen

in shadowboxes at the Radisson Hotel and Conference Center and at Marriot Hotels in Washington DC and California. A display of Oneida Chiefs can be viewed in the entrance of the Norbert Hill Center. The duo also makes dolls on a smaller scale.

"We did a wedding doll for the top of a wedding cake," said Cornelius.

Montana tribes look to stop megaloads

MISSOULA, Mont. (AP) — Two Indian tribes are asking to take part in a lawsuit aimed at preventing the hauling of oversized equipment through Montana to the oil sand fields in Alberta, Canada.

The Missoulian reports that Western Montana's Confederated Salish and Kootenai Tribes, as well as the Nez Perce of Idaho, filed a motion in District Court in Missoula on Wednesday asking to have their say in the lawsuit against the state Department of Transportation.

Missoula County and three environmental groups say the department failed to analyze or disclose potential adverse effects in its environmental assessment of Imperial Oil/ExxonMobil's transportation plan. The MDT denies the claims.

The tribes say they share many of the concerns of the plaintiffs, but have some of their own that might not otherwise be addressed in court.

Imperial/Exxon is apparently modifying its original proposal to send 207 oversized loads from Lewiston, Idaho, to the Canadian border in north-central Montana. Still, the companies continue to seek clearance to ship more than 100 loads up U.S. Highway 12 through the Nez Perce Reservation in Idaho.

Yurok tribe buys forest in Humboldt County

KLAMATH, Calif. (AP) — A Native American tribe is acquiring more than 34 square miles of ancestral land on Northern California's Redwood Coast.

The Yurok Tribe says it completed the purchase Thursday of the Humboldt County property from the Green Diamond Resource Company.

Tribal Chairman Thomas O'Rourke says the acquisition marks the long-sought return of the tribe's ancestral land and more than doubles its territory on the lower Klamath River.

O'Rourke says tribe plans to create a salmon sanctuary and use tribal management practices to protect wildlife habitat and restore water quality.

The tribe bought the land with help from the nonprofit Western Rivers Conservancy and \$18.75 million from a state clean water fund.

The property is home to Chinook salmon, coho salmon, rainbow trout and several imperiled bird species.

Housing Update

On April 14th, I attended a Housing Task Force meeting. The Task Force received a report from Housing Director Dale Wheelock which included many new housing initiatives including (1) the building of many new rental and home ownership housing units, and (2) the development of new regulations which will allow more Tribal members to become eligible for Oneida Housing Authority services. The new regulation, hopefully to be developed and implemented in the very near future, will provide more housing opportunities for Tribal families who have been financially devastated by today's poor economy.

Wage Petition Update

In February, Tribal elder Yvonne Metivier submitted a petition to increase employee wages by .75 cents per hour for all employees earning \$60,000 and below. She says

it's been years since Tribal employees have received a raise. She's right on that issue. The General Tribal Council will consider her request at the July Semi-annual Mtg.

The Business Committee and Tribal administration is currently reviewing a 1.8% wage increase for 2012. That 1.8% proposal may change before it comes before GTC (date to be determined by the new Business Committee). Under the 1.8% proposal:

- A Slot Tech, whose average wage is \$18 per hour, would receive an approximate .32 cent an hour wage increase (a \$12.80 weekly increase).
- A top executive, whose wage is perhaps \$65 per hour, would receive an approximate wage increase of \$1.17 per hour (a \$46.80 weekly increase).

Note: If I were still a young man and making the wage of a

Slot Tech, and if I still had young children to feed, clothe and maybe even buy diapers for, I would have absolutely no problem choosing the .75 cent an hour increase over the 1.8% proposal and would tell the Business Committee to stop wasteful spending, to carefully examine all of the Tribe's spending proposals, and to find the financial resources to provide our Tribal employees with a fair increase after years of being neglected. As a Business Committee member, I hope we can find a compromise.

Biomass "Waste to Energy" Update

The position of my Office on the Seven Generations Biomass project from the get-go has been that this a great opportunity for our Oneida Tribe to take a leadership posi-

tion in clean energy development. My responsibility as a member of the Business Committee is to ensure that the project is profitable and safe, safe for our workers who will be our own people, and safe for

mental effects, or the DOE will conduct a more comprehensive environmental assessment which could take up to a year. I have provided this subject to the membership to let our people know that the entire Business Committee is hopeful that the Biomass Waste to Energy Project is successful. Some of us may worry more than others about the Project's economic or environmental impact, some of us may ask more questions than others, but none of us want this project to fail. And finally, I would hope that some of the personnel at the Seven Generations Corporation would be a little more respectful towards members of the Business Committee the next time they come before the Oneida people to report as the Business Committee has always been respectful to all of them.

It's interesting how statistics can be slanted. The article states that 70% of the respondents consider the Reservation an excellent or good place to live. The stats shown in the article also states that only 20% of the respondents consider the Reservation an excellent place to live while 22% consider the Reservation a Fair or Poor place to live.

The article states that 65% of the respondents consider the Reservation is an excellent or good place to raise a family. The stats shown in the article also states that only 18% of the respondent consider the Reservation is an excellent place to raise a family while 26% consider the Reservation a Fair or Poor place to raise a family.

Thirdly, the Reservation as a retirement location; 23% of the respondents consider it an excellent location whereas 26% of the respondents consider it a Fair or Poor place to retire.

It looks like there is a need to re-evaluate the survey. There's only 1% difference between Excellent and Fair. And the most percentage under the Good category is 50%. Not too good of a report card grade.

But I must say that the article is attempting to show that living on the Reservation is better than living in Brown or Outagamie counties. Which I can't argue with since there's no statistics shown to prove the writer's assertions.

It's disappointing that this submission was not edited before it was made a part of the newspaper and it speak volumes about the Oneida

Statistics Office.

Good Morning Patricia,

I am responding to your inquiry to the Quality of Life article. I have attached the article for your reference. All of the ratings were based on a 4-point scale: excellent, good, fair, and poor. This forces the respondent to choose either a positive (excellent or good) or a negative (fair or poor) rating.

For the Reservation as a place to live, 20% rated it excellent and 50% rated it good which equals 70% rating it excellent or good. For the Reservation as a place to raise a family, 18% rated it excellent and 47% rated it good which equals 65% rating it excellent or good. For the Reservation as a place to retire, 23% rated it excellent and 45% rated it good which equals 68% rating it excellent or good.

There is no attempt to sway the readers in any way. The goal of the article is just to present the results of the survey. In future articles, departments within the organization will add what initiatives they are working on to respond to the perceptions of members.

I am not quite sure if I have alleviated any of your issues with the article, but I would be happy to meet with you to discuss them. Feel free to call me.

Frequently Asked Questions

Oneida Tribal General Election Primary

How will the election process be different for the 2011 General Election?

In 2011, a Primary Election will be held. In years past there was no primary election.

What is a primary?

Excerpts from Oneida Tribal Election Law:

2.12-2. There shall be a primary election for Business Committee positions whenever there are three (3) or more candidates for any officer positions or sixteen (16) or more candidates for the at-large council member positions.

(a) The two (2) candidates receiving the highest number of votes cast for each officer position shall be placed on the ballot.

(b) The fifteen (15) candidates receiving the highest number of votes cast for the at-large council member positions shall be placed on the ballot.

(c) Any position where a tie exists to determine the candidates to be placed on the ballot shall include all candidates where the tie exists.

2.12-3. The Election Board shall cancel the primary election if the Business Committee positions did not draw the requisite number of candidates for a primary by the petitioning deadline set for the primary.

2.12-4. In the event a candidate withdraws or is unable to run for office after being declared a winner in the primary, the Election Board shall declare the next highest primary vote recipient the primary winner. This procedure shall be repeated as necessary until the ballot is full or until there are no available candidates. If the ballot has already been printed, the procedures for notifying the Oneida public in section 2.5-11 and 2.5-12 shall be followed, including the requirement to print a notice in the Tribal newspaper if time lines allow.

Why have a primary?

To give members a chance to select from fewer candidates or the Business Committee positions in the General Election.

Will there be a primary for all vacancies?

No. The primary election is for Business Committee vacancies only.

When will the primary be held?

On Saturday, May 7, 2011 at the Oneida Health Center and the SEOTS Building in Milwaukee. Polls will be open from 7:00 a.m. to 7:00 p.m.

If there are only two candidates running for an officer position, will a primary still be held for that position?

No. The primary is designed to get the top two candidates for each officer position. If only two applicants run for that position, each applicant will automatically be placed on the General Election ballot as a candidate.

If a candidate didn't advance in the primary, can I write their name on my ballot at the General Election?

No. Write-in candidates are not allowed.

When will the Caucus be held?

On Saturday, March 12, 2011 at the Norbert Hill Center at 1:00 p.m.

Is the Caucus just for vacancies within the Business Committee?

No, the Caucus will be for ALL vacancies of all boards, committees, and commissions with elected positions to be filled at the 2011 General Election.

When can I submit application for candidacy?

Officially this is done at the Caucus by being nominated and submitting the required application by the deadline date to the Tribal Secretary's Office.

If I can't attend the Caucus, can I still submit my application to be a candidate?

Yes. You will need to complete a petition and submit the required application by the deadline date.

How long do I have to submit an application to become a candidate?

All applications are due by 4:30 p.m. on Friday, March 18, 2011 to the Tribal Secretary's Office.

When is the General Election?

On Saturday, July 16, 2011 at the Oneida Health Center and the SEOTS Building in Milwaukee. Polls will be open from 7:00 a.m. to 7:00 p.m.

When can I begin campaigning?

Whenever you wish.

Excerpt from Oneida Election Law: **2.5-9.**

Campaign Signs and Campaigning:

(a) Placement of campaign signs:

(1) Campaign signs shall not be posted or erected on any Tribal property except for private property with the owner/tenant's permission.

(2) No campaign sign shall exceed sixteen (16) square feet in area. A maximum of seven (7) such signs may be placed on a building or on a lot.

(3) No campaign sign shall project beyond the property line into the public right of way.

(b) Removal of campaign signs. All campaign signs shall be removed within five (5) business days after an election.

(c) Employees of the Tribe shall not engage in campaigning for Tribal offices during work hours. Tribal employees shall be subject to disciplinary action under the personnel policies and procedures for political campaigning during work hours.

(d) Enforcement. The Zoning Administrator shall cause to be removed any campaign signs that are not in compliance with this law, in accordance with the Zoning and Shoreland Protection Law.

(e) Fines. Violation of the campaign sign restrictions shall result in a fine imposed by the Election Board in an amount specified in a resolution adopted by the Business Committee.

Can I vote by absentee ballot?

No. Article III Section 2 of the Constitution states "All enrolled members of the Oneida Tribe of Indians of Wisconsin who are 21 years of age or over shall be qualified voters provided they present themselves in person at the polls on the day of election."

Will the Milwaukee voting site be open for both the primary and general election?

Yes. Business Committee Resolution 03-13-2002-O states: "NOW THEREFORE BE IT RESOLVED: that an approved facility; compliance with the Oneida Election Law, 2.8-0, Section B, located in Milwaukee, Wisconsin, is hereby designated as a second polling site for Oneida triennial elections, beginning with the July, 2002, election." The SEOTS Building is located at 6820 West Wedgewood Drive, Milwaukee, WI.

- Shall serve a full term of 3 years unless appointed to fill a vacancy created by resignation with more than one year remaining, then shall be remainder of term.
- Membership may not be such that a conflict of interest between the private interest and the official responsibilities of a person in a position of trust or any other recognized hearing body within the Oneida Tribe.

Membership may not be such that nepotism is created by the following relationships: father, mother, husband, wife brother, sister, daughter, son, father-in-law, mother-in-law, daughter-in-law, brother-in-law, son-in-law, grandparent, grandchild, step-children, step-parents, or significant other.



Taking a look at Housing: Addressing Social Issues

The Oneida Housing Authority (OHA) is well aware of the ramifications of behavioral issues related to housing needs so they are reaching out to those in need.

At numerous staff levels within OHA, individuals and families that appear in need are often extended help.

"If something comes up and is brought (our)

way (we) make the connections and go from there," said Scott Denny, OHA's Housing Coordinator. "(We) make referrals to internal and external services, we will use the likes of Social Services and Behavioral Health."

The OHA also employs multiple case workers who perform assessments to better identify which resources would

be best suited to assist a family or individual. A Resident Opportunities and Self Sufficiency Coordinator receives referrals from OHA staff and works at a more intimate level to offer assistance. The grant-funded position also organizes training and educational sessions that are geared to create a better-rounded individual.

Starting next month OHA will be offering a series of educational sessions highlighting credit, budgeting, the responsibilities of renting, home buying education, and home maintenance.

"There are a lot of things that OHA is doing at socially responsible level

and we are trying to go beyond the 'we-supply-you a physical place at an affordable price,'" said Denny.

He is quick to point out that if behavioral issues aren't addressed social issues will not be solved by simply providing housing.

"When people are having problems with (social issues), yes, when they get in (here) they are looking for a physical unit, yes, not having a physical unit is a problem, but if we take that same family that is having these issues and put them in a unit and nothing is there to help support that family they just get kicked out of here," he added.

Every OHA client isn't the classic case for in-depth counseling or

training says Denny.

"We want to see the best for each individual and family, when you see these problems out there you can provide a means to help themselves or to stand by and do nothing," said Denny. "The reality is these are the problems. To me to sleep better at night you have to say you have done what you can do. If a family has chosen to not take the avenues that you shed light on exist, you can't help that. If I can show you five avenues you can travel down, I owe it to you."

OHA is also taking a stand to provide a safe environment for their clients. They complete background checks on each individual applying for housing assistance along with a five-year waiting period for any individual convicted of a felony along with any drug charge being immediately disqualified from housing.

"We see housing related problems to be more than just not having the inventory. People are dealing with issues all the time that become barriers or challenges and reasons why they can't obtain housing here or elsewhere. That's why we are doing this," said Denny.

The game of softball has been present in the Oneida community for decades. Played by men and women of all ages for competition, recreation, or even a fun activity at a summer family reunion. But one aspect of softball has been missing from the community, an Oneida High School softball team. Well, Oneida High School Physical Education teacher Cecily Dawson has gotten the ball rolling on an Oneida girls softball team.

The formation of an Oneida softball team actually started last spring after a few high school students expressed some interest about playing the sport. Cecily Dawson recalls, "We started, but we just didn't have enough people, we had six. So the kids who played last year never got to play an actual game." Because most of the girls did not have a lot of experience playing softball, the team used this time to work on their skills beginning with the basics. 
Learning to play the game of softball is a skill that will fit nicely into the Oneida community by not only providing a healthy springtime activity, but also contin-

But Cherokee has a list of tweaks for the cheering squad, "More extension with your arms and keep the movements crisp." This attention to detail is what makes the Green Bay Elite All-Stars one of the best and most decorated cheer programs in the area.

As another successful cheer season nears its end the Green Bay Elite All-Stars host an annual showcase at their facility, showcasing each cheer level's routine. "We travel around the country, a lot of times our compe-


titions are in Indianapolis or Chicago, so it gives a chance for the families to come and see them. We also try to do a benefit with the event," explains Coach Cherokee Greendeer. This year the program chose to help Families with Cancer because a couple of families involved in the program are dealing with cancer; also a Hobart family whose home recently burned down. Cherokee states, "We just wanted to make sure they are taken care of with goods and other things."

With the end of the cheer season in sight the Green Bay Elite program looks forward to the final competition of the year, the Worlds Cheering Competition, which Cherokee describes as the "Olympics of cheerleading." The cheering levels range from one through five, with five being the highest level. For those at the fifth level of cheering the Worlds Competition offers up a bit of pressure to perform and carry on the success of the Green Bay Elite

All-Stars.

However, the program does more than create award-oriented cheering squads; teams are also formed for those not interested in traveling or for those looking to learn the sport of cheerleading without the pressure of competition. The program teaches all levels from beginners that meet once a week, to intermediate, to advanced levels of cheering. Green Bay Elite offers participants the option of being highly involved in the sport or use it as a recreational activity.

Cherokee also hopes to recruit more Oneida Tribal citizens to the Green Bay Elite program, aside from the few that already participate. "We're very excited we have about six or seven (Oneida Tribal citizens) in our program. They range from our beginner team all the way to our advanced team. So we do as much as we can and the family support is huge. But we would love to have more."







Authors Collins and Alexie make list of most challenged books

NEW YORK, New York (AP) ~ Author Suzanne Collins didn't expect everyone to approve of "The Hunger Games."

"I've read in passing that people were concerned about the level of violence in the books," Collins said of her dystopian trilogy that's sold more than a million copies. "That's not unreasonable. They are violent. It's a war trilogy."

In what's become a virtual rite of passage for young adult sensations, a Collins novel has made its first appearance on the American Library Association's annual top 10 list of books most criticized in their communities. "The Hunger Games," the title work of Collins' series about young people forced to hunt and kill each other on live television, has been cited for violence and sexual content. In recent years, J.K. Rowling's "Harry

Potter" books and Stephenie Meyer's vampire novels also have been on the association's list.

"Hunger Games" ranked No. 5 this year and was joined Monday by Meyer's "Twilight" (No. 10), which debuted on the list last year, and Sherman Alexie's "The Absolutely True Diary of a Part-Time Indian," winner in 2007 of the National Book Award for young people's literature. Criticisms of Alexie's novel include language, racism and sexual content.

"It almost makes me happy to hear books still have that kind of power," Alexie said. He laughed at the idea his work might be harmful, noting that he receives fan mail every day from readers thanking him for his story of a bright but bullied teen estranged from his fellow Indians on the Spokane Reservation and from the rich white kids at the high school he attends.

"And there's nothing in my book that even compares to what kids can find on the Internet," he said.

Alexie acknowledges one disappointment; his book only ranked No. 2, trailing "And Tango Makes Three," a picture story by Justin Richardson's and Peter Parnell about two male penguins who hatch a donated egg and raise the baby penguin. It's the fourth time in five years "Tango" has been No. 1, with reasons for criticism including the book's discussion of homosexuality.

The library association reported 348 challenges to books in 2010 and at least 53 outright bans, with other challenges and bans likely undocumented. The ALA defines a challenge as an effort "to remove or restrict materials from school curricula and library bookshelves."

Collins said "The Hunger Games" was recommended for ages 12 and up but said kids sensitive to the material might want to wait longer.

The author's daughter, meanwhile, may have been ready before age 12. She had already started reading Collins' previous series, "The Underland Chronicles," written for a slightly younger audience.

"I knew she would already have been through one war series with me and, of course, I'd be on hand if there was anything she needed to discuss," Collins said. "Emotional readiness and previous exposure to a similar type of subject matter - those seem like key elements to me in

determining whether a young person can handle a book."

Barbara M. Jones, director of the ALA's Office for Intellectual Freedom, says some books on the list reflect current trends and changes in technology, including "Hunger Games," inspired in part by reality television; Aldous Huxley's classic "Brave New World," (No. 3), which anticipates antidepressants and artificial fertilization; and a work of nonfiction: "Nickel and Dimed" (No. 8), Barbara Ehrenreich's despairing account of trying to get by as a waitress, maid and Walmart worker.

"The closer books come to things that are really happening in a lot of lives, the more they become a reminder of what people don't like to think about," Jones said, noting that Ehrenreich's book "really hits hard what it's like to have a low paying job."

"Nickel and Dimed" has been criticized for language, drugs and for its political and religious viewpoints.

Also on the list:

"Crank," Ellen Hopkins (drugs, language, sexual content).

"Lush," Natasha Friend (language, sexual content).

"What My Mother Doesn't Know," Sonya Sones (sexism, sexual content).

"Revolutionary Voices," a collection of gay-themed stories edited by Amy Bonnie (homosexuality, sexual content).

Tribal 'war game' gains fans at Okla. colleges

TAHLEQUAH, Okla. (AP) ! Northeastern State senior Kinsey Shade emerged from the dog pile and streaked toward a pole, heaving the ball at a wooden fish near its top.

The ball missed the fish by inches and another melee quickly ensued.

Cries filled the air on a recent Saturday at NSU in Tahlequah as a faded red ball the size of a child's fist flew through the air and landed with a thud, a swarm of sticks and hands trying to grab it.

As traditionally played by the southeastern tribes such as the Cherokee and Choctaw, stickball was once used to settle conflicts.

Now the "little war game" is bringing Native American students together at area colleges.

It's been a staple of area tribes' national holiday celebrations for years, but social stickball is seeing a resurgence at some Oklahoma colleges.

At NSU, six Native American student groups on campus host anywhere from one to three stickball games a semester, said Asa Lewis, the interim student coordinator for the school's Center for Tribal Studies.

Recently, the groups hosted a stickball exhibition for students vis-

iting from Chicago's Northeastern Illinois State University. Another game is planned for April 13 as part of the school's annual Symposium on the American Indian.

"It's fellowship and part of our culture," said Shade, a citizen of the Cherokee Nation. "You just go out there and play."

After getting a crash course on the rules, many of NSU's guests from Chicago joined in. Within the small space, observers were forced to take cover more than once from errant throws.

"It looks like they're having a blast out there," said Veronica Rangel, one of the group's chaperones. "It's like watching lacrosse's more rugged cousin."

In Stillwater, Oklahoma State University's Alpha Pi Omega Sorority, a historically Native American sorority, hosts a monthly stickball game in front of Edmon Low Library.

"We wanted to foster a greater cultural awareness on campus," said political science senior and chapter president Tabatha Harris. "This game originated with the Five Civilized Tribes and this is an interactive way for us to introduce our culture to students who might not have grown up around it."

The chapter's monthly games usually attract about 20 players, including students from Oklahoma City University and the University of Oklahoma. The Stillwater stickball players, in turn, send teams to tournaments, including a recent one at OU.

"I got hit in the head with a stick and broke my thumb at that tournament," Harris said. "I've had (sorority) sisters hurt their knees, ankles and elbows in stickball games. Have to be tough to play."

Student Jake Roberts didn't pick the game up until college.

"It's all-inclusive," he said. "Yes, it's a part of my culture, but it's also got men, women and children all out there at once, playing and having fun."



Oneida Nation funds lawsuit over attorney fees

ALBANY, N.Y. (AP) — The Oneida Indian Nation has backed a lawsuit against Madison County Attorney S. John Campanie and New York Comptroller Thomas DiNapoli, claiming the attorney improperly received more than \$800,000 over 13 years from a law firm he helped pick to fight county legal battles with the Oneidas.

The suit in state Supreme Court in Albany said DiNapoli was contacted last October about the allegedly improper payments but failed to do anything about them. It was filed Monday on behalf of two county residents who work for the Oneidas, who own and operate the Turning Stone casino and resort in central New York.

It seeks restitution to taxpayers of money

that it says improperly went from the state to the Nixon Peabody law firm to Campanie.

The county attorney is prohibited from getting extra money for doing county work to avoid having conflicts of interest, and the bills were for legal work beyond authorized land claim litigation, according to the lawsuit.

"The payments are in clear violation of state law," said lawyer George Carpinello, who was paid by the Oneidas to file the lawsuit.

"Of the more than \$12 million the state has paid to Nixon Peabody and Mr. Campanie, it appears that most of it has been work for which state law does not authorize payment, such as tax and trust litigation," Carpinello wrote to DiNapoli last fall.

The 19 Madison County supervisors issued a joint statement

Tuesday calling the lawsuit "a desperate attempt" by the Oneidas to deny effective legal counsel to the county and state against the Indians' claims to more than 250,000 acres. Campanie's pay arrangements have been disclosed since 1998 in annual filings with the county Ethics Board, they said.

The legislators said their lawyers' shared victories included the U.S. Supreme Court ruling in 2005 rejecting Oneida claims of sovereignty on aboriginal land and a later ruling by a midlevel court against land title and damages claims that will likely be appealed.

The Oneidas have claimed the land was illegally purchased by the state in the 18th and 19th centuries and that the state underpaid them by about \$500,000. With compound interest, that would be \$500 million

or more today.

"Accordingly, the defense effort continues," the county legislators wrote, and noted the tribe was pressing "an unprecedented land in trust application" and refusing to pay property taxes or to collect and remit sales taxes.

Campanie said their collective legal work helped save the state \$250 million in the Cayuga land claim case and hundreds of millions of dollars in the Oneida case.

Nixon Peabody declined to comment.

DiNapoli spokesman Dennis Tompkins said Tuesday the comptroller has not yet been served with the court papers.

"We are aware of the issues that have been raised. We've been looking at this closely for several months," Tompkins said. "It's fairly complicated situation."

detoured on the opposite route.

Access for the Oneida Casino and Radisson Hotel will be off of South Point Road. Access for the airport will begin at the South Point Road/WIS 172 intersection and detoured by way of internal airport roads.

During stage 2, beginning in mid-July, the work constructing the WIS 54/172 is being done in two phases. WIS 172 is being closed ini-

tially from 1.5 miles west of County GE to WIS 54. County E will be closed from 0.1 miles south of WIS 172 to WIS 172. During this phase, westbound WIS 172 traffic will be routed from the WIS 172/County GE intersection northbound on County GE and westbound on WIS 54 to the intersection of WIS 54/172. Eastbound traffic will again follow the opposite route. This work is expected to last

approximately six weeks and upon its completion, the WIS 172 and County E legs of the roundabout will open.

During the second phase or the last approximately two weeks of the project, WIS 54 will be closed from 0.25 miles west of Dexter Road to 0.25 miles east of County U. Eastbound WIS 54 traffic will be detoured from the WIS 54/County U intersection eastbound on County U, northbound

on County E, eastbound on WIS 172, and northbound on County GE to the intersection of WIS 54/County GE. The westbound detour also follows the opposite route. The entire roundabout will open by mid-September.

Access will be maintained to all businesses and residences throughout the project.

Exploring the Three Sisters


What are the Three Sisters?

The three sisters refers to corn, beans, and squash. These three vegetables were planted together and grew very well with one another. We were dependent on our three sisters crops for survival. Women planted and harvested hundreds of acres of our three sisters crops in our original territory, which is now the state of New York. Today we continue to carry on our tradition of planting the three sisters together.

Corn is the oldest sister. She stands tall in the center.

Squash is the next sister. She grows over the mound, protecting her sisters from weeds and shades the soil from the sun with her leaves, keeping it cool and moist.

Beans are the third sis-



ter. She climbs through squash and then up corn to bind all together as she reaches for the sun. Beans help keep the soil fertile by converting the sun's energy into nitrogen filled nodules that grow in its roots. As beans grow they use the stored nitrogen as food.

How to Plant the Three Sisters

Plant the corn in late May. It is best if the ground has warmed and is no longer cold and wet.

Soak corn seeds for several hours, but not more than eight hours before planting.

Prepare low hills that

are 3-4 feet apart within and between rows. Place 5-7 corn seeds evenly spaced to a depth of 1-1 ½ inches. Cover with soil.

According to Iroquois tradition, corn seeds should be planted with kind thoughts three days before the full moon.

After young corn plants come up, begin removing weeds. As you are weeding, gently mound, or hill, the soil around the young plants.

When the corn plants are about 6 inches high, pole beans and pumpkins can be planted around the corn plants.

Plant 4-5 bean seeds in each hill. Plant 4-5 pumpkin seeds in every seventh hill, placing them around the young corn plants.

Traditional planting method: Corn and beans are planted together. Pumpkin is planted in every seventh hill. The pumpkin seeds can be planted alone, or with the corn and beans in the seventh hill.





Recycling is Still the Law!

With all the media surrounding the state's pending budget bill there has been confusion surrounding recycling. Do we still recycle in Oneida? Will there still be recycle collection in Oneida?

The answer to both of these questions is **YES**. Recycling is still the law and Oneida will not be discontinuing service!

Budget Language

The proposed budget would:

- Eliminate the requirement that a municipality or county operate a recycling program

- Eliminate the financial assistance for local governmental recycling programs

- Convert the recycling fund to the economic development fund

This means your local municipality would no longer be mandated to operate a recycling program, be it curbside collection or drop-off. Also, the funding that participating local governments received (responsible unit grant) to assist in the operation of the recycling program, will no longer be available.

Recycling Fund

The recycling fund is a segregated fund created specifically to help fund the responsible unit grants. It is generated by a \$7 "recycling fee" assessed on each ton of all solid waste that is disposed of in the State of Wisconsin. When this law passed, the state made a promise to communities that cost sharing would be returned to operate local recycle programs. Under the proposed budget the fee would still be assessed, but the money

would not go towards recycling programs as it was intended to.

How is Oneida Affected?

The Oneida Tribe does receive a responsible unit grant from the Department of Natural Resources to run its recycle program. In past years the grant was approximately \$38,000 and was used to fund the solid waste and recycle program. Our solid waste and recycle collection is self-funded through the collection fee. This means the recycle collection will continue. What we will be losing is a number of education opportunities for tribal members and employees and a reduced capacity for

program expansion.

What Can You Do?

K E E P R E C Y - CLING! Do not stop recycling, Oneida will not suspend recycle collection.

Recycle collection will continue to be picked up weekly, even if the State budget does get passed with the proposed elimination of the recycling fund. You can also contact your local and state legislators about the proposed legislation.






Lacrosse Practice Begins

The Oneida Tribe provides many services utilizing the revenues generated from gaming and according to IGRA, this is exactly what we are supposed to be doing - maintaining the government and providing services to the Membership.

That will remain my priority as I work with the Committee to present a balanced budget. It will be a tremendous challenge because we no longer have reserves to tap for expenditures and we are fully utilizing all revenues generated through Gaming and Enterprises. Expenses continue to increase for many reasons, but inflation is the one reason that affects the Tribe and each one of us.

Until new revenue is generated to help support the organization, we must look at cutting back in areas that provide the least negative impact on the Membership. A large operation contains volumes in the detail. I will have to take an extremely focused approach to once again becoming thoroughly familiar with Tribal operations details.

Oneida is a labor intensive organization. It's difficult when cutbacks need to occur and the only place left to cut is in personnel. There has been work on lowering the labor costs through the severance package. This is a package that allows an employee to request an early retirement and if considered, the supervisor must also look at eliminating that job or another one of comparable status. The Tribe has managed to marginally lower its total employment through this package. Attrition is another means of accomplishing this same task.

I am extremely sensitive to the desire to not initiate any layoffs. But if we cut everything else that can possibly be cut, this may be the only step left to us. However, I believe there are areas of service that can be eliminated without creating too great a disruption and still maintain our workforce.

A significant part of solving any budget deficit is getting to the root of the problem. We are at a critical point in which the dam is breaking and band-aid fixes are not going to carry us through another fiscal year. The changes needed cannot be those of any one person alone so we must all work together. Any viable solutions need to have an immediate impact while providing long-term sustainability. Some initial ideas include:

- Considering more employee options such as allowing employees flexibility to voluntarily work part-time or decrease their hours. This would offer immediate savings by lowering wage costs per hour while decreasing associated personnel costs and resource expenses.
- Requesting GTC to review the GTC Stipend Policy for possible alternatives to the \$100 payment, even if on a trial basis. Example: an Oneida gift card would stimulate Oneida's economy.
- Consolidating as many departments as possible into central locations to share resources, reduce travel and offsite meetings.
- Reviewing construction and capital expenditure projects to assess if need is absolutely immediate.
- Ensuring Tribal enterprises are placed in prime storefronts that we own.

- Leases should be aggressively pursued for all vacant Tribal commercial properties.
- In all departments, we need to continue to encourage technologies which conserve resources, reduce our carbon footprint, and save money.

- Clearly and regularly communicating the status of cost containment measures.

There are more cost saving measures that can be looked at. Difficult decisions and unpopular choices will undoubtedly have to be made in order to bring the budget into line with projected revenues. 



Yes, these are hard choices to make, but the reality is that we have to



In regard to "what would I do about a projected budget deficit in 2012", without access to detailed financial reports, it's difficult to comment on a projected deficit plan.

Although most of my experience is in the

healthcare industry, I've still learned a great deal about money management from my managerial and budget-preparation experience. From this experience I know the largest source of financial responsibility lies in personnel and associated fringe benefit costs. However, I view our employment base as our largest investment, rather than an expense. Yes, the employee base can be leaner but perhaps, instead of involuntary cuts, I feel we should re-visit the earlier proposed Plan B organization re-structure which would integrate services thereby making more efficient use of our employees.

Another example is the use of consultants. Let us trust our own experienced professionals rather than outsourcing important decisions.

Another important consideration is a thorough comparison of all revenue streams against current debt and day-to-day expenses such as travel, vehicles, charge cards, etc. I'm not saying I'm against any of these expenses but rather, I advocate a careful cost/benefit analysis be applied to all of them.

Finally, being born and raised in Oneida the 7 generation philosophy is deeply engrained in me. However, I think that together, we can create and execute innovative and strategic ideas to personify our way of life for much longer than the next 7 generations. Let's begin.



As a Councilman in the FY11 budget cycle, I helped lead the Business Committee through virtually every departmental budget and we zeroed out meeting and business expense line items among other expenses. It was a difficult process to look at each department, but necessary to reduce expenditures and to reduce the budget itself.

If we continue to follow our cost constraints as recommended by the CFO we will reduce a large portion of the deficit. I do believe we need to look ahead at our GTC mandates to build

on our local needs and infrastructure. One suggestion is looking at Per Capita and the Education scholarship to more adequately manage our budget.

Per Capita could be on a percentage, if we make more profits we get more, make less

we get less, which puts less of a burden on the programs and service

provided to our members. The Education scholarship fund I believe could be utilized more by the organization to create and maintain jobs for our tribal members, as of now we have very educated individuals coming back from school and yet they have many barriers to our organization, one being lack of experience.

Mentorship and Succession programs would be vital to the retention of an experienced employee's knowledge and wisdom to be passed to a young qualified educated tribal member. I also believe we need to continue with our housing initiatives that put more homes on the reservation to build up our community that will serve as a solid foundation for a sustainable local economy. The creation of the Oneida Chamber of Commerce will be a focal point in creating that economy in keeping Oneida money in Oneida by supporting our Tribal entrepreneurs.

The Hobart Episcopal church in Oneida

Third Series on the
Hobart Episcopal
Church in Oneida

It is important to mention Reverend Edward A. Goodnough's burial, historically, since he had served the Oneidas longer than any other priest at Oneida. In the Green Bay Press Gazette, dated January 25, 1890, was an article about the memorial service held for him, as follows: "The services yesterday at Hobart Church and at the cemetery on the Oneida Reservation were held in memory of the late beloved pastor, the Rev. Edward A. Goodnough who was of an especially impressive and interesting character".

There were four priests who administered the burial services who were the Reverend Solomon S. Burleson, (who succeeded Goodnough at Oneida), his son, the Reverend Allen Burleson, the Reverend Dr. Gardiner of Nashotah House, and an address was given by former resident priest, Reverend F.R. Haff who had become the rector of the Christ Episcopal Church in Green Bay, (after he left Oneida).

At the conclusion of the services, a procession was led by Captain A t i s q u e t t e , (Archiquette), the Brass Band of Oneida, followed by the congregation and the clergy, all marching from the church to the cemetery. The Indian Choir also present, sang two hymns at the grave site in addition to having participated in the church services.

Having arrived at the Monument, one could see these words printed

on the front of the monument, "Beneath this Stone awaiting the Resurrection lies the body of Edward Augustus Goodenough for Thirty-Six years, Paster and Friend of the Oneidas." On the back of the monument was inscribed, "This Stone of Remembrance is erected by his grateful children in the Lord, the Indians of Hobart Church, Oneida". Today, the Monument can be seen on the Southern part of the Cemetery enclosed by a rod-iron black fence where he is resting with other members of his family.

Next to arrive to serve at Hobart Church in 1891 was the Reverend Solomon S. Burleson. An experienced priest, he was nearing retirement when he arrived. He had studied medicine, dentistry and understood the law, which was in addition to his priesthood studies. When he realized the need for medical care of the entire Oneida community, he helped the Oneidas pursue the building of an Oneida hospital.

He had received a small grant from the government and used these funds to help those in need of medical care. In addition, he became involved in other areas of need for the Oneidas. Even though the building of a boarding school was already in progress, he helped in whatever way he could to make the school become a reality. Burleson was also supportive of the building of a much needed bridge over the Duck Creek. One year after Burleson passed away, the Oneida Hospital opened its doors for the entire Oneida community in 1898.

At this same time, an

Oneida, Miss Lavina Cornelius who had graduated from Hampton Normal Institute and also the New Haven Training School for Nursing was hired to be in charge of the Hospital and served from 1898 until 1899 after she received an appointment to serve at the Oneida Boarding School. She was replaced by another Oneida, Miss Nancy Cornelius (no relation) who had also graduated from the Hartford Training School for Nursing, but had attended the Carlisle Institute prior to that. She served until 1904 when she married.

When Reverend Burleson arrived in Oneida, his five sons had already entered the priesthood and all were already serving throughout the area, except for one son who was helping him serve at Oneida.

Reverend Burleson spent six years in his service to Oneida, prior to his death on February 22, 1897. He is also buried in the church cemetery which is on the northern part of the cemetery, high on a hill.

The Reverend Cornelius Hill became a deacon on June 27, 1885 and ordained a priest on June 24, 1903. He spent his entire life in the service of others, beginning early on in life when he attended Nashotah House at the age of ten years of age, returning to Oneida at the age of 13 after being chosen a chief of the Bear Clan, then returning to complete his training at Nashotah. At the age of 18, he began to travel with other Oneida chiefs to council meetings. He undertook all duties assigned to him in this role. He was recognized as a leader of the

people at a young age and went on to serve the Oneidas both politically and in their spiritual needs. He worked faithfully at Hobart Church serving as a delegate to the Episcopal Church Councils in Milwaukee and supported the mission work in Oneida throughout his life. It is important to mention that he spoke on behalf of the Oneidas when it came to protecting their lands from outsiders making several trips to Washington, with other Oneida leaders.

There is much to be said about all that has been accomplished throughout the church's early history and those who played a role in these happenings.

In 1903, at the age of 69, Hill was ordained a priest and this was a very special day for him by the congregation as well as by others. He passed

away in 1907 and is buried in the church yard at Hobart Church with as much celebration as provided to those who went before him.

In 1897, the Reverend F. R. Merrill was assigned to Oneida. It can be said that it was during this time that the new stone church was finally completed, that is, a full completion of all necessary work. The celebration included one-thousand people in attendance. At this time, there was the re-naming of the

Hospital that the First World War was in progress. Dr. Powless was called upon to serve.





During Reverend Merrill's term, Josiah Powless, M.D. was in charge of the Oneida Hospital for twelve years.

He began his career by excelling in his studies and finally completed his medical training at the Milwaukee Medical College (now Marquette University).

It was while he was working at the Oneida

Conducting activities to identify elders eligible for services, providing information to eligible elders about available service, and encouraging an elder to use existing services. This is a one-on-one contact, not a group service such as public education.

Homemaker Services/ In Home Chore:

Providing assistance for housecleaning, laundry, shopping, and meal preparation.

Respite:

Respite care is non medical care provided to a frail elder so that the caregiver can have a break.

Personal Care/Home Health Aid Service:

Providing personal assistance with eating, dressing, bathing, toileting, transferring in and out of bed/chair or walking.

Do not provide any medical services, which does require trained personnel.

Home Chore Service:

Providing assistance to persons having difficulty with heavy cleaning, yard work, walk maintenance, minor home repair, wood chopping, hauling water and other heavy duty activities which the older person(s) is unable to handle on his/her own and which do not require the services of trained homemaker or other specialist.

Visiting:

Visiting services include going to see an elder in order to comfort or help in reading or writing a letter.

Telephoning:

Telephone services include phoning in order to provide comfort to help or check up on the elder.

Family Support:

Family support services include providing services to family members who care for an elder such as counseling or discussing the elder's situation.

Health Promotion and Wellness:

Activities conducted to improve the mental and physical health of elders, including walking groups, exercise classes, other types of recreation, and health education classes on health care. (Matter of Balance, Chronic Disease Self Management, Powerful Tools for Caregivers, Elder Driver Safety)

All background security checks are completed by Oneida Human Resource Department.

Items to Consider When Selecting a Beneficiary

Lat'sanalo-loks... They gather the Names

Selecting a beneficiary is a very personal decision. Consider these questions:

- Upon your death, who will bear the responsibility of your expenses?
 - Are there people who count on you for their financial support?
 - Would you like to assign payment of the funeral expenses to a specified funeral home (Assignment of Proceeds) to not burden family members? If so, remaining proceeds will go to your beneficiary(ies) after EPIC pays the funeral home.
 - What are the state regulations – am I able to select anyone I choose as my beneficiary? For example, in Wisconsin, your spouse may be entitled to 50% of the proceeds, unless the spouse waives their right to such proceeds.
- If you are naming someone other than your spouse as a beneficiary(ies), your spouse must sign the spousal waiver to waive their rights to the proceeds.**
- EPIC recommends that you research your options before choosing a beneficiary, and discuss your objectives and concerns with your professional advisors before making this important decision. According to the default provisions of the policy, if you do not elect a beneficiary, EPIC will pay the first available individual

or individuals using the following naming sequence:

- For deceased members over the age of 18:

- Widow or widower
- Child(ren) (natural or legally adopted children)
- Grandchild or grandchildren
- Parent(s)
- Brother(s) and sister(s)
- Member's estate

- Members who are minors will not designate a beneficiary or have a designation elected for them. All payments will be designated using the following naming sequence:

- Widow or widower
- Child(ren) (natural or legally adopted children)

- Parent(s) or legal guardian(s)
- Brother(s) and sister(s)
- Grandparent(s)
- Member's estate

Keep your beneficiary designation up to date. You may want to modify your designation in the event of important family changes, such as a birth, death, marriage, or divorce.

Step-by-Step Instructions for Completing This Form

- A. Please print your full name, date of birth, Oneida enrollment number, and full address in the designated areas.

- B. Primary Beneficiary(ies) – Will receive the proceeds as long as they are alive and legally capable of receiving the benefit. The percentage(s) assigned to your primary beneficiary(ies) must total 100%.

- C. Contingent Beneficiary(ies) – Will receive the proceeds only if all primary beneficiaries are deceased or not eligible due to disqualification by law. For example, you elect your spouse as the primary beneficiary, and your two children as contingent beneficiaries; you and your spouse are killed in a car accident; your children would receive the

proceeds. The percentage(s) assigned to your contingent beneficiary(ies) must total 100%.

- D. This document is only valid if it contains your signature and date. EPIC does not require this form to be notarized, but you may have it notarized if you wish.

- E. Check the Marital Property law in your state. Based on Wisconsin's Marital Property law, if you are married and you elect a primary beneficiary other than your spouse, your spouse must sign the spousal waiver to waive their rights. Otherwise, your spouse may be entitled to 50% of the proceeds.

USDA Announces Nutrition Education Grants

WASHINGTON, April 8, 2011 -- Agriculture Secretary Tom Vilsack announced today that tribal nutrition education projects in 10 states have been selected to receive grants this year through USDA's Food Distribution Program on Indian Reservations (FDPIR). The grants will help develop creative, self-initiated projects designed to enhance the nutrition knowledge and to foster positive lifestyle changes of FDPIR participants in low-income households living on Indian reservations and to American Indian households residing in approved areas near reservations or in Oklahoma. Janie Hipp, Director of USDA's Office of Tribal Relations, joined Governor Bill Anoatubby and Lt. Governor Jefferson Keel of the Chickasaw Nation in Oklahoma to announce the grants on behalf of Agriculture Secretary Tom Vilsack.

"We are committed to working with Tribal nations to improve the nutrition and health on Indian Reservations and tribal lands," Vilsack said. "These projects will help support and expand nutrition education through self-initiated projects and provide better access to more fruits and vegetables so that we

can make great strides in improving the nutrition and health of tribal members."

Each year, Indian Tribal Organizations and state agencies that administer the program can apply for funding to expand nutrition education efforts. USDA chose 15 applicants, located in California, Kansas, Minnesota, Mississippi, Montana, New Mexico, Oklahoma, South Dakota, Washington and Wisconsin, to receive FY 2011 funding to develop nutrition education projects that incorporate the Dietary Guidelines within the Native American culture.

Projects chosen this year for the grants, which total \$1 million, include a recipe toolkit containing menus, shopping lists, and snack ideas featuring more fruits, vegetables, and whole grains; summer camp programs for youth to teach healthy cooking techniques; nutrition education sessions held during scheduled food deliveries for participants in remote reservation areas; and community gardens to promote fruit and vegetable consumption. The announcement comes as First Lady Michelle Obama's Let's Move! initiative celebrates National Gardening Month (April).




