

OBC approves Secretary's office re-org plan

The Oneida Business Committee (OBC) took action dissolving a department as part of the tribe's re-organization effort that started when the Chief of Staff and General Manager positions were eliminated September of last year.

With a three votes in favor, one against, and three abstaining, the Communications

Department was dissolved with staff being shifted to Legislative Affairs office, Tribal Secretary's office, and the Internal Services Division.

In all, 27 positions were affected as 19 were transferred, two were reassigned, and six were eliminated. All of the eliminated positions have already been vacated and many of the reassignments and transfers were completed before the OBC action on Wednesday.

During the September 28, 2011 OBC meeting the committee took

action to undertake a major re-organization of the tribe's structure.

In 2000 the General Tribal Council approved re-organization of the tribe under a proposal called Plan B.

The then sitting OBC viewed the GTC action as out of order and rejected Plan B.

During the 2011 meeting, the current OBC rescinded resolution BC-8-2-00-B, which ruled the GTC action in 2000 was out of order. By rescinding the resolution Plan B was put in place eventually eliminating the General Manager,

Assistant General Manager and Chief of Staff positions.

With the addition of staff to the Legislative Affairs office it will reorganize as the Office of Public Affairs to include public relations functions.

The Tribal Secretary's office will also provide tribal member information services. A new position titled Tribal Member Information Services Manager will be created by eliminating the political appointee position in the Tribal Secretary's office.

OBC Councilmember

Brandon Stevens feels the re-organization topic still has more work that needs to be done.

"The committee still needs to address this issue," he said. "There was a big emphasis in the beginning of our administration to do this and it fell to the side."

According to Tribal Secretary Patty Hoeft, the employee movement will positively affect the major functions of her office. The employees will offer assistance handling administrative duties of the Secretary's office to the OBC and General Tribal Council

(GTC), getting information to the GTC, and records management.

"A lot of these people will be put in positions that will really enhance their experience," she said.

When asked if pay rates for affected employees would stay the same Hoeft wouldn't offer specific details.

"We are trying to approach this as we have been discussing since the start of this business cycle of trying to reduce our expenses," she said.

Tribes may soon approve own land leases

WASHINGTON (AP) ~ A bill giving Native American tribes authority over agreements to lease their lands for development awaits the president's signature.

Supporters say the legislation, called the HEARTH Act, will hasten housing construction,

clean energy and business or industry development on tribal lands. It allows tribes to approve their own land leasing agreements rather than the Bureau of Indian Affairs, if they choose. The Navajo Nation already has this sort of authority.

The Interior Secretary still must approve the tribes' leasing regula-

tions. The bill does not apply to oil and gas leases. The administration issued new leasing regulations last November that set deadlines for approval of leases to end long delays.

The House approved the bill in May. The Senate approved it Tuesday by voice vote. The president's signature would make it law.

Ancient remains found in western WI construction site

Onalasks, WI (AP) – Archaeologists are finding ancient remains that might be of Native Americans beneath the reconstruction of Highway 35.

Scientists from the Mississippi Valley Archaeology Center have found almost two dozen likely skeletal fragments. They've also found hundreds of food and garbage pits, cooking hearths, tools and other artifacts of the Oneota people who inhabited the Onalaska area between about 1300 and 1600 A.D.

All burial sites are protected by state law. Jim Becker, the archaeology program manager for the Wisconsin Department of Transportation, told the La Crosse Tribune that any time remains are discovered during construction, the state must stop work and consult with the Wisconsin Historical Society.

“We knew that we had a burial site in there and that there was going to be more coordination,” Becker said.

In accordance with federal law, state officials met with interested parties, including the historical society and the Ho-Chunk Nation to agree on a process for monitoring construction and looking for archaeologi-

cal and human remains. The site was previously a village occupied by ancestors of the Ho-Chunk, Ioway, Oto and Missouri tribes, said laboratory director Connie Arzigian. In many cases, Arzigian said, they've only found bone fragments, which will be sent to a skeletal analyst to verify whether they are human.

When remains are found, archaeologists usually try to leave them in place, but the road project makes that difficult, Arzigian said.

work with the natural resources conservation service and the forest service," said Sherman. "I'm learning an enormous amount about the Oneida."

Sherman visited the Menominee reservation on Tuesday to learn about their forestry operation.

"I think both of these tribes are representative of many of the positive, expanding examples USDA has working with tribes across the country. And I'm learning a tremendous amount about how we can strengthen and improve our relationships," he said.

Sherman was particularly impressed with the way the 11 tribes in

Wisconsin coordinated their work with the Natural Resources Conservation Service and the United States Forest Service.

"That's a model for the United States. I think this is the first time that this is happened in the country, and we're hoping that the tribes here in Wisconsin will reach out and provide this example to other tribes in other states," he said.

Sherman stated the USDA was working on improving protection and access to sites sacred to Native American.

"There are a variety of very important, historical sites that Native Americans want to preserve, they want access to those sites, so part of

our goal is to help to facilitate an appreciation, an awareness of that, make sure that we are doing our job to protect those sites and allow Native Americans to get to those sites and to honor their culture and their history," he said.

Patrick J. Pelky, Division Director of Environmental, Health & Safety Division, stated his department was excited to welcome Sherman and Leavenworth.

"It was a great opportunity to showcase our successful partnerships with some of the USDA programs on how our Tribe is making a real difference on our Tribal lands," Pelky wrote in an email. "They seem

pleased with our stewardship of our natural resources, including agricultural lands, forestland, wetlands, streams and small lakes through our sound agricultural and natural resources technical practices and projects."

OBC Councilman Paul Ninham was pleased to work with Sherman.

"The Natural Resources Conservation Service works very close with Tribes throughout Indian Country. The most notable exchange during the day was the Under Secretary offering the Oneida Tribe to visit him in DC and that he would introduce us to key persons drafting the Farm Bill," wrote Ninham in an email.

Farmers Encouraged to Report Crop Losses and Low Yields to FSA

Appleton, WISCONSIN ~ With recent dry weather conditions in some areas of the state, the Farm Service Agency (FSA) encourages farmers to document and report crop losses or low crop yields to their local FSA county office.

Producers must report crop losses resulting from a weather-related disaster event within 15 days of the disaster or when the loss first becomes apparent, this includes crops covered by crop insurance and the Noninsured Crop Disaster Assistance Program (NAP). Prevented planting must be reported no later than 15 days after the final

planting date.

Crop losses are acres that were timely planted with the intent to harvest, but the crop failed because of a natural disaster. It is important that producers file accurate and timely loss reports to prevent the potential loss of FSA program benefits.

Although low yield acreage does not need to be reported, producers are encouraged to keep good production records on acreage with a low crop yield to document crop losses.

Farmers are reminded that they may revise FSA crop reports free of charge. A crop report revision, however, must be verified by physical

evidence of the crop in a field spot check.

In addition, farmers are encouraged to report crop conditions to their county FSA offices so that the information may be used to support the potential request for a disaster declaration.

Additional information in regard to failed crop acreage or crop losses covered by the Non-Insured Assistance Program (NAP) can be obtained by contacting your local county office. FSA program information is also available online at

School Days

Ongoing Kalihwisaks Column • Providing a connection to the past

I was born on June 8, so I entered school when I was just six years old. There was no kindergarten that I could go to. We lived on Kalb Avenue in The Little Yellow House, perpendicular from Schroeder's Greenhouse on Webster. It was a rural area, in that there were only farms across the road. One of the farms belonged to Ben Hunt and his wife. They were a black family with two children: Ben and Jessie Ellen. Later, Ben and Jessie Ellen were placed in the Guardian Angel School at Oneida. I liked to go to their house because they had a full size Charley McCarthy dummy, some goats and chickens.

I walked to school, more than a mile away—past two huge cemeteries, the Woodlawn Cemetery and the Allouez Catholic Cemetery, both on Webster Avenue and St. Joseph's Orphanage, and the Bishop's House. That was a first class adventure for a six year old kid. By that time, I heard a lot of stories about cemeteries. The Nuns were always herding the orphans in rows, two by two, and I had to make my way around them on the sidewalk. I didn't pay much attention to the orphans, but I liked the huge chestnut trees that lined the walk from the orphanage. One time, when the bushes along the walkway were turning yellow and brown, I looked back and thought I saw a tiger. After that, I ran all the way home and was scared to venture in that direction again.

The Allouez Elementary School was

next to the Catholic Cemetery. There is a CVS Drug Store there now. After the school building was razed, a Walgreen's Drug Store was built there.

Here, I attended the first and second grades. Miss Fogarty was my first grade teacher. I remember she had a hairdo called a bob and black net stockings. Why I would remember that at age six is anybody's guess. We did a lot of art work with colored construction paper, blunt scissors and white paste. The white paste came in a huge jar—maybe about a two quart size. I tasted the paste and it was kind of minty, so I ate a lot of it. I was caught and admonished and I bawled a long time. We studied the famous Dick and Jane books. See Dick. See Dick Run. Run Dick Run, same thing for Jane. I knew the whole story before I entered school because my mother, Grace Skenandore Kurowski, taught me how to read at home before I ever went to school. I was indignant and quite upset when Miss Fogarty introduced me to a book I had not seen before.

For some reason I do not remember the name of my second grade teacher. I do remember what she looked like though. She was an older lady. My highlight in the second grade was a Felix the Cat movie. And I think there was a character in it called Steam Boat Willie. I belonged to a girl's group that played games like "Ring Around the Rosie" and "Duck, Duck, Goose". I was a year older, but I was still afraid to walk past the cemeteries and the Bishop's house.

In 1939, we moved to 1230 Thomas Street, just

off Velp Avenue. This area was sparsely settled with just a few houses on each block. Dad had about an acre of garden that he spaded and worked by hand. I walked to Elmore School in the third grade. Miss Donavan was my teacher and she was a little on the plump side. I remember a lot about the third grade. I built a solar system with clay balls suspended on string in a cardboard box. I drew two geisha girls in among the cherry blossoms. I didn't know what geisha girls were, but they struck my fancy, so I drew them and won an honors award for it. We did a dance called the minuet. I had a long "Martha Washington" dress that our neighbor, Mrs. Okray, made for me. We had singing class every Friday. That's where I learned the Brahm's lullaby.

Dad bought Stuckart's farm on the Second Ridge. We moved there in September, 1941. The farm is midway between the Oneida Village and Silvery Summit School on the First Ridge—two miles in either direction. My sister Shirley and I walked to Silvery Summit School. We did have bicycles, blue for me, maroon for Shirley. They were heavy and lots of fun flying down the hills on them on the gravel roads, but they had to be pushed up the opposite hill and that was a big job for a nine-year-old and a seven year old.

School was fun for me. There were five grades in the big classroom. Some grades only had three students. Our class was the largest. There were four guys who always hung around together: Mervin Jordan, Hyson Powless, Erwin Cottrell and Max Antepenko.

Two Summers' girls sisters: Noel (Fudge) and Lavinia. Jane and Ruth Skenandore, Louise's family, were also sisters, Marie Webster and Thelma King and myself. There may have been two others that I can't recall.

This is the little school where I learned everything. My fourth grade geography had stories about Baffin Island, the Congo and the Great Sahara Desert. My Social Studies book taught me Greek Mythology and about the Hanging Gardens of Babylon. A picture of "The Gleaners" was hanging on the wall, so I had to find out what that was about. I think it was done by Millet showing women picking up grain in the fields that had been left. I read every book in the library. I got A's in every subject and D in deportment. Deportment is behavior. I didn't want to bring my report card home with a D on it, especially in deportment. My fifth grade teacher was LaPearl Powless. She was the daughter of Manuel and Lydia Powless and an excellent teacher. We fifth graders wrote out "The Christmas Carol" with an indelible pencil and then made copies on the gelatin medium. We put the play together. I was Marley with the chains. I put up an entire life-size display of the Crusaders in action on the Black Board. I really didn't know what the Crusades were all about, but the display looked fantastic. The majority of the students attending Silvery Summit were Oneida students, but there were no subjects that taught Indian studies or the Oneida history.

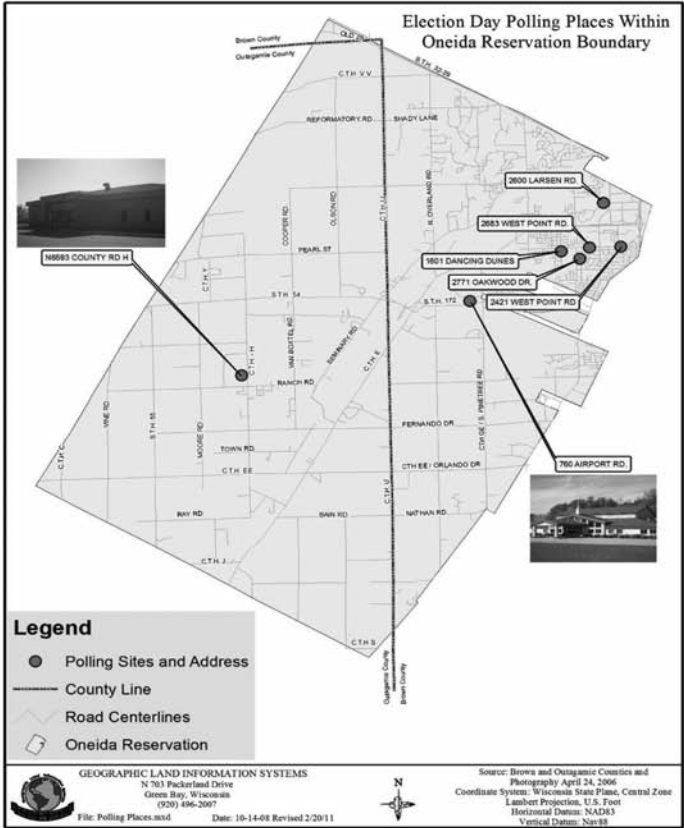
GET OUT THE VOTE

Purpose: *Oneida Child Support Law Amendments*

The intent of the Oneida Child Support Law (the Law) is to establish the legal responsibility of parents to provide financially for their children's well-being based on the real earning capability of parents. The Law establishes a standard of support for those children whose paternity has been established or acknowledged and encourages the use of voluntary agreements to resolve any disputes over child support obligations. The proposed amendments to the Law are as follows:

• **Amendment of Name.**

Change the name from Oneida Child Support Enforcement Agency to Oneida Tribe Child Support Agency (Agency). The purpose of this change is to better portray what the Agency does, as enforcement is only a portion of the work being done.

• **Overtime Pay.**

Specifically include overtime pay in the definition of Gross Income for the purposes of paying child support.

• **Jurisdiction.**

Add long-arm jurisdiction as is provided in the Wisconsin State Statutes. This allows for broader jurisdiction over those respondents' who may not reside in the normal defined jurisdiction of the Appeals Commission.

• **Notice.**

Amend notice of hearings, thereby requiring that only the notice of the initial action be served via certified mail and all subsequent notices by first-class mail.

• **Publication.**

Amend the provision regarding notice via publication. Due to the Kalihwisaks changing the frequency of their publication, the law now requires publication three consecutive times in either the Kalihwisaks or other newspaper in the county where the respondent resides.

• **Past-due Obligations.**

Update the section on arrears to now include past-due obligations.

• **Review.**

Require the Agency to review the child support order

every two years. If a substantial change in circumstances exists, then the agency is required to file a motion with the Appeals Commission to have the order amended if the parties cannot agree to the amendment.

• **Motion to Amend.**

Authorize any party to file a motion to modify the child support order, and sets the timing for scheduling a hearing to no sooner than ten calendar days after the date of service on the opposing party.

August 9, 2012

Purpose: *Oneida Paternity Law Amendments*

The intent of the Oneida Paternity Law (the Law) is to establish paternity of Oneida children and other Indian children in order to protect the best interests of these children regarding such matters as enrollment, customs and traditions of the Tribe, survivorship and inheritance, health, support, and social security benefits. The proposed amendments to the Law are as follows:

• **Amendment of Name.**

Change the name from Oneida Child Support Enforcement Agency to Oneida Tribe Child Support Agency (Agency). The purpose of this change is to better portray what the Agency does, as enforcement is only a portion of the work being done.

• **Jurisdiction.**

Add long-arm jurisdiction as is provided in the Wisconsin State Statutes. This allows for broader jurisdiction over those respondents' who may not reside in the normal defined jurisdiction of the Appeals Commission.

• **Timing of Filing.**

Allow a petition to determine paternity to be filed at any time after the child is born.

• **Notice.**

Amend the provision regarding mail delivery to allow for regular first-class mail rather than registered or certified mail.

• **Update of Address.**

Require the alleged fathers' who appear and participate in an action to inform and keep

updated their current address at all time with the Agency and the Appeals Commission.

• **Administrative Subpoenas.**

Authorize the Agency to issue administrative subpoenas to require the mother, child and alleged father(s) to appear and take a paternity test.

• **Reopening of Judgment.**

Clarify that either the adjudicated father or the Agency can reopen a default judgment of paternity.

• **Stipulations.**

Allow for the alleged father to stipulate to paternity and then to custody, placement and child support matters.

Public Hearing Process

I. Testimony:

A. Oral: There will be a 5 minute limit for all oral presentations. Each participant is encouraged to provide a written transcript of his/her oral testimony, to be submitted while present at the public hearing or within ten (10) business days from the date of public hearing to the below named individuals.

B. Written: For those who cannot attend the scheduled public hearing or do not plan to speak at the hearing, the Oneida Tribe encourages those to submit written testimony. A maximum of ten (10) pages, doubled spaced, can be submitted within ten (10) business days from the date of public hearing to the Tribal Secretary (Patricia Hoeft) or to the Legislative Reference Office Paralegal, Tonya Boucher, at the Norbert Hill Center, 2nd floor or mail to PO Box 365, Oneida WI 54155.

Thompson goes after Hovde in new US Senate race ad

Madison, WI (AP) – Former Wisconsin Gov. Tommy Thompson has unleashed his first attack ad of the U.S. Senate race campaign, accusing hedge fund manager Eric Hovde of gaming the system and betting against American taxpayers.

Hovde, who polls show is gaining on Thompson with the primary three weeks away, posted a response on his campaign website Monday calling Thompson's television ad "a disappointing and disingenuous display of politics as usual."

Thompson's latest spot going after Hovde, released on Saturday, came a day after Thompson sent both Hovde and third candidate Mark Neumann a letter complaining about their ads attacking him.

The latest back and forth between the candidates shows a further intensification of the race to fill Wisconsin's open Senate seat vacated by the retire-

ment of Democrat Herb Kohl. Besides Thompson, Hovde and Neumann, state Assembly Speaker Jeff Fitzgerald is also running as a Republican. U.S. Rep. Tammy Baldwin is the only Democrat in the race.

Hovde opponents have been trying to knock down his campaign as it appears to be gaining momentum. The national anti-tax group Club for Growth launched

a television ad attacking him and Thompson two weeks ago. Neumann is also running his own spot attacking Hovde's conservative credentials because he donated \$500 to Democratic Gov. Jim Doyle in 2006.

Hovde responded with his own spot last week, accusing Thompson and Neumann of slinging mud in an attempt to distract

attention from their own poor records.

In Thompson's latest, his first attack ad of the campaign, he accuses Hovde of running a hedge fund that "used 'Uncle Sam' to buy banks" and "gamed the system and bet against American companies and homeowners."

Ongoing investigation of fires on Lac Courte Oreilles reservation

Madison, WI (AP) – Police are investigating a rash of suspicious fires on a northwestern Wisconsin tribal reservation.

Lac Courte Oreilles (lah-COOT'-oh-ray) tribal police issued a statement saying authorities

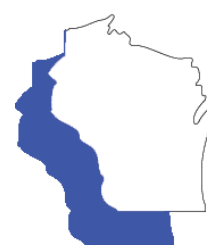
received reports of six fires on Saturday and Sunday. The fires damaged a store's siding, a storage shed, two sweat

lodges, tribal powwow grounds and a ceremonial ring.

The statement says tribal police contacted the state fire marshal. Tribal police and the Sawyer County Sheriff's Department apprehended a person of interest on Sunday evening but the statement offers no further details.

Raylene Wolf, a tribal

police office assistant, says the department won't release any additional information because the investigation is ongoing. A message left at the sheriff's department wasn't immediately returned. State Justice Department spokeswoman Dana Brueck referred questions to tribal police.



Wisconsin At a Glance

Wis. DOJ starts voter ID appeal process

Madison, WI (AP) – The state Justice Department has begun the process of appealing a Madison judge's order blocking Wisconsin's new voter identification law.

Republicans passed a bill last year that requires all voters to show photo identification at the polls. Dane County Circuit Judge David Flanagan ruled last week that the law impairs the right to vote.

Republican Attorney General J.B. Van Hollen,

who leads the Justice Department, has said he believes the law is constitutional. On Monday the agency filed an appeal notice with the 2nd District Court of Appeals in Waukesha, a Republican stronghold.

The notice begins the appeal process.

Another Madison judge has blocked the law in a separate lawsuit. Van Hollen is appealing that decision, too.

Wis. DNR reminds hunters app deadline approaching

Madison, WI (AP) – The state Department of Natural Resources is reminding hunters the permit application deadline for multiple seasons is fast approaching.

Applications are due by Aug. 1 for the fall turkey, sharp-tailed grouse, bobcat, fisher

and otter seasons as well as for Canada geese in the Horicon Zone.

Hunters can apply for permits on the DNR's website, at any authorized license agent or at DNR service centers. A bobcat permit application runs \$6. Applications for the other seasons cost \$3.

As drought continues, Wisconsin corn crop suffers

Milwaukee, WI (AP) – As the drought continues, Wisconsin's corn crop remains in sad shape.

In its weekly crop progress report for Wisconsin, the U.S. Department of Agriculture said Monday that 43 percent of the state's corn crop is in very poor or poor condition, with just 31 percent rated as good to excellent. Hay yields are coming up short due to a lack

of moisture, plus insects.

Only 23 percent of the state's soil has adequate moisture, with 46 percent of the state very short. Ninety-nine percent of the soil in south-central Wisconsin is rated short or very short.

Forty-five percent of the corn in the 18 states that planted the most corn acreage last year is in very poor to poor condition as the drought continues across most of the Midwest.

Report: 10,000 construction jobs lost in Wisconsin

Madison, WI (AP) – A new report says Wisconsin lost more than 10,000 construction jobs in the last year.

The Associated General Contractors of America says the state's construction employment dropped about 11 percent from June 2011 to June 2012. Only Alaska is worse with a 20 percent job loss in the construction industry.

The trade group's chief

economist, Ken Simonson, says private sector demand for buildings is up in most states, but single-family home building is spotty and public investments in construction are shrinking.

The Milwaukee Journal Sentinel reports Wisconsin got hit harder than some other states because of its shorter construction season.

Wis. domestic-violence victims seeking more help

Madison, WI (AP) – State officials say victims of domestic abuse are staying longer in shelters and seeking more assistance.

The Department of Children and Families says the number of victims staying in domestic-abuse shelters is roughly constant, but those victims are staying 12 percent longer.

Shannon Barry is the executive director of Domestic Abuse Intervention Services in Madison. She tells Wisconsin Public Radio

her shelter is feeling the effects of that trend.

She says many victims are reporting more severe violence, more stalking and more death threats. They require longer shelter stays with more intensive support.

Carmen Pitre is with the Sojourner Family Peace Center in Milwaukee. She says she's seeing the same trend.

Barry and Pitre both attribute the situation to a challenging combination of poverty and unemployment.

No one hurt as wildfires spread on SD reservation

SIOUX FALLS, S.D. ~ Just as firefighters had contained about 25 percent of the wildfires cutting through the Rosebud Indian Reservation in south-central South Dakota, a lightning strike started another blaze, effectively doubling the battleground.

Dozens of residents remained evacuated Monday as authorities looked hopefully at weather forecasts predicting thunderstorms Monday and Tuesday nights.
But Rocky Mountain Area Incident Commander Joe Lowe said the weather so far hasn't been cooperating. The area saw rain over the weekend, but the "thunderstorms come in and

just miss us by about four or five miles," he told a gathering of residents and officials Monday at a Rosebud Sioux Tribe meeting broadcast on the web.

So far, no homes have been hit and no injuries reported. But some residents aren't sure whether they've lost pets or cattle in the blazes, which began late last week.

Authorities estimated that various fires cover at least 7,500 acres - or more than 11 square miles - on the reservation. That's similar in size to another blaze 10 miles northwest of Edgemont, where firefighters built a fire line Monday around the newest portion of the Mossagate Fire. Meanwhile, the nearly 16-square-mile Myrtle fire continued to burn far-

ther west in the Black Hills. Authorities on Monday said that blaze was about 40 percent contained _ thanks, in part, to weekend rainfall.

Shane Del Grosso, a fire behavior analyst, told Rosebud residents that the reservation fires were fueled in part by the recent drought. Flames were 8 to 9 feet high. Where there's brush, some flames soared past 20 feet, he said.

Tribe President Rodney Bordeaux has asked for state and federal help. Residents have been told to document losses to report to the Federal Emergency Management Agency.

Firefighters planned to pre-emptively burn off brush in hopes of controlling the fires' path, a move Del Grosso

acknowledged was risky.

"We're doing it under our terms, and not the fire's terms," he said.

Lowe said a helicopter would go up late Monday or early Tuesday in hopes of spotting at-risk cattle, some of whom could be wandering in the burn area without water. Firefighters also hoped to find and save domestic animals.

State Fire Meteorologist Darren Clabo said that even without rain, cooler temperatures are headed to the area, with highs hitting the low 90s. Humidity should also increase, helping firefighters' efforts.

"Hopefully, that'll help put this fire to bed," he said.

High winds cause damage, injuries on Pine Ridge

OGLALA, S.D. (AP) ~ Several residents of the Pine Ridge Indian Reservation are recovering after strong winds tore through the area this weekend, damaging homes.

Oglala Sioux Tribe spokeswoman Donna Salomon tells The Associated Press that the wind blew some trailers away. She says several people suffered injuries when the homes were

blown away and were sent to the Pine Ridge Indian Health Services Hospital for injuries. The extent of the injuries is unclear.

Wayne Weston, the tribe's emergency manager, is surveying the damage.

The tribe will be working with the Red Cross to provide the displaced families clothing, food and personal items.

Leaders say climate is changing Native way of life

WASHINGTON ~ Native American and Alaska Native leaders told of their villages being under water because of coastal erosion, droughts and more on Thursday during a Senate hearing intended to draw attention to how climate change is affecting tribal communities.

The environmental changes being seen in native communities are "a serious and growing issue and Congress needs to address them," Tex Hall, chairman of the Mandan, Hidatsa and Arikara Nation of New Town, North Dakota, said Wednesday.

Mike Williams, chief

of the Yupit Nation in Akiak, Alaska, said in the informational Senate Indian Affairs Committee hearing, that villages are literally being wiped out by coastal erosion. Williams said he can cast a net and catch salmon at his childhood home because the home is under water, he said. He also described how the Iditarod Trail Sled Dog Race, in which he participates, has been moved because of lack of snowfall and that dogs must run at night to stay cool.

"We've always lived off the land and off the waters and continue to do that. But we're bearing the burden of living with these conditions today,"

Williams said.

Sen. Daniel Akaka, committee chairman, acknowledged that environmental changes are widespread, but the Hawaii Democrat said native communities are disproportionately impacted because they depend on nature for traditional food, sacred sites, and for cultural ceremonies. Several tribes already are coming up with plans to adapt to the changes and federal agencies are assisting with resources, Akaka said.

Members of several West Coast tribes and Alaska communities have been in Washington this week for a symposium at the Smithsonian

Institution's National Museum of the American Indian on the impact of climate change on indigenous people and their communities. The symposium, titled First Steward, brought together tribal leaders, people experiencing the changes and scientists.

Williams said Congress needs to come up with a strategic plan to address the impact to help ensure Alaska Natives and American Indian tribes continue to exist. He said in coming up with the plan, Congress should consider Native practices and traditional knowledge.

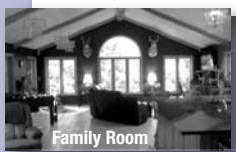

Native Americans to celebrate white bison in Conn.

GOSHEN, Conn. ~ The birth of a white bison, among the rarest of animals, is bringing Native Americans who consider it a sacred event to celebrate at one of the least likely of places, a farm in New England.

Hundreds of people, including tribal elders from South Dakota, are expected to attend naming ceremonies later this month at the northwestern Connecticut farm of Peter Fay, a fourth-generation Goshen farmer.

Native Americans in the area have come with gifts of tobacco and colored flags for Fay and the bull calf since it was born there a month ago, and Fay is planning to offer his hay field as a campsite for the expected crowds.

“They say it’s going to bring good things to all people in the world. How can you beat that? That’s the way I look at it,” Fay said.

Connecticut farms host only about 100 bison, a tiny fraction of the populations in Western states, such as South Dakota, the home of Sioux tribes that attach the greatest spiritual meaning to white bison. As some push for greater recognition of the bison's significance to both the United States and Native Americans, advocates say the event on the far-flung East Coast is well-

placed to boost exposure for the cause. Fay, whose family traditionally stuck to dairy farming, took on bison four years ago as a hobby, enamored by the animals’ toughness. He built his herd to 40 before recently selling half of them.

Word spread rapidly after the arrival of the white bison, which experts say is as rare as one in 10 million, and Fay invited Native Americans for the ceremonies at his farm below Mohawk Mountain. In turn, he and his two daughters were asked to participate in the celebrations, which will include a feast and talks by the elders.

“They’re here almost every day, teaching me,” said the 53-year-old Fay, who has bison tattoos on his shoulder and chest.

Marian White Mouse, a member of the Oglala Lakota tribe in South Dakota, said the birth of a white bison is a sign from a prophet, the White Buffalo Calf Woman, who helped them endure times of strife and famine. White Mouse's family of four is flying to Connecticut for the ceremonies.

“For me, it’s like a surreal event. I never thought in my wildest dreams I would ever come in contact with one of them in my lifetime,” said White Mouse, 51, of Wanblee, S.D.

Jim Stone, the executive director of the InterTribal Buffalo Council in Rapid City, S.D., said the oral traditions of many tribes honor white bison, which have become a universal symbol for hope and unity. He said each such birth is also an opportunity for tribes to share their history, and the celebration in Connecticut is likely to touch many non-tribal people.

The calf, born on June 16, is off-white - not an albino - and Fay said he is certain the bloodlines are pure, although he has sent its DNA for testing to confirm there was no intermingling with cattle. Fay, who also works at an excavating and rock-crushing business, focuses on breeding and selling the bison calves, but he has not determined what will happen with the white one.

To address concerns for the calf’s safety, he also has at least one person stay at the farm

around the clock. Last year, a white bison calf born in Texas was found dead and skinned - a slaughter that some suspect as an anti-Indian hate crime. Fay did not want the date of the ceremonies this month publicized.

Tens of millions of bison once roamed America’s plains, but the over-hunted population shrank to about 1,000 toward the end of the 1800s. Their numbers have rebounded to several hundred thousand, and wildlife and tribal groups are now pushing Congress to have the bison recognized as America’s “national mammal.” The National Bison Legacy Act was introduced in the Senate in May.

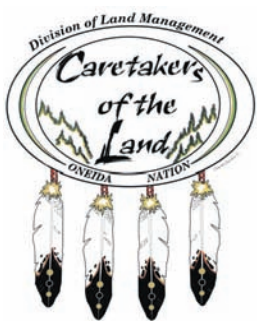
“Any kind of awareness we can raise around bison is a good thing,” said Jim Matheson, assistant director of the National Bison Association in Denver.

Feds urge colleges to adopt new student aid form

U.S. Education Secretary Arne Duncan is urging colleges and universities to adopt an easy-to-understand financial aid form to help students make smarter decisions on where to study, how to pay and determine what they'll owe.

The Department of Education and the Consumer Financial Protection Bureau are unveiling a "shopping sheet" Tuesday that would provide each incoming student with information on the costs of tuition, housing and other fees.

The one-page document also is designed to help students figure out how much they would receive in grants and scholarships and what options are available for loans. Additionally, it would also provide details on the percentage of students who graduate, how much the average student pays monthly on federal loans after graduation and the default rate.

Colleges and universities will not be required to use the form. Duncan said he will be sending an open letter encouraging all institutions to adopt it. In June, the Education Department announced that 10 universities had agreed to provide information similar to what is in the new form.

The Education Department and the Consumer Financial Protection Bureau released findings from a report on Friday concluding that risky lending caused private student loan debt to balloon over the last decade, leaving many Americans struggling to pay off loans they cannot afford.

The study focused on private student loans, which spiked from \$5 billion in 2001 to more than \$20 billion in 2008. The market shrank to \$6 billion in 2011 after the financial crisis and a tightening of lending standards. Student loan debt has surpassed credit cards as the largest source of unsecured debt for U.S. consumers; Americans now owe more than \$1 trillion in student loans.

Duncan said many colleges and universities use student aid letters that are confusing to understand and don't make clear exactly how much is being offered in aid and scholarships, making it difficult for families to comparison shop.

He called the shopping sheet a "step in the right direction."

"All of us share a responsibility for making college affordable," he said. "And for keeping the middle class dream alive."

Researchers report more condom use among teenagers

WASHINGTON (AP) ~ More high school students are using condoms than 20 years ago - but progress has stalled with a lot of work still needed to protect young people from the AIDS virus, government researchers reported Tuesday.

Today, 4 of every 10 new HIV infections occur in people younger than 30, according to the Centers for Disease Control and Prevention - and the teen years, just as youths become sexually active, are key for getting across the safe-sex message.

Using a long-standing survey of high school students' health, the CDC tracked how teen sexual behavior has changed over 20 years. The results are decidedly mixed.

About 60 percent of sexually active high school students say they used a condom the last time they had sex, researchers said Tuesday at the International AIDS Conference. That's an improvement from the 46 percent who were using condoms in 1991.

"This is good news," said Dr. Kevin Fenton, director of CDC's HIV prevention center. But, "we need to do a lot more."

The problem: Condom use reached a high of 63 percent back in 2003.

Black students are most likely to heed the safe-sex message, yet their condom use dropped from a high of 70 percent in 1999 to 65 percent last year, the study found.

If mom and dad get antsy about discussing condoms, well, about half of high school students have had sex, a proportion that hasn't changed much over the two decades, the CDC reported. Today, 47 percent say they've had sex, down just a bit from 54 percent in 1991. Again, black teens made the most progress, with 60 percent sexually active today compared with 82 percent two decades ago.

The average age when teens begin having sex:

16, CDC said.

The more partners, the more risk. Fifteen percent of high school students say they've had four or more partners, down from 19 percent in 1991.

Fenton said part of the problem is that many school systems don't have strong enough sex education policies that include teaching teens about how to prevent HIV. But he cautioned that the CDC study can't link the abstinence-only policies pushed by Congress through the late 1990s and early 2000s to the stalled progress.

Focusing on individual risk behaviors is just part of the story. Increasingly, HIV is an infection of the poor, and specialists at the world's largest AIDS meeting all week are making the point that tackling it globally will require broader efforts to address problems of poverty including better access to overall health services and fighting stigma.

In the U.S., where new infections have stubbornly held at about 50,000 a year for a decade, complacency is part of the problem, Fenton added.

"We have to generate a new sense of urgency," he said.

Overall, though, a characteristic of the young is to think they're invincible, Fenton added.

Lawrence Stallworth II, 20, of Cleveland can attest that they're not. He learned he was infected with HIV at age 17, when he was a high-school senior, after a hospitalization. A black gay man, he's among one of the nation's highest-risk groups.

He's now an Ohio AIDS activist who works to teach young people that they need to protect themselves, and how.

"I want people to have the tools to keep themselves safe," said Stallworth, who at this week's AIDS conference is working with the non-profit Advocates for Youth to increase young people's awareness of an epidemic that in the U.S., today gets little publicity.

Part of that involves our society getting "better at being more open about being able to talk about sex," Stallworth added. "It's still a taboo issue."

Indeed, at this week's conference, the world's largest AIDS meeting, young gay men are emerging as a population in special danger from rising HIV infections worldwide, and young black gay men especially in the U.S.

Black gay and bisexual men account for 1 in 500 Americans but 1 in 4 new HIV infections. The odds that a black man who has sex becomes infected rise from 1 in 4 at age 25 to a stunning 60 percent by age 40, said Phill Wilson of the Black AIDS Institute.

But they're not the only ones at risk. The CDC recommends that everyone in the U.S. ages 13 to 65 be tested for HIV at least once. Those at increased risk - such as people who have multiple sex partners or men who have sex with men - should be tested more frequently, at least once a year.

In South Carolina, 18-year-old Quinandria Lee offers an example of the safe sex practices that CDC says more young people should adopt.

Lee was frustrated at her school's abstinence-only focus. She learned about both male and female condoms from the South Carolina Contraceptive Campaign, and last year her principal allowed her to teach her classmates about them. Condoms are the only contraceptive that also protect against HIV infection.

But Lee credits her mother's frank talk about sex with this key protective step: Lee persuaded her boyfriend to go with her to a clinic where both got a clean bill of health before they ever had sex. Still, they use a condom every time.

"It's hard," she said of that get-tested conversation. But "you can't be too sure."

Information for patients who utilize OCHC On-Call Nurse

Registered Nurses (RN) are available for patient phone calls – 24 hours a day/7days a week. When the clinic is closed the RN is home. They do not have access to medical records or pharmacy information.

When to call and speak with the RN after clinic hours:

- You/your child have an urgent health care need/question that cannot wait until the next open day of the clinic.
- Don't call the RN when you are having a life threatening issue. For example, chest pain, difficulty breathing, or bleeding profusely from wound. Access the nearest emergency department to get medical attention as soon as possible. Call 911 as needed for intervention. Call the Contract Health Services Department to report the visit within 72 hours to ensure coverage.
- The RN's on call also work 40 + hours per week at the OCHC medical clinic, in addition to providing on call services. Calling in the middle of the night with a concern that is not urgent is not appropriate.

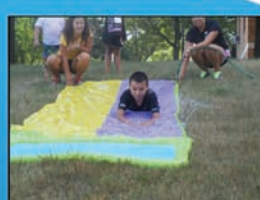

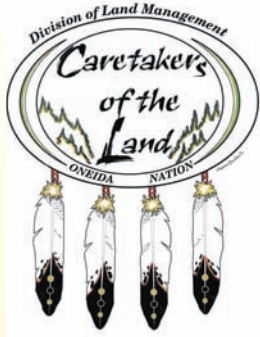
