### Tribe inks service agreement with town of Oneida

Ink was put to paper the morning of Friday, July 27 as a new three-year service agreement between the Oneida Tribe and Town of Oneida was executed at the Town of Oneida Town Hall.

Tribal Chairman Ed Delgado and Town of Oneida Chairman Norman Austin signed the agreement as officials

from the tribe and town were present.

The three-year agreement calls for an annual payment of \$100,000 to be paid to the town. Broken down, \$17,000 is for trust land within the town's boundaries related to the town's tax rate, \$25,000 for fire and first responder services, \$55,000 towards town equipment improvement and town staff salaries, and \$3,000 for an annual trash collecting event similar to the tribe's Clean Sweep program.

The new annual payment is substantially larger than the prior

agreement, which had a \$24,300 payment to the town in its final year. Delgado pointed to the need to ensure satisfactory customer service levels from the town remained the same.

"The tribe chose to include this provision as we recognized the value that their staff brings when providing customer service to our members when they need to conduct business with the Town of Oneida. These contributions to staffing

The boycott is desired due to the company's relationship with the NFL's Washington Redskins.

The Internal Services Division report was approved. The Emergency Management and Homeland Security update was deferred to the Chairman's office for clarification.

**Board, Committee, Commissions**  
Marjorie Schwieger appointment to the South Eastern Oneida Tribal Services advisory board was approved. The recommendation of Gary Jordan to the Bay Bank Corporation board was tabled.

Reports from the Oneida Police Commission, Oneida Nation Veterans Affairs Committee, Oneida Powwow Committee, and Oneida Arts Board were approved. The SEOTS report was deferred to the August 8 meeting.

and equipment will also allow the Town to continue to address the needs of all citizens in a manner that will keep them engaged with the community, allows progress with the addition of new technology, and will help broaden communication efforts and services more effectively throughout the community," he said.

The agreement also states the town will not oppose the tribe's efforts

to place land into trust within the town jurisdiction. It goes in effect on August 1 of this year.

Delgado also praised the town's leadership and the working relationship between the two governments.

"I look forward to continuing the positive government-to-government relationship we share with the Town of Oneida and their elected officials. The expanded

services will offer tremendous value to the entire Oneida Community," he said.

The prior service agreement between the tribe and town expired June 30 of this year. The tribe now has service agreements in place with Outagamie and Brown Counties, the Village of Ashwaubenon, and the City of Green Bay.

resources to do something, but that shouldn't stop you from making the first steps to going forward to getting something done," he said in an interview.

Participants went through the steps of developing a description of their product or service and how to pitch it to potential customers.

"What I want them to realize is that it's not enough to simply have an idea and then talk to your friends about it, because it just sits in your head and over time you begin to hope, to wish - I wish I had done something with that," said Dr. Stamp.

Dr. Stamp speaks to several corporations and colleges every year, but enjoys doing presentations on Native American reservation because he grew up near a reservation in Minnesota.

"Growing up in the middle of nowhere in a rural community, you're often told there are a lot of things you can't do. What I realized that the better way to go through life is to focus on what you do best at and then get other people to help you with the things that you're not really good at," he said. "We live in a world now where the individual can do so much more than they used to be able to do, we live in a world where the individual can do things,

there's a lot of resources. It's a good time if you have an idea for something to consider doing something with it."

Many of the aspiring entrepreneurs had business ideas ranging from an electronic gaming venue to services for the elderly. Norbert Hill Jr. attended the presentation to develop entrepreneurial methods for the Oneida Enrollment Board to communicate with Oneida citizens.

"How do we be creative in finding opportunities for the tribe, and seeing what are dynamics of entrepreneurship and being successful and being able to peek around the corner of opportunity?" he said.

Hill stated he enjoyed Dr. Stamps presentation, and wished more people attended.

"I think the tribe needs to be more creative and entrepreneurial and hungry in creating opportunities so we can sustain what we're doing and not just be dependent on just one enterprise - gaming - that we need to diversify or chances of success and sustainability," he said.

The workshop was sponsored by the Department of the Interior, Office of Indian Energy and Economic Development, Oneida Tribe of Indians of Wisconsin, and College of Menominee Nation.

**Qualifications:**

- The Veterans Affairs Committee will be made up of members of the Oneida Tribe of Indians of Wisconsin who have served honorably on active duty in the Armed Forces of the United States of America.
- Members shall have been inducted into, or voluntarily entered, active duty in one of the service branches of the Armed Forces of the United States of America and who did not receive a discharge from active duty with that branch of the Armed Forces of the United States of America due to "less than honorable conditions."

- a) The ERB shall consist of nine (9) enrolled members of the Oneida Tribe of Indians of Wisconsin who are not employed within the Environmental Dept., the Conservation Dept., or other areas of the Oneida Tribe over which the ERB has direct oversight responsibility and authority.
- b) Commissioners shall be appointed by the Oneida Business Committee to serve a three (3) year term.
- c) All ERB members, within one hundred eighty (180) days of the appointment to the ERB, are required to participate in training as follows:
  1. Environmental Law-Eight (8) hours, two (2) hours of which shall be Oneida Tribal law and procedures.
  2. Grievance, Hearing, and Appeals.
  3. Six (6) hours of training in formal opinion writing and the basics of evidence.
  4. Two (2) hours of professional ethics, including issues of confidentiality.
  5. Thereafter, all ERB members shall either accumulate a minimum of eight (8) hours annually in the above training or shall review annually the lessons and materials connected with the above training.
  6. A minimum of three (3) hours training in a formalized process for conducting meetings as determined by the ERB.
  7. The ERB may, at its discretion, extend the time allowed for completion of any and all required training of a member for good cause shown.

# The Legislative Reference Office

Legislative Reference Office  
The Oneida Nation Legislative Operating Committee (LOC) has a resourceful extension of their function called the Legislative Reference Office (LRO). The assignments delegated to the LRO by the LOC are generally the reinforcement needed to help forge Oneida sovereignty into words. Sovereignty is not found on paper, but the powers can be communicated through the written word. Writing down the powers of a people and getting everyone to agree can be nearly impossible. The LRO staff positions are not designed for those fearful of intense analytical scrutiny, as day in and day out, constant revision and redrafting through the consultative process of the people is seemingly endless in an attempt to do the impossible, yet the voices are heard. As a Higher Education intern in the LRO this summer, one of my assignments was to observe and learn the process and to share it with our people in an article. Having an eight week all access immersion into the challenge that is our Oneida tribal legislative process, I am

now ready to share my story of the voices that were heard, because I listened.

Several good articles have appeared in this publication detailing the flow of formal documents and show colorful graphic charts to help us understand how we get from A to B at the Norbert Hill Center. This article provides insight into the spirit of our law and not necessarily paper shuffling into a written book of codes. The spirit of our law begins in the heart and mind of what we feel is right and just. Feelings and emotions run rampant through the mind and can provide a voice with many things to say. Sometimes the voice is reactionary to hurt or a painful experience, while other times the mind is at peace having thought about what the voice should say with clarity and purpose. Our people inherently are supposed to come from this central core as a foundation for what we want as an accord providing protections for our sovereignty. These are the voices that were heard.

The Oneida process provides several opportunities for a voice to be heard. It is also the inher-

ent responsibility of an actively concerned member of our people to take part in this process or as witnessed repeatedly, be constrained by the voices that do. Our vote is a voice and consequently our elected officials are the collection of our voices. Imagine coming to work with the weight of Oneida on your back. That is what we have asked of our leaders, to hear all of us and make the right choices based on a harmony of voices in agreement despite opposition. Decidedly by our own pronouncement only a portion of voices are heard going into endorsing what words get on a document in front of the LOC. The five members of the LOC give the LRO only a percentage of a resource to craft an instrument reflective of the entirety of Oneida and its sovereignty. It cannot be flawed, it will be shattered. It cannot be weak, it will be ignored. It cannot be pre-empted, it will be taken. If we as Oneida have ever had any power to endure through time immemorial, it did not come from silence. If the process of making Oneida laws is to provide for the seventh generation, then know there is

an office for the process where all of this is done, and is done by crafting actions from active voices, those of the voices that were heard.

In order to be heard there must be someone that is listening. Leadership must be willing to never turn a deaf ear to the voices of the people. I did not come here to be heard. I came here to listen. There were no shortages of people that had something to say, voices that so desperately wanted to be heard and voices that demanded to be heard. In order to maintain balance I have been taught that to truly listen is to truly understand. Coming here as a student of my own people I am beginning to truly understand and it is thanks to all whom I have heard and special thanks to those, even though I am a student, whom took the time to listen.

### In Regard to Transit

I am confused and upset in regard to the Oneida Transit System's mess. I keep hearing the blame pushed off on someone else, and/or excuses.

I have multiple ailments. Memorial Day I slipped and fell into the tub and bruised my tail bone. I made a call at 8:00am to be picked up at Aurora Bay Care for 10:00am for therapy. I waited until 10:30am to ask where my ride was. Carol told me the driver was almost there, so I waited. At 10:45am. I called, mad and crying. I was told that she was at the front door. I was standing there and the driver was not there. So I was angry, I told him what was happening. He put me on hold, and came back on the phone and said she was there again. I told him that I was standing in the entrance. Then he came back on the phone and tells me he was sorry, the driver was

at the wrong place. He clearly blamed the driver for that mess, but doesn't she get her destinations from dispatch? For this mess I got a free ride home, and an \$8 ticket on the bounciest big truck. I have requested a van most of the time, and have only received a van twice. Also, I still request they come to the alley because my front door faces the alley. When they do come to the alley I am always ready.

On 7/11/12 I went to transit with a voucher for a medical pass. I gave Brandon the voucher and scheduled my pick-ups for the next couple of days. He gave me a pass and I asked three times if I was going to get where I needed to be on the eastside. Brandon said yes. Well, I was sitting outside, and I hear a horn. Of course the driver finally was there. I showed the pass, he said it would be an additional \$6. I blurted out hell no. I'm not going through this crap again! We had words, he tells me to get

on the bus, they can bill me later. I was already dialing the office. I asked if Brandon was in. Carol said yes and transferred me to him. Of course it went to voice mail. I let him know again how mad I am that he, the supervisor, would not stand up to his own mistake. I still have not gotten a call back from him.

If it were up to me they would be gone. They should put someone in there that cares. They're

too comfy in their jobs. Transit needs a facelift. I will be putting a call out to Don White, not that it matters; he also has never called me back.

## Highlights from Special Vestry meeting to address church repairs

A Special Vestry meeting was held on July 23rd to address fixing the church building. Three motions were on the floor the first two died in deadlock (4:4) and the proceeding third motion passed by one vote; allowing the Bishop to decide. Everyone should be asking the same question, why was the Vestry deadlocked? It would be easy to sum the votes as four Vestry members

wanted to fix the church and the other four Vestry members did not but, there is more to it than that. And, that is what this update will try to elucidate.

Four Vestry members wanted to fix most the outside problems at once. This is favorable because it addresses needed church repairs to include the eroded roof valley-tin and gives the greatest overall financial breaks; for example the construction company does not have to move equipment

twice or three times as you would in phases. The down side is that fixing the outside of the church leaves little to no operating capital (more on this below).

One Vestry member played Indian, placing the pledge card on his forehead (not literally) suggesting that we do not get enough financial support from our congregation to support needed repairs.

One Vestry member suggested that we would lose too much interest income, suggesting that

operating capital was more important than fixing the church. This is somewhat skewed because the Vestry does not have a balanced budget. In general, the Vestry spends about 50% more each year than it should. It would be similar to buying \$150 of groceries knowing you can only afford \$100 and since you spend more money on groceries than you should; the oil in the car does not get changed leading to engine damage. In this analogy, instead of neglecting our car we

have neglected our church.

One Vestry member wanted to compromise and just fix what was required to allow access back into the church for church functions. This left the question of what to do with the other needed repairs; when would they get repaired and who would pay for it?

In summary, because of neglect for so many years I am suggesting that the Vestry is now faced with a difficult job; fixing our church spiritually, physically, and financially. The

difficulty is further compounded by little to no community support. We may care but, we do not support.

Here I offer support suggestions, **1)** come to church on Sunday at 10am, **2)** get a bunch of your family together and host a dinner, **3)** donate the extra toaster you got for Christmas, **4)** come to meetings.

## Treasurer's Report

Sheku, Greetings

With school starting soon and summer coming to a close, I hope everyone has enjoyed the beautiful weather and has created priceless moments that will stay with you always.

The GTC Budget Meeting has been set for Monday, September 17th at 6:00 pm at the Radisson. Prior to the GTC meeting we will be

holding presentations in Oneida and at SEOTS to present the budget and answer questions. The dates of these sessions will be posted in the Kalihwisaks and on the Oneidanation.org website.

The Finance Department has had to face many challenges to complete this upcoming fiscal year's budget and despite everyone's best efforts, we are still facing

a deficit of about \$9 million dollars. This is very troublesome because it is apparent we cannot continue to do business in the same manner without some significant changes being made.

It was my understanding that the reorganization process was intended to address the over-staffing issue and the duplication of services. Unfortunately the restructuring has met with bias and favoritism. Even though I have had many heated moments in these Business Committee meetings, my voice is only one and decisions have been made without my input. I cannot support adding staff to already over-staffed area. I also cannot support the creation

of new positions. When jobs are created we need to ensure we have the funds to support the job, the job is needed, and the job description is reviewed and posted according to the Human Resource Department guidelines. With a \$9 million plus dollar deficit, it is not sound business practice to add new positions and keep unnecessary staff.

As Oneida Business Committee Treasurer I am forced to make tough decisions every day and I make these choices based on facts and good business practice. When I see or hear something this is not appropriate I stand alone in my beliefs and am smeared throughout the community for

being direct. I would rather have that than be accused of not looking out for the best interest of the Tribe.

Many times I ask things of management they are unaware of. This is unfortunate and speaks to our corporate culture. If management is unaware, either by choice or necessity, how effective is our organization? I believe this question was answered when the GTC voted in favor of restructuring.

As time goes on, the decisions facing the Oneida Business Committee will only get tougher. If we cannot significantly decrease the budget deficit by creating additional revenue; jobs, services, and programs will all be in jeopardy. It

is unfortunate that we are in this position and it is disturbing that various members choose not to see the reality of our financial status. The Finance Department and I have been diligently working on ways to increase our revenue and to stop ventures that may result in additional debt for the Tribe. Ours is a thankless job most of the time but I know our work is well appreciated by our community.

I hope to see you all at the September 17th Budget Meeting and hope the remainder of your summer is memorable.

## OBC Forum...

I hope you and your families are having a great summer, this summer has been off to a good start. The recent powwow and other events have been well attended and I look forward to seeing you at the many other events coming up over the next few weeks.

On the home front, it has been an eventful summer. My office has been diligently working on various policy matters and I have been busy with budget meetings, committee assignments, legislative policy drafting work and meetings with constituents. I also recently had the opportunity to attend a housing training event at Housing and Urban Development.

Locally, there have been some nice accomplishments by staff, many projects around the community have been completed or are underway. The newly remodeled Westwind One Stop is complete and open for business. Construction has begun on a new One Stop on Larsen Road even though the project was initially delayed. This is a new facility in a type of business area we know, so with the projected growth we will hopefully see a busy and profitable store soon.

Community trails are being completed throughout the Reservation. Long term projections for harvesting a more progressively designed community are beginning to take shape. These types of projects will hopefully continue to unify the look and feel of the Reservation. *We have a presentation on these matters coming up this week, please stop out and see the presentation and provide your input. Details on the event are listed at the end of this article.*

### Challenges

I will say, after being in office for a year, it has been great to have an opportunity to try and make a difference. Oneida is a dynamic

place with a lot of great people. Individually and collectively we all have outstanding potential. Just think of our history, if there is any nation that can overcome challenges it is ours.

We need to maximize opportunities for both our people and on our land. One of my main goals is to fully tap the potential of our people and our tribe. We must start thinking strategically about how we invest in our people and how we invest in our land. In my estimation, we have to foster a posture towards our people and the land which realizes us investing directly to maximize the productivity of both. To me, Oneida has the tenacity to resolve all of our own issues.

There are many challenges confronting us today. I would note, leadership and the people of a nation have been confronted with serious issues throughout history, today is such a moment for us. The challenge today is, how will we respond?

I look at the current Oneida Business Committee (OBC) and I see us going into our second budget cycle with no new movement around creating new opportunities. Think about it, two-thirds of our budgets will realize no new investment or growth in new programs or new economic pursuits. The OBC needs to find creative solutions.

Today, Oneida is in a sort of a holding pattern. Economic growth is stagnant and layoffs may need to be discussed in the future. Also, housing shortages are present and we still need to engage in some level of restructuring. Operations of this tribe need various levels of re-tooling and as a people we need to rethink what we're doing.

Now, with the above being said, this is not to say that we're not doing good things, there are a lot of positives here. Services are still flowing and employees at the

casino and elsewhere are still helping to keep this tribe alive and running.

The challenge for us is how to forge change in order to maneuver towards a brighter future. We need to actively engage in shedding the non-functional waste while harvesting new ground. My goal is for us to think hard about what we're doing and look at the various attributes we already have to maximize our future opportunities as a tribe.

### Change

One of the obstacles for us is change. Many people are simply uncomfortable with the idea of change and I can understand that, but our future relies on us being able to change certain aspects of what we're doing when it's clearly not working.

I have continually sensed an undercurrent of resistance to change. For example, I have offered various projects which could create valuable new jobs and open the door to economic growth. Unfortunately, it seems there is no real interest or energy to try something new. Change can create various types of newly needed job opportunities for our people. New initiatives can spawn new industry. This is a serious challenge for the Oneida Tribe; can we take the initiative to create new job opportunities and advance ourselves economically?

Here is a brief overview on just two job making projects that I have brought forward:

- An Oneida housing plant proposal to build custom homes here in Oneida. This project would have created 30 plus new

jobs.

- A federal contracting project to engage in Naval Shipping contracting. This project would have created 50 new jobs.

These are but two examples of opportunities that we should have pursued. Eighty (80) plus new jobs could have really been an economic shot in the arm for Oneida. There are other projects that are a possibility, but we need to first see how change is embraced in order to help us pursue and commit to creating new opportunities for our people.

### Housing

When it comes to Oneida and housing, talk has not yielded results. I continue to be concerned about housing related matters. There are hundreds of Oneidas who need housing now. On the idea of a new housing push, I am hearing from some that say, "New housing for Oneidas will cause urban sprawl." I am hearing from others saying, "Why make it easier for Oneidas to get housing, they won't take care of the homes." Ironically, everyone I hear from who is against a new housing movement, already have homes.

I agree that on housing matters, we need to come

forward with a broader approach where a majority of the people can have agreement. I would note, the idea of urban sprawl is coming, no matter how much we resist. 

## Purpose: Oneida Child Support Law Amendments

The intent of the Oneida Child Support Law (the Law) is to establish the legal responsibility of parents to provide financially for their children's well-being based on the real earning capability of parents. The Law establishes a standard of support for those children whose paternity has been established or acknowledged and encourages the use of voluntary agreements to resolve any disputes over child support obligations. The proposed amendments to the Law are as follows:

- **Amendment of Name.** Change the name from Oneida Child Support Enforcement Agency to Oneida Tribe Child Support Agency (Agency). The purpose of this change is to better portray what the Agency does, as enforcement is only a portion of the work being done.
- **Overtime Pay.** Specifically include overtime pay in the definition of Gross Income

for the purposes of paying child support.

- **Jurisdiction.** Add long-arm jurisdiction as is provided in the Wisconsin State Statutes. This allows for broader jurisdiction over those respondents' who may not reside in the normal defined jurisdiction of the Appeals Commission.
- **Notice.** Amend notice of hearings, thereby requiring that only the notice of the initial action be served via certified mail and all subsequent notices by first-class mail.
- **Publication.** Amend the provision regarding notice via publication. Due to the Kalihwisaks changing the frequency of their publication, the law now requires publication three consecutive times in either the Kalihwisaks or other newspaper in the county where the respondent resides.
- **Past-due Obligations.** Update the section on arrears to now include past-due obligations.
- **Review.** Require the Agency to review the child support order

every two years. If a substantial change in circumstances exists, then the agency is required to file a motion with the Appeals Commission to have the order amended if the parties cannot agree to the amendment.

- **Motion to Amend.** Authorize any party to file a motion to modify the child support order, and sets the timing for scheduling a hearing to no sooner than ten calendar days after the date of service on the opposing party.

## Purpose: Oneida Paternity Law Amendments

The intent of the Oneida Paternity Law (the Law) is to establish paternity of Oneida children and other Indian children in order to protect the best interests of these children regarding such matters as enrollment, customs and traditions of the Tribe, survivorship and inheritance, health, support, and social security benefits. The proposed amendments to the Law are as follows:

- **Amendment of Name.** Change the name from Oneida Child Support Enforcement Agency to Oneida Tribe Child Support Agency (Agency). The purpose of this change is to better portray what the Agency does, as enforcement is only a portion of the work being done.
- **Jurisdiction.** Add long-arm jurisdiction as is provided in the Wisconsin State Statutes. This allows for broader jurisdiction over those respondents' who may not reside in the normal defined jurisdiction of the Appeals Commission.
- **Timing of Filing.** Allow a petition to determine paternity to be filed at any time after the child is born.
- **Notice.** Amend the provision regarding mail delivery to allow for regular first-class mail rather than registered or certified mail.
- **Update of Address.** Require the alleged fathers' who appear and participate in an action to inform and keep updated their current

address at all time with the Agency and the Appeals Commission.

- **Administrative Subpoenas.** Authorize the Agency to issue administrative subpoenas to require the mother, child and alleged father(s) to appear and take a paternity test.
- **Reopening of Judgment.** Clarify that either the adjudicated father or the Agency can reopen a default judgment of paternity.
- **Stipulations.** Allow for the alleged father to stipulate to paternity and then to custody, placement and child support matters.

## Public Hearing Process

## I. Testimony:

- **A. Oral:** There will be a 5 minute limit for all oral presentations. Each participant is encouraged to provide a written transcript of his/her oral testimony, to be submitted while present at the public hearing or within ten (10) business days from the date of public hearing to the below named individuals.
- **B. Written:** For those who cannot attend the

scheduled public hearing or do not plan to speak at the hearing, the Oneida Tribe encourages those to submit written testimony. A maximum of ten (10) pages, doubled spaced, can be submitted within ten (10) business days from the date of public hearing to the Tribal Secretary (Patricia Hoeft) or to the Legislative Reference Office Paralegal, Tonya Boucher, at the Norbert Hill Center, 2nd floor or mail to PO Box 365, Oneida WI 54155.

Applications must be submitted between Aug. 1 and Aug. 31. Permits will be awarded by drawing, and successful applicants will be notified by

mail. The application fee is \$10.

If you apply but you don't get a permit, you'll receive a 'preference point' that improves your chances of being selected in future drawings.

The Natural Resources Board established six wolf-harvest zones. Each zone will have a wolf

quota, although the quotas are still being finalized.

The state Department of Natural Resources set the overall harvest limit at 201 wolves. The DNR estimates as many as 880 may roam the state.

The season runs from Oct. 15 through Feb. 28.

## Judge rules pollution at Wis. mine

**MADISON, Wis. (AP)** ~ A federal judge has ruled that Flambeau Mining Co. violated federal clean water laws at its former copper mine near Ladysmith, but that the amount of pollution was minimal.

In her ruling Tuesday, U.S. District Judge Barbara B. Crabb also said the company's environmental practices were "exemplary."

Environmentalists, including the Wisconsin Resources Protection Council, had sued, alleging that the mine violated the Clean Water Act when copper and zinc from the mine entered a small stream that fed the Flambeau River.

Crabb said evidence showed the mine was the source of the pollution, despite Flambeau's contention that it couldn't be

traced to a mine filter designed to capture leftover toxic material.

But the judge also said the discharges were slight and that Flambeau deserved "commendation, not penalties" for its stewardship of the site. She ordered the company to pay \$275 for the discharges and denied a request to have Flambeau pay the plaintiffs' legal expenses, the Milwaukee Journal Sentinel reported.

The Flambeau mine operated from 1993 to 1997. Over the past year, it again drew attention when mining advocates, seeking to make changes in Wisconsin mining laws, cited the mine as a model of mineral extraction while environmentalists emphasized the toxic discharges into the Flambeau.

"We are pleased that the judge was clear in her ruling that the Flambeau River has been and is protected, and that discharges from the biofilter on our property have never threatened the river's water quality, as the plaintiffs claimed," Dave Cline, a project manager for Flambeau, said in a statement Wednesday.

An environmentalist had a different take on the ruling.

"We're glad to see the court recognized what concerned citizens have known for years: that even a relatively small-scale copper mine can still pollute waters for years after it has closed," said Al Gedicks, executive secretary of the Wisconsin Resources Protection Council.

## Tribes want federal regulation of Internet gaming

WASHINGTON (AP) ~ With some states readying to start online gambling, Native American tribal leaders are calling on the federal government to step in as it did with brick-and-mortar gambling and establish regulations that ensure tribes get a piece of the action without having their revenue taxed and their sovereignty compromised.

A new set of regulations is unlikely before this year's election, but recent events have given momentum to efforts to launch online gambling in some states. Since a December 2011 Department of Justice opinion that not all Internet gambling is banned by federal law, Delaware has legalized online gambling and

Nevada is closing in on making online poker possible. New Jersey, too, is working to make it a reality.

Some tribes worry if regulation is left to states, it will be a patchwork of rules that aren't considerate of the relationship Native Americans have with the federal government.

"Tribes should be extremely hesitant to entrust their economic futures to the tender mercies of the 50 states, many of whom are still in financial crises and looking for new sources of revenue," Bruce "Two Dogs" Bozsum said Thursday in testimony before the Senate Indian Affairs Committee. Bozsum is chairman of the Mohegan Tribe of Uncasville, Conn., which

has large casino operations.

Bozsum said his tribe has invested a "great deal of time" preparing Internet gambling regulations. "These regulations now stand ready to be implemented, and will meet or exceed the toughest regulations found anywhere in the world, including the new standards recently established in Nevada," Bozsum said.

According to the Senate Indian Affairs Committee, tribal gambling was a more than \$27 billion industry in 2011, while commercial gambling was \$35.6 billion and worldwide gambling revenues were \$30 billion.

Glen Gobin, secretary of the Tulalip Tribal Council, reminded the

committee that he previously testified against legalizing Internet gambling. But on Thursday, Gobin said that with states ready to start their own Internet gambling, "tribes must have equal footing to participate."

Gobin said his tribe, in Tulalip, Wash., plans to move forward as gambling evolves because the revenue pays for many of the tribe's government services. The Tulalip do not have regulations ready because tribes' participation has not been decided.

"To say we are ready for the full regulatory aspect, we are not, but I have full confidence we have the capabilities," Gobin said.

Jon Porter, a lobbyist for the Poker Players Alliance, urged tribes to

get prepared because online gambling "has to happen."

Senate Majority Leader Harry Reid, D-Nev., and Sen. Jon Kyl, R-Ariz., have been working on online gambling legislation. On Wednesday, the Senate Indian Affairs Committee spelled out how the federal government could regulate online gambling so tribes are protected and included at a meeting of tribal leaders for the National Indian Gaming Association's Legislative Summit on Wednesday.

"We in Congress - and especially on this committee - also have a responsibility to ensure that tribal views and priorities are part of any legislation that could impact

tribal gaming," said committee chairman Daniel Akaka, D-Hawaii.

Also Thursday, the Senate voted to move forward on cybersecurity legislation, intended to protect U.S. computer systems and infrastructure from cyberattacks. But if the bill moves forward and ultimately passes the Senate, it still would need to be reconciled with a House version. Little other legislation has moved through Congress, making it more likely that any movement on Internet legislation would happen after elections in the lame-duck session.

## New York tribe moves to evict non-Indians

BRANT, N.Y. (AP) ~ The Seneca Nation, a native American tribe in western New York known for its defiant stances on sovereignty, said Friday that it would evict around 80 families living in a lakeshore community on its territory because the residents aren't members of the tribe.

The action covers an area on the shores of Lake Erie called Snyder Beach, now dotted with summer cottages, many of which are occupied by people who have been there for decades. Tribal leaders said in a written statement that they want the families out by Nov. 8.

"This is a long-standing issue of unlawful occupation and is key for the Seneca Nation. The Cattaraugus Territory is for Senecas and removing the unlawful occupants will make more land available for Senecas," Seneca President Robert Odawi Porter said in the statement. "It is quite clearly an illegal occupation, even if that may surprise some of the current residents and the general public."

The statement said tribal authorities had issued permits in the past for the last, but hadn't done so in many decades.

The eviction threat outraged longtime Snyder

Beach residents, who acknowledged that they lived within the Seneca's Cattaraugus Territory, but said they leased the property annually from a Seneca businessman.

"I built this house. My family has been here 55 years," retired Buffalo firefighter William McNamara, 81, told the Buffalo News. "We built this ourselves. For a lot of us who live here, it's been a lot of hard work, blood and memories. My neighbor is 92 years old, and he says, 'I'll be damned if I'm going to turn my property over to the Indians.'"

The businessman renting the land to the families, John Metzger, told

the newspaper he believed the tribe had no right to throw out his tenants.

"It verges on a cleansing operation, in my opinion," he said. He said Seneca Nation leaders had threatened a similar action six times before, but had never before gone as far as to serve eviction notices.

Seneca officials said Metzger isn't allowed to give leases to people who are not Senecas. Only the Tribal Council has the power to grant permission to the families to live on the territory, they said.

People on both sides said the dispute is certain to wind up in court.

## New federal charges against Native Mob members

MINNEAPOLIS (AP) ~ Updated federal charges against alleged members of a Native American-based gang now include murder and aiding attempted murder.

The superseding indictment charges Shaun Martinez with killing another Native Mob member in February 2011. Prosecutors say Martinez killed Jereme Kraskey to keep him from giving information to law enforcement.

The original indictment filed in January accused 24 suspected Native Mob members with conspiracy to participate in racketeering, alleging they

used violence and intimidation to keep the gang in power.

The Bemidji Pioneer says the latest federal charges also accuse two other defendants with aiding and abetting attempted murder in March 2010. They're accused of shooting a man while he held his 5-year-old daughter.

Authorities say the gang wields power from the Twin Cities to reservations throughout Minnesota, North Dakota, South Dakota and Wisconsin.

## Our Changing Climate and the Parched Aquatic Habitats

It has been a tough summer for the aquatic animals on the Reservation. The drought-like weather and heat has caused many of the wetlands and creeks to become unusually dry and lack any flow. To the best of their abilities, the Oneida Environmental Health and Safety Division (EHSD) have been working on lessening the impacts of unfor-

giving weather on the environment through numerous restoration projects. The University of Wisconsin Sea Grant Institute projects our climate to gradually become warmer. This warming is expected to result in drier summers because of increases in evaporation due to the warmer temperatures. They predict that annual precipitation levels will remain relatively the

same, but seasonal precipitation levels will shift. Average summer precipitation may decline by as much as twenty percent, while average winter precipitation levels will increase. Climate change (predicted by many climatologists for decades), is becoming clearly evident, even to skeptics. Extreme heat events are occurring more frequently. The higher temperatures have been causing

environmental stress for plant and wild animals as well as for humans. Insect species, kept in check by cold winters, have recently invaded more northerly areas resulting in huge losses to agricultural crops as well as to natural plant communities. The Oneida EHSD has been working on a restoration project to reintroduce brook trout into Trout Creek. It has taken over

a decade of work to restore the stream to a condition suitable for trout to survive in. That effort included manure management, buffer establishment and re-establishing stream sinuosity. However, cold water species such as brook trout require high oxygen levels and cold water temperatures. They decline dramatically in high temperatures that contain less oxygen. Warmer water species expand their ranges when water temperatures rise. These species out compete the heat and oxygen stressed trout making brook trout reintroductions difficult to sustain in these conditions. Additionally, EHSD has been working on stream restoration projects that protect and improve water quality. It is critical that stream flows are sustained throughout the year so that nature can more eas-

ily recover from harsh climatic events such as this summer's drought and heat wave. To further protect and enhance water quality, trees will be planted alongside the streams to provide shade and to cool the water. This will improve habitat and cover for brook trout and a variety of aquatic animals, many of which are food sources for brook trout. Even with all of the climate change that is occurring, we must keep in mind the Seven Generations and continue to protect the environment so our children and grandchildren will be able to enjoy the land and water as we do now. It is only through constant and ongoing environmental management that our descendants will be able to fish for and catch brook trout in Trout Creek where brook trout were once absent.

## Oneida Nation Child Support Agency Child Support VS. Custody/ Placement/Visitation

As the Oneida Child Support Agency begins to grow, there are many questions, not only regarding child support but often questions pertaining to issues of custody, placement and visitation that Oneida Child Support cannot address. Once these matters have been ordered in a previous action changes cannot be made by the Child Support Agency. However, we would like to educate and remind the community of the definitions of related matters and correct departments to contact when and if there are questions.

Custody-The authority assigned to one or both parents by the court to make major decisions regarding their child(ren). OCL 79.10(a) presumes that joint legal custody is in the best interest of the child.

Physical Placement-Periods of time a child spends in the care of a parent frequently called visitation. Placement can be stated as primary physical placement, where the child resides a majority of the time, and or secondary physical placement, where the child spends less time with the other parent. Secondary placement may also be referred to as, visitation.

Shared Time- The child lives with each parent part of the time. Both parents assume all costs in proportion to the number of days he or she cares

for the child. The time with each parent may or may not be equal.

Split Placement- A family with 2 or more children in which one parent has primary placement of one or more children and the other parent has primary placement of the other children.

Once issues of custody, placement, and visitation have been ordered by the court or agreed upon by the parties, subsequent changes must be handled by the court through a Stipulation and Order (an agreement signed by both parties) or if the parties do not agree, a Motion may be filed with Oneida Tribal Judicial System (OTJS), this is NOT a child support matter. The agency is prohibited from offering legal advice and must stay objective in the matter. The Child Support Agency will be

notified if there are changes in the Custody, Placement and or Visitation due to a hearing, and will then submit a recommendation for child support to OTJS.

If both parties on a case are in agreement to any changes to issues regarding custody and placement there are blank pro se forms that can be found at OTJS and filled and out and notarized, therefore removing any court action if not necessary.

Again, it is important to reiterate that every family has different circumstances and the answer for each question will never be the same. Feel free to contact your Child Support worker at 920-490-3700 or Oneida Tribal Judicial System 920-496-5300 for any additional questions.

## Oneida Community Integrated Food Systems

In 1994, the Oneida Tribe purchased a 2,400 tree Apple Orchard as part of their continuing strategy of reacquiring lands within the original boundaries of the reservation. The Apple Orchard has 24 acres of original orchard and an additional 10 acres of new orchard, which now totals approximately 4,200 trees. The majority of the apples are Macintosh, Cortlands, and Honey Golds. Thirty other varieties are also available. Also available is a large variety of meat products such as: Black Angus and Buffalo steaks, roasts and hamburgers, pork & chicken. There is also a wide variety of winter squash, pumpkins and other produce.

Part of the Orchard's goal is to generate interest in the area of agricul-

ture as well as encourage our children to understand at a young age, the importance of growing healthy food, and finding natural ways to eliminate pests.

The Apple Orchard is part of the Youth Day on the Farm event that takes place each April. The Oneida Elementary School 6th graders partake in this event. It has been quite successful in generating the youth's interest in agriculture. It also teaches them the many techniques which are used to naturally eliminate pests such as trapping insects, releasing bugs to control other bugs, and having range chickens which eat apple maggot flies.

The Apple Orchard offers fresh fruits and vegetables to all community members. They can purchase these products starting late summer.



Each September the Orchard participates in the Big Apple Fest. This year Big Apple Fest will be on Saturday, September 22 from 10am

## Gymnast claims title in first national competition

Olivia Fabry walked into her first national gymnastics competition not expecting much, but what she earned was a national championship.

Fabry participated in the 2012 YMCA National Gymnastics Championships that were held in Milwaukee, WI on July 1, 2012.

The gymnasts were judged in balance beam, uneven bars, floor, and vault events and then given an overall score based on the results of those individual events.

Displaying her consistency in all of the events Fabry finished 4th in vault, 3rd in bars, 2nd in beam, and 2nd in floor giving her an overall score of 35.375.

The final score was enough to make Fabry the Level 5 juniors National All-Around Champion in gymnastics.

"I didn't really think I was going to win I thought I was going to come in 30th or something. I just wanted to be able to place and do my best," Fabry said with a giggle.

As a member of the YMCA Gym Stars team she gets to travel around Wisconsin for competitions throughout the season.

Being a serious gymnast requires dedication and a tireless work ethic and so far Fabry displays both. She practices at the downtown Green Bay YMCA three nights a week, attends private lessons, and spends much of her time at home progressing her skills as a gymnast.

Perhaps the most startling fact is that the 11 year old has been involved in gymnastics for only a couple of years, beginning at the age of nine.


The span of two years has allowed Fabry to identify her favorite events to participate in.

"My favorite events to do are beam and floor, those two are kind of tied. The vault is my least favorite. I don't like vault at all because I'm not good at it," said Fabry.

Despite not liking the vault event and claiming she is not good at it Fabry was the 2011 level 4 state champion on vault.

Suffering an unfortunate string of injuries during the past year had forced her to miss a lot of time. Fabry had her appendix removed, suffered a knee injury, healed from an elbow injury, and broke a toe.

Having dealt with injuries throughout the year it would have been understandable for Fabry to give gymnastics a break. But Fabry persevered. Her perseverance has made her a national gymnastics champion.

"I just love doing gymnastics, everything about it I like doing. The only thing I don't like about

gymnastics is conditioning. But I want to keep trying really hard in gymnastics so I can get as far as I can," said Fabry.

Watching the current U.S.A. gymnastics teams compete at the Olympics is providing motivation to improve her skills.

"Watching the Olympics is motivating for me because whenever I can't do something I think to myself 'Come on Olivia! They were doing this when they were your age,'" Fabry added.

Olivia is the daughter of Ryan and Tracy Fabry, granddaughter of Sandie and Bob Mahn, and great granddaughter of Francis "Stitch" and Leona House.
