## Heat, lack of water lead to death of buffalo

An accidental or intended action lead to the death of 22 buffalo at the buffalo pasture on Cooper Road in Oneida.

On Tuesday, September 4 staff at the Oneida Farm were informed of dead buffalo and discovered the water supply to the herd was shut off sometime over the Labor Day weekend.

A veterinarian confirmed all of the deaths

were due to dehydration. 18 were discovered Tuesday while four more were found Wednesday.

The last visit by staff to the pasture was Thursday, August 30. According to farm staff, tame buffalo held in captivity can go about four days without water while wild buffalo can survive seven to 10 days.

The deaths took place in the west pasture, which is used for reproduction and growth of the herd.

The grass fed herd is used as a tourist attraction along with producing buffalo meat for sale. It has roughly 150 head.

An investigation is underway to determine if the turned off water supply was an accident or intentional.

An update will be provided in an upcoming Kalihiwisa issue.

## New NFL policy allows gaming ads

New NFL stadium advertising rules will increase the visibility of the tribe at Lambeau Field this coming season.

During the spring NFL Owners Meetings teams were granted the authority to allow casino advertising in limited locations throughout the stadium and game day activities such as programs and local radio broadcasts.

Prior policies limited gaming advertising as the NFL looked to keep sports betting at an arm's length and not affiliated with the game.

"The previous NFL policy did not allow clubs to have any advertising with



casinos and other state-licensed gambling related establishments. It is now permissible, for clubs to have limited advertising with casinos and other

state-licensed gambling establishments, as long as they do not have a sports book," said Craig Benzel, Packers Director of Marketing and Corporate

two seasons and requires limited advertising language.

"We believe this a well thought-out rule change by the NFL. In addition to no sports book relationships, all advertising with casinos or other state licensed gambling related establishments must have an audience reasonably anticipated to be composed of mostly individuals 21 years of age or older and include a prominent responsible gambling message," said Benzel.

The Oneida Casino will utilize this new policy and is excited for the opportunities the new advertising platform creates. Signage was in place for the Packers' first preseason game on August 16.

"Internal sign messag-

ing will allow for cross marketing opportunities with our website and social media and allow Oneida Casino to bring awareness to casino offerings pre and post game," said Mike Overman, Director of the Gaming Marketing Department. "45 percent of Packer game attendees fall into the 45-plus age demographic. This group accounts for the majority of Oneida Casino revenues annually."

The two-year agreement will include signage in concourses and Atrium area along with a full-page ad in the game day program. It also guarantees the casino will have exclusivity meaning no other casinos will have advertising during the contract.

A relationship between the Packers and Oneida Tribe already exists as multiple advertisements can be seen throughout the stadium on game days along with the Oneida Nation gate.

"(The) agreement solidifies Oneida Casino's relationship with the most admired franchise in the NFL. This adds integrity," said Overman.

"Since we have had a long-term partnership with Oneida Nation, the new NFL rules are allowing us to work closer with the Nation and casino. We are able to continue our work together in the community, as well as offer new opportunities to promote one of northeast Wisconsin's major destinations," added Benzel.

## Decisions to be made at GTC Budget Meeting

The Kalihwisaks gave members of the Oneida Business Committee (OBC) and community an opportunity to comment on the Fiscal year 2013 Budget ahead of the General Tribal Council (GTC) meeting being held Monday, September 17. Here are the responses.

### Chief Financial Officer Mr. Larry Barton

The proposed Fiscal Year 2013 Budget has been adopted by the Oneida Business Committee and is ready for presentation to the General Tribal Council for consideration. After months of Budget Meetings and revisions, the proposed Fiscal Year 2013 Budget will be presented to General Tribal

Council on September 17th 2012. The total requested initial amount of this years' budget has been reduced by approximately \$24 million dollars. The reductions were necessary to present a balanced Budget for 2013' to the Tribal Membership. The proposed reductions were very challenging to consider and represent sacrifice at many levels in the community. Importantly, the proposed budget maintains current employment, General Tribal Council mandates and continuation of essential services. Further, the proposed Fiscal Year 2013 budget attempts to further strengthen the Oneida Tribe financially by incrementally reducing debt service obligations and building the contingency fund for financial emergencies. Importantly, the overall economy continues to struggle toward recovery slowly. This circumstance combined with an expectation that Federal Grant Dollars will diminish, requires continuation of careful allocation of reduced resources. Austerity measures are here for the indefinite. The organization and community has and ideally will continue to adapt to the current economic climate and resultant financial pressures. The Finance area will continue to strive toward



## From 1A/Budget: OBC offer opinions, thoughts

guiding the community toward financial sustainability strategies now and in the future. Thank You.

### OBC Councilman David Jordan

I am in support of this year's budget. Every budget meeting I attended with directors and managers, I feel they had a good handle on their day-to-day expenses and made necessary cuts whenever possible. However, this should not be a status quo budget. We should be working to decrease our spending and saving money within our budget at every opportunity we can get. We need to be able to sustain our Tribe in the years to come and if we don't curtail our spending, we may not be able to afford our members' future services.

### OBC Treasurer Cristina Danforth

The 2013 Budget development process began in February of this year. A directive from my office was given to set the parameters for funding the operations and provided technical assistance for the utilization of standardized forms and procedures. The budget allocation was derived from Fiscal Year 2011 audited financials. A set aside is also determined to meet General Tribal Council directives and mandates. In June and July meetings were scheduled to allow the Oneida Business Committee to dialogue with tribal departments on their budget requests. When these sessions were concluded we had an \$8.9 million shortfall. As a result of the shortfall the finance team met with the BC to direct further cuts and reduction of operational expense. Items reduced were; CIP project costs, reduction in Educational fund, 10% reduction in supply

expense, reduced overtime expense, reduced capital contributions to Oneida Golf Enterprise, finance donation line reduction, decrease in tribal contribution of health insurance and increase in revenue from enterprises and a reduction of technology projects. All of these items allowed for the development of a balanced budget that was then forward to the GTC. The budget development task requires a lot of staff time and cooperation from everyone who is impacted by our financial obligations and as beneficiaries.

### OBC Councilman Vince DelaRosa

The tribal budget process has been challenging over the last year. We have a built in structural deficit which needs some level of managing. We are at a crossroads here, it's something we need to think about. For example, economic diversification is critical for our success, but to pursue this path, other things need to go. As we see a leveling out of our resources to support a large employment base over the next few years, we have to try and grow top end revenues. We either have to grow revenue or look at more serious measures to cut expenses. Sadly, we are heading into deep and choppy waters without strategic long and short term plans to grow through economic diversification. Over the next 14 months, if we fail to grow revenue, there will be little options left but to start more drastic measures to balance future budgets with the trending rising expenses.



# Contractor approved for church restoration

On August 14th the Vestry unanimously came together and approved a contractor for restoring the bell tower. A down payment is scheduled to be released on August 24th with construction scheduled to start on September 1st. A survey of original Oneida quarry stone was completed and a plan to retrieve one pallet of sacred stone for construction will save Holy Apostles \$1,200 in material costs.

There is some confusion in the community about church repair costs so I want to take a moment to address this. A total of \$494,000 was requested to complete repairs and restoration of the outside of the church only. Unfortunately only \$260,000 is made available.



able. The shortfall is \$234,000 which means the roof and west stone walls will not get repaired. The question the community needs to ask is when will the rest of the church be repaired?







## Treasurer's Report

**Sheku, Greetings**

One important aspect of safeguarding assets is inventory control. We need to assure we have an ample supply of items but not be overstocked. In order to do this effectively, inventory controls should be in place in every department of the Tribe.

Tangible assets or things we can touch and see are the most common items we think of when we talk about inventory. Gaming should have an inventory of playing cards, slot machine parts, blank player cards, etc. DPW should have an inventory of tools, plumbing pipes, electrical outlets, etc. While other departments have an inventory of pens, pencils, paper, books, etc. All of these types of items are paid for by the

### Housing

I have continued to advocate and pursue options and solutions to housing matters. My focus has been on changing the approach we have had to housing. We have to be more strategic in our response to housing issues, infrastructure, and economic development. Strategies for leveraging resources and coordinating efforts to better meet the needs of our communities now needs to be the focus of housing discussions. Housing options need to be improved through new housing start-ups in Oneida and elsewhere. The truth is it is time for us to leverage opportunities and seek partnerships to find the best solutions. We have to seek the best solutions and results.

**Economic Diversification**  
Economic diversification is critical for our success. As we see a leveling out of our resources to support a large employment base over the next few years, we have to try and grow top end revenues. We either have to grow revenue or look at more serious measures to cut expenses. The simple reality is without strategic long

and short term plans to grow through economic diversification there will be little option but to start more drastic measures to balance future budgets with the trending rising expenses.

We are looking at different model approaches which will involve partnerships and outside equity resources which can help address these matters.

### Legislation

#### 1) Election Law

The Election Law amendments are near completion and will soon be submitted to the Legislative Operating Committee (LOC) for their review. Some of the substantial changes I am recommending are:

- Extending the appeal timeframe to 30 days from an election to allow sufficient time for candidates to appeal any portion of the election process which may have impacted the election results.
- Setting term limits for all elected offices. I am recommending a two term limit with a required one term break before being eligible for election to the same office.
- Reducing the timeframe of the primary. In general, I am not in favor of a Tribal primary but do realize the GTC has supported and approved the primary so therefore I am recommending some language to make this process run a bit more efficiently. My recommendation is to reduce the requirement for the primary caucus date from 90 days to 60 days.

- Decreasing the number of Business Committee candidates (non-officers) that will proceed after a primary. The current law allows for the top 15 primary candidates to proceed to the general election bal-

menu for the week calls for use of 10 lbs. of potatoes and 5 lbs. of flour, the amounts used are recorded. At the end of the week, the log should show 10 lbs. of potatoes and 15 lbs. of flour available. This information is used when ordering for the next week.

Inventory control also deals with intangible assets such as human capital or employees. We except our employees are working their scheduled hours and to ensure they are, we have time clocks that record the time the employee starts and ends work. If the employee is scheduled for 40 hours per week but the time clock shows the employee only worked 35, the employee has the choice to fill those 5 missing hours with personal time or only get paid for 35.

In the case of salaried employees, the assumption is employees will work the scheduled 40 hours and more, not less. Specific positions are deemed salaried as a cost savings to the Tribe in not having to pay overtime.

Keeping accurate records is very important

in every organization. At any time, the Audit and/or Accounting Department should be able to walk into any department and ask for their inventory records. The logs should be clear, concise, accurately completed and easy to read. Audit and/or Accounting should be able to take any log and compare it to the supplies on hand. If there are any discrepancies, they are noted and management is asked to explain the difference.

The whole idea behind inventory control is to accurately account for items while developing a benchmark for forecasting in the next budget cycle. If we know what we have and what we used, we can make an accurate guess as to what we need. Inventory control also assists in discouraging theft and fraud. If employees know everything is accounted for there should be less enticement to steal.

Like everything else in today's world, there are ways to alter records however, and that is what is most disturbing. A log can state we started with

15 items, received 10 more, used 12 and have 13 left. When the items are counted and 13 are found, the logs and inventory match so there is no need for investigation. The part that is missing is where did the 12 items we used go? Or the bigger question, did the 12 items go where the log states?

A similar question could be asked about time. Employees who use a time sheet to attend a two hour meeting write their beginning and ending times on the sheet. If the meeting only lasts one hour and ten minutes, the time sheet should reflect the actual meeting time. If the designated two hours is recorded instead of the actual time, this can be considered fraudulent record keeping and a violation of the Blue Book Policies and Procedures.

The same question needs to be posed to Boards, Committees, and Commissions who receive a stipend. Some have time minimums that need to be met while others are just paid according to time. Accurate records need to be kept

by our Boards, Committees, and Commissions just as they are expected from our internal departments.

As we enter into a new budget cycle, these types of inventory control measures need to be implemented and documents need to be standardized throughout the Tribe. In some areas, changes will need to be made, in others, their current practices are a p r o p r i a t e . Accountability, planning, checks and balances are all necessary to assure we stay efficient and that is why all of these requirements are necessary.

As school begins and the construction on Hwy 54 continues, I hope we all take extra time to be cautious in and around our school zones as our kids may not be aware of the various detours. We need to look for them and they need to be conscious of us. I hope everyone's school year is safe, happy, healthy and successful.

Since June I have been requesting feedback regarding the components that the Finance area feels should be covered in a Budget Management Act. I want to gather input, ideas and concepts from the area that plays a significant and important role in our budget processes. Once I receive this feedback, I will have a starting point for preparing legislation that will streamline our budget processes and offer clear and consistent direction fiscal year to fiscal year.

### 4) Oneida Small Business Funding

I am calling for small business funding to be restored at Bay Bank using some of our compact funds which should be going back into funding the Oneida Small Business Project 2000 at Bay Bank.

As part of the request for funding I have submitted some amendments to the Oneida Small Business Project 2000 Policy for the LOC to

want to send a thank you out to my staffer Mrs. Cathy Bachhuber; she is an outstanding worker who really helps keep the office moving in the right direction. I would say, throughout this tribe there are so many outstanding employees. It is with these great employees and with harvesting good ideas we can make great strides here. The future is bright here in Oneida.

### Chairman's Message Regarding Indian Health Care

The old Mormon Cemetery here on the Oneida Reservation contains the grave of Patricia Ann Delgado, my older sister. She was only ten-years-old when she passed in 1951. I can barely remember her, although I think of her often. She left this world because she got sick, probably from bad water. But the tragedy of my sister is not limited to her story or the story of my family. Throughout Indian Country in any graveyard on any Reservation, one can find the graves of many many Indian children. Ten-years-old is too young to die, no matter what race or what culture you may come from.

But in the 1950s, there were no resources for Indian health care; no resources for safe water; and no community development where safe water could be provided. The average life expectancy of an Indian in the 1950s was about 50 years, if that. It was as if the hundreds of Indian treaties which promised to care for Indian people in exchange for land had vanished as United States federal policy attempted to empty the Reservations one way or the other.

So what, some may say. But to those non-Indians who might not really care about the tragedies of our people, I say your babies were dying too, your life expectancy was not much higher than ours, and you too, more often than not, had no health care if you got sick. It wasn't really until the late 1960s and former President Lyndon Johnson's War on Poverty, that health care started to improve for both Indian and non-Indian people. And for a long time both Democrats and Republicans worked together to improve the health conditions of all Americans.

The Oneida Tribe has always been pretty neutral in national politics. The

Tribes takes no official stance on any political party. Democrats, we have many. And we have many Republicans too. Wisconsin Governor Walker has been there to support us on many issues, or at least there to listen, and that's important too, to at least listen. Republicans Reid Ribble and Tim Johnson, they too, I feel, are trying hard to serve the Indian and non-Indian populations in their districts. However, at the very top of that Republican ticket for the upcoming Presidential election is candidate Mitt Romney. Candidate Romney has promised to do away with what he calls "Obama Care." He must know that contained within President Obama's Health Care Plan is the Re-authorization of Indian Health Care. In other words, without Obama's Health Plan there will be no re-authorization of Indian Health Care, and the health of our beloved Indian people could be at risk. And that I could never support, and I would hope, that no other Indian would support it either. I encourage the Oneida people who might currently be considering supporting Mitt Romney for President, to

write him and ask him why he would jeopardize the re-authorization of Indian Health Care in Indian Country. Tell him that the Indian nations do not want a return to a past when far too many of our children's lives were cut short simply because they got sick and adequate health care was not available. Then make your decision on which Presidential candidate you feel would best serve our people.

### Chairman's Message Regarding Community Meetings

Our Oneida Constitution, adopted by our Oneida ancestors 76 years ago, starts out in part with "We, the people." It is evident to me that it's the people who form the basis of our Tribal nation under our Constitution. It's the elders who teach and provide guidance to our children who then carry on our legacy as Oneidas; it's the mothers and fathers who go to work every day and carry out their responsibilities to provide for their families, it's the casino workers and the Tribal program workers who provide the financial resources and services that the Tribe needs to

serve the people; and it's the Oneida Business Committee who carry out the directives of the General Tribal Council who are "We the people." In August, the Oneida Business Committee voted to hold monthly community meetings on the first Saturday of every month. The purpose of the monthly community meetings will be to better serve the people of the Oneida Tribe by providing a monthly message or issue and will then provide the people the opportunity to discuss and comment on that message or issue, or other topics that might be of interest to the people. We have not yet established the place for these meetings, but food will be served, and all Business Committee members are expected to attend.

### Chairman's Message Regarding Tribal Employment

With unemployment so high among our Oneida people, it has been for more than seven years now, my goal and message to our Tribal managers to increase the number of Oneidas who are employed by the Oneida Tribe. For seven years now, the goal is not being

attained. The message, I guess, is not being heard and our Tribal people are paying the price by remaining unemployed. Recently, I received a communication from a Tribal mother who after witnessing her son being screened out time after time for a gaming position, wrote the following (portions deleted for conservancy of space):

"...My son and my friend's child applied for the same position. My friend's non-Oneida child was hired for the position and my son was not interviewed. My friend's child graduated from high school in June and was working at Gaming by late June/early July."

My Office has received many complaints from Tribal members who meet the qualifications, do not have criminal records, but are not even granted interviews at Gaming. This issue will be discussed soon by the Oneida Business Committee, but it surely appears something's not working.

## OBC Forum...

### Shekólih,

On September 17th the General Tribal Council will be asked to approve the fiscal year 2013 (FY'13) budget. Many of you are aware that during a special BC meeting on August 14, 2012, I opposed approving the FY '13 budget and I entered a "for the record statement" which states "I certainly appreciate the work of the CFO and Asst. CFO in leading the BC through the budget process with goals of ensuring no lay offs and preservation of services to the membership. However, it is with regret that I oppose the budget due to the fact that this is a status quo budget and is not based on priorities by the leadership as a whole. Also, we wanted to be as transparent as possible, and yet the budget work meetings weren't posted as open meetings to our tribal membership and major decisions to cut were made at "work meetings". Some of our division directors were allowed to come to the BC and make cuts to departments that weren't fully communicated to and to date the departments still haven't been communicated the changes in their budget that may impact their area, which indicates to me that the departments may not be knowledgeable of a change in vision/direction their entity may be headed and have no input in to that vision and that is not transparency and not communication. I commend the work of the Business Committee and Finance to balance the budget, but just cannot support another status quo budget that is not based on nation priorities." Since this decision, I have received support of my decision through phone

calls, emails and social media. Some of the encouragement also came with inquiries on the specifics of why I am opposing the upcoming budget. I have responded to each request for additional information and to ensure everyone has the same chance to have their questions answered. I am taking this time to share more details about why I voted to not support the FY '13 budget.

One of the main reasons I opposed the budget was that the current budget process no longer fits the needs of the Tribe and is not based on a strong vision and clear priorities. The budget process takes place every year and for many years, especially when there was money to spare, the current process utilized to balance the budget was an acceptable method to bring a balanced budget before the GTC. Here is a high-end overview of how the budget process works.

First, the entire organization receives a request to submit all of the division's respective budgets and operational plans, usually with little to no guidance from the BC as a whole; then the budget requests are compiled and a projected dollar amount is provided to show what the division's needs are. When the division's needs don't match our revenue projections, the BC and divisions engage with our Finance area in cutting the budget until it is balanced. Unfortunately, this method of balancing and approving the budget is not based on anything, least of all a strategic plan and/or goals for our Nation. At least four budget cycles ago, the BC agreed we could no longer afford to continue budgeting in this manner. In understanding we could

longer continue to allocate resources to everything, the BC put forth some effort to make change and in fiscal year 2010, sat down and tried to develop budget priorities. Although most of us recognized that

this wasn't going to solve all of our problems, we understood that developing priorities would be a good start in order for us to justify how we would spend that year's budget and explain what priorities will be addressed in that budget cycle. Unfortunately, this practice too fell to the wayside, as key players on the Business Committee walked from the table when major decisions were about to be made.

Other attempts to change the budget process included the Budget Management and Control Act, which was first introduced as a concept about 6 years ago and again during this current term; however, this legislative mechanism has not been completed to date. In May, 2012 the BC engaged in the Native Nation's governance building whereby the Business Committee was asked to determine what needed to be changed. It was again confirmed by the BC there needs to be a change the Tribe's budgeting methods, and once again the same budget principles and methodology continued with no initiative or progress being made to support this determination. Also, the current budget process allows for changes to occur after the BC has provided direction and without communication,

Finally, I have researched the invest-

ments that the Tribe has made over the past 20 years, and have also personally seen the political climate with which decisions have to be made.

Also, the current method of budget development does not engage the GTC or the Oneida community in a meaningful way. Your questions, criticisms and solutions are not taken into consideration collectively and no process exists to garner the community's input on what you would like to see in the budget, or what you would support the BC doing to move us forward in a fiscally responsible manner.

For example, we continuously hear we must get our employee base down to 2,500 full-time equivalent positions, but what is not being said is that this only holds true, if we do not make change organizationally and fiscally. Additionally, if the bottom line is ultimately that we must consider laying-off employees; I firmly believe we should only do lay-offs based on something rather than nothing. That means we need proper analysis of each area in order to determine what the need is, the purpose for the service as well as the long-term goals. But, before we can determine the need, purpose and goals, we must take a big step back and look at the big picture and determine the Nation's strategic direction, identify what the desired outcomes are and then develop goals and objectives to achieve those outcomes and then we budget according to what our priorities are.

Finally, I have researched the invest-

Operating Committee. GTC could direct the Business Committee to bring a draft forward at the January 2012 GTC Annual meeting.

2. GTC could mandate the Business Committee as a whole to develop a strong vision and clear priorities and bring back to the January 2012 GTC Annual meeting or a Special GTC meeting in February for GTC to approve the vision and priorities.

3. GTC could mandate the Business Committee bring back a draft Commerce Code or action plan that addresses the separation of commerce/enterprises to be brought back at the July 2013 Semi-Annual GTC meeting.

As this was a very difficult decision to make, I pray that together we can stand strong and make change for the long-term benefit of our people. I want to end with a quote that I drew inspiration from while making this decision. This quote truly puts in to words, why it is important for us to think long-term "7 Generations"; to have a strategy; to fight for our sovereignty; to teach and practice our culture and language; and ultimately take care of each other.

*"Upon suffering beyond suffering: the Red Nation shall rise again and it shall be a blessing for a sick world. A world filled with broken promises, selfishness and separations. A world longing for light again. I see a time of Seven Generations when all the colors of mankind will gather under the Sacred Tree of Life and the whole Earth will become one circle again." ~ Crazy Horse*



stated some comments earlier about what I think are non-performers that need to

be eliminated from the budget, probably should have been a long time ago. We did ask and I think the record should stand clear that this council did ask each Division Director before they came before us, if they understood the budget directions and the directives and the responses that we were seeking from them and they all said yes, except for one and that was the Housing Director. He seemed to be unsure of what we had asked him to do. The Development Division, I'm not sure if they were perfectly clear, but everyone else seemed to be very clear and the Division Directors by and large, I thought they had communicated down. I'm hearing new information that maybe there wasn't clear communications but we did ask them specifically, because there was an assertion that there was an unclear direction given during the budget process and everyone communicated, over 90% of them communicated that the directions were clear. So I support the budget because we need to get a budget in place, but I think that the idea, the concepts around matrix staffing model issues and creating new economic growth for this community have to be pursued at some point. This is a status quo budget, but we have to get a budget in place, that is our responsibility. We do have operations that have to continue going on to provide the services that Tribal members need, so therefore I support moving this budget forward. Thank you.

**For the record:** Brandon Stevens stated I support this budget moving forward because it's the reality that we're faced as of today, because of lack of priorities, because of lack of general consensus on where our direction is heading, but I think I'd be remised if we would say, if we would try to have a continuing resolution to try and address some of these things and be subject to the same standards going through that continuing budget, trying to develop the things we need to develop during the course of this next year, which would probably only be implemented in 2014 anyways. So, having this, knowing that...it's with regret, I do approve this budget but looking at some of directions that we need to go strategically and fiscally and looking at our enterprises on how we approach their effectiveness, you know that needs to be vetted out thoroughly and doing that in this fashion, we don't have a process for it so we have the direction of the three year budget. It's just a roadmap basically, we don't have initiatives. How are we going to do this economic devel-

opment, with no funds? How are we going to create housing, with no funds? How are we going to do all these things with lack of visioning and planning? So allowing this next fiscal year for that development, I think, is reality.

**For the record:** Paul Ninham stated I do believe that hopefully something good is going to come out of today's action as we move this forward. I just wanted to state that we really do need to sit down, as a committee and I guess come up and develop some priorities that we all have. I would really like to see this nine member committee, move something forward for the organization. I don't know what that is yet, but I would love to sit down and develop our priorities. One thing I would like to state is that we never did finish transition and we talked about that from a year ago. We did not quite finish transition and I think through the Councilman's proposed retreat session, I do believe that something very positive is going to come out. That we are going to be able move something forward and hopefully do it correctly.

**For the record:** David Jordan stated I would actually like to thank the CFO, Larry Barton and Ralinda, they worked very hard. I was at every single budget meeting that there was and I made a lot of opinions for the right reasons, but I cannot do those alone. So as a BC we should be there all together, not just two, three, three, four, that's all we had. We never had a full committee at any one of those meeting. So yes it's status quo, but there are only a handful of us that actually had to make all those decisions on our own. It kind of upsets me to find out that there are people opposing something that didn't even really help put this in place. I believe you should be at every meeting, for the budget. Motion by Melinda J. Danforth that in accordance with an already standing GTC motion, the BC directs the LOC to

bring back a draft Budget Management Control Act to the BC within 3 months, seconded by Patty Hoeft. Motion carried unanimously.

## Wis. ranks near the bottom for charitable giving

MILWAUKEE (AP) ~ Wisconsin ranks near the bottom of states for charitable giving, according to a new study by the Chronicle of Philanthropy.

Wisconsin ranks 44th among the 50 states, according to the Milwaukee Journal Sentinel.

Residents contributed \$2 billion, based on 2008 dollars, with a median contribution of \$1,747, according to the study published this week that takes an extensive look at giving in America.

That means residents allocated 3.4 percent of their income to charity. The national median is 4.7 percent.

Utah, with a large

Mormon population and a tradition of tithing, was the most giving state. Utah residents allocate 10.6 percent of their income to charity. New Hampshire ranked last, with residents donating 2.5 percent of their income to charity.

The study relied on 2008 Internal Revenue Service data from itemized deductions. Only taxpayers who earned \$50,000 or more were examined. For total contributions, Wisconsin ranked 26th.

Deborah Fugenschuh is president of the Donors Forum of Wisconsin, which works to promote and support philanthropy. She wasn't surprised by Wisconsin's ranking.

"It's always been that way," she said. "It isn't new news. We just don't have the wealth that many states have. Our wealth is earned. And we don't have deep inherited wealth. We do have very wealthy people, but we don't have a strong middle class."

Wisconsinites aren't unwilling to help those in need, she said.

"We are frugal. We respond to disasters," she said. "But it's an important time to sustain our social services network."

## Special court for Wis. veterans to begin in Nov.

RACINE, Wis. (AP) ~ Some military veterans who face criminal charges in Kenosha, Racine and Walworth counties could be tried in a new treatment court geared specifically toward veterans.

The Veterans Treatment Court is designed to hold veterans accountable for criminal

acts. But it's also intended to include opportunities for substance-abuse and mental health treatment. It will also introduce veterans to federal benefits and services they might not have known about.

A Journal Times of Racine report says the first session will be Nov. 14 in Racine. Court

administrators are reaching out to prosecutors in the three counties, asking that staffers identify defendants who might be eligible.

To qualify, veterans must have a diagnosable mental health condition or an issue with drug or alcohol abuse.

## Wis. DNR: Bird migration to peak this month

MADISON, Wis. (AP) ~ State wildlife officials say bird migration should peak over the next three weeks.

Bird experts with the Department of Natural Resources are telling bird watchers to be on the lookout for hummingbirds, warblers, vireos and thrushes.

Nighthawks and chimney swifts also will be on the move during evening hours.

DNR officials say the migration likely will be more stressful for birds this year because drought conditions have hurt their food sources. The dry weather has reduced moisture dependent

insect populations and prevented plants from flowering and dropping seeds.

The agency says homeowners can help by providing birds with a water source and vegetation that provides fruit and shelter.

## Wisconsin DNR dusts off plans for more elk

MADISON, Wis. (AP) ~ State wildlife officials are dusting off an old plan to bring more elk to Wisconsin.

The University of Wisconsin-Stevens Point introduced 25 elk to the Clam Lake area in far northwestern Wisconsin in 1995. The DNR has wanted to expand that herd and start another herd in Jackson County ever since.

The department shelved the effort, though, after chronic wasting disease was discovered in the state in 2002 and state agriculture officials effectively banned wild deer and elk importation.

Now DNR officials say they've identified a disease-free elk herd in Kentucky and are negotiating with wildlife officials there to bring some of the animals to bolster the northern herd and start the Jackson County herd.

The move requires legislation to lift the importation ban.

# Neb., SD wildfires grow with help of strong wind

OMAHA, Neb. (AP) ~ Wildfires in northwestern Nebraska tripled in size in less than 24 hours, as strong winds pushed flames through the rugged, rural terrain.

More than 285 square miles - an area more than twice the size of the state's largest city, Omaha - had burned by Sunday afternoon, fire officials said. One of the fires had crossed into South Dakota this weekend and burned more than 50 square miles, including land on the Pine Ridge Indian Reservation.

A day earlier, the fires had only burned roughly 93 square miles in the ranching territory that's favored by deer and turkey hunters.

"We've got a very challenging situation out here because of the winds and the very dry conditions," Gov. Dave Heineman said Sunday after touring the damage and meeting with officials.

Cooler weather moved through the area Saturday night, helping firefighters mostly contain two major fires - the West Ash and Douthit fires - near Chadron. But winds gusted up to 40 mph Sunday, helping spread the fires through drought-stricken trees and grasses.

The Wellnitz fire, north of Rushville, broke through containment

lines Sunday, Heineman said. The Nebraska Emergency Management Agency said it had burned roughly 150 square miles by Sunday evening.

Heineman said it will likely take several more days to fully contain the fires, but he says firefighters appear to have all the resources they need to do that.

Overall, the fires have damaged at least 10 homes and more than 50 structures in Nebraska and South Dakota. The fires also forced the evacuation of several small communities, although residents of the small town of Whitney, southwest of Chadron, were allowed to return home Sunday.

Rushville Assistant Fire Chief Jerry Kearns said Sunday that firefighters are working hard to contain the fires and protect property, but they sometimes have to make difficult choices. Kearns said it's hard to watch a rancher's hay burn because of this summer's ongoing drought.

Those very ranchers know the wildfires will scar the land.

Verona Douthit, 65, has always lived in these hills on land her family bought in 1929. Because one of the current fires started on her ranch, officials have named it after her last name.

Douthit says she knows it takes a long time for

the land to recover - some of her family's land burned in 1989 - and the pine trees she loves may never be the same.

"It probably will take a person's lifetime to see it like it was again, and it may never happen," Douthit said.

The Douthit fire is nearly contained, but it burned about 30,000 acres. The other fire in the area, the West Ash fire, had consumed nearly 58,000 acres by Sunday and was about half contained.

Douthit said it has been fantastic to see the way people came together to help fight the fire and support those affected. She and her 66-year-old husband especially appreciated the help because of their age.

"We're retirement age, so we're not as agile anymore," Douthit said.

Firefighters have already battled several wildfires in Nebraska this summer, and more than 35 volunteer firefighting departments are working with NEMA and federal incident command teams to contain these.

Conditions are likely to remain ripe for fires for at least several more weeks because the land is so dry.

"Firefighters have put more water on the ground than Mother Nature this year," Chadron Fire Chief Pat Gould said during the governor's tour.

# Red flag warning for much of Wyoming

CHEYENNE, Wyo. (AP) ~ More warm, dry, windy weather is keeping the fire danger high across much of Wyoming.

Red flag warnings were in effect through Tuesday evening. The National Weather Service said an approaching Canadian cold front would produce gusty winds from the

north in south and central Wyoming.

Rain on Friday and Saturday helped slow the growth of wildfires already burning in Wyoming.

Two fires are burning in the Teton Wilderness, the 13,727-acre North Buffalo Fire, which is 10 percent contained, and the 1,510-acre Butte Creek

fire.

On the Wind River Indian Reservation, fire managers are monitoring the Alpine Lake Fire, which is burning on 10,545 acres in rugged terrain.

The lightning-sparked Gilead Fire southwest of Story is burning on about 1,300 acres.

# Judge: 2 NY tobacco wholesalers broke law

NEW YORK (AP) ~ A judge has ruled two tobacco wholesalers broke the law selling untaxed cigarettes to retailers on an Indian reservation that then resold them at reduced prices in New York.

The judgment is a victory for New York. It's waged a legal battle for years to collect taxes on

cigarettes sold by Indian-owned businesses to non-Indians.

According to The New York Times, Judge Carol Amon said Long Island company, Mauro Pennisi, sold more than 11 million cartons of untaxed cigarettes to Indian retailers on the Poospatuck Reservation from 2008 to 2011. She said Gutlove &

Shirvint, a Queens company, sold a similar amount to the same tribe.

Both companies voluntarily stopped selling to the Indian retailers after the city sued in 2006. But Amon ruled they should've stopped sooner.

For the first time in the three-year existence of eight-man football at the Oneida Nation High School a state championship is an obtainable goal.

After finishing 4-5 last season, the Thunderhawks have joined the newly formed 8 Man North Conference after the WIAA officially sanctioned the sport.

With the sanction, a true state champion can be crowned and head coach Bryan Peterson has his sights on it.

"We want to win the first state championship. There hasn't been an eight-man state champion and we want to be the first," said Peterson. "We have the talent this year to do it."

Prior season saw the Thunderhawks playing a schedule of teams not affiliated with each other. The new conference creates tangible goals reachable for the players and team.

"It's really nice to have something to play for. It's

The Thunderhawks will lean heavily on their run game and experience to make their run at a championship season.

said Peterson. "We run the ball very well. We have three running backs just as good as the other and are interchangeable."

Moving the ball and scoring points shouldn't be a problem but, according to Peterson, the defensive side of the ball needs improvement.

"We have to do better. Our goal is going to be to hold teams to under 21

points a game," he said.

The smaller eight-man field along with less defenders has Peterson focused on tackling this season.

"If you miss a tackle they score. We have to work a lot on fundamentals," Peterson said.

The Thunderhawks lost their season opener to New Auburn 50 - 12 on Friday, August 31.

# West Nile Virus symptoms

West Nile virus (WNV) is a potentially serious illness. Experts believe WNV is established as a seasonal epidemic in North America that flares up in the summer and continues into the fall. Wisconsin has not seen wide spread disease as they have in states like Texas. But the virus has been detected in dead birds throughout the State of Wisconsin and one confirmed human case in Dodge County.

## What Are the Symptoms of WNV?

- No Symptoms in Most People. Approximately 80 percent of people (4 out of 5) who are infected with WNV will not show any symptoms at all.

- Milder Symptoms in Some People. Up to 20 percent of the people who become infected have symptoms such as fever, headache, and body aches, nausea, vomiting, and sometimes swollen lymph glands or a skin rash on the chest, stomach and back.

- Serious Symptoms in a Few People. About one in 150 people infected with WNV will develop severe illness. The severe symptoms can include high fever, headache, neck stiffness, stupor, disorientation, coma, tremors, convulsions, muscle weakness, vision loss, numbness and paralysis.

sis. These symptoms may last several weeks, and neurological effects may be permanent.

## How Does West Nile Virus Spread?

WNV is not spread through casual contact. WNV is most often spread by the bite of an infected mosquito. Mosquitoes become infected when they feed on infected birds. Infected mosquitoes can then spread WNV to humans and other animals when they bite. People typically develop symptoms between 3 and 14 days after they are bitten by the infected mosquito.

## How Is WNV Infection Treated?

There is no specific treatment for WNV infection. In cases with milder symptoms, people experience symptoms such as fever and aches that pass on their own, although even healthy people have become sick for several weeks. In more severe cases, people usually need to go to the hospital where they can receive supportive treatment including intravenous fluids, help with breathing and nursing care.

## What Should I Do if I Think I Have WNV?

Milder WNV illness improves on its own, and people do not necessarily need to seek medical attention for this infection though they may choose to do so. If you develop symptoms of severe WNV illness, such as unusually severe headaches or confusion,

seek medical attention immediately. Severe WNV illness usually requires hospitalization. Pregnant women and nursing mothers are encouraged to talk to their doctor if they develop symptoms that could be WNV.

## What Can I Do to Prevent WNV?

The easiest and best way to avoid WNV is to prevent mosquito bites.

- When you are outdoors, use insect repellent containing an EPA-registered active ingredient. Follow the directions on the package.

- Many mosquitoes are most active at dusk and dawn. Be sure to use insect repellent and wear long sleeves and pants at these times or consider staying indoors during these hours.

- Make sure you have good screens on your windows and doors to keep mosquitoes out.

- Get rid of mosquito breeding sites by emptying standing water from flower pots, buckets and barrels. Change the water in pet dishes and replace the water in bird baths weekly. Drill holes in tire swings so water drains out. Keep children's wading pools empty and on their sides when they aren't being used.

# Pertussis Outbreak in Wisconsin

Wisconsin is currently experiencing a widespread outbreak of pertussis disease. From January 1, 2012 through August 14, 2012, 3,819 cases (2,773 confirmed and 1,046 probable) of pertussis with completed investigations have been reported among Wisconsin residents. We are seeing confirmed cases in both Brown and Outagamie Counties.

Vaccination is the most effective prevention. In the United States, the recommended pertussis vaccine for infants and children is called DTaP.

This is a combination vaccine that protects against three diseases: diphtheria, tetanus and pertussis.

Pertussis is a contagious bacterial disease that can cause serious illness in infants, children and adults. It is commonly known as "whooping cough" because of the "whooping" sound that is made when gasping for air after a fit of coughing.

Pertussis infection can be life-threatening, especially in infants. More than half of infants less than 1 year of age who get pertussis are hospitalized.

Pertussis can begin like a cold, with a low grade fever and a mild, irritating cough that can appear

within 7 to 20 days after exposure. The illness progresses to include explosive coughing that can interrupt breathing, eating and sleeping, and may be followed by vomiting and exhaustion.

Vaccination is the most effective prevention. In the United States, the recommended pertussis vaccine for infants and children is called DTaP.

This is a combination vaccine that protects against three diseases: diphtheria, tetanus and pertussis.

toms should contact their healthcare provider. Your doctor will determine if you need treatment for pertussis infection. Those with pertussis should be isolated from school, work or other activities until completing at least the first five days of the recommended antibiotic therapy.

## What can I do to protect myself and my family?

Make sure your children are up to date with their immunizations. Pertussis vaccination is included in the mandatory school immunization law.

# Information for patients who utilize OCHC On-Call Nurse

Registered Nurses (RN) are available for patient phone calls – 24 hours a day/7days a week. When the clinic is closed the RN is home. They do not have access to medical records or pharmacy information.

## When to call and speak with the RN after clinic hours:

- You/your child have an urgent health care need/question that cannot wait until the next open day of the clinic.
- Don't call the RN when you are having a life threatening issue. For example, chest pain, difficulty breathing, or bleeding profusely from wound. Access the nearest emergency department to get medical attention as soon as possible. Call 911 as needed for intervention. Call the Contract Health Services Department to report the visit within 72 hours to ensure coverage.
- The RN's on call also work 40 + hours per week at the OCHC medical clinic, in addition to providing on call services. Calling in the middle of the night with a concern that is not urgent is not appropriate.
- On call staff does not determine Contract Health eligibility. You need to contact the Contract Health Department when the clinic reopens to check on eligibility.

**Lisa Behringer vs. Patrick Stensloff, Sandra Gauthier & Oneida Purchasing Dept.** Docket No. 12-AC-007, April 10, 2012. Judicial Officers Janice L. McLester, Lois Powless, Stanley R. Webster presiding. Reconsideration Denied according to Rules of Appellate Procedure, Rule 9(F) Contesting a Decision: An appellant denied acceptance of an appeal may file one motion for reconsideration within five days of receipt of the decision denying acceptance...Rule 4 Time (A) Business/Calendar Days: All reference to days in these rules of appellate procedure shall refer to the use of calendar days...Reconsideration motion due March 26, 2012 and not filed until April 10, 2012, untimely.

**Susan Graves vs. Kristen Cornelius.** Docket No. 12-AC-012, April 17, 2012. Judicial Officers Winnifred L. Thomas, Janice L. McLester, Lois Powless presiding. Denied in accordance with Rules of Appellate Procedure, Rule 9(E): Failure of Allegations: If appellant failed to sufficiently allege one of the criteria of Rule 9(D) above such that the Initial Review body cannot determine the basis for the allegation or the issue with the orig-

inal hearing body decision, the appeal may be denied.

**Appellate Court Decisions**

**Donald J. Hahnke vs. Donald R. White.**

Docket No. 12-AC-002, May 24, 2012. Judicial Officers Janice L. McLester, Lois Powless, Jennifer Webster, Linda Cornelius (Pro Tem) and James Van Stippen (Pro Tem) presiding. This was an appeal of an Oneida Personnel Commission (OPC) upholding Appellant, Donald J. Hahnke's layoff. Mr. Hahnke alleged the layoff to be an adverse employee action taken after he filed a Formal Written Complaint against his supervisor, Respondent Donald R. White. Mr. Hahnke asserted the OPC decision to be clearly erroneous and against the weight of the evidence. Mr. Hahnke failed to provide clear and convincing evidence that the layoff was retaliatory. OPC decision affirmed.

**Trial Court Decisions**

**Betsy Leiterman vs. HRD/Benefits & Crawford Insurance.**

Docket No. 12-TC-001, April 9, 2012. Judicial Officers Jean M. Webster, Mary Adams, and Leland Wigg-Ninham presiding. January 5, 2012 Petitioner filed a Hearing Application to address the denial for continued medical costs and total disability benefits for an injury received on March 1, 2010. February 14, 2012 a pre-trial was held resulting in the case moving to a trial to determine if Petitioner reached the Maximum Medical Improvement as allowed per Oneida Tribe Worker's Compensation law. Trial was scheduled for April 9, 2012 and Petitioner failed to appear. Respondent motioned the court to dismiss without prejudice. Per Rule 16(C) of the Oneida Tribal Judicial Code, Chapter II case was dismissed as Petitioner failed to appear.

**Dennis King vs. Dale Wheelock, Oneida Housing Authority.**

Docket No. 12-TC-062, April 11, 2012. Judicial Officers Jean M. Webster, Mary Adams, and Leland Wigg-Ninham presiding. This case involved a request for a Temporary Restraining Order from Petitioner, Dennis King requesting the court that a tenant within his home be able to remain there until school was out. March 13, 2012, Petitioner received notice that due to a violation that resulted in a felony charge by a tenant within Petitioner's home, the tenant needed to vacate the premises. On March 23, 2012 Respondent/OHA met with Petitioner and modi-

fied the eviction to allow Petitioner to remain in the home, however, the tenant within the home was to vacate the premises by April 6, 2012. Petitioner filed an appeal at the Oneida Tribal Judicial System, deliberation was held April 9, 2012, and appeal was moved to a hearing on April 11, 2012. The court affirms the decision of the Respondent/OHA and tenant was to vacate the premises by April 27, 2012.

**Christl Stevens vs. Dale Wheelock, Oneida Housing Authority.**

Docket No. 11-TC-106, May 15, 2012. Judicial Officers Mary Adams, Jean M. Webster and Leland Wigg-Ninham presiding. This case involved a request for a Temporary Restraining Order from Petitioner, Christl Stevens and a Motion for Enforcement and Deficiency Judgment in the amount of \$3,159.03 from Respondent, Dale Wheelock - Oneida Housing Authority. The Oneida Tribal Judicial System granted the Respondents Request for an Eviction. A Hearing was held on December 13, 2011, Petitioner nor did the advocate/attorney for the Petitioner appear. Respondent was present. The Court ordered Petitioner to vacate the premises by January 31, 2012, and ordered Petitioner to not commit waste on the home. On May 7, 2012 Respondent filed a Motion for Enforcement and Deficiency Judgment requesting reimburse fees of \$2,542.52 in tenant damages, \$350 in utilities and \$266.50 in rent arrears for a total of \$3,159.03. Respondent included supporting photos of the damages. The Court granted the Motion for Enforcement and Deficiency Judgment in the amount of \$3,159.03.

**Kenneth B. Metoxen vs. Gerald Hill.** Docket No. 12-TC-071, May 18, 2012. Judicial Officers Mary Adams, Jean M. Webster, Leland Wigg-Ninham presiding. The Petitioner in this case requested the Oneida Judicial System to issue a Temporary Restraining Order against the Respondent, Gerald Hill and an order of protection. Two tribal members in a dispute, one is seeking a protective order, fearful for his safety. The actual facts are unknown, the court has not heard any evidence and is not taking one side or the other. This case was dismissed because the Oneida Tribe does not have the laws which permit us to exercise our jurisdiction over these types of cases, where a protective order is sought.

**Timothy J. Skenadore, Electric**

**Experts vs. Marjorie Stevens, Indian Preference Department.**

Docket No. 12-TC-051, June 27, 2012. Judicial Officers Mary Adams, Jean M. Webster and Sandra L. Skenadore presiding. This case involved the Indian Preference Department's refusal to certify Petitioner as an Indian-owned business. On March 12, 2012 Petitioner filed an appeal against Respondent claiming Respondent violate 57.5-4 and 57.4-3 when it denied Petitioner certification due to his alleged lack of involvement in the day-to-day operations on a full time basis. The law does not specifically say an owner must be at a business when there is no work. Respondent based their denial on their premise that it takes all businesses 24/7 to, in their initial startup, make it successful. Petitioner pointed out, his business is small and is currently at a part time level. The meaning of "day-to-day" is subjective; it could mean on the days the business is in operation Petitioner must be involved. What if the business operates in the evenings and on weekends? One full time job does not preclude a person from doing a full time second job. One of the purposes of the Indian Preference Law is to "maximize economic benefits" for Indian-owned business and to provide "maximum opportunity," Sec. 57.1-5, to them to supply materials and services. Petitioner's request to be certified as an Indian-owned vendor was granted.

**Family Court Cases**

Due to the nature of the cases that come before the Oneida Tribal Judicial System, Family Court, individual cases are held in the strictest confidence and will not be summarized for publication. We will, however, begin reporting the number of cases filed before this court per quarter beginning in calendar year 2012.

All of us who work with Twahwahtsi lāyā wish to start once again with our big Yaw'ko. We wish to say Yaw'ko to Dr. Toni House who brought the youth of Yethiya?tanúhā a class on relationships this summer.

We also wish to express a big Yaw'ko to Mercie Danforth and Littlebear Webster who helped make it possible for us to begin surveying the community in regard to our youth. Because of their efforts we were able

to set up a table by the entrance of the Oneida Health Care Center where we collect over 60 surveys.

Yaw'ko, Anita Barber and the Staff at Oneida Cultural Heritage for allowing us to collect surveys at the 'Oneida Gathering'.

The surveys asked 1.) Do you believe we support our youth?

- 2.) What are important qualities or skills you wish for our Oneida youth?:
- a. Behaviors,
- b. Family Relationships,
- c. School,
- d. Peer Relationships,
- e. Identity,
- f. Spirituality,

- 3.) What do you see as the factors that will strengthen our youth?
- 4.) What changes and/or additions can be made in the community to assist our youth?

We will use this information to better direct the Twahwahtsilāyā and its programs including Yethiya?tanúhā. We will also share our results with any other Oneida Youth Programs that are interested. Hi, my name is Tone Pagan and Denise Metoxen-Rivera and I have known each other for over 30 years, One day she expressed interest in knowing where her great grandfather was born. She knew it was somewhere in Pennsylvania but didn't know the exact location? Unbeknownst to me, her

great-grandfather's birthplace was right next to Gettysburg, which is only 60 miles from my home. Well one thing led to another and her family tree was born. From there and through conversations with her I discovered who her great-uncle was, leading up to this tour of his former office.

I was doing a genealogy trace of Denise's family. With the help of Denise's distant cousins I

was able to locate a few headstones and after piecing together a few facts, I built a large tree for Denise. She was excited about knowing every little detail so I kept her abreast of my fact finding mission. As I learned more from her I was informed of her great-uncle and his contributions to the Oneida Tribe.

Denise and her close friend Wendy Graika-

Robinson decided to take a vacation and come to Pennsylvania so Denise could see for herself where her line came from on her mother's side. As a surprise, I planned a trip to Washington, DC for Denise and Wendy to visit the Bureau of Indian Affairs (BIA) and the office where her great-uncle Robert (Bob) LaFollette Bennett once worked. I had the honor of reaching out and talking with Ms. Nedra Darling, Director of Public Affairs for the Bureau of Indian Affairs. Nedra set up a tour at the old Department of the Interior where Denise's great uncle Robert LaFollette Bennett once worked. On August 21, we were greeted in the lobby by Michael R. Smith, Deputy, Bureau Director, Field Operations for BIA in Washington, D.C. Mr. Smith became the Deputy in November, 2004 and previously served in senior management positions as the Regional Director, Southern Plains Region in Anadarko, Oklahoma and Director of the Office of Tribal Services in Washington, D.C. Michael was absolutely

wonderful and a pleasure to talk with as he was very informative about the building and history of it.

We were given a tour of Denise's great uncle's office, Bob Bennett (b. 1912 d. 2002), For those unfamiliar with Robert Bennett's history, he was the second Native American appointed Commissioner of the U.S. Bureau of Indian Affairs. He was an Oneida lawyer and administrator. Robert Bennett was born on the Oneida Reservation and attended the BIA's boarding school at Haskell Institute in Kansas. Afterwards he studied law at Southeastern University School of Law in Washington, D.C., earning his law degree in 1941. Robert served in the U.S. Marine Corps during World War II. For his legal work supporting native land claims, he received the Indian Achievement Award in 1962 and Outstanding American Indian Citizen Award in 1966. In 1966, President Lyndon B. Johnson personally appointed Robert Bennett head of BIA. Robert left the BIA in 1969 and moved to

Albuquerque, New Mexico, where he founded the American Indian Athletic Hall of Fame. Robert was Director of the American Indian Law Center at the University of New Mexico Law School from 1970 to 1975. He was recognized as Outstanding Member of the Oneida tribe of Wisconsin in 1988.

The office that Mr. Bennett occupied at the time is currently the Director's office of Surface Mining The very same office where the Joint Chiefs met to make decisions affecting the lives of millions of people during World War II, and the present auditorium was the map room. During the war, the doors of the map room were closed and sealed, and an opening was cut in the floor to allow a sliding carriage to raise maps from the basement-level boiler pit. By the close of the war, the Joint Chiefs of Staff had held 201 meetings, most of which took place in their Combined Chiefs of Staff Building.

It was truly an honor to be able to share in this unforgettable experience with Denise.






