The event was somber, but yet it was a celebration of keeping the tradition alive and knowing that the fish still come up the creek.

Two Oneida fishermen took advantage of the beautiful weather and fished after the ceremony.



Embattled tribal leader says he'll stay, despite son's alleged involvement

RED LAKE, Minn. (AP) – Tribal politics at the Red Lake Indian reservation have been turbulent over the years, long before the son of tribal chairman Floyd "Buck" Jourdain

was arrested in connection with a deadly school shooting

But despite calls for his resignation, Jourdain said he'll remain as chairman of the Red Lake Band of Ojibwe, arguing that his

departure could make the tribe more unstable.

"If there's ever a time our tribe needs leadership, it's now," Jourdain said last Friday. "It's a time of crisis. It would be another blow to the community to lose its leader."

His son, Louis Jourdain, was arrested last week in connection with a shooting that left 10 people dead, including 16-year-old gunman Jeff Weise. Federal authorities have suggested that Louis Jourdain may have had prior

knowledge of Weise's plans; Floyd Jourdain denies that and maintains his son is inno-

arrest, some of Jourdain's political opponents questioned whether he could continue to lead the tribe. Several of those critics then backed off that suggestion, saying it had angered some tribal members.

As at many reservations, tribal politics at Red Lake have been rocky. Jourdain's short tenure as chairman has not been marked by overt controversy, but observers said it doesn't take much to incite long-standing feuds.

"In our community when you combine anger and politics, it's a flammable mixture," said Lee Cook, director of the American Indian Resource Center at nearby Bemidii State University.

"I've realized this is a very sensitive issue," said Francis Brun, whose son Derrick, a Red Lake High School security guard, was killed by Weise. Brun, a political rival of Jourdain's and longtime tribal administrator, was fired last year when Jourdain took office.

Some have suggested that

Brun could be a potential opponent. "I think I'm too old now," Brun countered, saying that his son's death dealt an enormous blow he might not recover from.

Teachers were expected to return to Red Lake High School last Monday – the first time for most faculty since the March 21 shooting rampage. Classes resumed this past Tuesday. Under Jourdain's tenure,

the tribe has joined two other northern Minnesota tribes to

partner with the state in opening a casino in the Twin Cities area. But Jourdain is said to be cool to the idea, only letting it go forward because it is supported by a majority of tribal council members.

Cook said Jourdain aligns himself with tribal elders who above all else prize the tribe's sovereignty.

"There is a feeling among elders that the gaming deal is going to erode the tribe's sovereignty," Cook said.

Not everyone sees it that way. "He's more inclined to take the tribe back to more isolationism," said Bill Lawrence, publisher of the Ojibwe News and another Jourdain opponent.

Lawrence said there seems to be a lack of viable alternatives to Jourdain even if public support for him starts to erode.

Still, Jourdain doesn't appear to face an immediate threat to his power. Judy Roy, secretary of the tribal council, added "this isn't the time to be rushing into any major changes."

Remembering the family of a fallen officer

It is well known that officers in a police department are like family. In the unfortunate event of an officer dying while on duty, officers from around the state and even from around the country attend the funeral services to pay their respects to a fallen comrade.

What happens to the officer's family after the dust settles and they are left with the realization that their husband or wife and father or mother is no longer with them? Who do they turn to during a time of need?

Oneida Police Chief Rick Cornelius believes that the family should be able to turn to the police department. After attending training along with Sgt. Marty Antone, Sgt. Rich VanBoxtel and Officer Jack Mehojah about how families deal with the loss of an officer. The program was named COPS. Which stands for Concerns of Police Survivors.

The training really struck home with the officers as they realized that they had lost touch with the family of Jeff Skenandore.

Skenandore was in a car crash 12 years ago while responding to a call on duty.

He died a month later in the hospital as a result to the injuries obtained from the crash.

In an effort to reconnect with Jeff Skenandore family, the Oneida Police Department wants to do a few things. There have been talks of having a memorial, naming a room after him in the department or having a golf outing that will

raise funds for scholarships.

"My main goal is not to forget about them," Chief Cornelius said. "We as a department are still here for them and we are still thinking of them."

Chief Cornelius realizes it has been 12 years and acknowledges that the department and family are in the process of building a relationship.

Cornelius and a few other officers have had breakfast with Officer Skenandore's children, Stephanie, Jeffrey Jr., and Jamison. They have met a few other times as well in an effort to plan the golf outing.

"We need to re-connect with the family," Cornelius

According to the COPS website between 140 and 160 officers are killed in the line of duty each year and their families and co-workers are left to cope with the tragic COPS provides loss. resources to help them rebuild their lives.





SECTION ONE: Types of Per Capita Distributions

1. Elder 65 Distribution:

- The General Tribal Council passed Resolution 6-30-90-A which directed a cash disbursement of \$500.00 per year to tribal members age 65 and over, payments to begin in 1994.
- Commencing with the 2003 payment and every other year thereafter, members age 65 and over will be receiving a 5% inflationary increase. This payment is to be perpetual. The 2005 Distribution amount increased to <u>\$551.25.</u>
- For those turning age 65 in October, November or December 2005 your Elder 65 monies will be paid one month after you turn 65. Example:

DOB: 12/1/1940 you will be paid end of January 2006.

2. Elder 62 Distribution:

- The General Tribal Council passed Resolution 8-11-97-A which directed a cash disbursement of \$2,000.00 per year to tribal members age 62 and over, beginning in 1998 and based on Gaming Compact renewal.
- For those turning age 62 in October, November or December 2005 your Elder 62 monies will be paid one month after you turn 62. Example: DOB: 12/1/1943 you will be paid end of January 2006.

3. General Membership Distribution:

The Oneida General Tribal Council passed resolution on 7-5-04-B which directed a cash disbursement of \$800.00 to be distributed to all mem-

- bers until the year 2013.
- These cash disbursements are eligible to all tribal members who become enrolled as of the deadline indicated by the Tribe, for each payment year. The monies for eligible members who are under the age of 18, at the time designated by the payment plan, are placed into a trust account.

4. Unclaimed 2004 Per Capita

Distributions:

- Please contact the Oneida Enrollment Department as each individual case may vary. The deadline to apply for the monies is close of business on Thursday, September 1, 2005.
- A FY-2005 Membership Payment Form or Supplemental Form must be filed by the deadline.
- 5. Minor Trust Account Payments:

- Individuals who have a trust account established will be mailed a payment form in the calendar quarter of the year which they turn the age of 18.
- Example: Your birth date is January 10, 1987, you fall into the 1st calendar quarter of the year, therefore, you will be mailed a minor trust payment form in January 2005 and you must return it on or before the deadline identified on the payment form. Your full trust account monies will then be mailed to you by the end of April
- Late payment forms will be paid with the Quarter Payment Group being processed at the time of submission.
- Individuals only have until their 26th birthday to claim their trust account monies.

SECTION TWO: Reporting and Taxation of Per Capita Distribution

- 1. All payments are subject to federal income tax and may be subject to state or other applicable taxes.
- 2. All payments must be reported as income and may affect eligibility for entitlement
- 3. Please contact your tax preparer, tax con

sultant or case worker with any questions. 4. Every person who is issued a payment will

- have a 1099-MISC tax form sent to them. 5. All minors who apply for their Trust Account monies in 2005, ESPECIALLY THOSE WHOSE BIRTH DATES FALL BETWEEN 9/1/1987 TO 12/31/1987, need to be sure to include the Trust Account monies when they file their 2005 taxes. A 2005 1099-MISC tax statement will be issued.
- 6. Persons that feel they may be imposed an

attachment(s) may want to consider completing the FY-2005 Membership Payment form to help reduce the amount of taxes owed on the full amount of their per capita paid on their behalf in 2005.

Example: Member #1 is eligible for \$800.00. A child support order is imposed as an attachment to take the entire \$800.00. Member #1 completes and returns the FY-2005 Membership Payment form, requesting to have 20% withheld for Federal Taxes. The child support agency will receive \$640.00 and \$160.00 will be paid on behalf of Member #1 towards their 2005 Federal Taxes withheld.

Note: Persons that may be imposed an attachment(s) and decide not to elect to have taxes withheld will still have to claim the total amount(s) paid on their behalf from the 2005 distribution and report the monies on their 2005 tax return.

SECTION THREE: Reminders and Miscellaneous Information

1. Power of Attorney and Guardians:

- Effective 2004 and every fourth year thereafter, the Oneida Enrollment Department requires that any person identifying themselves as a Power of Attorney or Guardian for an enrolled tribal member must submit acceptable documentation to be recognized.

- Per Capita payments are subject to attachment.
- Attachments are being defined as "claims made on Per Capita payment for debts owed".
- At this time, only the following are being considered:
 - A. Child Support
 - B. Tribal Debts

Redlake students are back in school

RED LAKE, Minn. (AP) -Three weeks after a teen gunman carried out a deadly killing spree, the students and staff of Red Lake High School were back in class for the first time on Tuesday.

District officials said they expected about half of the school's roughly 300 students wouldn't immediately return because of emotional trauma from the attack. But many students, they said, were ready for a return to normal-

"I think it's the perfect time to go back," Tom Barrett, a sophomore, told reporters gathered at a convenience store across the street from the school. "We have to be there for each other as a nation."

For the first time since the attack, the school complex parking lot was full. Cars and buses came and went to drop off students. The police presence was heavy, with a squad car patrolling the main parking lot. A memorial to victims of the shooting, which had been due to be taken down and burned in a ceremony, remained along a fence in front of the middle school.

Journalists weren't allowed on school grounds, and administrators didn't immediately return phone calls after school began.

On Monday, Principal Chris Dunshee described students as "tough" kids and said many of them were ready to come back _ even if it meant the mundanity of a math

"They may not get much math done, but they want a math class," Dunshee said.

Tuesday's return was to begin with a school assembly, with the school day to end at midday. Security was to include armed officers at the school, and locked class-

On March 21, 16-year-old student Jeff Weise entered the

school and killed an unarmed to return to class. security guard, a teacher and five students before killing himself. Earlier, he had killed his grandfather and his grandfather's companion.

Acting superintendent Carol Aenne said returning students would find a more relaxed atmosphere inside, with less attention paid to issues like tardiness.

The high school is divided into two sections _ a new wing, first used this school year, and the old section. The shootings happened in the new section, which was to be locked off beginning Tuesday in preparation for a major remodeling. Classes will be held in the old section, which had been slated for demolition, school officials said.

Students also will begin using a different school entrance, away from the main doors that Weise walked through, where the security guard was killed.

Some students said they were fearful but determined

"This is where I went to school," said Misty Roy, a 15year-old sophomore. "I know everybody here. I just want to stay here."

Jo Cobenais, a senior whose cousin was wounded in the attack, said she planned to return to class on Tuesday but wants to transfer to an alternative learning program within the district.

She said some of her friends don't want to go back "because they think other people are involved." After the shootings, the FBI arrested the 16-year-old son of the tribal chairman on suspicion of helping to plot the shootings. Tribal chairman Floyd Jourdain Jr. has maintained the boy's innocence.

Tuesday's resumption of classes followed a "healing ceremony" held Monday at the doors to the high school. Elders from the Red Lake Indian Reservation spoke in Ojibwe, sang songs and offered prayers, according to

students who attended. Police kept reporters away and school officials declined to describe the ceremony in detail.

After the ceremony, two boys wounded in the rampage led a group that included about 80 students back into the building for the first time since the shootings. School officials opened the building to allow students to collect their belongings from their lockers, and so they could visit the scene with their par-

Some of those who went inside were crying, Dunshee

"I think it was a healing process for all of them,' Dunshee said.

Counselors were there to listen to students who wanted someone to talk to, and Dunshee said some students did. Police officers also were visible inside. Posters and cards of encouragement from students in neighboring towns had been set up to view.

Oneidas ask to put lands in federal trust

SYRACUSE, N.Y. (AP) -The Oneida Indian Nation said Tuesday it applied to the U.S. Department of Interior to transfer title of approximately 17,000 acres of its lands in upstate New York to federal trust status.

The application was filed in response to the U.S. Supreme Court's recent decision against the tribe in its long-running dispute with the city of Sherrill over unpaid taxes on Indian-owned property.

"The Supreme Court detailed a roadmap for providing certainty regarding the nation's rights in its lands, and the nation is going to follow that roadmap," said Mark Emery, an Oneida spokesman.

In a near-unanimous decision two weeks ago, the Supreme Court reversed a lower appeals court ruling that 10 properties in Sherrill – among them a gas station, convenience store and defunct T-shirt factory- could revert to Indian land.

The Oneidas claimed because the Sherrill properties were once part of a sweeping 300,000-acre stretch of their land, those properties were no longer taxable by state and local officials after the tribe purchased the properties beginning in 1997.

Local officials were concerned the Oneida's would create a "disruptive" patchwork of local and Indian jurisdiction.

Although the Supreme Court disagreed with the tribe, saying too much time had passed for the Oneidas to claim tribal sovereignty on individual properties, the justices suggested the federal government "provides the proper avenue for the (tribe) to re-establish sovereign authority" over its reacquired aboriginal lands.

That mechanism, the high

court said, is asking the Interior Department's Bureau of Indian Affairs to hold the land "in trust" for the benefit of the tribe. Emery said the Oneidas

have asked to transfer all the

land they own in Madison and Oneida counties, including the properties in Sherrill. The process of accepting land into trust is expected to take six to nine months, Emery said. A spokesman for Gov.

George Pataki said the Oneida's application was not surprising in light of the tax consequences of the Sherrill decision.

"However, the federal landinto-trust process should not be used as an 'end-run' around the Supreme Court's concerns about creating a checkerboard of jurisdictions that would seriously burden local governments, taxpayers landowners," said Pataki spokesman Todd Alhart. "It is also very disappointing that the Nation took this action before consulting with Oneida and Madison counties."

Madison County Attorney John Campanie had a similar concern that the Oneidas were "attempting to negate the Supreme Court decision."

"It's good news that the Oneidas recognize that if they want sovereign status they must make application, and that the process involves standards that must meet," Campanie said. "But it's absolutely unacceptable that they would ask to put the entire 17,000 acres into trust."

As part of the application process, the federal government must consider, among other factors, the tribe's need for additional land, the purposes for which the land will be used, the impact on state and local governments of removing the land from tax rolls and other jurisdictional issues and potential land use conflicts, Sacks said.

Governer Doyle outlines State-Tribal Consultation Initiative

Governor Jim announced last week that his cabinet agencies will begin drafting internal policies to guide their interactions with the 11 Tribal governments on issues of shared concern. When adopted, the State-Tribal Consultation policies will have specific procedures in place directing agencies to consultation Wisconsin's tribal governments whenever they are

implementing programs or ing policies that have an effect on tribal governments or their citizens.

Among the many states that have tribes within their borders, Governor Doyle's State-Tribal Consultation initiative will place Wisconsin at the forefront in terms of fostering consultation and cooptribal governments.

The cabinet agencies' writ-

Consultation policies is pursuant to Executive Order #39 issued by Governor Doyle in February 2004, which directs cabinet agencies to establish procedures through which they would consult with the state's federally recognized tribal governments.

"The purpose of my eration among the state and Executive Order is to more closely facilitate interaction

between the State Wisconsin and the tribal governments whose citizens look to them to provide many of the same services that state provides," government Governor Doyle said. "This will open up opportunities to streamline, improve program efficiencies, avoid potential conflicts, and reduce the misunderstandings or mis-communications inherent in any government-to-government

To provide an available contact point for the tribes, Governor Doyle has established a section within the Department

relationship."

Oneida, Oneida

Administration, Division of Intergovernmental Relations. Laura Arbuckle, who was

raised on the Bad River Indian Reservation and an enrolled member, is the Division Administrator.

"I look forward to working with both the cabinet and elected tribal officials around the state to advance the Governor's bold new initiative," Arbuckle said. "The Governor understands that the state has not always consulted with the tribes when implementing policy. I firmly believe that this initiative is ushering in a new era in relations between the State of Wisconsin and the sovereign tribal nations within its borders."

To make sure that the Tribes have an opportunity to

provide input during the development of the consultation policies, Governor Doyle has offered to make members of his cabinet available for day-long visits to each of Wisconsin's 11 tribes. There, with the host Tribe and representatives from the other Tribal governments, each Secretary will solicit feedback on their proposed State-Tribal consultation policy prior to its adoption and implementation. The meetings have begun with the first meeting held in Lac du Flambeau on April 7. The meetings will run through the end of May.

An intro to the Oneida Compliance Division

What is the Oneida Compliance Division? The Compliance Division is a service and regulatory division composed of five departments; Licensing, Indian Preference, Occupational Health, Paralegal, and which Administration includes a Senior Advocate . The following is a brief overview of the functions of the different departments.

License **Department**

The License Department issues motor vehicle registrations with license plates and license tags for those Oneida tribal members living within the reservation boundaries pursuant to the regulations of the Oneida Motor Vehicle Registration Ordinance. This service for tribal members provides registration, plates and tags at a cost less than of the State fees. More importantly, though, the plates are a moving representation of our Nation's pride and sovereign-

The License Department issues vendor licenses pursuant to the regulations of the Oneida Vendor's Ordinance. This Ordinance mandates that those who do business with the tribe of \$1,000.00 or more must obtain a vendor's license and pay a \$75.00 yearly fee. This service ensures all vendors have the proper insurance and identification information.

The License Department issues alcohol sales licenses to The Tribe's Casinos pursuant to the regulations of the Oneida Alcohol Ordinance. Food vendor licenses are also issued pursuant to the regulations of the Oneida Food Service Code in conjunction with the Tribe's Health and Sanitation Department. These services, again, ensure the tribe's sovereignty and serves as a watchdog for the legal requirements of the sale of alcohol and food preparation health standards.

Indian Preference Department The Indian Preference

Department works under the requirements of the Indian Preference Law, and, for construction contracts, Rider I.

The Skills Bank of the Indian Preference Department assists individual Tribal members find work with those companies that contract with the Tribe within the Tribal boundaries. The Skills Bank works as a temporary agency for those Indian workers who need employment. Often, the temporary employment becomes permanent employment. This is one of the goals of the Indian Preference Department. Our people want and need employment, so those who contract with the Tribe must choose Indian workers from the Skills Bank list for employees in performance of the contract in accordance with the requirements of the Indian Preference Law.

Indian-Owned Business section of the department has a Certified Indian Preference vendor list for those Indian vendors that qualify under the Indian Preference requirements for certification. The certified Indian-owned businesses must be given an opportunity to bid as contractors and subcontractors for all bids over \$1,000.00 put out by the Tribe or the Tribe's general contractor. This service assists those Tribal members who own a business by assuring an opportunity for work on their own reservation.

Occupational Health

The Occupational Health Department is a service and regulatory department that is committed to support all employees at an optimum level of health and productivity. The nurses are occupational specialists with their emphasis in preventing illness, injuries and health hazards for tribal employees in the workplace.

Occupational Health provides pre-employment drug screening, CDL testing, and TB screening. They are also running blood pressure, cholesterol, and diabetes clinics throughout the employment environment. Teaching good health habits to employees and maintaining confidential health records is another function of the department. The department is regulated by the Federal Department of Education Health, Welfare's Public Health Service Regulations.

Paralegal Department

The Paralegal Department is a service to Tribal employees, in non-gaming, and to Tribal members.

The certified paralegals in this department provide answers, guidance and/or representation to tribal employees in a non-managerial or non-supervisory position regarding the policies and procedures for the employment disciplinary process pursuant to the regulations of the Oneida Personnel Policies and Procedures (the Blue Book) and the Administrative Procedures Act.

For GTC members, the paralegals will advise Tribal individuals in their questions of law and may represent them with their legal issues that fall within the jurisdiction of the Oneida Appeals Commission. The paralegals are also trained as pro-se divorce/family law specialists, to assist tribal members with their family law paperwork. One of the paralegals is currently being trained to draft simple wills, living wills and power of attorney documents for tribal members.

Senior Advocate of Compliance Administration

The Senior Advocate is an elder of the tribe that works part time to help and intervene for Tribal elders on or near the reservation area with their housing, employment and other difficulties they may experience related to their advanced years.

Legislative Update

The Land Claims Settlement

The Land Claims settlement has been our priority over the past year. As you may know, there is still the process of the New York State legislature approving the settlement legislation, and then on to Congress. This has been the status since the settlement agreement was adopted in December, 2004 by the General Tribal Council. Also, since December, the GTC reconvened to reconsider the adoption of the settlement, which failed and reiterated its support. 3 more GTC meetings have been requested to acquire a better understanding of what the settlement terms really mean. The OBC has scheduled these GTC dates for April 23, May 23 and June 11, 2005.

The City of Sherrill Case has also been decided by the Supreme Court. Although this was a case involving the Oneida Nation of New York, we did not know how it could impact our land claim settlement. As it stands today, it appears that the settlement can still move forward. The Supreme Court held unanimously, that this latest decision did not impact the Oneida Land Claims. The settlement will continue as planned. How detrimental this decision is to the Oneida Nation of New York, is still to be seen.

Another issue that could impact the "damages portion" of our settlement is a draft amendment to the Indian Gaming Regulatory Act being introduced by Congressman Pombo. This amendment is mostly aimed at restricting off reservation gaming activities that are currently being initiated by nized Tribes. Congressman Pombo assured us however, that he heard many concerns

from all types of tribes, and will not pursue this draft amendment without first holding public hearings on it. In addition he understands the unique situation rounding Oneida Tribe's interest in

New York and does not intend to disturb the resolution of the Land Claims. We continue to attend National Tribal Leaders meetings and are prepared to testify at any and all public hearings on this

Land To Trust

Land To Trust. This is another hot topic that the Business Committee has been working on. I would first like to express my sincere thanks and appreciation to the Land Management Staff, our Tribal Law Office and our Self- Governance Office for dedicating much time and attention to assisting us with this new development. What is that development? It is a Fee-to-Trust Consortium. The Fee-to-Trust Consortium was created for the purpose of streamlining and thereby expediting the land into trust applications for the participating Tribes, which are Oneida, WI and Shakopee. As the trustee for the Indian Tribes and people, the U.S. Federal Government has the responsibility to take land into trust on behalf of the tribes. Due to inadequate funding and staffing, the Midwest Regional Office (MRO) of the Bureau of Indian Affairs has been unable to process the large number of fee to trust applications submitted by tribes in the Midwest Region. It is the intent of this draft to provide the organization with the necessary authority to develop administrative rules to ensure just that. And I'm sure as we proceed through this process, the pain that we experience from change, will be minimal. The LOC will be mailing the draft out for public comment, and scheduling community, employee meetings and public hearings to gather as much input as possible. After all comments are received, and appropriate changes made, the final document will be forwarded to the July General Tribal Council Semi-annual meeting for consideration.

Tribes sign deal for reservation oil drilling

NEW TOWN, N.D. (AP) - than 20 barrels per day. The Three Affiliated Tribes has signed a deal with a izontal wells that will produce Denver-based group of oil from 500 to 900 barrels per companies to drill horizontal wells on the Fort Berthold early summer, Baker said. Reservation.

The five-year lease agreement with Black Rock Resources will involve the drilling of one well in each of the first two years. Other wells are possible depending on the success of the first two, said Kyle Baker, tribal geologist and minerals director.

It is the first time the tribe has made an agreement for oil development under the 1982 Indian Minerals Act, which expanded the authority of tribes to govern the development of their oil and gas resources, Baker said. Previously, the Bureau of Indian Affairs handled all the leasing.

There has never before been a successful well on land owned by the tribe, Baker said. The six current wells on the reservation all are on land owned by individual tribal members, and produce fewer

The tribe hopes to drill horday. Drilling could start by

Specific sites have not been determined, but Baker said one potential area is underneath Lake Sakakawea. The federal government returned most of the mineral rights under the lake to the tribe in 1984. The tribe completed a geological study of the lake about a year ago that defines target areas for exploration.

Baker said the tribe will ensure the drilling is done in a way that will not violate archaeological sites and sacred burial grounds, some of which are under the lake that was formed by the damming of the Missouri

"That's what we have to watch out for," he said.

Baker said oil development on the reservation will benefit

"It's a way to find money to fit our community needs," he said. "Every year we get more

community needs, and every year the government cuts back on funding."

The tribe is planning to build an oil refinery near Makoti, but Baker said that project is separate from the oil exploration agreement.



The students competed with over 500 other Native American Students from all over "Indian Country". It was an honor and an accomplish-





SECTION ONE: Types of Per Capita Distributions

1. Elder 65 Distribution:

- The General Tribal Council passed Resolution 6-30-90-A which directed a cash disbursement of \$500.00 per year to tribal members age 65 and over, payments to begin in 1994.
- Commencing with the 2003 payment and every other year thereafter, members age 65 and over will be receiving a 5% inflationary increase. This payment is to be perpetual. The 2005 Distribution amount increased to <u>\$551.25.</u>
- For those turning age 65 in October, November or December 2005 your Elder 65 monies will be paid one month after you turn 65. Example:

DOB: 12/1/1940 you will be paid end of January 2006.

2. Elder 62 Distribution:

- The General Tribal Council passed Resolution 8-11-97-A which directed a cash disbursement of \$2,000.00 per year to tribal members age 62 and over, beginning in 1998 and based on Gaming Compact renewal.
- For those turning age 62 in October, November or December 2005 your Elder 62 monies will be paid one month after you turn 62. Example: DOB: 12/1/1943 you will be paid end of January 2006.

3. General Membership Distribution:

The Oneida General Tribal Council passed resolution on 7-5-04-B which directed a cash disbursement of \$800.00 to be distributed to all mem-

- bers until the year 2013.
- These cash disbursements are eligible to all tribal members who become enrolled as of the deadline indicated by the Tribe, for each payment year. The monies for eligible members who are under the age of 18, at the time designated by the payment plan, are placed into a trust account.

4. Unclaimed 2004 Per Capita

Distributions:

- Please contact the Oneida Enrollment Department as each individual case may vary. The deadline to apply for the monies is close of business on Thursday, September 1, 2005.
- A FY-2005 Membership Payment Form or Supplemental Form must be filed by the deadline.
- 5. Minor Trust Account Payments:

- Individuals who have a trust account established will be mailed a payment form in the calendar quarter of the year which they turn the age of 18.
- Example: Your birth date is January 10, 1987, you fall into the 1st calendar quarter of the year, therefore, you will be mailed a minor trust payment form in January 2005 and you must return it on or before the deadline identified on the payment form. Your full trust account monies will then be mailed to you by the end of April
- Late payment forms will be paid with the Quarter Payment Group being processed at the time of submission.
- Individuals only have until their 26th birthday to claim their trust account monies.

SECTION TWO: Reporting and Taxation of Per Capita Distribution

- 1. All payments are subject to federal income tax and may be subject to state or other applicable taxes.
- 2. All payments must be reported as income and may affect eligibility for entitlement
- 3. Please contact your tax preparer, tax con

sultant or case worker with any questions. 4. Every person who is issued a payment will

- have a 1099-MISC tax form sent to them. 5. All minors who apply for their Trust Account monies in 2005, ESPECIALLY THOSE WHOSE BIRTH DATES FALL BETWEEN 9/1/1987 TO 12/31/1987, need to be sure to include the Trust Account monies when they file their 2005 taxes. A 2005 1099-MISC tax statement will be issued.
- 6. Persons that feel they may be imposed an

attachment(s) may want to consider completing the FY-2005 Membership Payment form to help reduce the amount of taxes owed on the full amount of their per capita paid on their behalf in 2005.

Example: Member #1 is eligible for \$800.00. A child support order is imposed as an attachment to take the entire \$800.00. Member #1 completes and returns the FY-2005 Membership Payment form, requesting to have 20% withheld for Federal Taxes. The child support agency will receive \$640.00 and \$160.00 will be paid on behalf of Member #1 towards their 2005 Federal Taxes withheld.

Note: Persons that may be imposed an attachment(s) and decide not to elect to have taxes withheld will still have to claim the total amount(s) paid on their behalf from the 2005 distribution and report the monies on their 2005 tax return.

SECTION THREE: Reminders and Miscellaneous Information

1. Power of Attorney and Guardians:

JOHN E. POWLESS, JR. FOR TRIBAL CHAIRMAN ONEIDA BUSINESS COMMITTEE

My name is John E. Powless Jr., I believe that my educational, tribal government and private sector experiences have prepared me to be the next Chairman of the Oneida

Political conversations and meetings have been a commonplace throughout my life...

I was born into this political environment on February 29, 1948 – son of John Sr. and Lois Powless. My paternal grandparents were Mark Powless and Margaret Stevens, and my maternal grandparents were Simon Moore and Irene Metoxen.

My grandfather, Mark Powless was elected Chairman after the formation of the tribal government under the Indian Reorganization Act of 1934. My grandmother, Irene Moore, was the first woman to be elected Chairperson of the Oneida Tribe. She was instrumental in encouraging Purcell Powless to run for Chairman. Purcell is a younger brother to my dad. Other family members who secured a position on the Oneida Business Committee include my uncle, Mark N. Powless, my mother, Lois, and my brother, Mark A. Powless.

Educational Background


