9. <u>Division 7 – Thermal and Moisture Protection</u>

- 9.1. Wall Sheeting to consist of 29-gauge galvanized G-100 substrate, Match existing.
- 9.2. Roof sheeting to consist of 26-gauge material with Moisture Lok (McElroy) for South Addition and 29-gauge material with Moisture Lok for North-East Waste Storage area.
- 9.3. Neoprene washers to be used for roof assembly.




