WHEREAS, on August 19, 1991, the Oneida General Tribal Council adopted Resolution 8-19-91-A and an addendum to the Resolution, which reauthorized the adoption of the Administrative Procedures Act and the creation of the Oneida Tribal

Judicial System, and

WHEREAS, on January 7, 2013, the Oneida General Tribal Council adopted Resolution 01-07-13-A, which repealed the lawmaking

WHEREAS, on January 7, 2013, the Oneida General Tribal Council adopted Resolution 01-07-13-B, which replaced the current

Oneida Tribal Judicial System with an Oneida Judiciary comprised of a Trial Court and a Court of Appeals to better serve

the needs of the Oneida people and expand the exercise of the Tribe's sovereign authority, and

WHEREAS, many of the laws contained in the Oneida Code of Laws and many of the Oneida Tribal Policies make reference to either

the Oneida Appeals Commission or the Oneida Tribal Judicial System, and it is necessary to amend those laws and

policies to reference the correct court system,

NOW THEREFORE BE IT RESOLVED, that the Oneida General Tribal Council authorizes the Oneida Business Committee, to complete corrective amendments to all of the laws contained in the Oneida Code of Laws and to all of the Oneida Tribal Policies that make reference to the Oneida Appeals Commission or the Oneida Tribal Judicial System and replace those terms with terms that are consistent with the Judiciary Law adopted by Resolution GTC-01-07-13-B,

BE IT FURTHER RESOLVED, that the Oneida General Tribal Council authorizes this action to bypass the procedural requirements in the Legislative Procedures Act for the purpose of efficiency,

BE IT FINALLY RESOLVED, that this Resolution shall be effective immediately.
