

Shekoli Oneida Students, Parents, Educational Leaders & Community Members:

I recognize the value of youth and their current contributions to our Nation. Youth are the future leaders who will continue to exercise and protect our sovereignty, speak and preserve our language, sustain our culture, and set the path for future generations.

For these reasons, the Oneida Business Committee supports the opportunity for up to six youth to attend the National Congress of American Indians Mid-Year Conference and Marketplace Youth Commission in Sparks, Nevada, June 23-27, 2019. Funding for the conference, travel, lodging and meals will be covered through the Business Committee's Special Projects budget. Students will be responsible for their own spending money.

All Oneida enrolled students who will be in 11th or 12th grade in fall 2019, who are interested in improving their leadership skills and actively contributing to the community, are invited to apply.

NCAI's Youth Commission provides a unique perspective on issues relevant to Tribal youth and is an opportunity to acquire knowledge about Tribal government, Native American legislative and governmental affairs and political science. It's also a chance to connect with youth from across Indian Country and give input to tribal leaders. The mission of the Youth Commission is focused on enhancing the spiritual, mental, physical and emotional well-being of tribal youth for a better Native America, which is a great approach to further developing our young leaders.

I will be attending the NCAI conference, as well as two other members of the Business Committee, and look forward to having the opportunity to interact with the youth who will also be in attendance. Additionally, Youth Enrichment Services (YES) employees will serve as chaperones on the trip.

The application and related details are attached to this letter and must be received, or post marked by May 15, 2019 and will be processed through the Senior Policy Advisor, Laura Laitinen-Warren.

The selection process is as follows: Upon receipt of completed applications, the Statements of Interest will be placed in a survey, without names, and a panel comprised of tribal leaders and community members will rate each of the responses on multiple criteria including:

- Clarity: Response is well thought out and easy to understand.
- Content: Response is complete with key ideas explained.
- Creativity: Response reflects the unique, personal voice of the student.

The six students with the highest scores will be eligible to represent the Oneida Nation at the National Congress of American Indians' Youth Commission. The student will be notified by phone and email on May 21st. Once notified, a future meeting will be set up to complete additional paperwork and to prepare the youth for their trip.
