INSTRUCTIONS FOR FILING A PETITION FOR ADOPTION

- 1. a. Complete the Petition for Adoption.
 - b. In the case of a stepparent adoption, complete the Petition for Adoption and the Summons.
- 2. a. Make a copy of the Petition for Adoption for yourself.
 - b. In the case of a stepparent adoption, make a copy of the Petition for Adoption and Summons for yourself and your spouse.
- 3. File the original and the copies of the Petition for Adoption and Summons, if applicable, and pay the \$25.00 filing fee with the Clerk.
 - a. In the case of a stepparent adoption, the Clerk will look over your papers and fill in the case number and the court date on the Summons.
- 4. In the case of a stepparent adoption, have your spouse complete the Admission of Service form and return the completed and notarized form to the Court prior to the adoption hearing (or have your spouse served pursuant to sections 803.5-6(a) (c) of the Oneida Judiciary Rules of Civil Procedure and return an Affidavit of Service to the Court prior to the hearing).
- 5. The Court will provide notice to the guardian of the child when ordering the adoption investigation pursuant to 7 O.C. 708.43-3.
- 6. While a parent who has had their parental rights terminated is not entitled to notice of an adoption hearing, they may appear as an interested party and may enter into an agreement regarding residual rights (e.g. communication, visitation, support and education, etc.) in any customary adoption pursuant to 7 O.C. 708.41-2(d) and 708.43-6.
