**RE:** Sanctions and Penalties law adoption packet for consideration by GTC

### **PURPOSE**

The Legislative Operating Committee (LOC) is requesting the Business Committee (BC) to accept the Sanctions and Penalties law adoption packet and to add an item to the tentatively scheduled 2020 annual General Tribal Council (GTC) meeting agenda in ordero for GTC to consider the proposed law. Business Committee approval is needed to add items to a GTC agenda.

### BACKGROUND

This same request came before the BC at the November 26, 2019, regular BC meeting. After discussion, the following motion was made:

Motion by Daniel Guzman King to defer the Sanctions and Penalties law materials back to the Legislative Operating Committee for considertation of today's discussion and reformatting of therequest to General Tribal Council, seconded by Ernie Stevens III. Motion carried.
